

1 [Planning Code - Consolidate Definitions, Reorganize Article 2, and Make Other
2 Nonsubstantive Changes to Update, Clarify, and Simplify Code Language]

3 **Ordinance amending the Planning Code to consolidate definitions into Section 102,**
4 **reorganize Article 2 to create Zoning Control Tables, and make nonsubstantive**
5 **changes to various sections in Articles 1, 2, 3, 4, 6, 7, and 8, in order to update, clarify,**
6 **and simplify Code language; affirming the Planning Department’s California**
7 **Environmental Quality Act determination; and making findings of consistency with the**
8 **General Plan, and the eight priority policies of Planning Code, Section 101.1.**

16 Be it ordained by the People of the City and County of San Francisco:

17 Section 1. Findings.

18 (a) The Planning Department has determined that the actions contemplated in this
19 ordinance comply with the California Environmental Quality Act (California Public Resources
20 Code Sections 21000, et seq.). The Board of Supervisors hereby affirms this determination.
21 Said determination is on file with the Clerk of the Board of Supervisors in File No. 141253 and
22 is incorporated herein by reference.

23 (b) On November 20, 2014, the Planning Commission, in Resolution No. 19280,
24 adopted findings that the actions contemplated in this ordinance are consistent, on balance,
25 with the City’s General Plan and eight priority policies of Planning Code Section 101.1. The
Board

1 adopts these findings as its own. A copy of said Resolution is on file with the Clerk of the
2 Board of Supervisors in File No. 141253 and is incorporated herein by reference.

3 (c) Pursuant to Planning Code Section 302, this Board finds that these Planning Code
4 amendments will serve the public necessity, convenience, and welfare for the reasons set
5 forth in Planning Commission Resolution No. 19280 and the Board incorporates such reasons
6 herein by reference.

7 Section 2. Article 1 of the Planning Code is hereby amended by adding Section 186.3,
8 revising Sections 102 through 102.37, 121.9, 124, 127, 128, 136, 136.1, 145.1, 145.4, 151.1,
9 155, 156, 159, 168, 178, 179.1, 181, 182, 183, 184, 186.1, 187.1, and 187.2, and deleting
10 Sections 121.5, 121.8, 136.2, 136.3, and 175.7, to read as follows:

11 **SEC. 102. DEFINITIONS.**

12 For the purposes of this Code, certain words and terms used herein are defined as set
13 forth in this and the following sections. Additional definitions applicable to Article 7,
14 Neighborhood Commercial Districts, and to Article 9, Mission Bay Districts, are set forth in
15 Section 790. Additional definitions applicable only to Article 8, Mixed Use Districts, are set
16 forth in Section 890. Additional definitions applicable only to the Bernal Heights Special Use
17 District are set forth in Section 242. Additional definitions applicable only to Article 9, Mission
18 Bay Districts, are set forth in Section 996. All words used in the present tense shall include the
19 future. All words in the plural number shall include the singular number, and all words in the
20 singular number shall include the plural number, unless the natural construction of the
21 wording indicates otherwise. The word "shall" is mandatory and not directory. Whenever any
22 of the following terms is used it shall mean the corresponding officer, department, board or
23

1 commission or its successor of the City and County of San Francisco, State of California,
2 herein referred to as the City: Assessor, Board of Supervisors, Planning Department ~~of City~~
3 ~~Planning~~, Department of Public Works, Director of Planning, ~~City~~ Planning Commission, or
4 Zoning Administrator. In each case, the term shall be deemed to include an employee of any
5 such officer or department of the City who is lawfully authorized to perform any duty or
6 exercise any power as a representative or agent of that officer or department.

7 A

8 **Adjacent Building.** Generally, a building on a lot adjoining the subject lot along a side lot line.

9 **Adult Business.** A Retail Sales and Service Use that includes the following: adult bookstore or
10 adult video store, as defined by Section 791 of the Police Code; adult theater, as defined by Section 791
11 of the Police Code; and encounter studio, as defined by Section 1072.1 of the Police Code. Such use
12 shall be located no less than 1,000 feet from another Adult Business use.

13 ~~SEC. 102.35. **Urban Agriculture.** Urban Agriculture shall be defined as follows: A Use~~
14 ~~Category that includes Neighborhood Agriculture, Large-Scale Urban Agriculture, and Greenhouse.~~

15 ~~(b) **Large-Scale Agriculture, Large-Scale Urban.** An Agricultural Use that is characterized by~~
16 ~~the use of land for the production of food or horticultural crops to be harvested, sold, or~~
17 ~~donated that occur: (1) (a) on a plot of land ~~± one~~ acre or larger or (2) (b) on smaller parcels~~
18 ~~that cannot meet the physical and operational standards for Neighborhood Agriculture. This~~
19 ~~use is subject to location and operational conditions outlined in Section 202.2(c) of this Code.~~

20 ~~(a) **Neighborhood Agriculture, Neighborhood.** An Agricultural Use that occupies less than~~
21 ~~± one~~ acre for the production of food or horticultural crops to be harvested, sold, or donated
22 and complies with the controls and standards herein. The use includes, but is not limited to,
23 home, kitchen, and roof gardens. Farms that qualify as Neighborhood Agricultural use may
24 include, but are not limited to, community gardens, community-supported agriculture, market
25 gardens, and private farms. Neighborhood Agricultural use may be principal or accessory use.
This use is subject to location and operational conditions outlined in Section 202.2(c) of this Code.

1 **Agriculture, Urban.** Any subgrouping of Agricultural Uses that includes either Neighborhood
2 Agriculture or Large-Scale Urban Agriculture.

3 ~~SEC. 102.1.~~ **Alley.** A right-of-way, less than 30 feet in width, permanently dedicated to
4 common and general use by the public.

5 **Ambulance Service.** See Service, Ambulance.

6 **Animal Hospital.** A Retail Sales and Service Use that provides medical care and accessory
7 boarding services for animals, not including a Kennel.

8 ~~SEC. 102.2.~~ **Arts Activities and Spaces.** ~~Arts activities shall~~ A Retail Entertainment, Arts
9 and Recreation Use that includes performance, exhibition (except exhibition of films), rehearsal,
10 production, post-production and some schools of any of the following: Dance, music, dramatic
11 art, film, video, graphic art, painting, drawing, sculpture, small-scale glassworks, ceramics,
12 textiles, woodworking, photography, custom-made jewelry or apparel, and other visual,
13 performance and sound arts and craft. It shall exclude accredited ~~s~~Schools and ~~accredited~~
14 ~~p~~Post-~~s~~Secondary ~~e~~Educational ~~i~~Institutions ~~as defined by 209.3(k), 217(h), 790.50(e) and~~
15 ~~890.50(e).~~ It shall include commercial arts and art-related business service uses including, but
16 not limited to, recording and editing services, small-scale film and video developing and
17 printing; titling; video and film libraries; special effects production; fashion and photo stylists;
18 production, sale and rental of theatrical wardrobes; and studio property production and rental
19 companies. Arts spaces shall include studios, workshops, ~~galleries, museums,~~ archives and
20 theaters, and other similar spaces customarily used principally for arts activities, exclusive of a
21 Movie ~~#~~Theaters ~~subject to Section 221(d), dance halls subject to Section 221(f), Amusement~~
22 Enterprise, ~~a~~Adult ~~e~~Entertainment ~~subject to Section 221(k) of this Code,~~ and any other
23 establishment where liquor is customarily served during performances.

24 **Automobile Assembly.** An Industrial Use that involves the assembly of parts for the purpose of
25 manufacturing automobiles, trucks, buses, or motorcycles. This use is subject to operational and
location restrictions outlined in Section 202.2(d) of this Code.

1 **Automobile Wrecking.** An Industrial Use that includes the storage of vehicles in not in
2 operational condition and/or sale of used automobile parts, or for the storage, dismantling, or
3 abandonment of junk, automobiles, trailers, machinery or parts thereof. This use is subject to
4 operational and location restrictions outlined in Section 202.2(d) of this Code.

5 **Automobile Sale or Rental.** A Retail Automotive Use that provides vehicle sales or rentals
6 within a building or on an open lot.

7 **Automotive Repair.** A Retail Automotive Use that provides any of the following automotive
8 repair services, when conducted within an enclosed building having no openings, other than fixed
9 windows or exits required by law, located within 50 feet of any R District: minor auto repair, engine
10 repair, rebuilding, or installation of power train components, reconditioning of badly worn or damaged
11 motor vehicles, collision service, or full body paint spraying. It may include other services for
12 automobiles including, but not limited to, accessory towing, if all towed vehicles stored on the premises
13 are limited to those vehicles that are to be repaired on the premises.

14 **Automotive Service.** A subgrouping of Retail Automotive Uses providing services for motor
15 vehicles that includes Automotive Gas Station, Automotive Service Station, Automotive Repair, and
16 Automotive Wash.

17 **Automotive Service Station.** A Retail Automotive Use that provides motor fuels and lubricating
18 oils directly into motor vehicles and minor auto repairs (excluding engine repair, rebuilding, or
19 installation of power train components, reconditioning of badly worn or damaged motor vehicles,
20 collision service, or full body paint spraying) and services that remain incidental to the principal sale
21 of motor fuel. Repairs shall be conducted within no more than three enclosed service bays in buildings
22 having no openings, other than fixed windows or exits required by law, located within 50 feet of any R
23 District. It may include other incidental services for automobiles including, but not limited to,
24 accessory towing, if the number of towing vehicles does not exceed one, and all towed vehicles stored
25 on the premises are limited to those vehicles that are to be repaired on the premises.

1 **Automotive Use.** A Commercial Use category that includes Automotive Repair, Ambulance
2 Services, Automobile Sale or Rental, Automotive Service Station, Automotive Wash, Gas Station, Parcel
3 Delivery Service, Private Parking Garage, Private Parking Lot, Public Parking Garage, Public
4 Parking Lot, Vehicle Storage Garage, Vehicle Storage Lot ,and Vehicle Tow Service. All Automotive
5 Uses that have Vehicular Use Areas defined in this Section of the Code shall meet the screening
6 requirements for vehicular use areas in Section 142.

7 **Automotive Use, Non-Retail.** A subcategory of Automotive Use that includes Ambulance
8 Services, Parcel Delivery Service, Private Parking Garage, Private Parking Lot, and Vehicle Tow
9 Service.

10 **Automotive Use, Retail.** A subcategory of Automotive Use that includes Automotive Repair,
11 Automotive Sale or Rental, Automobile Service Station, Automotive Wash, Gas Station, Public Parking
12 Garage, Public Parking Lot, Vehicle Storage Garage, and Vehicle Storage Lot.

13 **Automotive Wash.** A Retail Automotive Use that provides cleaning and polishing of motor
14 vehicles, including self-service operations. This use is subject to the location and operational
15 restrictions in Section 202.2(e).

16 **Awning.** A light roof-like structure, supported entirely by the exterior wall of a building;
17 consisting of a fixed or movable frame covered with cloth, plastic, or metal; extending over doors,
18 windows, and/or show windows; with the purpose of providing protection from sun and rain and/or
19 embellishment of the façade; as further regulated in Section 3105 of the Building Code.

20 **B**

21 **Bar.** A Retail Sales and Service Use that provides on-site alcoholic beverage sales for drinking
22 on the premises, including bars serving beer, wine and/or liquor to the customer where no person
23 under 21 years of age is admitted (with Alcoholic Beverage Control [ABC] license types 23, 42, 48, or
24 61) and drinking establishments serving beer where minors are present (with ABC license types 42 or
25 60) in conjunction with other uses such as Movie Theaters and General Entertainment. Such businesses
shall operate with the specified conditions in Section 202.2(a).

1 **Basement.** See Story.

2 ~~SEC. 102.29.~~ **Bedroom.** A room primarily used for "sleeping that meets the minimum
3 requirements ~~room~~" as defined in the Building Code for sleeping rooms.

4 **Board of Supervisors (Board).** The Board of Supervisors of the City and County of San
5 Francisco.

6 **Bona Fide Eating Place.** A place that is regularly and in a bona fide manner used and kept
7 open for the service of meals to guests for compensation and that has suitable kitchen facilities
8 connected therewith, containing conveniences for cooking of an assortment of foods that may be
9 required for ordinary meals.

10 (a) "Meals" shall mean an assortment of foods commonly ordered at various hours of the day
11 for breakfast, lunch, or dinner. Incidental food service, comprised only of appetizers to accompany
12 drinks, is not considered a meal. Incidental, sporadic, or infrequent sales of meals or a mere offering of
13 meals without actual sales is not compliance.

14 (b) "Guests" shall mean persons who, during the hours when meals are regularly served
15 therein, come to a bona fide public eating place for the purpose of obtaining, and actually order and
16 obtain at such time, in good faith, a meal therein. Nothing in this section, however, shall be construed
17 to require that any food be sold or purchased with any beverage.

18 (c) Actual and substantial sales of meals are required, during the normal days and meal hours
19 that a bona fide public eating place is open, provided that "normal days of operation" shall mean a
20 minimum of five days a week and "normal hours" of operation for meal service shall mean
21 approximately 7:00 a.m. to 11:00 a.m. if open for breakfast; 11:00 a.m. to 2:00 p.m. if open for lunch;
22 or 5:00 p.m. to 10:00 p.m. if open for dinner.

23 (d) The premises must be equipped and maintained in good faith. This means the premises must
24 possess working refrigeration and cooking devices, pots, pans, utensils, table service, condiment
25 dispensers, menus, signs, and enough goods to make substantial meals. The premises must comply with
all regulations of the Department of Public Health.

1 (e) A minimum of 51 percent of the restaurant's gross receipts shall be from food sales prepared
2 and sold to guests on the premises. Records of the restaurant's gross receipts shall be provided to the
3 Department upon request.

4 (f) A "bona fide eating place" does not include an Adult Business as defined in this Section of
5 the Code.

6 ~~SEC. 102.3.~~ **Building.** Any structure having a roof supported by columns or walls.

7 C

8 Canopy. A light roof-like structure, supported by the exterior wall of a building and on columns
9 or wholly on columns, consisting of a fixed or movable frame covered with approved cloth, plastic or
10 metal, extending over entrance doorways only, with the purpose of providing protection from sun and
11 rain and/or embellishment of the façade, as further regulated in Section 3105 of the Building Code.

12 Cat Boarding. A Retail Sales and Service Use that provides boarding only for cats.

13 Catering. A Non-Retail Sales and Service Use that involves the preparation and delivery of
14 goods including the following items: food, beverages; balloons, flowers, plants, party decorations and
15 favours; or cigarettes/candy.

16 Chair/Foot Massage. See Massage, Chair/Foot.

17 Change of Use. A change of gross floor area from one category of use to another category of
18 use listed in the use table for the zoning district of the subject lot.

19 Child Care Facility. An Institutional Community Use defined in California Health and Safety
20 Code Section 1596.750 that provides less than 24-hour care for children by licensed personnel and
21 meets the open-space and other requirements of the State of California and other authorities.

22 City. The City and County of San Francisco.

23 Commercial Use. A land use with the sole or chief emphasis on making financial gain,
24 including but not limited to Agricultural Uses, Industrial Uses, Sales and Service Uses, Retail
25 Entertainment Uses, and Auto Uses.

Commission. The San Francisco Planning Commission.

1 **Community Facility.** An Institutional Community Use that includes community clubhouses,
2 neighborhood centers, community cultural centers, or other community facilities not publicly owned
3 but open for public use in which the chief activity is not carried on as a gainful business and whose
4 chief function is the gathering of persons from the immediate neighborhood in a structure for the
5 purposes of recreation, culture, social interaction, health care, or education other than Institutional
6 Uses as defined in this Section.

7 **Community Facility, Private.** An Institutional Community Use that includes a private lodge,
8 private clubhouse, and private recreational facility other than a Community Facility as defined in this
9 section, and which is not operated as a gainful business.

10 **Community Recycling Collection Center.** A Utility and Infrastructure Use that collects, stores,
11 or handles recyclable materials, including glass and glass bottles, newspaper, aluminum, paper and
12 paper products, plastic and other materials which may be processed and recovered, if within a
13 completely enclosed container or building, having no openings other than fixed windows or exits
14 required by law, provided that: (1) Flammable materials are collected and stored in metal containers;
15 and (2) Collection hours are limited to 9:00 a.m. to 7:00 p.m. daily. It does not include the storage,
16 exchange, packing, disassembling or handling of junk, waste, used furniture and household equipment,
17 used cars in operable condition, used or salvaged machinery, or salvaged house-wrecking and
18 structural steel materials and equipment.

19 **Condition(s) of Approval.** A condition or set of written conditions imposed by the Planning
20 Commission or another permit-approving or issuing City agency or appellate body to which a project
21 applicant agrees to adhere and fulfill when it receives approval for the construction of a development
22 project subject to this Article.

23 **Corner Lot.** See Lot, Corner.

24 ~~SEC. 102.37.~~ **Cottage Food Operation.** An Accessory Use to a ~~d~~Dwelling ~~#~~Unit as
25 defined in Section 113758 of the California State Health and Safety Code.

1 ~~SEC. 102.4.~~ **Court.** Any space on a lot other than a yard ~~which~~ that, from a point not
2 more than two feet above the floor line of the lowest story in the building on the lot in which
3 there are windows from rooms abutting and served by the court, is open and unobstructed to
4 the sky, except for obstructions permitted by this Code. An "outer court" is a court, one entire
5 side or end of which is bounded by a front setback, a rear yard, a side yard, a front lot line, a
6 street, or an alley. An "inner court" is any court that is not an outer court.

7 **D**

8 **DBI.** The San Francisco Department of Building Inspection or its successor.

9 **Department.** See Planning Department.

10 **Development Impact Fee.** A fee imposed on a development project as a condition of approval
11 to mitigate the impacts of increased demand for public services, facilities, or housing caused by the
12 development project that may or may not be an impact fee governed by the California Mitigation Fee
13 Act (California Government Code Section 66000, et seq.).

14 **Design Professional.** A Non-Retail Sales and Service Use that provides professional design
15 services to the general public or to other businesses and includes architectural, landscape
16 architectural, engineering, interior design, and industrial design services. It does not include (1) the
17 design services of graphic artists or other visual artists which are included in the definition of Arts
18 Activities; or (2) the services of advertising agencies or other services which are included in the
19 definition of Professional Service or Non-Retail Professional Service, Financial Service or Medical
20 Service.

21 **Director.** The Director of the Planning Department or his or her designee.

22 ~~SEC. 102.5.~~ **District.** A portion of the territory of the City, as shown on the Zoning Map,
23 within which certain regulations and requirements or various combinations thereof apply under
24 the provisions of this Code. The term "district" shall include any use, special use, height and
25 bulk, or special sign district. The classes of use districts are described in Section 201 of this
Code.

1 **Drive-Up Facility.** A Use Characteristic that includes a structure designed for drive-to or
2 drive-through trade which provides service to patrons while in private motor vehicles, excluding
3 Automotive Gas Station, Automotive Service Station, Automotive Repair, and Automotive Wash.

4 **DPW.** The Department of Public Works or its successor.

5 ~~SEC. 102.6.~~ **Dwelling.** A building, or portion thereof, containing one or more ~~d~~Dwelling
6 ~~#~~Units. A "one-family dwelling" is a building containing exclusively a single ~~d~~Dwelling ~~#~~Unit. A
7 "two-family dwelling" is a building containing exclusively two ~~d~~Dwelling ~~#~~Units. A "three-family
8 dwelling" is a building containing exclusively three ~~d~~Dwelling ~~#~~Units.

9 ~~SEC. 102.7.~~ **Dwelling Unit.** A Residential Use defined as a room or suite of two or more
10 rooms that is designed for, or is occupied by, one family doing its own cooking therein and
11 having only one kitchen. A housekeeping room as defined in the Housing Code shall be a
12 ~~d~~Dwelling ~~#~~Unit for purposes of this Code. For the purposes of this Code, a ~~l~~Live/~~w~~Work ~~u~~Unit,
13 as defined in this Section ~~102.13 of this Code~~, shall not be considered a ~~d~~Dwelling ~~#~~Unit.

14 **E**

15 **Eating and Drinking Use.** A grouping of Retail Sales and Service Uses that provide food
16 and/or beverages for either on- or off-site food consumption including Bars, Restaurants, Limited-
17 Restaurants, and Take-out Food. Eating and Drinking Uses are subject to the conditions in Section
18 202.2(a).

19 **Entertainment.** See also Entertainment, Arts and Recreation Use, General Entertainment,
20 Limited Live Performance, Nighttime Entertainment, and Outdoor Entertainment.

21 **Entertainment, General.** A Retail Entertainment, Arts and Recreation Use that provides
22 entertainment or leisure pursuits to the general public including billiard halls, bowling alleys, skating
23 rinks, min-golf and game arcades, when conducted within a completely enclosed building, and which is
24 adequately soundproofed or insulated so as to confine incidental noise to the premises.

25 ~~SEC. 102.17.~~ ~~Nighttime~~ **Entertainment, Nighttime Uses.** Nighttime entertainment uses shall A
Retail Entertainment, Arts and Recreation Use that includes dance halls, discotheques, nightclubs,

1 private clubs, and other similar evening-oriented entertainment activities which require dance
2 hall keeper police permits or Place of Entertainment ~~or Limited Live Performance~~ police permits,
3 as defined in Section 1060 of the Police Code, which are not limited to non-amplified live
4 entertainment, including ~~r~~Restaurants and ~~b~~Bars which present such activities, but shall not
5 include any ~~a~~Arts Activity ~~activities or space as defined in Section 102.2 of this Code~~, any theater
6 performance space which does not serve alcoholic beverages during performances, or any
7 temporary uses permitted pursuant to Sections 205 through ~~205.3~~ 205.4 of this Code.

8 **Entertainment, Outdoor.** A Retail Entertainment, Arts and Recreation Use that includes
9 circuses, carnivals, or other amusement enterprises not conducted within a building, and conducted on
10 premises not less than 200 feet from any R District.

11 **Entertainment, Arts and Recreation, Non-Commercial.** A subcategory of Entertainment, Arts
12 and Recreation Uses that includes Open Recreation Area and Passive Outdoor Recreation.

13 **Entertainment, Arts and Recreation, Retail.** A subcategory of Entertainment, Arts and
14 Recreation Uses that includes Arts Activities, General Entertainment, Livery Stables, Movie Theater,
15 Nighttime Entertainment, Outdoor Entertainment, and Sports Stadium.

16 **Entertainment, Arts and Recreation Use.** A Use Category that includes Arts Activities,
17 General Entertainment, Livery Stables, Movie Theater, Nighttime Entertainment, Open Recreation
18 Area, Outdoor Entertainment, Passive Outdoor Recreation and Sports Stadiums. Adult Business is not
19 included in this definition, except for the purposes of Development Impact Fee Calculation as described
20 in Article Four.

21 **F**

22 **Façade.** An entire exterior wall assembly including, but not limited to, all finishes and siding,
23 fenestration, doors, recesses, openings, bays, parapets, sheathing, and framing.

24 **Façade, Front.** The portion of the Façade fronting a right-of-way, or the portion of the Façade
25 most closely complying with that definition, as in the case of a flag lot. Where a lot has more than one

1 frontage on rights-of-way. all such frontages shall be considered Front Façades except where a façade
2 meets the definition of "Rear Façade."

3 ~~SEC. 102.22. Principal Façades, Principal.~~ Exterior walls of a ~~b~~Building that are
4 adjacent to or front on a public street, park, or plaza.

5 Façade, Rear. That portion of the Façade facing the part of a lot that most closely complies
6 with the applicable Planning Code rear yard requirements.

7 Fair Return on Investment. Where the property owner does not own the business, the before
8 income tax total annual rent and other compensation received from the business for the lease of the
9 land and buildings, less the expenses of the lessor, on a cash basis. Where the property owner also
10 owns the business, the before income tax profit on the sale of all goods and services at the business on
11 a cash basis; for an Automotive Service Station business, it shall include the sale of gasoline, less the
12 cost of goods sold and operating costs.

13 ~~SEC. 102.8. Family.~~ A single and separate living unit, consisting of either: ~~(a) One~~
14 person, or two or more persons related by blood, marriage or adoption or by legal
15 guardianship pursuant to court order; plus necessary domestic servants and not more than
16 three roomers or boarders; ~~(b) or A~~ a group of not more than five persons unrelated by blood,
17 marriage or adoption, or such legal guardianship unless the group has the attributes of a family in
18 that it (a) has control over its membership and composition; (b) purchases its food and prepares and

23 of the several floors of a building or buildings, measured from the exterior faces of exterior
24 walls or from the centerlines of walls separating two buildings. Where columns are outside
25 and separated from an exterior wall (curtain wall) that encloses the building space or are
otherwise so arranged that the curtain wall is clearly separate from the structural members,

1 the exterior face of the curtain wall shall be the line of measurement, and the area of the
2 columns themselves at each floor shall also be counted.

11 plant, malt manufacturing or processing plant, fish curing, smoking, or drying, cereal manufacturing,

18 nuisance to the surrounding area including but not limited to a flour mill, sugar refinery, and wool
19 pulling or scouring. This use does not include the processing of wood pulp, and is subject to the
20 operating conditions outlined in Section 202.2(d)

21 **Formula Retail.** A type of retail sales activity or retail sales establishment that has eleven or
22 more other retail sales establishments located in the United States. In addition to the eleven
23 establishments, the business maintains two or more of the following features: a standardized array of
24 merchandise, a standardized façade, a standardized decor and color scheme, a uniform apparel,
25 standardized signage, and/or a trademark or a servicemark.

1 (a) For the purposes of this definition, a retail sales activity or retail sales establishment shall
2 include the following uses as defined in this Section of this Code: "Bar," "Drive-up Facility," "Eating
3 and Drinking Use," "Liquor Store," "Sales and Service, Other Retail," "Restaurant," "Limited-
4 Restaurant," "Take-Out Food," "Sales and Service, Retail," "Service, Financial," and "Movie Theater,"

5 (b) Standardized array of merchandise shall be defined as 50 percent or more of in-stock
6 merchandise from a single distributor bearing uniform markings.

7 (c) Trademark shall be defined as a word, phrase, symbol, or design, or a combination of
8 words, phrases, symbols, or designs that identifies and distinguishes the source of the goods from one
9 party from those of others.

10 (d) Servicemark shall be defined as a word, phrase, symbol, or design, or a combination of
11 words, phrases, symbols, or designs that identifies and distinguishes the source of a service from one
12 party from those of others.

13 (e) Decor shall be defined as the style of interior furnishings, which may include, but is not
14 limited to, style of furniture, wall coverings or permanent fixtures.

15 (f) Color Scheme shall be defined as a selection of colors used throughout, such as on the

2 187.1, and 228.

3 **General Entertainment.** *See Entertainment, General.*

4 **General Grocery.** *See Grocery, General.*

5 **Gift Store-Tourist Oriented.** *A Retail Sales and Service Use that involves the marketing of*
6 *small art goods, gifts, souvenirs, curios, or novelties to the public, particularly those who are visitors to*
7 *San Francisco rather than local residents.*

8 **Grain Elevator.** *An Industrial Use defined as a storage facility for grain that contains a bucket*
9 *elevator or a pneumatic conveyor that scoops up grain from a lower level and deposits it in a silo or*
10 *other storage facility. This use also covers the entire elevator complex including, but not limited to,*
11 *receiving and testing offices, weighbridges, and storage facilities.*

12 **Greenhouse.** *An Agricultural use that involves the cultivation of plants inside a glass building.*
13 *This definition does not include accessory structures located in a required rear yard that comply with*
14 *Section 136(c)(22) of this Code.*

15 **Grocery, General.** *A Retail Sales and Services Use that:*

16 *(a) Offers a diverse variety of unrelated, non-complementary food and non-food commodities,*
17 *such as beverages, dairy, dry goods, fresh produce and other perishable items, frozen foods, household*
18 *products, and paper goods;*

19 *(b) May provide beer, wine, and/or liquor sales for consumption off the premises with a*
20 *California Alcoholic Beverage Control Board License type 20 (off-sale beer and wine) or type 21 (off-*
21 *sale general) within the accessory use limits as set forth in Section 703.2(b)(1)(C)(vi);*

22 *(c) Prepares minor amounts or no food on site for immediate consumption; and*

23 *(d) Markets the majority of its merchandise at retail prices.*

24 *(e) May have a Limited Restaurant use within the accessory use limits as set forth in Section*
25 *703.2(b)(1)(C)(iii).*

(f) Such businesses shall operate with the specified conditions in Section 703.5.

1 **Grocery, Specialty.** *A Retail Sales and Services Use that:*

2 *(a) Offers specialty food products such as baked goods, pasta, cheese, confections, coffee, meat,*
3 *seafood, produce, artisanal goods, and other specialty food products, and may also offer additional*
4 *food and non-food commodities related or complementary to the specialty food products;*

5 *(b) May provide beer, wine, and/or liquor sales for consumption off the premises with a*
6 *California Alcoholic Beverage Control Board License type 20 (off-sale beer and wine) or type 21 (off-*
7 *sale general) within the accessory use limits as set forth in Section 703.2(b)(1)(C)(vi);*

8 *(c) Prepares minor amounts or no food on site for immediate consumption; and*

9 *(d) Markets the majority of its merchandise at retail prices.*

10 *(e) May provide Limited Restaurant services within the accessory use limits as set forth in*
11 *Section 703.2(b)(1)(C)(iii).*

12 *(f) Such businesses shall operate with the specified conditions in Section 703.5.*

13 **Gross Floor Area.** *See Floor Area, Gross*

14 **Group Housing.** *A Residential Use that provides lodging or both meals and lodging, without*
15 *individual cooking facilities, by prearrangement for a week or more at a time, in a space not defined by*
16 *this Code as a dwelling unit. Such group housing shall include, but not necessarily be limited to, a*
17 *Residential Hotel, boardinghouse, guesthouse, rooming house, lodging house, residence club,*
18 *commune, fraternity or sorority house, monastery, nunnery, convent, or ashram. It shall also include*
19 *group housing affiliated with and operated by a medical or educational institution, when not located on*

transfer, storage, resource recovery, disposal, or recycling of hazardous waste that is produced at an

1 off-site facility, but shall not include a facility that: (1) manages only used oil, used oil filters, latex
2 paint, antifreeze, small household batteries or lead acid batteries; or (2) establishes that it is not
3 required to obtain a hazardous waste facility permit from the State of California. The terms "hazardous
4 waste," "treatment," "transfer," "storage," "disposal," "off-site facility," and "used oil" as used herein
5 shall have the meaning given those terms in the California Health and Safety Code, Division 20,

8 **Heavy Manufacturing.** See Manufacturing, Heavy.

11 ~~indicated herein. For this purpose, the term "building" shall be deemed to include the term~~

12 **Homeless Shelter.** Homeless Shelter means living and/or sleeping accommodations without any
13 fee to individuals and families who are homeless, as defined in the Federal Homeless Emergency
14 Assistance and Rapid Transition to Housing (HEARTH) Act of 2009 (S.896), as amended from time to
15 time. Homeless Shelters shall comply with the requirements of the Standards of Care for City Shelters
16 contained in Administrative Code, Chapter 20, Article XIII, including the requirement for operational
17 standards in Section 20.404(d).

18 **Horizontal Elements.** All roof areas and all floor plates, except floor plates at or below grade.

19 **Hospital.** An Institutional Healthcare Use that includes a hospital, medical center, or other
20 medical institution that provides facilities for inpatient and outpatient medical care and may also
21 include medical offices, clinics, laboratories, and employee or student dormitories and other housing,
22 operated by and affiliated with the institution, which institution has met the applicable provisions of
23 Section 304.5 of this Code concerning institutional master plans.

24 **Hotel.** A Retail Sales and Services Use that provides tourist accommodations, including guest
25 rooms or suites, which are intended or designed to be used, rented, or hired out to guests (transient
visitors) intending to occupy the room for less than 32 consecutive days. This definition also applies to

1 buildings containing six or more guest rooms designated and certified as tourist units, under Chapter
2 41 of the San Francisco Administrative Code. For purposes of this Code, a Hotel does not include
3 (except within the Bayshore-Hester Special Use District as provided for in Sections 713 and 780.2 of
4 this Code) a Motel, which contains guest rooms or suites that are independently accessible from the
5 outside, with garage or parking space located on the lot, and designed for, or occupied by, automobile-
6 traveling transient visitors. Hotels shall be designed to include all lobbies, offices, and internal
7 circulation to guest rooms and suites within and integral to the same enclosed building or buildings as
8 the guest rooms or suites.

9 **Hotel, Residential.** A Residential Use defined in Chapter 41 of the San Francisco
10 Administrative Code that contains one or more residential hotel units. A residential hotel unit is a guest
11 room, as defined in Section 203.7 of Chapter XII, Part II, of the San Francisco Municipal Code
12 (Housing Code), which had been occupied by a permanent resident on September 23, 1979, or any
13 guest room designated as a residential unit pursuant to Sections 41.6 or 41.7 of Chapter 41 of the San
14 Francisco Administrative Code. Residential hotels are further defined and regulated in the Residential
15 Hotel Unit Conversion and Demolition Ordinance, Chapter 41, of the San Francisco Administrative
16 Code.

17 **Hours of Operation.** The permitted hours during which any commercial establishment, not
18 including automated teller machines, may be open for business. Other restrictions on the hours of
19 operation of Movie Theaters, Adult Businesses, and Entertainment Uses, as defined in this Section of
20 the Code, shall apply pursuant to provisions in Section 303(c)(5), when such uses are permitted as
21 conditional uses. A Pharmacy may qualify for the exception to operate on a 24-hour basis provided in
22 this Section the Code.

24 **Industrial Use.** A Use Category continuing the following uses: Automobile Wrecking,
25 Automobile Assembly, Food Fiber and Beverage Processing 1 and 2, Grain Elevator, Hazardous Waste
Facility, Junkyard, Livestock Processing 1 and 2, Heavy Manufacturing 1,2, and 3, Light

1 Manufacturing, Metal Working, Power Plant, Ship Yard, Storage Yard, Volatile Materials Storage, and
2 Truck Terminal.

3 **Infrastructure.** Open space and recreational facilities; public realms improvements such as
4 pedestrian improvements and streetscape improvements; public transit facilities; and community
5 facilities such as libraries, child care facilities, and community centers.

6 **In-Kind Agreement.** An agreement acceptable in form and substance to the City Attorney and
7 the Director of Planning, under which the project sponsor agrees to provide a specific set of community
8 improvements, at a specific phase of construction, in lieu of contribution to the relevant Fund.

9 **In Lieu Fee.** A fee paid by a project sponsor in lieu of complying with a requirement of this
10 Code and that is not a development impact fee governed by the Mitigation Fee Act.

11 **Institutional Community Use.** A subcategory of Institutional Uses that includes Child Care
12 Facility, Community Facility, Private Community Facility, Job Training, Philanthropic Administrative
13 Services, Religious Institution, Social Service or Philanthropic Facility, and Public Facility.

14 **Institutional Education Use.** A subcategory of Institutional Uses that includes Post-Secondary
15 Educational Institution, School, and Trade School.

16 **Institutional Healthcare Use.** A subcategory of Institutional Uses that includes Hospital,
17 Medical Cannabis Dispensary, and Residential Care Facility.

18 **Institutional Use.** A Use Category that includes Child Care Facility, Community Facility,
19 Private Community Facility, Hospital, Job Training, Medical Cannabis Dispensary, Philanthropic
20 Administrative Services, Religious Institution, Residential Care Facility, Social Service or
21 Philanthropic Facility, Post-Secondary Educational Institution, Public Facility, School, and Trade
22 School.

23 **Interior Lot.** See Lot, Interior.

24 **Internet Service Exchange.** A Utility and Infrastructure Use defined as a location that contains
25 any of the following uses (excluding Wireless Telecommunication Services Facility): switching
equipment (whether wireline or wireless) that joins or connects occupants, customers, or subscribers to

1 enable customers or subscribers to transmit data, voice or video signals to each other; one or more
2 computer systems and related equipment used to build, maintain, or process data, voice or video
3 signals, and provide other data processing services; or a group of network servers.

4 **J**

5 **Jewelry Store.** A Retail Sales and Service Use that primarily involves the sale of jewelry to the
6 general public. It may involve sales of precious stones, gems, precious metals, gold and silver, or
7 clocks and watches. Repair services or setting, custom design or manufacture of individual pieces of
8 jewelry may also be provided.

9 **Job Training.** A Institutional Community Use that provides job training and may also provide
10 vocational counseling and job referrals.

11 **Junk Yard.** An Industrial Use defined as an outdoor space where junk, waste, discarded or
12 salvaged materials are stored or handled, including house-wrecking yards, used lumber yards, and
13 places or yards for storage of salvaged house wrecking and structural steel materials and equipment,
14 excluding automobile wrecking operations, which is defined as a separate use in this Section of the
15 Code; yards or establishments for the sale, purchase, or storage of used cars or machinery in operable
16 condition; and the processing of used, discarded, or salvaged materials as part of a permitted
17 manufacturing operation in the same premises.

18 **K**

19 **Kennel.** A Retail Sales and Services Use where dogs are boarded for compensation, or are
20 cared for or trained for hire, or are kept for sale or bred for sale, where the care, breeding, or sale of
21 the dogs is the principal means of livelihood of the occupants of the premises.

22 **L**

23 **Laboratory.** A Non-Retail Sales and Services Use intended or primarily suitable for scientific
24 research. The space requirements of uses within this category include specialized facilities and/or built
25 accommodations that distinguish the space from Office uses, Light Manufacturing, or Heavy
Manufacturing. Examples of laboratories include the following:

1 (a) Chemistry, biochemistry, or analytical laboratory;

2 (b) Engineering laboratory;

3 (c) Development laboratory;

4 (d) Biological laboratories including those classified by the Centers for Disease Control (CDC)
5 and National Institutes of Health (NIH) as Biosafety level 1, Biosafety level 2, or Biosafety level 3;

6 (e) Animal facility or vivarium, including laboratories classified by the CDC/NIH as Animal
7 Biosafety level 1, Animal Biosafety level 2, or Animal Biosafety level 3;

8 (f) Support laboratory;

9 (g) Quality assurance/Quality control laboratory; and

10 (h) Core laboratory.

11 **Large-Scale Urban Agriculture.** See Agriculture, Large Scale Urban.

12 **Licensed Child Care Facility.** A child care facility that has been issued a valid license by the
13 California Department of Social Services pursuant to California Health and Safety Code Sections
14 1596.80-1596.875, 1596.95-1597.09, or 1597.30-1597.61.

15 **Life Science.** A Non-Retail Sales and Service Use that involves the integration of natural and
16 engineering sciences and advanced biological techniques using organisms, cells, and parts thereof for
17 products and services. This includes the creation of products and services used to analyze and detect
18 various illnesses, the design of products that cure illnesses, and/or the provision of capital goods and
19 services, machinery, instruments, software, and reagents related to research and production. Life
20 Science uses may utilize office, laboratory, light manufacturing, or other types of space. As a subset of
21 Life Science uses, Life Science laboratories typically include biological laboratories and animal
22 facilities or vivaria, as described in the Laboratory definition Subsections (d) and (e).

23 **Light Manufacturing.** See Manufacturing, Light.

24 **Limited Live Performance.** An Accessory Use as defined in Section 1060 of the Police Code

25 **Limited Restaurant.** See Restaurant, Limited.

1 **Liquor Store.** A Retail Sales and Service Use that sells beer, wine, or distilled spirits to a
2 customer in an open or closed container for consumption off the premises and that needs a State of
3 California Alcoholic Beverage Control Board License type 20 (off-sale beer and wine) or type 21 (off-
4 sale general) This classification shall not include retail uses that (1) are both (a) classified as a
5 General Grocery, a Specialty Grocery, or a Restaurant-Limited, and (b) have a gross floor area
6 devoted to alcoholic beverages that is within the applicable accessory use limits for the use district in
7 which it is located, and have both (a) a Non-residential Use Size of greater than 10,000 gross square
8 feet and (b) a gross floor area devoted to alcoholic beverages that is within accessory use limits as set
9 forth in Section 204.2 of this Code, depending on the zoning district in which the use is located. For
10 purposes of Planning Code Sections 249.5, 781.8, 781.9, 782, 783, and 784, the retail uses explicitly
11 exempted from this definition as set forth above shall only apply to General Grocery and Specialty
12 Grocery stores that exceed 5,000 square feet in size shall not: (a) sell any malt beverage with an
13 alcohol content greater than 5.7 percent by volume; any wine with an alcohol content of greater than
14 15 percent by volume, except for "dinner wines" that have been aged two years or more and maintained
15 in a corked bottle; or any distilled spirits in container sizes smaller than 600 milliliters; (b) devote
16 more than 15 percent of the gross square footage of the establishment to the display and sale of
17 alcoholic beverages; and (c) sell single servings of beer in container sizes 24 ounces or smaller.

18 **Livery Stable.** A Retail Entertainment, Arts and Recreation Use where horses and carriages are
19 kept for hire and where stabling is provided. This use also includes horse riding academies.

20 **Livestock Processing 1.** An Industrial Use that involves the live storage, killing or dressing of
21 poultry, rabbits or other small livestock, and/or the tanning or curing of raw hides or skins from an
22 animal of any size. Direct sales to customers is permitted on site. This use is subject to the location
23 and operating restrictions in Section 202.2(d).

24 **Livestock Processing 2.** An Industrial Use that involves the live storage, killing or dressing of
25 cows, pigs, goats, and other large livestock and/or the tanning or curing of raw hides or skins from an

1 animal of any size. Direct sales to customers is permitted on site. This use is subject to the location and
2 operating restrictions in Section 202.2(d).

3 **Live/Work Project.** A Housing Project containing more than one Live/Work Unit.

4 ~~SEC. 102.13.~~ **Live/Work Unit.** A live/work unit is hybrid Residential and PDR Use that is
5 defined as a structure or portion of a structure combining a residential living space for a group
6 of persons including not more than four adults in the same unit with an integrated work space
7 principally used by one or more of the residents of that unit; provided, however, that no
8 otherwise qualifying portion of a structure that contains a Group A occupancy under the ~~San~~
9 ~~Francisco~~ Building Code shall be considered a ~~Live/Work Unit~~. No City official, department,
10 board, or commission shall issue or approve a building permit or other land use entitlement
11 authorizing a new live/work unit as defined here, except as authorized as an accessory use under
12 Section 204.4. Lawfully approved live/work units are subject to the provisions of Sections 181 and 317
13 of this Code.

14 **Long Term Housing.** Housing intended for occupancy by a person or persons for 32
15 consecutive days or longer.

16 ~~SEC. 102.14.~~ **Lot.** A parcel of land under one ownership that constitutes, or is to
17 constitute, a complete and separate functional unit of development, and that does not extend
18 beyond the property lines along streets or alleys. A lot as so defined generally consists of a
19 single Assessor's lot, but in some cases consists of a combination of contiguous Assessor's
20 lots or portions thereof where such combination is necessary to meet the requirements of this
21 Code. In order to clarify the status of specific property as a lot under this Code, the Zoning
22 Administrator may, consistent with the provisions of this Code, require such changes in the
23 Assessor's records, placing of restrictions on the land records, and other actions as may be
24 necessary to assure compliance with this Code. The definition of "lot" shall also be applicable
25 to piers under the jurisdiction of the Port Commission.

1 ~~SEC. 102.15.~~ **Lot, Corner.** A lot bounded on two or more adjoining sides by streets that
2 intersect adjacent to such lot, provided that the angle of intersection of such streets along

12 *Mandatory Discretionary Review.* *A hearing before the Planning Commission that is required*
13 *by the Planning Code at which the Commission will determine whether to approve, modify, or*
14 *disapprove a permit application.*

15 *Manufacturing 1, Heavy.* *An Industrial Use having the potential of creating substantial noise,*
16 *smoke, dust, vibration, and/or other environmental impacts or pollution, and including, but not limited*
17 *to:*

18 *(a) Concrete mixing, concrete products manufacture,*

19 *(b) Electric foundry or foundry for nonferrous metals*

20 *(c) Enameling, lacquering, wholesale paint mixing from previously prepared pigments and*
21 *vehicles,*

22 *(d) Woodworking mill, manufacture of woodfibre, sawdust or excelsior products not involving*
23 *chemical processing,*

24 *(e) Blast furnace, rolling mill, or smelter; and*

25 *(f) Ice manufacturing plant.*

This use is subject to the location and operation controls in Section 202.2(d)

1 **Manufacturing 2, Heavy.** *An Industrial Use having the potential of creating substantial noise,*
2 *smoke, dust, vibration, and/or other environmental impacts or pollution, and including, but not limited*
3 *to:*

4 *(a) Production or refining of petroleum products.*

5 *(b) Rendering or reduction of fat, bones, or other animal material, where adequate provision is*
6 *made for the control of odors through the use of surface condensers and direct-flame afterburners or*
7 *equivalent equipment;*

8 *(c) Incineration of garbage, refuse, dead animals or parts thereof;*

9 *This use is subject to the controls in Section 202.2(d).*

10 **Manufacturing 3, Heavy.** *An Industrial Use having the potential of creating substantial noise,*
11 *smoke, dust, vibration, and/or other environmental impacts or pollution, and including, but not limited*
12 *to:*

13 *(a) Battery manufacture;*

14 *(b) Manufacture of corrosive acid or alkali, cement, gypsum, lime, plaster of Paris, explosive,*
15 *fertilizer, glue or gelatin from fish or animal refuse;*

16 *(c) Manufacture, refining, distillation, or treatment of any of the following: abrasives, acid*
17 *(noncorrosive), alcohol, ammonia, asbestos, asphalt, bleaching powder, candles (from tallow),*
18 *celluloid, chlorine, coal, coke, creosote, dextrine, disinfectant, dye, enamel, gas carbon or lampblack,*
19 *gas (acetylene or other inflammable), glucose, insecticide, lacquer, linoleum, matches, oilcloth, oil*
20 *paint, paper (or pulp), petroleum products, perfume, plastics, poison, potash, printing ink, refuse mash*
21 *or refuse grain, rubber (including balata or gutta-percha or crude or scrap rubber), shellac, shoe or*
22 *stove polish, soap, starch, tar, turpentine, or varnish.*

23 *(d) Foundry, structural iron or pipe works, boilermaking where riveting is involved, locomotive*
24 *works, roundhouse or railroad shop.*

25 *This use is subject to the location and operation controls in Section 202.2(d)*

1 **Manufacturing, Light.** An Industrial Use that provides for the fabrication or production of
2 goods, by hand or machinery, for distribution to retailers or wholesalers for resale off the premises,
3 primarily involving the assembly, packaging, repairing, or processing of previously prepared
4 materials. Light manufacturing uses include production and custom activities usually involving
5 individual or special design, or handiwork, such as the following fabrication or production activities
6 defined by the Standard Industrial Classification Code Manual as light manufacturing uses:

7 (a) Food processing;

8 (b) Apparel and other garment products;

9 (c) Furniture and fixtures;

10 (d) Printing and publishing of books or newspapers;

11 (e) Leather products;

12 (f) Pottery;

13 (g) Glass-blowing;

14 (h) Commercial laundry, rug cleaning, and dry cleaning facility; or

15 (i) Measuring, analyzing, and controlling instruments; photographic, medical, and optical
16 goods; watches and clocks.

17 It shall not include Trade Shop or Heavy Manufacturing 1,2, or 3. This use is subject to the
18 location and operation controls in Section 202.2(d)

19 **Maritime Use.** A Use Characteristic defined as any use that requires access to or use of San
20 Francisco Bay waters in order to function or operate in the normal course of business including, but
21 not limited to, uses associated with waterborne commerce, navigation, fisheries, and recreation, and
22 industrial, commercial, and other operations directly related to the conduct of waterborne commerce,
23 navigation, fisheries, or recreation on property subject to public trust. Maritime Uses also includes
24 houseboats or residential uses on the water.

25 **Marquee.** A permanent roofed structure attached to and supported entirely by a building,
including any object or decoration attached to or part of said marquee, no part of which shall be used

1 for occupancy or storage, with the purpose of providing protection from sun and rain and/or
2 embellishment of the façade, as further regulated in Section 3106 of the Building Code.

3 **Massage, Chair/Foot.** A Retail Sales and Service Use where the only massage service provided
4 is chair or foot massage, such service is visible to the public, and customers are fully clothed at all
5 times.

6 **Massage Establishment.** A Retail Sales and Service Use defined by Sections 29.1 through
7 29.32 of the San Francisco Health Code, except a use that is a sole proprietorship, as defined in
8 California Business and Professions Code Section 4612(b)(1), and where the sole proprietor is
9 certified pursuant to the California Business and Professions Code Section 4600, et seq., or one that
10 employs or uses only persons certified by the State's Massage Therapy Organization, pursuant to the
11 California Business and Professions Code Section 4600, et seq., provided that the massage
12 establishment has first obtained a permit from the Department of Public Health pursuant to Section
13 29.2 of the San Francisco Health Code, and provided that:

14 (a) The massage use is accessory to a principal use, if the massage use is accessed by the
15 principal use and (1) the principal use is a dwelling unit and the massage use conforms to the
16 requirements of Section 204.1, for accessory uses for dwelling units in R or NC districts; or (2) the
17 principal use is a Tourist Hotel that contains 100 or more rooms or an Institutional Use as defined in
18 this Code; or

19 (b) The only massage service provided is chair massage, such service is visible to the public,
20 and customers are fully clothed at all times.

21 (c) If the massage use does not meet the requirements of (a) or (b), above, then the massage use
22 shall obtain a conditional use permit from the Planning Commission, pursuant to Section 303 of this
23 Code. When considering an application for a conditional use permit pursuant to this Subsection, the
24 Planning Commission shall consider, in addition to the criteria listed in Section 303(c), the criteria
25 outlined in Section 303(o).

1 **Medical Cannabis Dispensary.** An Institutional Healthcare Use defined in Section 3301(f) of
2 the San Francisco Health Code, which is permitted only if it meets the conditions listed in Section
3 202.2(e).

4 **Metal Working.** An Industrial use that includes metal working or blacksmith shop; excluding
5 presses of over 20 tons' capacity and machine-operated drop hammers. This use is subject to location
6 and operational controls in Section 202.2(d).

7 **SEC. 102.34. Mobile Food Facility.** A ~~Mobile Food Facility shall be defined as~~ Retail Sales
8 and Service Use as defined in Public Works Code Section 184.80. Mobile Food Facilities shall
9 comply with the good neighbor policies set forth in Public Works Code Section 184.94.

10 **MOH.** The Mayor's Office of Housing and Community Development or its successor.

11 **Mortuary.** A Retail Sales and Services Use that provides funeral services, funeral preparation,
12 or burial arrangements, including retail establishments that predominantly sell or offer for sale
13 caskets, tombstones, or other funerary goods. In RH, RM, RTO, and RC Districts only, this use includes
14 Columbarium use, which provides for the storage of cremated remains in niches.

15 **Motel.** A Retail Sales and Services Use that includes an auto court, motor lodge, tourist court,
16 or other facility similarly identified, contains rooms or suites of rooms, none with individual cooking
17 facilities, which are offered for compensation and are primarily for the accommodation of transient
18 guests traveling by automobile, and where each sleeping unit is independently accessible from the
19 outside. This use is subject to the controls listed in Section 202.2(a).

20 **Movie Theater.** A Retail Entertainment, Arts and Recreation Use that displays motion pictures,
21 videos, slides, or closed-circuit television pictures. This use does not include an adult theater, which is
22 regulated as an Adult Business. Removal of a Movie Theater is subject to the controls in Section 202.4.

23 **MTA.** The Municipal Transportation Agency or its successor.

24 **MTA Director.** The Director of MTA or his or her designee.

25 **Municipal Railway (Muni).** The public transit system owned by the City and under the
jurisdiction of the MTA.

1 N

2 Neighborhood Agriculture. See Agriculture, Neighborhood.

3 Neighborhood-Serving Business. A neighborhood-serving business cannot be defined by the
4 type of use, but rather by the characteristics of its customers, types of merchandise or service, its size,
5 trade area, and the number of similar establishments in other neighborhoods. The primary clientele of
6 a "neighborhood-serving business," by definition, is comprised of customers who live and/or work
7 nearby.

8 While a neighborhood-serving business may derive revenue from customers outside the
9 immediately surrounding neighborhood, it is not dependent on out-of-neighborhood clientele.

10 A neighborhood-serving use provides goods and/or services which are needed by residents and
11 workers in the immediate neighborhood to satisfy basic personal and household needs on a frequent
12 and recurring basis, and which if not available require trips outside of the neighborhood.

13 A use may be more or less neighborhood-serving depending upon its trade area. Uses that, due
14 to the nature of their products and service, tend to be more neighborhood-serving are those which sell
15 convenience items such as groceries, personal toiletries, magazines, and personal services such as
16 cleaners, laundromats, and film processing. Uses that tend to be less neighborhood-oriented are those
17 which sell more specialized, more expensive, less frequently purchased comparison goods such as
18 automobiles and furniture.

19 For many uses (such as stores selling apparel, household goods, and variety merchandise),
20 whether a business is neighborhood-serving depends on the size of the establishment: the larger the
21 use, the larger the trade area, hence the less neighborhood-oriented.

22 Whether a business is neighborhood-serving or not also depends in part on the number and
23 availability of other similar establishments in other neighborhoods: the more widespread the use, the
24 more likely that it is neighborhood-oriented.

1 **Net Addition.** The total amount of gross floor area defined in Planning Code Section 102
2 contained in a development project, less the gross floor area contained in any structure demolished or
3 retained as part of the proposed development project.

4 **Nighttime Entertainment.** See Entertainment, Nighttime.

5 **Non-Auto Vehicle Sales or Rental.** A Retail Sales and Service Use offering new or used
6 bicycles, scooters, motorcycles, boats, or other marine vehicles for sale, rent, or lease when conducted
7 entirely within an enclosed building.

8 **Non-Commercial Entertainment and Recreation.** See Entertainment and Recreation, Non-
9 Commercial.

10 **Nonprofit Organization.** An organization organized and operated for nonprofit purposes
11 within the provisions of California Revenue and Taxation Code Sections 23701-23710, inclusive, as
12 demonstrated by a written determination from the California Franchise Tax Board exempting the
13 organization from taxes under Revenue and Taxation Code Section 23701.

14 **Non-Residential Use.** Space within any structure or portion thereof intended or primarily
15 suitable for, or accessory to, occupancy by retail, office, commercial, or uses other than a Residential
16 Use as defined in this Section. For the purposes of Article 4, residential components of Institutional
17 Uses other than Religious Institutions shall be defined as a "residential use," and non-residential use
18 shall not include PDR and publicly owned and operated community facilities.

19 **Non-Residential Use Size.** The permitted gross floor area allowed each individual non-
20 residential use. Gross Floor Area is defined in this Section of the Code.

21 **Non-Retail Use.** A type of Commercial Use that involves the sale of goods or services to other
22 businesses rather than the end user, or that does not provide for direct sales to the general public on
23 site. Uses in this category include, but are not limited to, Non-Retail Sales and Service Uses and Non-
24 Retail Automotive Uses.

25 **Notice of Special Restrictions.** A document recorded with the San Francisco Recorder's Office
for any unit subject to this Program detailing the sale and resale or rental restrictions and any

1 restrictions on purchaser or tenant income levels included as a Condition of Approval of the principal
2 project relating to the unit.

3 **Q**

4 **Occupied Floor Area.** *See Floor Area, Occupied.*

5 **Office, General.** *A Non-Retail Sales and Service Use that includes space within a structure or*
6 *portion thereof intended or primarily suitable for occupancy by persons or entities which perform,*
7 *provide for their own benefit, or provide to others at that location, services including, but not limited*
8 *to, the following: professional, banking, insurance, management, consulting, technical, sales, and*
9 *design; and the non-accessory office functions of manufacturing and warehousing businesses,*
10 *multimedia, software development, web design, electronic commerce, and information technology. This*
11 *use shall exclude Non-Retail Professional Services as well as Retail Uses; repair; any business*
12 *characterized by the physical transfer of tangible goods to customers on the premises; wholesale*
13 *shipping, receiving and storage; and design showrooms or any other space intended and primarily*
14 *suitable for display of goods.*

15 **Office Use.** *A grouping of uses that includes General Office, Retail Professional Services, and*
16 *Non-Retail Professional Services. This use shall exclude: retail uses other than Retail Professional*
17 *Services; repair; any business characterized by the physical transfer of tangible goods to customers on*
18 *the premises; wholesale shipping, receiving and storage; and design showrooms or any other space*
19 *intended and primarily suitable for display of goods.*

20 **SEC. 102.18. One Ownership.** Ownership of a parcel or contiguous parcels of property
21 or possession thereof under a contract to purchase by a person or persons, firm, corporation
22 or partnership, individually, jointly, in common, or in any other manner whereby such property
23 is under single or unified control. The term shall include condominium ownership. The term
24 "owner" shall mean the person, firm, corporation or partnership exercising one ownership as
25 herein defined.

1 **Open Air Sales.** A Commercial Use Characteristic generally categorized as a Retail Sales and
2 Service Use that involves open air sale of new and/or used merchandise, except vehicles, but including
3 agricultural products, crafts and/or art work.

4 **Open Recreation Area.** A Non-Commercial Entertainment, Arts and Recreation Use that is not
5 publicly owned which is not screened from public view, has no structures other than those necessary
6 and incidental to the open land use, is not operated as a gainful business, and is devoted to outdoor
7 recreation such as golf, tennis, or riding.

8 ~~SEC. 102.19.~~ **Open Space, Required.** Any front setbacks, side or rear yards, courts,

12 ~~SEC. 102.32.~~ **Ornamental Fencing.** A decorative metal fence ~~shall be~~ made of wrought
13 iron or fencing that gives the appearance of wrought-iron fencing, but expressly excludes
14 plastic-based materials, barbed wire, similar non-decorative fences as well as traditional
15 chain-link or woven wire fences. Chain-link or woven wire fences may be used if the fencing
16 visible from the public right-of-way is bordered by rails on the top and bottom and has well-
17 built columns that are at least 8" inches wide and are topped with caps. The columns shall be
18 spaced no more than 8' feet apart.

19 **Outdoor Activity Area.** A Commercial Use characteristic defined as an area associated with a
20 legally established use, not including primary circulation space or any public street, located outside of

22 establishment including, but not limited to, sitting, eating, drinking, dancing, and food-service
23 activities.

25 **Parcel Delivery Service.** See Service, Parcel Delivery.

1 **Parking Garage, Private.** A Non-Retail Automotive Use that provides temporary parking
2 accommodations for automobiles, trucks, vans, bicycles, or motorcycles in a garage not open to the
3 general public, without parking of recreational vehicles, mobile homes, boats, or other vehicles, or
4 storage of vehicles, goods, or equipment. Provisions regulating automobile parking are set forth in
5 Sections 155, 156, 157, and other provisions of Article 1.5 of this Code.

6 **Parking Garage, Public.** A Retail Automotive Use that provides temporary parking
7 accommodations for automobiles, trucks, vans, bicycles, or motorcycles in a garage open to the
8 general public, without parking of recreational vehicles, mobile homes, boats, or other vehicles, or
9 storage of vehicles, goods, or equipment. Provisions regulating automobile parking are set forth in
10 Sections 155, 156, 157, and other provisions of Article 1.5 of this Code.

11 **Parking Lot, Private.** A Non-Retail Automotive Use that provides temporary off-street parking
12 accommodations for private automobiles, trucks, vans, bicycles, or motorcycles on an open lot or lot
13 surrounded by a fence or wall not open to the general public, without parking of recreational vehicles,
14 motor homes, boats, or other vehicles, or storage of vehicles, goods, or equipment. Provisions
15 regulating automobile parking are set forth in Sections 155, 156, 157, and other provisions of Article
16 1.5 of this Code.

17 **Parking Lot, Public.** A Retail Automotive Use that provides temporary parking
18 accommodations for private automobiles, trucks, vans, bicycles, or motorcycles on an open lot or lot
19 surrounded by a fence or wall open to the general public, without parking of recreational vehicles,
20 motor homes, boats, or other vehicles, or storage of vehicles, goods, or equipment. Provisions
21 regulating automobile parking are set forth in Sections 155, 156, 157, and other provisions of Article
22 1.5 of this Code.

23 **Passive Outdoor Recreation.** A Non-Commercial Entertainment, Arts and Recreation Use
24 defined as an open space used for passive recreational purposes that is not publicly owned and is not
25 screened from public view, has no structures other than those necessary and incidental to the open land
use, is not served by vehicles other than normal maintenance equipment, and has no retail or wholesale

1 sales on the premises. Such open space may include, but not necessarily be limited to, a park,
2 playground, or rest area.

3 **PDR Use.** See Production, Distribution, and Repair Use.

4 **SEC. 102.33. Permeable Surfaces.** Permeable surfaces are those that allow
5 stormwater to infiltrate the underlying soils. Permeable surfaces shall include, but not be
6 limited to, vegetative planting beds, porous asphalt, porous concrete, single-sized aggregate,
7 open-jointed blocks, stone, pavers, or brick that are loose-set and without mortar. Permeable
8 surfaces are required to be contained so neither sediment nor the permeable surface
9 discharges off the site.

10 **Pharmacy.** A Retail Sales and Service Use in which the profession of pharmacy is practiced
11 and where prescriptions are compounded and offered for sale. This Section shall not be construed to
12 limit any qualifying pharmacy from offering other retail goods in addition to prescription
13 pharmaceuticals. Pharmacies are subject to controls in Section 202.2(a).

14 **Philanthropic Facility.** See Social Service or Philanthropic Facility.

15 **SEC. 102.21. Plan Dimensions.** The linear horizontal dimensions of a building or
16 structure, at a given level, between the outside surfaces of its exterior walls. The "length" of a
17 building or structure is the greatest plan dimension parallel to an exterior wall or walls and is
18 equivalent to the horizontal dimension of the corresponding elevation of the building or
19 structure at that level. The "diagonal dimension" of a building or structure is the plan
20 dimension between the two most separated points on the exterior walls.

21 **Planning Commission (Commission).** The San Francisco Planning Commission.

22 **Planning Department (Department).** The San Francisco Planning Department. For purposes
23 of Article 4, may include the Planning Department's designee, including the Mayor's Office of Housing
24 and other City agencies or departments.

25 **Post-Secondary Educational Institution.** An Institutional Education Use, public or private,
that is certified by the Western Association of Schools and Colleges, provides educational services such

1 as a college or university, and has met the applicable provisions of Section 304.5 of this Code
2 concerning institutional master plans. Such institution may include employee or student dormitories
3 and other housing operated by and affiliated with the institution. Such institution shall not have
4 industrial arts as its primary course of study.

5 **Power Plant.** A Industrial Use defined as a steam, fossil-fuel, or any other type of thermal
6 power plant. A Power Plant shall mean each individual power generation unit capable of independent
7 operation, but shall not include on-site power generation units less than ten megawatts in size.
8 Intensification of a Power Plant use requires Conditional Use authorization per Section 178(c), and is
9 subject to the controls in Section 202.2(d).

10 **Principal Façades.** See Façades, Principal.

11 **Production, Distribution, and Repair (PDR) Use.** A grouping of uses that includes, but is not
12 limited, to all Industrial and Agricultural Uses, Ambulance Services, Animal Hospital, Automotive
13 Service Station, Automotive Repair, Automotive Wash, Arts Activities, Business Services, Cat Boarding,
14 Catering Service, Commercial Storage, Kennel, Motor Vehicle Tow Service, Livery Stable, Parcel
15 Delivery Service, Public Utilities Yard, Storage Yard, Trade Office, Trade Shop, Wholesale Sales, and
16 Wholesale Storage.

17 **Public Facility.** An Institutional Use that consists of publicly or privately owned use that
18 provides public services to the community, whether conducted within a building or on an open lot, and
19 which has operating requirements that necessitate location within the district and is in compliance with
20 the General Plan, including civic structures (such as museums, post offices, administrative offices of
21 government agencies), public libraries, police stations, and transportation facilities. Such use shall not
22 include service yards, machine shops, garages, incinerators, and publicly operated parking in a garage
23 or lot (Public Automobile Parking Garages and Lots). **Public Transportation Facility.** A Utility and
24 Infrastructure Use involving passenger terminal facilities for mass transportation of a single or
25 combined modes including, but not limited to, aircraft, ferries, fixed-rail vehicles and buses, whether
public or privately owned or operated, when in conformity with the General Plan. In Districts where

1 such uses are permitted, conditional use authorization shall be required if the facility is: (a) an
2 Automotive Use, as defined in this Section; and (b) other than a boarding platform, bus stop, transit
3 shelter, or similar ancillary feature of a transit system; or(c) a landing field for aircraft.

4 **Public Utilities Yard.** A Utility and Infrastructure Use that is defined as a service yard for
5 public utility, or public use of a similar character, if conducted entirely within an area completely
6 enclosed by a wall or concealing fence not less than six feet high.

10 **Rear Façade.** See Façade, Rear.

11 **Recreation.** See Entertainment and Recreation Use.

12 **Religious Institution.** An Institutional Community Use with a tax-exempt status as a religious
13 institution granted by the United States Government and that is used primarily for collective worship or
14 ritual or observance of common religious beliefs. Such institution may include, on the same lot, the
15 housing of persons who engage in supportive activity for the institution.

16 **Replacement of Use.** The total amount of Gross Floor Area, as defined in Section 102 of this
17 Code, to be demolished and reconstructed by a development project.

18 **Required Open Space.** See Open Space, Required.

19 **Residential Building.** Any structure containing one or more Residential Units as a principal
20 use, regardless of any other uses present in the building.

21 **Residential Care Facility.** An Institutional Healthcare Use providing lodging, board and care
22 for a period of 24 hours or more to persons in need of specialized aid by personnel licensed by the
23 State of California. Such facility shall display nothing on or near the facility that gives an outward
24 indication of the nature of the occupancy except for a sign as permitted by Article 6 of this Code, shall
25 not provide outpatient services, and shall be located in a structure which remains residential in
character. Such facilities shall include, but not necessarily be limited to, a board and care home, family

1 care home, long-term nursery, orphanage, rest home or home for the treatment of addictive, contagious
2 or other diseases, or psychological disorders.

3 **Residential Hotel.** See Hotel, Residential.

4 **Residential Unit.** A legal conforming or non-conforming Dwelling Unit or a legal non-
5 conforming Live/Work Unit

6 **Residential Use.** A Use Category consisting of uses that provide housing for San Francisco
7 residents, rather than visitors, including Dwelling Units, Group Housing, Residential Hotels, and
8 Senior Housing, and for the purposes of Article 4 only any residential components of Institutional Uses.
9 Single Room Occupancy and Student Housing designations are consider characteristics of certain
10 Residential Uses.

11 **Restaurant.** A Retail Sales and Service Use that serves prepared, ready-to-eat cooked foods to
12 customers for consumption on or off the premises and which has seating. It may have a Take-Out Food
13 use as defined by Planning Code Section 790.122 as a minor and incidental use. It may provide on-site
14 beer, wine, and/or liquor sales for drinking on the premises (with ABC license types 41, 47, 49, 59, or
15 75); however, if it does so, it shall be required to operate as a Bona Fide Eating Place as defined in
16 Section 790.142. It is distinct and separate from a Limited-Restaurant. Such businesses shall operate
17 with the specified conditions in Section 202.2(a).

18 It shall not be required to operate within an enclosed building pursuant to Section 703.2(b)(1)
19 so long as it is also a Mobile Food Facility as defined in Section 102.34. Any associated outdoor
20 seating and/or dining area is subject to regulation as an Outdoor Activity Area as set forth elsewhere in
21 this Code.

22 **Restaurant, Limited.** A Retail Sales and Service Use that serves ready-to-eat foods and/or
23 drinks to customers for consumption on or off the premises, that may or may not have seating. It may
24 include wholesaling, manufacturing, or processing of foods, goods, or commodities on the premises as
25 an accessory use as set forth in Section 703.2(b)(1)(C)(v). It includes, but is not limited to, specialty
foods provided by bakeries, delicatessens, and confectioneries meeting the above characteristics, but it

1 is distinct from a Restaurant, and a Bar. It may also operate as a Take-Out Food use. It shall not
2 provide on-site beer and/or wine sales for consumption on the premises, but may provide off-site beer
3 and/or wine sales for consumption off the premises with a California Alcoholic Beverage Control
4 Board License type 20 (off-sale beer and wine) within the accessory use limits as set forth in Section
5 703.2(b)(1)(C)(vi). Such businesses shall operate with the specified conditions in Section 202.2(a).

6 **Retail Entertainment, Arts and Recreation.** See Entertainment, Arts and Recreation, Retail.

7 **Retail Sales and Service, General.** A Retail Sales and Service Use that provides goods and/or
8 services to the general public and that is not listed as a separate Retail Sales and Service Use in this
9 Section of the Code.

10 **Retail Use.** A Commercial Use that includes uses that involve the sale of goods, typically in
11 small quantities, or services directly to the ultimate consumer or end user including, but not limited to,
12 Retail Sales and Service Uses, Commercial Entertainment, Arts and Recreation Uses, and Retail
13 Automotive Uses.

14 **S**

15 **Sales and Services, Non-Retail.** A Commercial Use category that includes uses that involve the
16 sale of goods or services to other businesses rather than the end user, or that does not provide for
17 direct sales to the consumer on site. Uses in this category include, but are not limited to: Business
18 Services, Catering, Laboratory, Life Science, Commercial Storage, Design Professional, Non-Retail
19 Professional Service, General Office, Wholesale Sales, Wholesale Storage, and Trade Office.

20 **Sales and Services, Retail.** A Commercial Use Category that includes uses that involve the sale
21 of goods, typically in small quantities, or services directly to the ultimate consumer or end user with
22 some space for retail service on site excluding Retail Entertainment Arts and Recreation, and Retail
23 Automobile Uses and including, but not limited to: Adult Business, Animal Hospital, Bar, Cat
24 Boarding, Fringe Financial Services, Tourist Oriented Gift Store, General Grocery Store, Specialty
25 Grocery Store, Gym, Hotel, Jewelry Store, Kennel, Liquor Store, Massage Establishment, Chair and
Foot Massage, Mobile Food Facility, Mortuary (Columbarium), Non-Auto Sales, Pharmacy,

1 Restaurant, Limited Restaurant, General Retail Sales and Service, Financial Services, Limited
2 Financial Services, Health Services, Motel, Personal Services, Retail Professional Services, Self-
3 Storage, Take-Out Food Facility, Tobacco Paraphernalia Store, and Trade Shop.

4 **San Francisco.** The City and County of San Francisco.

5 **School.** An Institution Educational Use, public or private, certified by the Western Association
6 of Schools and Colleges that provides educational instruction to students in kindergarten through
7 twelfth grade. Such institution may include employee or student dormitories and other housing
8 operated by and affiliated with the institution. This use is distinct and separate from a Post-Secondary
9 Educational Institution, which is defined under this Section of the Code.

10 **Senior Housing.** A Residential Use defined as dwellings that are specifically designed for and
11 occupied by senior citizens. Senior Housing is subject to the conditions listed in Section 202.2(h).

12 **Service, Ambulance.** A Non-Retail Automotive Use that provides medically related
13 transportation services.

14 **Service, Business.** A Non-Retail Sales and Service Use that provides the following kinds of
15 services to businesses and/or to the general public and does not fall under the definition of Office:
16 radio and television stations, newspaper bureaus, magazine and trade publication publishing,
17 microfilm recording, slide duplicating, bulk mail services, parcel shipping services, parcel labeling and
18 packaging services, messenger delivery/courier services, sign painting and lettering services, or
19 building maintenance services.

20 **Service, Financial.** A Retail Sales and Service Use that provides banking services and products
21 to the public, such as banks, savings and loans, and credit unions, when occupying more than 15 feet of
22 linear frontage or 200 square feet of gross floor area. Any applicant for a financial service use shall
23 provide the Planning Department with a true copy of the license issued to it by the State of California.

24 **Service, Fringe Financial.** A Retail Sales and Service Use that provides banking services and
25 products to the public and is owned or operated by a "check casher" as defined in California Civil
Code Section 1789.31, as amended from time to time, or by a "licensee" as defined in California

1 Financial Code Section 23001(d), as amended from time to time. Any applicant for a fringe financial
2 service use shall provide the Department with a true copy of the license issued to it by the State of
3 California. A Nonprofit Fringe Financial Service shall mean a Fringe Financial Service that is
4 exempted from payment of income tax under Section 23701(d) of the California Revenue and Taxation
5 Code and Section 501(c)(3) of the Internal Revenue Code of the United States. Any such Nonprofit
6 Fringe Financial Service shall provide the Planning Department with a true copy(ies) of its income tax
7 documentation demonstrating its exemption from payment of income tax under State and Federal Law.
8 A new Fringe Financial Service, with the exception of a Nonprofit Fringe Financial Service, shall not
9 locate within one-quarter mile of an existing Fringe Financial Service.

10 **Service, Health.** A Retail Sales and Service Use that provides medical and allied health
11 services to the individual by physicians, surgeons, dentists, podiatrists, psychologists, psychiatrists,
12 acupuncturists, chiropractors, or any other health-care professionals when licensed by a State-
13 sanctioned Board overseeing the provision of medically oriented services. It includes a clinic, primarily
14 providing outpatient care in medical, psychiatric, or other health services, and not part of a Hospital or
15 medical center, as defined by this Section of the Code. It also includes a massage establishment, as
16 defined by Sections 29.1 through 29.32 of the Health Code, that is a sole proprietorship, as defined in
17 California Business and Professions Code Section 4612(b)(1), and where the sole proprietor is
18 certified pursuant to the California Business and Professions Code Section 4600, et seq., and one that
19 employs or uses only persons certified by the State's Massage Therapy Organization, pursuant to the
20 California Business and Professions Code Section 4600, et seq.

21 **Service, Instructional.** A Retail Sales and Service Use that includes instructional services not
22 certified by the State Educational Agency, such as art, dance, exercise, martial arts, and music classes.

23 **Service, Limited Financial.** A Retail Sales and Service Use that provides banking services,
24 when not occupying more than 15 feet of linear frontage or 200 square feet of gross floor area.
25 Automated teller machines, if installed within such a facility or on an exterior wall as a walk-up
facility, are included in this category; however, these machines are not subject to the hours of

1 operation, as defined in this Section of the Code and as set forth in the respective zoning district. Any
2 applicant for a limited financial service use shall provide the Planning Department with a true copy of
3 the license issued to it by the State of California.

4 **Service, Motor Vehicle Tow.** A Non-Retail Automotive Use that provides vehicle towing
5 service, including accessory vehicle storage, when all tow trucks used and vehicles towed by the use
6 are parked or stored on the premises.

7 **Service, Non-Retail Professional.** A Non-Retail Sales and Service Office Use that provides
8 professional services to other businesses including, but not limited to, accounting, legal, consulting,
9 insurance, real estate brokerage, advertising agencies, public relations agencies, computer and data
10 processing services, employment agencies, management consultants and other similar consultants,
11 telephone message services, and travel services. This use may also provide services to the general
12 public but is not required to. This use shall not include research services of an industrial or scientific
13 nature in a commercial or medical laboratory, other than routine medical testing and analysis by a
14 health-care professional or hospital.

15 **Service, Parcel Delivery.** A Non-Retail Automotive Use limited to facilities for the unloading,
16 sorting, and reloading of local retail merchandise for home deliveries where the operation is conducted
17 entirely within a completely enclosed building, including garage facilities for local delivery trucks, but
18 excluding repair shop facilities. Where permitted in PDR Districts, this use is not required to be
19 operated within a completely enclosed building.

20 **Service, Personal.** A Retail Sales and Services Use that provides grooming services to the
21 individual, including salons, cosmetic services, tattoo parlors, and health spas, bathhouses, and steam
22 rooms. Personal Service does not include Massage Establishments or Gym, which are defined
23 separately in this Section.

24 **Service, Philanthropic Administrative.** An Institutional Community use that provides executive,
25 management, administrative, and clerical services and support related to philanthropic activities that
serve non-profit institutions and organizations; such philanthropic activities may include funding and

1 support of educational, medical, environmental, cultural, and social services institutions and
2 organizations. Such uses:

3 (a) may not be located on the first story of buildings where the most recent prior use was any
4 use other than residential or office; and

5 (b) may be located in a single undivided space not physically separated from a residential use;
6 provided that:

7 (1) any Residential Conversion above the first story, associated with, or following
8 commencement of such use, shall be considered a conditional use requiring approval pursuant to
9 Section 703.2(b)(1)(B); and

10 (2) any loss of Dwelling Units described in Section 317 of this Code shall require
11 approval as provided in Section 317.

12 **Service, Retail Professional.** A Retail Sales and Service Use that provides to the general
13 public, general business, or professional services including, but not limited to, management, clerical,
14 accounting, legal, consulting, insurance, real estate brokerage, and travel services. It may provide
15 services to the business community, provided that it also provides services to the general public.
16 Otherwise, it shall be considered a Non-Retail Professional Service Use as defined in this Section of the
17 Planning Code.

18 This use does not include research service of an industrial or scientific nature in a commercial
19 or medical laboratory, other than routine medical testing and analysis by a health-care professional or
20 hospital.

21 **Shipyard.** An Industrial Use that includes the building and repairing of ships.

22 **Single Room Occupancy (SRO) Unit.** A Residential Use characteristic, defined as a Dwelling
23 Unit or Group Housing room consisting of no more than one occupied room with a maximum gross
24 floor area of 350 square feet and meeting the Housing Code's minimum floor area standards. The unit
25 may have a bathroom in addition to the occupied room. As a Dwelling Unit, it would have a cooking
facility and bathroom. As a group housing room, it would share a kitchen with one or more other single

1 room occupancy unit/s in the same building and may also share a bathroom. A single room occupancy
2 building (or "SRO" building) is one that contains only SRO units and accessory living space.

3 **Small Enterprise Workspace (S.E.W.).** An S.E.W. is a use comprised of discrete workspace
4 units of limited size that are independently accessed from building common areas. S.E.W.'s are subject
5 to the controls listed in Section 202.2(g)

6 **Social Service or Philanthropic Facility.** An Institutional Community Use providing assistance
7 of a charitable or public service nature, and not of a profit-making or commercial nature.

8 **SOMA.** The area bounded by Market Street to the north, The Embarcadero to the east, King
9 Street to the south, and South Van Ness and Division Streets to the west.

10 **Specialty Grocery.** See Grocery, Specialty.

11 **Sports Stadium.** A Retail Entertainment, Arts and Recreation Use that includes any open-air
12 sports stadium or arena, if conducted on premises not less than 200 feet from any R District.

13 **Storage, Commercial.** A Non-Retail Sales and Service Use defined as a facility that stores
14 within an enclosed building: contractors' equipment, building materials, or goods or materials used by
15 other businesses at other locations. This use shall not include the storage of waste, salvaged materials,
16 automobiles, inflammable or highly combustible materials, and wholesale goods or commodities.

17 **Storage, Self.** A Retail Sales and Service Use defined as a facility that stores, within an
18 enclosed building, household and personal goods.

19 **Storage, Volatile Materials.** An Industrial Use defined as bulk storage of inflammable, highly
20 combustible, or explosive materials.

21 **Storage, Wholesale.** A Non-Retail Sales and Service Use defined as a facility that stores, within
22 an enclosed building, wholesale merchandise that is not accessory to a Wholesale Sales use. This use
23 includes cold storage facilities, but not storage of inflammables or hazardous materials, which is
24 covered under Hazardous Materials Storage.

25 **Storage Yard.** An Industrial Use involving the storage of building materials or lumber, stones
or monuments, livestock feed, or contractors' equipment, if conducted within an area enclosed by a

1 wall or concealing fence not less than six feet high. This use does not include Vehicle Storage or a
2 Hazardous Waste Facility.

3 ~~SEC. 102.23.~~ **Story.** That portion of a building, ~~except a mezzanine as defined in the~~
4 ~~Building Code,~~ included between the upper surface of any floor and the upper surface of the
5 floor next above, except that the topmost story shall be that portion of a building included
6 between the upper surface of the topmost floor and the ceiling or roof above.

7 Any mezzanine, or intermediate level, shall be considered part of a story constituted by another
8 floor provided it is an open and integral part of the story or room of which it is a portion. There shall
9 be only one such mezzanine per story and it shall have a minimum glazed or unglazed opening of 50
10 percent on the interior side of the room or story and an area not exceeding one-third of the floor area
11 of the story or room in which it is located. Any mezzanine not meeting these criteria shall be considered
12 a separate story.

13 (a) **First Story.** The highest building story with a floor level that is not more than six feet above
14 grade at the centerline of the frontage of the lot where grade is defined.

15 (1) **Grade.** For purposes of this definition, “grade” is the point of elevation of the
16 finished surface of the ground, paving, or sidewalk at the property line located along primary frontage,
17 i.e., any street frontage between two consecutive streets or alleys where the total street frontage is
18 entirely within an NC District. If the lot has more than one property line or no property line located
19 along primary frontage, the Zoning Administrator shall choose the property line facing a street or alley
20 where the grade is defined. In such situations, the Zoning Administrator shall favor streets that serve as
21 major transportation routes, major or secondary thoroughfares, and streets along which other
22 commercial districts are located. When the property line is five feet or more from the building frontage,

5 with the Ground Floor Residential Design Guidelines, as adopted and periodically amended

6 of all provided spaces, and shall be designed so as to facilitate access to the subject property
7 while minimizing interference with street and sidewalk circulation. Any such private service
8 driveway shall be of adequate width to accommodate drive-in movement from the adjacent
9 curb or inside traffic lane but shall in no case exceed 30 feet. Notwithstanding the foregoing, if
10 an adjacent street or alley is determined by the Zoning Administrator to be primarily used for
11 building service, up to four off-street freight or loading spaces may be allowed to be
12 individually accessible directly from such a street or alley, pursuant to the provisions of
13 Section 309 in a C-3 District, the provisions of Section 307(g) in a South of Market Mixed Use
14 District, the provisions of Section 309.1 in a DTR District, the provisions of Section 329 for
15 projects subject to Section 329 in a MUO, WMUO, MUG, WMUG, or MUR District, or by
16 administrative decision of the Zoning Administrator for projects that are not subject to Section
17 329 in a MUO, WMUO, MUG, WMUG or MUR District.

19 (s) **Off-Street Parking and Loading in C-3 Districts.** In C-3 Districts, restrictions on
20 the design and location of off-street parking and loading and access to off-street parking and
21 loading are necessary to reduce their negative impacts on neighborhood quality and the
22 pedestrian environment.

23 (1) **Ground floor or below-grade parking and street frontages with active**
24 **uses.**

25 (A) All off-street parking in C-3 Districts (both as accessory and principal
uses) shall be built no higher than the ground-level (up to a maximum ceiling height of 20 feet

1 from grade) unless an exception to this requirement is granted in accordance with Section 309
2 and subsection 155(s)(2) or a conditional use is authorized in accordance with Section 303
3 and subsection 155(s)(3) below.

4 (B) Parking located at or above ground level shall conform to the street

22 for access to off-street loading. Shared openings for parking and loading are encouraged. The
23 maximum permitted width of a shared parking and loading garage opening is 27 feet.

10 (c) Required off-street parking spaces for all uses other than dwellings shall be located
11 on the same lot as the use served, as an accessory use, or within a walking distance of 800

14 (d) Walking distance for purposes of Subsections (b) and (c) above shall mean the
15 distance from an outside entrance of a structure or use or part thereof, to each off-street

18 (e) In order to be credited toward the requirements of this Code, any off-street parking
19 space located as above on a lot other than the lot on which the structure or use to be served
20 is located must be available for the actual lifetime of the structure or use to be served. Such
21 availability shall be assured either by ownership of both the lot containing the structure or use
22 to be served and the lot containing the off-street parking space by at least one common
23 owner, or by a lease or other instrument providing for the availability of the parking space for
24 not less than the actual lifetime of the structure or use to be served; an attested copy of any
25 such instrument shall be filed with the Planning Department ~~of City Planning~~ prior to approval
 by said Department of any building permit application affected by this arrangement for

1 provision of required off-street parking. In addition, in either case, a document in a form
2 approved by the City Attorney shall be executed by the parties concerned, and by the Zoning
3 Administrator, and recorded in the office of the County Recorder, serving as a notice of the
4 restrictions under this Code applying to both the lot containing the structure or use to be
5 served and to the lot containing the off-street parking space, by virtue of this arrangement for
6 provision of required off-street parking.

18 ~~E~~ntertainment ~~and Recreation~~ use as defined in Sections ~~102 218 and 221~~ of the Planning
19 Code; that is 5,000 square feet or more in size for which a building permit is issued on or at
20 least six months after the effective date of this Section, unless the building will not be
21 accessible to the public and;

22 (C) a new ~~a~~Amusement ~~s~~Game ~~a~~Arcade, ~~e~~Eating and ~~D~~drinking use,
23 ~~i~~Institution, ~~o~~Other ~~L~~arge, ~~i~~Institution, ~~o~~Other ~~s~~Small, ~~m~~Movie ~~t~~Theater, ~~s~~Sales and ~~s~~Service,
24 ~~o~~Other ~~r~~Retail, or ~~s~~Sales and ~~s~~Service ~~r~~Retail use, as defined in Articles 7 and 8 of the Planning

1 least six months after the effective date of this Section, unless the building will not be
2 accessible to the public; and

3 (D) a new library operated by the San Francisco Public Library, or a new,

5 City for which final City approvals have been given on or at least six months after the effective
6 date of this Section.

7 (2) **"Substantially Renovated."** Any construction or renovation project ~~which~~
8 *that* has an estimated cost of at least \$50,000.00 for which a building permit is issued, or, in
9 the case of City-owned structures, for which final City approval is given, to any of the uses
10 listed in Subsection (a)(1) above, which were existing as of the effective date of this Section,
11 or which were completed on or at least six months after the effective date of this Section.

12 (3) **"Baby Diaper-Changing Accommodation."** A safe, sanitary and
13 convenient baby diaper-changing station, deck table or similar amenity ~~which~~ *that* is installed
14 or placed in a separate, designated location in a Public-Serving Establishment subject to the
15 provisions of this Section. Such accommodations may include, but are not limited to, stations,
16 decks and tables in women's and men's restrooms or unisex/family restrooms.

4 **SEC. 178. CONDITIONAL USES.**

5 The following provisions shall apply to conditional uses:

6 (a) **Definition.** For the purposes of this Section, a permitted conditional use shall refer
7 to:

8 (1) Any use or feature authorized as a conditional use pursuant to Article 3 of
9 this Code, provided that such use or feature was established within the time limits specified as
10 a ~~e~~Condition of Approval authorization or, if no time limit was specified, within a reasonable
11 time from the date of authorization; or

12 (2) Any use or feature ~~which~~ that is classified as a conditional use in the district in
13 which it is located and ~~which~~ that lawfully existed either on the effective date of this Code, or
14 on the effective date of any amendment imposing new conditional use requirements upon
15 such use or feature; or

16 (3) Any use deemed to be a permitted conditional use pursuant to Section 179
17 of this Code.

18 (b) **Continuation.** Except as provided for temporary uses in Section 205 of this Code,
19 and except where time limits are otherwise specified as a ~~e~~Condition of Approval authorization,
20 any permitted conditional use may continue in the form in which it was authorized, or in the
21 form in which it lawfully existed either on the effective date of this Code or the effective date of
22 any amendment imposing new conditional use requirements upon such use or feature, unless
23 otherwise provided in this Section or in Article 2 of this Code.

24 (c) **Enlargements, ~~or~~ Alteration, or Intensification.** A permitted conditional use may not
25 be significantly altered, enlarged, or intensified, except upon approval of a new conditional
use application pursuant to the provisions of Article 3 of this Code.

1 (1) Internet Services Exchange. With regard to an Internet Services Exchange as
2 defined in Section 102 209.6(e), any physical alteration ~~which~~ that will enlarge or expand the
3 building for the purpose of intensifying the use shall be deemed to be significant under this
4 section, and any increase in the size of electrical service to the building ~~which~~ that will require
5 a permit from the Department of Building Inspection shall be deemed to be significant under
6 this ~~s~~Section.

7 (2) Power Plant. A Power Plant use, as defined in Section 102, shall, whether
8 nonconforming or conditionally permitted, require conditional use authorization in order to enlarge,
9 intensify, or extend the use if such changes would expand a power plant use, make it more permanent,
10 or substantially change the use. An intensification of use shall include the following changes, without
11 limitation and in addition to the criteria set forth in Article 1.7 of the Planning Code:

12 (A) An increase in output capability by more than 10 percent (either an increase
13 in capacity or increase in planned or permitted output per year);

14 (B) A change in type of fuel;

15 (C) A greater than 5 percent increase in the volume of monthly discharge of
16 waste water into the sewer or into the San Francisco Bay, or an increase in the temperature of existing
17 waste water discharges into the San Francisco Bay;

18 (D) Any increase greater than 5 percent in the emission rate or the total annual
19 tons of emission for particulate precursors, ozone precursors or greenhouse gases;

20 (E) A greater than 5 percent increase in the volume of regulated substances used
21 on site on a monthly basis, or in the volume of regulated substances stored on site or in the volume of
22 regulated substances transported to the site on a monthly basis; or

23 (F) Improvements to any power generation unit costing more than 25 percent of
24 the assessed value of the same unit prior to improvement.

25 (d) **Abandonment.** A permitted conditional use which is discontinued for a period of
three years, or otherwise abandoned, shall not be restored, except upon approval of a new

1 conditional use application pursuant to the provisions of Article 3 of this Code. For purposes of
2 this Subsection, the period of nonuse for a permitted conditional use to be deemed
3 discontinued in the North Beach, Castro Street Neighborhood Commercial Districts, and the
4 Jackson Square Special Use District shall be eighteen (18) months, except that in the North
5 Beach Neighborhood Commercial District, the period of non use for a Restaurant use, as
6 defined in Section 102 790.94, to be deemed discontinued shall be three years.

7 (e) **Changes in Use.** The following provisions shall apply to permitted conditional uses
8 with respect to changes in use:

9 (1) A permitted conditional use may be changed to another use listed in Section
10 102 and ~~Articles 2,~~ 7 or 8 of this Code as a principal use for the district in which it is located
11 and the new use may thereafter be continued as a permitted principal use.

12 (2) A permitted conditional use may be changed to another use listed in Section
13 102 and ~~Articles 2,~~ 7 or 8 of this Code as a conditional use for the district in which the property
14 is located, subject to the other applicable provisions of this Code, only upon approval of a new
15 conditional use application, pursuant to the provisions of Article 3 of this Code.

16 (3) A permitted conditional use may not be changed to another use not
17 permitted or prohibited by the Zoning Control Table for the district in which the lot is located
18 ~~Articles 2, 7 or 8 of this Code~~. If a permitted conditional use has been wrongfully changed to
19 another use in violation of the foregoing provisions and the violation is not immediately
20 corrected when required by the Zoning Administrator, the wrongful change shall be deemed to
21 be a discontinuance or abandonment of the permitted conditional use.

22 (4) Once a permitted conditional use has been changed to a principal use
23 permitted in the district in which the property is located, or brought closer in any other manner
24 to conformity with the use limitations of this Code, the use of the property may not thereafter
25 be returned to its former permitted conditional use status, except upon approval of a new
conditional use application pursuant to the provisions of Article 3 of this Code.

1 (5) In the North Beach Neighborhood Commercial District, any use that exceeds
2 the use size provisions of Section 121.2(a) or 121.2(b) may be changed to a new use only
3 upon approval of a new conditional use application. The Commission's approval of such
4 conditional use application shall explicitly address the use size findings of Section 303(c).

5 (6) In the Castro Street Neighborhood Commercial District, any use that
6 exceeds the use size provisions of Section 121.2(a), but is smaller than the maximum use
7 size limit of Section 121.2(b), may be changed to a new use only upon approval of a new
8 conditional use application. The Commission's approval of such conditional use application
9 shall explicitly address the use size findings of Section 303(c).

10 (f) Notwithstanding the foregoing provisions of this Section 178, a structure occupied by
11 a permitted conditional use that is damaged or destroyed by fire, or other calamity, or by Act
12 of God, or by the public enemy, may be restored to its former condition and use without the
13 approval of a new conditional use application, provided that such restoration is permitted by
14 the Building Code, and is started within 18 months and diligently pursued to completion.
15 Except as provided in Subsection (g) below, no structure occupied by a permitted conditional
16 use that is voluntarily razed or required by law to be razed by the owner thereof may
17 thereafter be restored except upon approval of a new conditional use application pursuant to
18 the provisions of Article 3 of this Code.

19 (g) None of the provisions of this Section 178 shall be construed to prevent any
20 measures of construction, alteration or demolition necessary to correct the unsafe or
21 dangerous condition of any structure, other feature, or part thereof, where such condition has

24 the proposed measures have been declared necessary, by such official, to correct the said

1 **SEC. 179.1. LEGITIMIZATION OF USES LOCATED IN THE EASTERN**
2 **NEIGHBORHOODS.**

3 (a) **Intent.** As a result of the Eastern Neighborhoods Zoning Controls, certain land uses
4 that were previously permitted, particularly office and housing, are no longer permitted. The
5 purpose of this Section is to establish a time-limited program wherein existing uses that have
6 operated without the benefit of required permits may seek those permits. Uses that could be
7 "legitimized" under this Section are those uses which, under the current provisions of this
8 Code and without this Section, could not otherwise seek the required permits.

9 (b) **Applicability.**

10 (1) **Geography.** This Section shall apply only to property located in the Eastern
11 Neighborhoods Mixed Use Districts, the SLI District, or any PDR District which is located
12 within the boundaries of the Eastern Neighborhoods Project Area pursuant to Section 423.3
13 ~~327.2(j)~~. This Section shall not apply to any Live/Work use as ~~set forth~~ defined in Section 102
14 ~~233~~.

15 (2) **Eligibility.** Any use that is the subject of an application under this Section
16 shall be one that is determined by the Zoning Administrator as one which:

17 (A) exists as of the date of the application;

18 (B) would have been principally permitted or permitted with ~~e~~Conditional
19 ~~#~~Use authorization under provisions of the Planning Code that were effective on April 17,
20 2008;

21 (C) would not be permitted under current provisions of this Code;

22 (D) is a land use that either:

23 ~~(+)~~ (i) has been regularly operating or functioning on a continuous basis
24 for no less than 2 years prior to the effective date of this Section; or

1 (2) (ii) has been functioning in the space since at least April 17, 2008, and
2 is associated with an organization, entity or enterprise which has been located in this space
3 on a continuous basis for no less than 2 years prior to the effective date of this Section;

4 (E) is not accessory to any other use; and

5 (F) is not discontinued and abandoned pursuant to the provisions of
6 Section 183 that would otherwise apply to nonconforming uses.

7 (3) **Sunset.** All applications for a determination of eligibility under Subsection (d)
8 must be received by the Zoning Administrator on or before November 12, 2012. If the
9 Planning Department fails to timely issue notice pursuant to Subsection (c), the Zoning
10 Administrator may extend this termination date for an additional period of time not to exceed
11 the number of days that the Department delayed in issuing the notice. An applicant who has
12 received a determination of eligibility must submit to the Department all required application
13 materials for legitimization within 90 days of the date of issuance of the determination of
14 eligibility and diligently pursue the legitimization process until completion. For purposes of this
15 section, "diligently pursue" shall mean timely responding to all requests for additional
16 information from the Department or other City agency reviewing the matter and timely
17 applying for and pursuing all permits and other approvals required to legitimize the use.
18 Failure to do so may result in the Zoning Administrator's revocation of the legitimization letter.

19 * * * *

20 (e) **Determination of Eligibility.** The Zoning Administrator shall determine compliance
21 with the criteria set forth in Subsection (b)(2), above, through a written decision. No less than
22 30 days prior to making a determination, the Zoning Administrator shall mail and post a notice
23 of intent to render a determination as set forth below so that parties other than the applicant
24 are afforded the opportunity to present information which may have bearing on the
25 determination;

1 (1) By mailing notice to owners within 300 feet of the property in question as set
2 forth in Section 306.3(a)(2);

3 (2) by mailing notice to current tenants of the subject property using materials
4 submitted pursuant to Section (d)(3), above;

5 (3) by mailing notice to all individuals or neighborhood organizations having
6 made written request for notification for either (i) applications under this Section or (ii) specific
7 properties or areas; and

8 (4) by posting a notice on the subject property as set forth in Section 306.8. (f)
9 Application to Legitimize. Uses that are determined to be in compliance with the criteria of
10 Subsection (b)(2), above, shall be governed as set forth below. Unless specifically stated by
11 the Planning Commission in the case of a Conditional Use authorization, approval of any
12 application under this Subsection shall be deemed to authorize all aspects of the use and
13 portions of the structure housing the use under the Planning Code. Those portions of the use
14 or structure that do not comply with current provisions of this Code shall be deemed
15 nonconforming uses or noncomplying structures under Article ~~1.8~~ 1.7 of this Code. Action
16 under this Subsection in no way shall affect the applicability of relevant portions of the
17 Building Code or other portions of the Municipal Code.

18 (1) Those uses which, under the provisions of this Code that were applicable on
19 April 17, 2008, would have either: (i) required Conditional Use authorization pursuant to
20 Section 303 or (ii) been principally permitted but required an allocation of office space of less
21 than 50,000 gross square feet under the Annual Limit pursuant to Section 321(b)(4), may
22 seek such authorization pursuant to all requirements of the applicable Section.

23 (2) Those uses which, under the provisions of this Code that were applicable on
24 April 17, 2008, were principally permitted may seek a building permit in order to legally
25 establish the use. Upon the Department's determination that the application is consistent with

1 the enabling Zoning Administrator's decision, the Planning Department shall approve such
2 permit.

3 (3) Those uses which, under the provisions of this Code that were applicable on
4 April 17, 2008, would have required an allocation of office space of 50,000 or more gross
5 square feet under the Annual Limit, may seek such authorization pursuant to the requirements
6 of Section 321; however, no application may be acted on by the Planning Commission until
7 the termination date of the application period set forth in Subsection (b)(3), above. After that
8 time, Planning Department staff shall take all reasonable steps to schedule pending eligible
9 applications for Planning Commission review based on the order in which a project's
10 determination of eligibility was issued. Nothing in this Section shall preclude the Director of
11 Planning, based on the demand for participation in this program, from limiting the number of
12 projects that appear before the Planning Commission in a given period of time.

13 (g) **Fee Amount.** Any use authorized under Subsection (f) above shall, in addition to
14 any applicable application fees, pay for the area being legitimized the following impact fees:

15 (1) If the use is legitimizing as office, (as defined in Sec. 102 890.70)

16 (A) If the project is subject to the Transit Impact Development Fee (as
17 defined in Section 411), a \$2.00/gross square foot Transit Impact Development Fee.

18 (B) If the project is subject to the Jobs-Housing Linkage Fee (as defined
19 in Section 413), an \$8.50/gross square foot Jobs-Housing Linkage Fee.

20 (C) No Eastern Neighborhoods Impact Fees shall be charged.

21 ~~(2) If the use is legitimizing as Integrated PDR, (as defined in Sec. 890.49)~~

22 ~~(A) If the project is subject to the Transit Impact Development Fee (as defined in~~
23 ~~Section 411), a \$2.00/gross square foot Transit Impact Development Fee.~~

24 ~~(B) If the project is subject to the Jobs-Housing Linkage Fee (as defined in~~
25 ~~Section 413), a \$4.00/gross square foot Jobs-Housing Linkage Fee.~~

~~(C) No Eastern Neighborhoods Impact Fees shall be charged.~~

1 (32) If the use is legitimizing as ~~retail~~ *or Entertainment* (as defined in *Section 102*
2 *Sec. 217) or entertainment (as defined in Sec. 313.1.16)*)

3 (A) If the project is subject to the Transit Impact Development Fee (as
4 defined in Section 411), a \$2.00/gross square foot Transit Impact Development Fee.

5 (B) If the project is subject to the Jobs-Housing Linkage Fee (as
6 described in Sec. 413), a \$7.20/gross square foot Jobs-Housing Linkage Fee.

7 (C) No Eastern Neighborhoods Impact Fees shall be charged.

8 (4) If the use is legitimized as any other use authorized under Subsection (f)
9 above, the use shall pay the Jobs-Housing Linkage Fee and Transit Impact Development Fee
10 in the amount applicable as of January 18, 2009.

11 (h) **Fee Payment.** Fees shall be paid upon issuance of the first construction permit (as
12 defined in Sec. 401) or *if* an applicant ~~has~~ *may* ~~elected~~ to participate in a deferred payment
13 program, as specified below:

14 (1) Prior to issuance by DBI of the first construction permit, at least 20% of
15 applicable fees are due. Henceforth, at least 20% of applicable fees are due by July 1st of
16 each subsequent calendar year, such that final payment must be made within four years of
17 receiving the first building or site permit.

18 (2) The applicant may elect to pay any outstanding balance at any time within
19 these four years.

20 (3) A Notice of Special Restrictions shall be placed on the title of the property
21 specifying that additional payment is required. This Notice of Special Restrictions shall be
22 released when payment is complete.

23 (4) All outstanding fees will be adjusted annually based on the cost of living as
24 defined by the Controller's Office.

25 (5) The Department may assess an additional fee for time and materials spent
implementing this deferred fee program.

1 (6) Failure to comply with the terms of the program and associated NSR as
2 specified in this Subsection shall be deemed a violation of this Code and result in an
3 enforcement action by the Department, which may include, referral to the Bureau of
4 Delinquent Revenue and a lien on the subject property. Any enforcement action also may
5 result in additional charges or penalties to cover the City's costs in the enforcement action,
6 including, but not limited to City Attorney's fees.

7 **SEC. 181. NONCONFORMING USES: ENLARGEMENTS, ALTERATIONS AND**
8 **RECONSTRUCTION.**

9 The following provisions shall apply to non-conforming uses with respect to
10 enlargements, alterations and reconstruction:

11 (a) **Increases in Nonconformity.** A nonconforming use, and any structure occupied by

20 (c) **Dwellings Nonconforming as to Density.**

21 (1) A ~~Dwelling~~ or other housing structure exceeding the permitted density of
22 ~~Dwelling~~ Units or other housing units set forth in the Zoning Control Table for the district in
23 which the lot is located ~~Sections 207.5, 208, 209.1, 209.2, or 215 of this Code for the district in which~~
24 ~~it is located~~ shall be classified as a nonconforming use under Section 180 of this Code, but
25 only to the extent that such ~~Dwelling~~ or other housing structure exceeds the permitted
density.

1 (2) In districts where a dDwelling #Unit is a principally permitted use, this Section
2 181 shall not apply with respect to enlargements, alterations, and reconstruction of the
3 nonconforming portion of such dDwelling or other housing structure, consisting of those
4 dDwellings #Units or other housing units ~~which~~ that exceed the permitted density, so long as
5 such enlargements, alterations, or reconstruction do not otherwise extend beyond the building
6 envelope as it existed on January 1, 2013.

7 (3) No enlargements, alterations, or reconstruction shall be permitted under
8 Subsection (c)(2) for any dDwellings #Unit if any tenant has been evicted pursuant to
9 Administrative Code Sections 37.9(a)(9) through 37.9(a)(14) where the tenant was served
10 with the notice of eviction after December 10, 2013 if the notice was served within ten (10)
11 years prior to filing an application to enlarge, alter or reconstruct such dDwellings or other
12 housing unit. Additionally, no such enlargements, alterations, or reconstruction shall be
13 permitted for any dDwellings #Unit if any tenant has been evicted pursuant to Administrative
14 Code Section 37.9(a)(8) where the tenant was served with a notice of eviction after December
15 10, 2013 if the notice was served within five (5) years prior to filing an application to enlarge,
16 alter or reconstruct such dDwellings or other housing unit. This Subsection (c)(3) shall not
17 apply if the tenant was evicted under Section 37.9(a)(11) or 37.9(a)(14) and the applicant(s)
18 either (A) have certified that the original tenant reoccupied the unit after the temporary eviction
19 or (B) have submitted to the Planning Commission a declaration from the property owner or
20 the tenant certifying that the property owner or the Rent Board notified the tenant of the
21 tenant's right to reoccupy the unit after the temporary eviction and that the tenant chose not to
22 reoccupy it.

23 (4) Any dDwellings #Unit or other housing unit coming within the density limit shall
24 not be affected by this Section 181. Except as provided in Sections 181(h) and 182(e), no
25 dDwellings or other housing structure exceeding the permitted density of dDwellings #Units or
other housing units shall be altered to increase the number of dDwellings #Units or other

1 housing units therein, or to increase or create any other nonconformity with respect to the

5 **SEC. 182. NONCONFORMING USES: CHANGES OF USE.**

5 pursuant to the provisions of Article 3 of this Code, and the new use may thereafter be

9 (e) A nonconforming use may be converted to a dDwelling uUnit and to two or more

12 required off-street parking, and the Zoning Administrator may provide relief from certain other

Subdistrict.

1 (B) Any use described in zoning categories .51, .52, or .53, as defined in

3 in zoning categories .51, .52, or .53, even though such other use is not permitted in that
4 Neighborhood Commercial District.

SEC. 202. USES PERMITTED BY THIS CODE.

(a) The use limitations of this Code shall be set forth in Articles 2, 6, 7, 8, and 9 for the use districts of the City, as established by Sections 201, ~~701, 801 and 902~~ of this Code and as shown on the Zoning Map referred to in Section 105 of this Code, subject to the provisions of Section 105. The uses permitted under this Code shall consist of the following:

(1) Principal uses, permitted as of right in each established district where listed for that class of districts in Articles 2, 7, 8, and 9 as regulated herein and elsewhere in this Code.

(2) Conditional uses, permitted in each established district when authorized by the ~~City~~ Planning Commission under Section 303 of this Code, where listed for that class of districts in Articles 2, 7, 8, and 9 and as regulated herein and elsewhere in this Code;

(3) Accessory uses for such permitted principal and conditional uses, as defined and regulated in Sections 204 through 204.5, Section 703.2(b)(1)(C), Section 803.3(b)(1)(C), Section 903(a)(3), and Section 986 of this Code. Any use not qualified under such sections as an accessory use shall be classified as a principal or conditional use.

(b) Permitted uses shall include in each established district such uses not specifically listed in Articles 2, 7, or 8 of this Code as are from time to time determined by the Zoning Administrator to be permitted uses in accordance with Section 307(a) of this Code.

(c) No use shall be permitted in any R District, C District, PDR-1 Districts, or M-1 District which by reason of its nature or manner of operation creates conditions that are hazardous, noxious or offensive through emission of odor, fumes, smoke, cinders, dust, gas, vibration, glare, refuse, water-carried waste, or excessive noise.

1 (d) Except as specifically provided herein to the contrary, the provisions of Articles 2,
2 7, 8, and 9 of this Code shall apply to all uses, properties, and developments, both public and
3 private, including those of the City and County of San Francisco.

4 **202.1. ZONING CONTROL TABLES.**

5 (a) All Districts that are provided for in Section 201 of this Code have a corresponding Zoning
6 Control Table that details basic development standards and use controls. Zoning Control Tables for R,
7 C, PDR, and M Districts are located in Article 2; Zoning Control tables for Neighborhood Commercial
8 Districts are located in Article 7; Zoning Control tables for Chinatown and Mixed Use Districts are
9 located in Article 8; and Zoning Control tables for Mission Bay Districts are located in Article 9.
10 Zoning Control Tables are intended to be used in conjunction with other relevant sections of the Code.
11 Descriptions for Zoning Control Tables in Articles 7, 8, and 9 are located in the corresponding Article.
12 Each of the Zoning Control Tables contains a brief summary of, and reference guide to, the specific
13 rules that appear elsewhere in this Planning Code. To the extent of any inconsistency between a Table
14 and the relevant governing sections, the latter shall control.

16 (b) Zoning Control Tables in Article 2 are organized as follows:

17 (1) **Building Standards:** This section lists basic Code requirements that are specific to
18 that particular Zoning District and apply to all buildings in that District regardless of the proposed
19 use.

20 (2) **Residential Standards and Uses:** This section lists basic Code requirements for
21 Residential uses, permitted residential uses, and permitted densities for the subject District.

22 (3) **Non-Residential Standards and Uses:** This section lists basic Code requirements for
23 Non-Residential Uses and Non-residential use controls.

24 (c) The columns in the Zoning Control Tables in Article 2 are organized as follows:

25 (1) The first column in the Zoning Control Table, titled "Zoning Category," provides
either the title of the listed requirement or the Use.

1 (2) The second column, titled "§ References," contains numbers of other sections in the
2 Planning Code, and other City Codes, in which additional control provisions, including exceptions and
3 definitions where pertinent, are contained. Any requirements in these sections pertinent to the zoning
4 district shall be followed.

5 (3) In the third and subsequent columns, the controls applicable to the various Districts
6 are indicated either directly, by reference to other Code Sections that contain the controls, or by
7 indicating when a specific requirement is required.

8 (d) The uses and features listed in the Zoning Control Tables in Articles 2, 7, 8, and 9 are
9 permitted in the Districts as indicated by the following symbols in the respective columns for each
10 district:

11 P: The use or project is permitted as a principal use in this district.

12 C: The use or project is subject to approval by the Planning Commission as a conditional use in
13 this district as provided in Section 303 of this Code.

14 DR. A Mandatory Discretionary Review hearing before the Planning Commission is required
15 before the Planning Department can approve the proposed use or project. Uses or projects subject to
16 Mandatory Discretionary Review may be disapproved or modified by the Planning Commission.

17 NA: This listing not applicable to this district.

18 NP or Blank Space: The use or project is not permitted in this district.

19 R: Required.

20 (1) Determinations as to the classification of uses not specifically listed shall be made in
21 the manner indicated in Sections 202 and 307(a) of this Code.

22 (2) References shall be made to Sections 204 through 204.5 for regulations pertaining to
23 accessory uses permitted for principal and conditional uses listed in Sections 206.1 through 206.4.

24 (3) Reference shall also be made to the other Articles of this Code containing provisions
25 relating to definitions, off-street parking and loading dimensions, areas and open spaces,

1 nonconforming uses, height and bulk districts, signs, historic preservation, and other factors affecting
2 the development and alteration of properties in these use Districts.

3 (4) Reference shall be made to Section 249.1 for provisions pertaining to uses in the
4 Folsom and Main Residential/Commercial Special Use District.

19 the development, and doorways and paths of access to and within the housing units, shall be

23 development shall be equipped with standard height railings or grab bars to assist persons

10 meet all of the requirements of Civil Code Section 51.3 including, but not limited to, the

12 occupancy, residency, and use based on age. Any such limitation shall not be more exclusive
13 than to require that one person in residence in each dwelling unit may be required to be a

9 **GROCERY STORE USE.**

10 Notwithstanding any other provision of this Article, a change in use or demolition of a
11 ~~g~~General ~~s~~Grocery ~~s~~Store use, ~~a retail sales use~~ as set forth in Section ~~218(a)~~ 102 and as further
12 defined in Section 790.102, which use exceeds 5,000 gross square feet shall require
13 ~~e~~Conditional ~~#~~Use authorization pursuant to Section 303 of this Code. This Section shall not
14 authorize a change in use if the new use or uses are otherwise prohibited.

15 **SEC. 202.4. 221.1 LIMITATION ON CHANGE IN USE OR DEMOLITION OF MOVIE**
16 **THEATER USE.**

17 Notwithstanding any other provision of this Article, a change in use or demolition of a
18 Movie Theater use, as ~~set forth~~ defined in Section ~~221(d)~~ 102 shall require Conditional Use
19 authorization pursuant to Section 303, including the specific conditions in that Section for
20 conversion of such a use. This Section shall not authorize a change in use if the new use or
21 uses are otherwise prohibited.

22 **SEC. 202.5 228 CONVERSION OF AUTOMOTIVE SERVICE STATIONS.**

23 * * * *

24 (b) **Definitions.** Whenever used in this Section, unless a different meaning clearly
25 appears from the context:

1 (1) "Automotive Service Station" or "service station" shall mean a retail
2 automotive service use ~~which provides motor fuels and lubricating fluids directly into motor vehicles~~
3 ~~and performs minor auto repairs and services which remain incidental to the principal sale of motor~~
4 ~~fuel,~~ as defined in Sections ~~102 790.17 and 890.18~~ of this Code.

5 * * * *

6 (c) **Limitation on Conversions.**

7 (1) No owner of a property used as an Automotive Service Station shall change
8 the use of the property to a different type of use without first applying for and receiving either a
9 ~~e~~Conditional ~~u~~Use authorization from the Planning Commission or a conversion determination
10 from the Zoning Administrator. Such authorizations shall be in addition to any other permit or
11 authorization required for a proposed service station conversion under any applicable City,
12 State, or Federal law or regulation. Automotive Service Stations that front on Primary Transit
13 Streets or Citywide Pedestrian Network Streets, as designated in the General Plan, shall be
14 exempt from the conversion limitations of this Section. The procedures for service station
15 conversion applications shall be as described in Sections 306 and 306.1 of this Code for
16 conditional use and variance actions.

17 (2) Either the Planning Commission or the Zoning Administrator shall determine
18 at a public hearing whether an applicant is entitled to convert the service station, depending
19 on the grounds on which the permit is sought. The Planning Commission shall make

21 (d). The Zoning Administrator shall make service station conversion determinations under the
22 grounds set forth in Subsection (e). An applicant may, but need not, apply to the Planning
23 Commission for a ~~e~~Conditional ~~u~~Use authorization pursuant to Subsection (d) and apply to the
24 Zoning Administrator for a conversion authorization pursuant to Subsection (e), provided that
25 if either one approves the application at the first hearing held on it, no hearing shall be
necessary before the other. The procedures for service station conversion hearings shall be

1 as described in Sections 306 through 306.5 and 306.8 of this Code for conditional use action
2 (Planning Commission hearings) and variance action.

3 (d) **Criteria for Planning Commission Conditional Use Authorization.** In acting on
4 any application for eConditional #Use authorization for conversion, the Commission shall
5 consider the following criteria in lieu of the criteria set forth in Section 303(c) of this Code.

6 * * * *

7 (3) In making determinations under Subsection (1)(B), the Planning Commission
8 shall consider the following factors:

9 (A) If the proposed use is a #Residential use, the total number of units to
10 be provided and the number of those units that are affordable units;

11 (B) If the proposed new use is a eCommercial use, the types of goods
12 and services to be offered and the availability of comparable products and services in the
13 vicinity;

14 (C) The importance of the street on which the service station fronts to
15 walking, cycling, and public transit, and the impact of automobile access and egress to the
16 service station and of the proposed new uses and structures on the safety and comfort of
17 pedestrians, cyclists, and transit riders;

18 (D) The relative environmental dangers posed by the current and
19 proposed uses including, but not limited to, the quality and character of waste generated,
20 noxious or offensive emissions, fire and explosion hazards and noise, and whether the service
21 station conversion would facilitate the cleanup of existing contamination at the property;

22 (E) The relative employment opportunities offered by the service station
23 and the proposed new use;

24 (F) The relative amount of taxes or other revenues to be received by the
25 City or other governmental bodies from service station use and the proposed new use;

1 (G) The compatibility of the existing service station and of the proposed
2 new use or structure with the General Plan and area plan urban design policies and the street
3 frontage standards of this Code; and

4 (H) Whether the service station use and the proposed use are permitted
5 principal uses, conditional uses, or nonconforming uses.

6 (e) **Criteria for Zoning Administrator Conversion Determination.** The Zoning
7 Administrator shall approve the application and authorize the service station conversion if the
8 Zoning Administrator determines from the facts presented that the owner of the subject
9 property is not earning a ~~f~~Fair ~~r~~Return on ~~i~~Investment, *as defined in Section 102*. The owner
10 shall bear the burden of proving that the owner is not earning a ~~f~~Fair ~~r~~Return on ~~i~~Investment.

11 (1) **Application.** A property owner's application under this Section shall be
12 signed by the owner or an authorized representative of the owner and, under penalty of
13 perjury, declared to contain true and correct information. The application shall be
14 accompanied by:

15 (A) An independent appraisal of the property stating its value;

16 (B) A written statement from an independent Certified Public Accountant
17 summarizing the applicant's financial records, including the property appraisal and stating the
18 return on investment calculated pursuant to ~~this~~ Section 102;

19 (C) A certified statement from the Certified Public Accountant identifying
20 the owner of the property and the owner of the service station business; and

21 (D) Such other financial information as the Zoning Administrator may
22 reasonably determine is necessary to make the determination provided for in this Section.

23 (2) **Rebuttable Presumption.** There shall be a rebuttable presumption that the
24 property owner is earning a ~~f~~Fair ~~r~~Return on ~~i~~Investment if the property owner has earned at
25 least a ~~9~~ nine percent return on the property owner's total investment in the property for the
24-month period immediately preceding the filing of the application, or in the case of a service

1 station business that ceased operations after October 12, 1989, for the 24-month period
2 immediately preceding the date the service station ceased operations. The property owner
3 may rebut this presumption by offering evidence demonstrating that because of special facts
4 regarding his or her property the property owner is not earning a ~~f~~Fair ~~r~~Return on ~~i~~Investment
5 or that because of special demonstrated circumstances the applicant would not earn a fair
6 return on investment from service station use during that 12-month period after the filing of the
7 service station conversion application.

9 **SEC. 202.6 ~~233~~ LIVE/WORK UNITS.**

10 No City official, department, board or commission shall issue or approve a building
11 permit or other land use entitlement authorizing a new Live/Work Unit, as defined in Section
12 ~~102.13~~ of this Code, except as authorized as an accessory use under Section 204.4. Lawfully
13 approved Live/Work Units are subject to the nonconforming use provisions of Section 181 of
14 this Code.

15 **SEC. 202.7 ~~230~~ DEMOLITION OF INDUSTRIAL BUILDINGS IN PDR DISTRICTS,**
16 **REPLACEMENT REQUIREMENTS.**

17 (a) In order to preserve the existing stock of buildings suitable for industrial activities
18 and to create new viable space for ~~i~~Industrial ~~Uses operations, as defined in Section 102,~~ in PDR
19 Districts, an industrial building that is not unsound and is proposed for demolition must be
20 replaced by a new building that complies with the criteria set forth below:

21 (1) If the building proposed for demolition represents greater than 0.4 FAR, then
22 the replacement building shall include at least one square foot of ~~i~~Industrial ~~#~~Use for each
23 square foot of ~~i~~Industrial ~~#~~Use in the building proposed for demolition.

24 (2) If the building proposed for demolition represents 0.4 FAR or less, then the
25 replacement building shall include at least two square feet of ~~i~~Industrial ~~#~~Use for each square
foot of ~~i~~Industrial ~~#~~Use in the building proposed for demolition.

1 (b) **Definitions.** For the purpose of this ~~s~~ubsection, the following definitions shall
2 apply:

3 (1) Unsound shall refer to buildings in which rehabilitation would cost ~~fifty~~ 50
4 percent (~~50%~~) or more to construct a comparable building.

5 (2) ~~For purposes of this section, industrial use shall refer to any legally authorized use~~
6 ~~of a building or portion of a building that is included in Planning Code Sections 220, 222, 223, 224,~~
7 ~~225, 226, 227(a), 227(b), 227(c), 227(t), and 227(u).~~

8 (3) An industrial building shall mean any building containing any ~~i~~ndustrial ~~u~~se.

9 **SEC. 204. ACCESSORY USES, GENERAL.**

10 Subject to the limitations set forth in this Code, and especially as specified in Sections
11 204.1 through 204.5, a related minor use ~~which~~ that is either (a) necessary to the operation or
12 enjoyment of a lawful principal use or conditional use; or (b) appropriate, incidental, and
13 subordinate to any such use; and (c) in the case of Internet Services Exchange as defined in
14 Section 102, ~~209.6(e)~~ which use does not exceed 25,000 gross square feet of floor area or use
15 more than two megawatts of back-up power generators, shall be permitted as an accessory
16 use when located on the same lot; provided, however, that in the Outer Clement
17 Neighborhood Commercial District the storage of materials for a commercial use shall be
18 permitted as an accessory use if the storage occurred prior to 1985, if it is within 200 feet of
19 the use to which it is accessory, if it is accessible to the principal permitted use without the
20 use of a public sidewalk or other public right-of-way, and if the provision of storage would not
21 conflict with the provisions of Section 145.1 relating to street frontage in N-C Districts. In PDR
22 Districts, accessory uses to non-Office uses (as defined in Section 102-890.70) may occupy
23 space ~~which~~that is non-contiguous or on a different story as the principal use so long as the
24 accessory use is located in the same building as the principal use and complies with all other
25 restrictions applicable to such accessory uses.

SEC. 204.1. ACCESSORY USES FOR DWELLINGS IN ~~R OR NC~~ ALL DISTRICTS.

1 No use shall be permitted as an accessory use to a dwelling unit in any ~~R or NC~~ District
2 ~~which~~that involves or requires any of the following:

3 (a) Any construction features or alterations not residential in character;

4 (b) The use of more than ~~1/4~~one-third of the total floor area of the dwelling unit, except in
5 the case of accessory off-street parking and loading or Neighborhood Agriculture as defined
6 by Section 102.~~35~~;

7 (c) The employment of any person not resident in the dwelling unit, other than a
8 domestic servant, gardener, janitor, or other person concerned in the operation or
9 maintenance of the dwelling unit: except in the case of a Cottage Food Operation, which allows the
10 employment of one employee, not including a family member or household members of the Cottage
11 Food Operation;

12 (d) Residential occupancy by persons other than those specified in the definition of
13 family in this Code;

14 (e) In RH-1(D), RH-1, and RH-1(S) Districts, the provision of any room for a roomer or
15 boarder with access other than from within the dwelling unit;

16 (f) Addition of a building manager's unit, unless such unit meets all the normal
17 requirements of this Code for dwelling units;

18 (g) The maintenance of a stock in trade other than garden produce related to
19 Neighborhood Agriculture as defined by Section 102.~~35~~, or materials and products related to a
20 Cottage Food Operation; or

21 ~~(h) The~~ use of show windows or window displays or advertising to attract customers or
22 clients; ~~or~~

23 ~~(hi)~~ The conduct of a business office open to the public other than sales related to
24 garden produce of Neighborhood Agriculture as defined by Section 102.~~35~~, or the finished
25 products of a Cottage Food Operation; or

1 (i) A Medical Cannabis Dispensary as defined in Section ~~102 209.3(k) and 217(k)~~ of this
2 Code.

3 Provided, however, that Subsection (h) of this Section shall not exclude the
4 maintenance within a ~~d~~ Dwelling ~~u~~ Unit of the office of a professional person who resides
5 therein, if accessible only from within the dwelling unit; and provided, further, that Subsection
6 (g) shall not exclude the display of signs permitted by Article 6 of this Code.

7 **SEC. 204.2. ACCESSORY USES FOR USES OTHER THAN DWELLINGS IN**
8 **RESIDENTIAL DISTRICTS.**

9 No use shall be permitted as an accessory use to a use other than a dwelling in any
10 Residential District ~~that which~~ involves or requires any of the following:

11 (a) The use of more than one-fourth of the total floor area occupied by such use and
12 the principal or conditional use to which it is accessory, except in the case of accessory off-
13 street parking and loading;

14 (b) The use of show windows or window displays or advertising to attract customers or
15 clients, except for an identifying sign and regulated in Article 6 of this Code; or

16 (c) The conduct of any activity of a profit-making or commercial nature, except as an
17 integral part of the permitted principal or conditional use where such activity is expressly
18 permitted by ~~the Zoning Control Table for the district Sections 209.1 through 209.9 of this Code~~; or

19 (d) A Medical Cannabis Dispensary as defined in Section ~~102 209.3(k) and 217(k)~~ of this
20 Code.

21 **SEC. 204.3. ACCESSORY USES FOR USES OTHER THAN DWELLINGS IN C, RC, M, AND**
22 **PDR DISTRICTS.**

23 * * * *

24 (b) **PDR and M Districts.** No use shall be permitted as an accessory use to a lawful
25 principal or conditional use in any PDR or M District ~~that which~~ involves or requires the use of
more than one-third (1/3) of the total floor area occupied by such use and the principal or

1 conditional use to which it is accessory, except in the case of accessory retail, off-street
2 parking, and loading. Multiple PDR uses within a single building or development may combine
3 their accessory retail allotment into one or more shared retail spaces, provided that the total
4 allotment of accessory retail space per use does not exceed what otherwise would be
5 permitted by this Section.

6 **SEC. 205.2. TEMPORARY USES: ONE- OR TWO-YEAR LIMIT.**

7 A temporary use may be authorized for a period not to exceed two years for any of the
8 following uses:

9 (a) Temporary structures and uses incidental to the construction of a group of buildings
10 on the same or adjacent premises;

11 (b) Rental or sales office incidental to a new residential development, not including the
12 conduct of a general real estate business; provided, that it be located within the development,
13 and in a temporary structure or part of a dwelling. A temporary use may be authorized for a
14 period not to exceed one year (including any extensions) for the following year.

15 (c) In any M-1 or M-2 District, an ~~Automobile~~ ~~Wrecking~~ use operation covered by as
16 defined in Section 102 225(p) of this Code, provided, if the operation would be a conditional use
17 in the district in question, that the Zoning Administrator determines the operation will meet
18 within 90 days of commencing operation all conditions applicable to such use in that district.

19 **SEC. 205.4. TEMPORARY USES: INTERMITTENT ACTIVITIES.**

20 An intermittent activity is an outdoor use which, while occasional, occurs with some
21 routine or regularity. Intermittent activities include, but are not limited to, the following uses:
22 mobile food facilities, farmers markets, and open-air craft markets. Such uses typically require
23 additional authorization(s) from other City Departments. An intermittent activity may be
24 authorized as a temporary use for a period not to exceed one year.

25 (a) In all Districts other than RH, RM, RED, and RTO Districts an intermittent activity is
permissible if it satisfies all of the following conditions:

1 (1) It shall not be located within a Bbuilding as defined in Section 102 ~~102.3~~ of this
2 Code.

3 (2) It shall not be located on the property for more than either: (i) ~~six~~ (6) calendar
4 days for longer than 12 hours per day in any ~~seven~~ 7-day period; or (ii) ~~three~~ (3) calendar days
5 for longer than 24 hours per day in any ~~seven~~ 7-day period. At the time of application, the
6 applicant shall designate in writing which of the foregoing options shall apply to the activity.
7 No changes shall be made during the authorization period without first filing a new application.

8 (A) The time periods referenced in Subsection (a)(2) each constitute
9 complete calendar days and apply without regard to whether the activity is open to the public
10 or whether the activity is located on the subject property for consecutive days.

11 (B) Days of unused authorization cannot be stored or credited, and any
12 portion of a day that the intermittent activity is located at the subject property shall count
13 toward the 12-hour or the 24-hour limit of Subsection (a)(2).

14 (C) This Subsection (a)(2) shall not apply to any ~~m~~Mobile ~~f~~Food ~~f~~Facility
15 located within a Public (P) District that together with any directly adjoining P District(s)
16 contains more than one ~~(1)~~ acre.

17 (3) It shall be open for business only during the hours of operation permitted as a
18 principal use for the District in which it is located, if any such hourly limits exist.

19 (4) If located in a District that is subject to any of the neighborhood notification
20 requirements as set forth in Section 312 of this Code, notification pursuant to Section 312 shall
21 be required as follows:

22 (A) Notification shall be required if the vending space, as defined below,
23 would exceed 300 square feet.

24 (B) Notification shall be required if any portion of the vending space would
25 be located within 50 feet of an RH, RM, RED₇ or RTO District. Distances to RH, RM, RED₁

1 and RTO Districts shall be measured from the extreme perimeter of any vending space to the
2 nearest property line of any parcel which is partially or wholly so zoned.

3 (C) For purposes of this Section, "Vending Space" shall be defined as the
4 entire area within a single rectangular perimeter formed by extending lines around the
5 extreme limits of all carts, vehicles, tables, chairs, or other equipment associated with all
6 intermittent activities located on the parcel.

7 (D) Notwithstanding Subsections (4)(A) and (B) above, and in order to
8 eliminate redundant notification, notification shall not be required for the resumption of an
9 intermittent activity or the extension of time for an intermittent activity when all of the following
10 criteria are met: (i) an intermittent activity is currently authorized on the property or has been
11 authorized on the property within the 12 months immediately preceding the filing of an
12 application for resumption or extension; (ii) the existing or recent intermittent activity lawfully
13 exceeds or exceeded the thresholds of Subsections (4)(A) and/or (B), above, and was the
14 subject of neighborhood notice under Section 312 at the time of its establishment; and (iii) the
15 intermittent activity would not further exceed the thresholds of Subsections (4)(A) and/or (B),
16 above.

17 (b) An intermittent activity is allowed in a RH, RM, RED, and RTO District only if it: (1)
18 satisfies all the conditions set forth in Subsection (a); and (2) is located on a parcel that
19 contains or is part of a Hospital medical institution, as defined in Section 102-209.3(a), or a
20 Post-Secondary Educational Institution, as defined in Section 102-209.3(i). An intermittent
21 activity authorized under this Subsection shall not operate between the hours of 10:00 p.m. to
22 7:00 a.m.

23 **SEC 206. (RESERVED).**

1 **SEC. 207. DENSITY OF DWELLING UNITS ~~IN R-DISTRICTS.~~**

2 The density of dwelling units permitted in the various ~~R~~-Districts shall be as set forth in
3 *the Zoning Control Table for the district in which the lot is located Sections 207.1, 207.2, 207.5 and*
4 *209.1 of this Code.* The term "~~d~~Dwelling ~~u~~Unit" is defined in Section ~~102-102.7~~ of this Code.

5 **SEC. 207.1. RULES FOR CALCULATION OF DWELLING UNIT DENSITIES.**

6 In districts that establish a maximum dwelling unit density, the following rules shall apply
7 in the calculation of dwelling unit densities under this Code:

8 (a) The entire amount of lot area per ~~d~~Dwelling ~~u~~Unit specified by the Code shall be
9 required for each ~~d~~Dwelling ~~u~~Unit on the lot. A remaining fraction of one-half or more of the
10 minimum amount of lot area per ~~d~~Dwelling ~~u~~Unit shall be adjusted upward to the next higher
11 whole number of ~~d~~Dwelling ~~u~~Units.

12 (b) Where permitted by this Code, two or more of the dwelling and other housing uses
13 specified in the Code may be located on a single lot, either in one structure or in separate
14 structures, provided that the specified density limits are not exceeded by the total of such
15 combined uses. Where ~~d~~Dwelling ~~u~~Units and ~~g~~Group ~~h~~Housing are combined, the maximum
16 permitted density for ~~d~~Dwelling ~~u~~Units and for ~~g~~Group ~~h~~Housing shall be prorated to the total
17 lot area according to the quantities of these two uses that are combined on the lot.

18 (c) Where any portion of a lot is narrower than five feet, such a portion shall not be
19 counted as part of the lot area for purposes of calculating the permitted dwelling density.

20 (d) No private right-of-way used as the principal vehicular access to two or more lots
21 shall be counted as part of the lot area of any such lot for purposes of calculating the
22 permitted dwelling unit density.

23 (e) Where a lot is divided by a use district boundary line, the dwelling unit density limit
24 for each district shall be applied to the portion of the lot in that district, and none of the
25 ~~d~~Dwelling ~~u~~Units attributable to the district permitting the greater density shall be located in
 the district permitting the lesser density.

1 (f) For projects that are not located in any RH-1 or RH-2 zoning district, or are not
2 seeking and receiving a density bonus under the provisions of California Government Code
3 Section 65915, where 20 percent or more of the dWelling #Units on-site are “Affordable
4 Units,” the on-site Affordable Units shall not count towards the calculation of dwelling unit
5 density. This Planning Code Section does not provide exceptions to any other Planning Code
6 requirements such as height or bulk. For purposes of Section 207.1, “Affordable Units” shall
7 be defined as meeting (1) the criteria of Section 406(b); (2) the requirements of Section 415 et
8 seq. for on-site units; or (3) restricted units in a project using California Debt Limit Allocation
9 Committee (CDLAC) tax-exempt bond financing and 4 percent tax credits under the Tax
10 Credit Allocation Committee (TCAC). If a project sponsor proposes to provide “Affordable
11 Units” that are not restricted by any other program, in order to receive the benefit of the
12 additional density permitted under this Subsection (f) or Subsection (g), the project sponsor
13 shall elect and the Planning Department and MOHCD shall be authorized to enforce,
14 restricting the units as affordable under Planning Code Section 415.6 up to a maximum of 20
15 percent of the units in the principal project. The project sponsor shall make such election
16 through the procedures described in Section 415.5(g) including submitting an Affidavit of
17 Compliance indicating the project sponsor’s election to pursue the benefits of Subsection (f) or
18 (g) and committing to 20% on-site units restricted under Section 415.6 prior to approval by the
19 Planning Commission or Planning Department staff. If a project sponsor obtains the
20 exemption from the density calculation for Affordable Units provided in this subsection, the
21 exemption shall be recorded against the property. Any later request to decrease the number
22 of Affordable Units shall require the project to go back to the Planning Commission or
23 Planning Department, whichever entity approved the project as a whole.

24 (g) In RTO Districts, on-site dWelling #Units that are “Affordable Units,” as defined in
25 Subsection (f), shall not count toward density calculations or be limited by lot area.

1 (h) Double Density for Senior Housing in RH, RM, and RC Districts. Senior Housing, as
2 defined in and meeting all the criteria and conditions defined in Section 102 of this Code, is permitted
3 up to twice the dwelling unit density otherwise permitted for the District.

4 Projects in RC Districts or within one-quarter of a mile from an RC or NC-2 (Small-Scale
5 Neighborhood Commercial District) zoned area or higher, including named Neighborhood
6 Commercial Districts, and located in an area with adequate access to services including but not limited
7 to transit, shopping, and medical facilities, shall be principally permitted. Projects in RH and RM
8 Districts located more than one-quarter of a mile from an RC or NCD-2 (Small-Scale Neighborhood
9 Commercial District) zoned area or higher, including named Neighborhood Commercial Districts,
10 shall require Conditional Use authorization.

11 **SEC. 207.2. SECOND UNITS.**

12 (a) Second units, as defined and referred to in Government Code Section 65852.2, are
13 precluded in RH-1(D) and RH-1 zoned areas, except for ~~where second units are currently~~
14 ~~permitted under Section 209.1(m) or (n) for~~ units designed for and occupied by senior citizens
15 (“Senior Housing” as defined by Section 102) and except as may hereafter be permitted by later
16 amendments to this Code governing second units.

17 * * * *

18 (15) There are no large districts suitable for the provision of second units, but
19 instead there are small subareas which must be reviewed on a case-by-case basis with
20 community participation in the review process. A case-by-case review is needed in order to
21 determine those areas of the City where the traffic congestion problems described above
22 would be least likely to occur and where second units may therefore be permitted without
23 adverse impact to the public. Furthermore:

24 (A) The Planning Code presently permits a secondary unit in all single-
25 family homes in RH-1(S) (House, One-Family with Minor Second Unit), RH-2 (House, Two-
Family) and RH-3 (House, Three-Family) Districts no matter what the lot size. Second units in

1 single-family homes are permitted in all other multifamily residential districts (all RM and RC
2 Districts), depending on the size of the lot.

3 (B) The Planning Code ~~Section 209.1(e)~~ permits the mapping of the RH-
4 1(S) (House, One-Family with Minor Second Unit) District. These RH-1(S) Zoning Districts
5 provide for a two-family dwelling with the second dwelling limited to 600 square feet of net
6 floor area. The second unit remains subordinate to the owner's unit and the structures retain
7 the appearance of single-family dwellings. The RH-1(S) Zoning District has been mapped in
8 four areas of the City. Additional mapping of the RH-1(S) Zoning District may be used to
9 legalize existing secondary units in single-family homes and to increase the number of
10 secondary units.

11 (C) Dwellings specifically designed for and occupied by senior citizens
12 (“Senior Housing”) are presently permitted at a density ratio or number of ~~d~~Dwelling ~~u~~Units not
13 exceeding twice the number of ~~d~~Dwelling ~~u~~Units otherwise permitted as a principal use in the
14 district by the ~~City~~ Planning Code (~~Section 209.1(m) and (n)~~).

16 **SEC. 207.6. REQUIRED MINIMUM DWELLING UNIT MIX IN RTO, RCD, NCT, DTR, AND**
17 **EASTERN NEIGHBORHOODS MIXED USE DISTRICTS.**

18 * * * *

19 (b) **Applicability.**

20 (1) This Section shall apply in the RTO, RCD, NCT, DTR, and Eastern
21 Neighborhoods Mixed Use Districts.

22 (2) This Section shall apply to all applications for building permits and/or
23 Planning Commission entitlements that ~~which~~ propose the creation of five or more ~~d~~Dwelling
24 ~~u~~Units.

25 (3) This Section does not apply to buildings for which 100 percent of the
residential uses are: ~~g~~Group ~~h~~Housing, ~~d~~Dwelling ~~u~~Units that ~~which~~ are provided at below

market rates pursuant to Section 406(b)(1) of this Code, Single Room Occupancy (SRO) Units, Student Housing (~~as defined in Sec. 102.36~~), (all as defined in Section 102 of this Code) or housing specifically and permanently designated for seniors or persons with physical disabilities.

SEC. 208. DENSITY LIMITATIONS FOR GROUP HOUSING.

Except for single room occupancy units in the South of Market Mixed Use Districts, the density limitations for ~~g~~Group ~~h~~Housing, as described in Sections ~~102 209.2(a), (b), and (c)~~, 790.88(b) and 890.88(b) of this Code, shall be as follows:

(a) The maximum number of ~~b~~Bedrooms on each ~~l~~Lot shall be as specified in the Zoning Control Table following table for the ~~d~~District in which the ~~l~~Lot is located, except that in RTO, RTO-M, RCD, UMU, MUG, WMUG, MUR, MUO, WMUO, RED, RED-MX, SPD, DTR, and all NCT ~~d~~Districts the density of ~~g~~Group ~~h~~Housing shall not be limited by lot area, and except that for ~~l~~Lots in NC Districts, the group housing density shall not exceed the number of ~~b~~Bedrooms permitted in the nearest Residential District provided that the maximum density not be less than the amount permitted by the ratio specified for the NC District in which the lot is located.

13 (b) For purposes of calculating the maximum density for gGroup hHousing as set forth
14 *herein in this Section 208*, the number of bBedrooms on a lLot shall in no case be considered to
15 be less than one bBedroom for each two beds. Where the actual number of beds exceeds an
16 average of two beds for each bBedroom, each two beds shall be considered equivalent to one
17 bBedroom.

18 (c) The rules for calculation of dwelling unit densities set forth in Section 207.1 shall
19 also apply in calculation of the density limitations for gGroup hHousing, except that in NC
20 Districts, any remaining fraction of one-half 1/2 or more of the maximum amount of lot area per

22 (d) The group housing density in all RTO Districts and all NCT Districts, as listed in

24 limitations elsewhere in this Code, including but not limited to height, bulk, setbacks, open
25 space, and exposure, as well as by the Residential Design Guidelines in RTO dDistricts, other

1 applicable design guidelines, applicable elements and area plans of the General Plan, and
2 design review by the Planning Department.

3 **SEC. 209. 206. DESCRIPTION AND PURPOSE OF RESIDENTIAL AND RESIDENTIAL-**
4 **COMMERCIAL DISTRICTS.**

5 The following statements of description and purpose outline the main functions of the
6 Residential and Residential-Commercial (Residential) Districts in the zoning plan for San
7 Francisco, supplementing the statements of purpose contained in Section 101 of this Code.

8 (a) Purpose. These ~~d~~Districts are established for purposes of implementing the
9 Residence element and other elements of the General Plan, according to the objectives,
10 principles, and policies stated therein. Among these purposes are the following:

11 ~~(a)~~ (1) Preservation, improvement, and maintenance of the existing housing
12 stock through protection of neighborhood environments and encouragement of sound
13 ownership practices and rehabilitation efforts;

14 ~~(b)~~ (2) Recognition and protection of the architectural characteristics and
15 densities of existing residential areas;

16 ~~(c)~~ (3) Maximizing of housing choice by assuring the availability of quality owner
17 and rental housing of various kinds, suitable for a whole range of household types, lifestyles,
18 and economic levels;

19 ~~(d)~~ (4) Encouragement of residential development that will meet outstanding
20 community needs, provide adequate indoor and outdoor spaces for its occupants, and relate
21 well to the character and scale of existing neighborhoods and structures; and

22 ~~(e)~~ (5) Promotion of balanced and convenient neighborhoods having appropriate
23 public improvements and services, suitable nonresidential activities that are compatible with
24 housing and meet the needs of residents, and other amenities that contribute to the livability
25 of residential areas.

1 ~~Additional purposes for Eastern Neighborhoods and South of Market Mixed Use Districts are listed in~~
2 ~~Article 8 of this Code.~~

3 (b) Uses and Features Permitted in Residential and Residential-Commercial Districts. The
4 uses and features permitted in Residential and Residential-Commercial Districts are listed in the
5 Zoning Control Tables in Sections 209.1 through 209.4

6 **SEC. 209.1. ~~206.1~~ RH (RESIDENTIAL, HOUSE) DISTRICTS.**

7 These ~~d~~Districts are intended to recognize, protect, conserve, and enhance areas
8 characterized by dwellings in the form of houses, usually with one, two, or three units with
9 separate entrances, and limited scale in terms of building width and height. Such areas tend
10 to have similarity of building styles and predominantly contain large units suitable for family
11 occupancy, considerable open space, and limited nonresidential uses. The RH Districts are
12 composed of five separate classes of districts, as follows:

13 **RH-1(D) Districts: One-Family (Detached Dwellings).** These ~~d~~Districts are
14 characterized by lots of greater width and area than in other parts of the City, and by single-
15 family houses with side yards. The structures are relatively large, but rarely exceed 35 feet in
16 height. Ground level open space and landscaping at the front and rear are usually abundant.
17 Much of the development has been in sizable tracts with similarities of building style and
18 narrow streets following the contours of hills. In some cases, private covenants have
19 controlled the nature of development and helped to maintain the street areas.

20 **RH-1 Districts: One-Family.** These ~~d~~Districts are occupied almost entirely by single-
21 family houses on lots 25 feet in width, without side yards. Floor sizes and building styles vary,
22 but tend to be uniform within tracts developed in distinct time periods. Though built on
23 separate lots, the structures have the appearance of small-scale row housing, rarely
24 exceeding 35 feet in height. Front setbacks are common, and ground level open space is
25 generous. In most cases, the single-family character of these ~~d~~Districts has been maintained
for a considerable time.

1 **RH-1(S) Districts:** One-Family with Minor Second Unit. These ~~d~~Districts are similar in
2 character to RH-1 Districts, except that a small second dwelling unit has been installed in
3 many structures, usually by conversion of a ground-story space formerly part of the main unit
4 or devoted to storage. The second unit remains subordinate to the owner's unit and may
5 house one or two persons related to the owner or be rented to others. Despite these
6 conversions, the structures retain the appearance of single-family dwellings.

7 **RH-2 Districts: Two-Family.** These ~~d~~Districts are devoted to one-family and two-
8 family houses, with the latter commonly consisting of two large flats, one occupied by the
9 owner and the other available for rental. Structures are finely scaled and usually do not
10 exceed 25 feet in width or 40 feet in height. Building styles are often more varied than in
11 single-family areas, but certain streets and tracts are quite uniform. Considerable ground-level
12 open space is available, and it frequently is private for each unit. The ~~d~~Districts may have
13 easy access to shopping facilities and transit lines. In some cases, ~~g~~Group ~~h~~Housing and
14 institutions are found in these areas, although nonresidential uses tend to be quite limited.

15 **RH-3 Districts: Three-Family.** These ~~d~~Districts have many similarities to RH-2
16 Districts, but structures with three units are common in addition to one-family and two-family
17 houses. The predominant form is large flats rather than apartments, with lots 25 feet wide, a
18 fine or moderate scale, and separate entrances for each unit. Building styles tend to be varied
19 but complementary to one another. Outdoor space is available at ground level, and also on
20 decks and balconies for individual units. Nonresidential uses are more common in these areas
21 than in RH-2 Districts.

SEC. ~~209.2, 206.2.~~ RM (RESIDENTIAL, MIXED) DISTRICTS.

These ~~d~~Districts are intended to recognize, protect, conserve, and enhance areas characterized by a mixture of houses and apartment buildings, covering a range of densities and building forms according to the individual district designations. Despite the range of densities and building sizes, most structures are of a scale that respects the traditional lot patterns, open spaces, and articulation of façades typical of San Francisco neighborhoods. These ~~d~~Districts provide unit sizes and types suitable for a variety of households, and contain supporting nonresidential uses. The RM Districts are composed of four separate classes of districts, as follows:

RM-1 Districts: Low Density. These ~~d~~Districts contain a mixture of the dwelling types found in RH Districts, but in addition have a significant number of apartment buildings that broaden the range of unit sizes and the variety of structures. A pattern of 25-foot to 35-foot building widths is retained, however, and structures rarely exceed 40 feet in height. The overall density of units remains low; buildings are moderately scaled and segmented, and units or groups of units have separate entrances. Outdoor space tends to be available at ground and upper levels regardless of the age and form of structures. Shopping facilities and

1 transit lines may be found within a short distance of these districts. Nonresidential uses are
2 often present to provide for the needs of residents.

3 **RM-2 Districts: Moderate Density.** These dDistricts are generally similar to RM-1
4 Districts, but the overall density of units is greater and the mixture of building types and unit
5 sizes is more pronounced. Building widths and scales remain moderate, and considerable
6 outdoor space is still available. The unit density permitted requires careful design of new
7 structures in order to provide adequate amenities for the residents. Where nonresidential uses
8 are present, they tend to offer services for wider areas than in RM-1 Districts.

9 **RM-3 Districts: Medium Density.** These dDistricts have some smaller structures, but
10 are predominantly devoted to apartment buildings of 6, 8, 10, or more units. Most of these
11 districts are close to downtown and have been developed in this manner for some time. The
12 units vary in size, but tend to be smaller than in RM-1 and RM-2 Districts. Many buildings
13 exceed 40 feet in height, and in some cases additional buildings over that height may be
14 accommodated without disruption of the district character. Although lots and buildings wider
15 than 25 or 35 feet are common, the scale often remains moderate through sensitive façade
16 design and segmentation. Open spaces are smaller, but decks and balconies are used to
17 advantage for many units. Supporting nonresidential uses are often found in these areas.

18 **RM-4 Districts: High Density.** These dDistricts are devoted almost exclusively to
19 apartment buildings of high density, usually with smaller units, close to downtown. Buildings
20 over 40 feet in height are very common, and other tall buildings may be accommodated in
21 some instances. Despite the intensity of development, distinct building styles and moderation
22 of façades are still to be sought in new development, as are open areas for the residents.
23 Group housing is especially common in these districts, as well as supporting nonresidential
24 uses.

These ~~d~~Districts are intended to recognize, protect, conserve, and enhance areas characterized by structures combining ~~r~~Residential uses with neighborhood-serving ~~e~~CCommercial uses. The predominant ~~r~~Residential uses are preserved, while provision is made for supporting ~~e~~CCommercial uses, usually in or below the ground story, that meet the frequent needs of nearby residents without generating excessive vehicular traffic. The compact, walkable, transit-oriented and mixed-use nature of these ~~d~~Districts is recognized by no off-street parking requirements. The RC Districts are composed of two separate districts, as follows:

1 **RC-3 Districts: Medium Density.** These *d*Districts provide for a mixture of medium-
 2 density *d*Dwellings similar to those in RM-3 Districts, with supporting *e*Commercial uses. Open
 3 spaces are required for *d*Dwellings in the same manner as in RM-3 Districts, except that rear
 4 yards need not be at ground level and front setback areas are not required.

5 **RC-4 Districts: High Density.** These *d*Districts provide for a mixture of high-density
 6 *d*Dwellings similar to those in RM-4 Districts with supporting *e*Commercial uses. Open spaces
 7 are required for *d*Dwellings in the same manner as in RM-4 Districts, except that rear yards
 8 need not be at ground level and front setback areas are not required.

1 **SEC. 210.2. ~~210.3~~ C-3 DISTRICTS: DOWNTOWN COMMERCIAL.**

2 Downtown San Francisco, a center for City, regional, national, and international
3 commerce, is composed of four separate districts, as follows:

4 **C-3-O District: Downtown Office.** This district, playing a leading national role in
5 finance, corporate headquarters, and service industries, and serving as an employment center
6 for the region, consists primarily of high-quality office development. The intensity of building
7 development is the greatest in the City, resulting in a notable skyline symbolizing the area's
8 strength and vitality. The district is served by City and regional transit reaching its central
9 portions and by automobile parking at peripheral locations. Intensity and compactness permit
10 face-to-face business contacts to be made conveniently by travel on foot. Office development
11 is supported by some related retail and service uses within the area, with inappropriate uses
12 excluded in order to conserve the supply of land in the core and its expansion areas for further
13 development of major office buildings.

14 **C-3-O(SD) District: Downtown Office Special Development.** This area south of
15 Market Street and east of Third Street comprises the southern side of the core central
16 business district, and is similar to and generally indistinguishable from the C-3-O District in
17 terms of uses and character. The area is centered on the Transbay Transit Center. This
18 district permits densities that exceed those in the C-3-O district and contains the tallest height
19 limits in the City, reflecting its unparalleled public transportation access and geographically
20 central position in the downtown.

21 **C-3-R District: Downtown Retail.** This ~~a~~District is a regional center for comparison
22 shopper retailing and direct consumer services. It covers a compact area with a distinctive
23 urban character, consists of uses with cumulative customer attraction and compatibility, and is
24 easily traversed by foot. Like the adjacent Downtown Office District, this district is well-served
25 by City and regional transit, with automobile parking best located at its periphery. Within the
~~a~~District, continuity of retail and consumer service uses is emphasized, with encouragement

of pedestrian interest and amenities and minimization of conflicts between shoppers and motor vehicles. A further merging of this *d*District with adjacent, related districts is anticipated, partially through development of buildings that combine retailing with other functions.

C-3-G District: Downtown General Commercial. This *d*District covers the western portions of downtown and is composed of a variety of uses: Retail, offices, hotels, entertainment, clubs and institutions, and high-density residential. Many of these uses have a Citywide or regional function, although the intensity of development is lower here than in the downtown core area. As in the case of other downtown districts, no off-street parking is required for individual commercial buildings. In the vicinity of Market Street, the configuration of this *d*District reflects easy accessibility by rapid transit.

C-3-S District: Downtown Support. This *d*District encompasses Yerba Buena Gardens, which includes San Francisco's Convention Center, hotels, museums and cultural facilities, housing, retail, and offices arranged around public gardens and plazas. The *d*District continues to accommodate important supporting functions such as wholesaling, printing, building services, and secondary office space. It also contains unique housing resources. The *d*District is within walking distance of rapid transit on Market Street, and is served by transit lines on Third, Fourth, Mission and Folsom streets.

10 and large-scale retail, which are not permitted in these districts. Other uses that share
11 operational characteristics with PDR uses are permitted in these districts, as they require
12 large flexible spaces and prefer separation from intensive housing districts. PDR-zoned land
13 is also an important reservoir of space in San Francisco for new and evolving industry and
14 activity types that cannot be foreseen today and cannot practically function or compete for
15 space in a typical downtown office or neighborhood commercial environment. Business and

maintenance, alterations, and repairs involving replacing features with similar features or

1 adding similar features; restoration of preexisting conditions; and signs, awnings, or canopies,
2 shall be subject to review of the urban design of the proposed use under the waterfront design
3 review process, as provided under Section 240(c) of this Code.

4 (e) In considering any application in this special use district under Section 303 *of this*
5 *Code*, the Planning Commission shall consider the following criteria in lieu of the criteria set
6 forth in Section 303(c):

7 (1) That such use or feature as proposed is consistent with the Waterfront Land
8 Use Plan (WLUP) adopted by the Port Commission, including any amendments thereto which
9 the Planning Commission has found to be consistent with the General Plan;

10 (2) That such use or feature as proposed is consistent with the WLUP
11 Waterfront Design and Access goals, policies, and criteria adopted by the Port Commission,
12 including any amendments thereto which the Planning Commission has found to be
13 consistent with the General Plan;

14 (3) Provision to the extent feasible, along the sea wall and along the perimeters
15 of piers or platforms, of public access and of open spaces available for public use and suitable
16 for viewing purposes or water-oriented recreation;

17 (4) Limitation of water coverage in the Northern Waterfront area from the Hyde
18 Street Pier to Pier 46 so as not to exceed the degree of coverage by piers as existing at the
19 effective date of this Section;

20 (5) Construction of new piers or platforms so that the water's edge shall be
21 maintained at the sea wall where feasible;

22 (6) Provision or maintenance of view corridors along streets into the Bay, and of
23 panoramic views, in accordance with the view policies of the Northeastern Waterfront Plan, a
24 part of the General Plan; and

25 (7) Development over the water generally on piers or platforms rather than on
fill.

1 (f) Off-street parking requirements may be modified by the Planning Department and
2 Planning Commission, as provided in Section 161(f) of this Code.

3 (g) The basic floor area ratio limit shall be 5.0 to 1 to the extent provided in Section
4 124(e) of this Code. To calculate the floor area ratio on piers under the jurisdiction of the Port
5 Commission, all building permit applications shall include a map of the lot or lease area with
6 precise boundaries showing its location on the pier under consideration. The proposed lot
7 shall be reviewed and approved as part of the building permit and be the basis for further
8 alterations or expansions of the structure.

9 **SEC. 241. DOLORES HEIGHTS SPECIAL USE DISTRICT.**

10 In order to preserve and provide for an established area with a unique character and
11 balance of built and natural environment, with public and private view corridors and
12 panoramas, to conserve existing buildings, plant materials and planted spaces, to prevent
13 unreasonable obstruction of view and light by buildings or plant materials, and to encourage
14 development in context and scale with established character and landscape, there shall be a
15 Dolores Heights Special Use District as designated on Section al Map No. 7 SU07 of the
16 Zoning Map *of the City and County of San Francisco*. In this ~~d~~District, all provisions of the ~~City~~
17 Planning Code applicable in RH-1 Districts shall continue to apply except that rear yard and
18 height limit provisions of this Section 241 shall be substituted for rear yard and height limit
19 provisions found elsewhere in this Code.

20 (a) The minimum rear yard depth shall be equal to 45 percent of the total depth of the
21 lot on which building is situated, but in no case shall the rear yard be less than 25 feet deep.

22 (b) No portion of a building shall exceed a height of 35 feet above the existing grade of
23 the lot, with the intent that the building shall be contained within an envelope that slopes
24 upward or downward with the slope of the property. The "height of a building" for purposes of
25 this Section, shall be measured in the manner described in Section 260 ~~102.12~~ of ~~the City~~

1 ~~Planning~~ this Code, whether the lot being measured slopes upward or downward from the
2 street.

3 (c) Variances may be granted from the rear yard and height limit provisions in
4 Paragraphs (a) and (b) above in accordance with procedures specified in Section 305 of this
5 ~~the City Planning~~ Code provided that no such variance shall permit a building to have a height
6 in excess of that otherwise permitted in an RH-1 District.

7 **SEC. 243. VAN NESS SPECIAL USE DISTRICT.**

8 (a) **General.** A Special Use District entitled the Van Ness Special Use District, the
9 boundaries of which are shown on Sectional Map No. SU02 of the Zoning Map of the City and
10 County of San Francisco, is hereby established for the purposes set forth below.

11 (b) **Purposes.** In order to implement the objectives and policies of the Van Ness
12 Avenue Area Plan, a part of the General Plan, which includes ~~(i)~~ (1) creation of a mix of
13 residential and commercial uses on the boulevard, ~~(ii)~~ (2) preservation and enhancement of
14 the pedestrian environment, ~~(iii)~~ (3) encouragement of the retention and appropriate
15 alteration of architecturally and historically significant and contributory buildings, ~~(iv)~~ (4)
16 conservation of the existing housing stock, ~~(v)~~ (5) enhancement of the visual and urban design
17 quality of the street, and ~~(vi)~~ (6) the establishment of an area appropriate for a medical center
18 use (the "Van Ness Medical Use Subdistrict") to support citywide and regional health care at
19 the transit nexus of Van Ness Avenue and Geary Boulevard, the following controls are
20 imposed in the Van Ness Special Use District.

21 (c) **Controls.** All provisions of the ~~City~~ Planning Code applicable to an RC-4 District
22 shall apply except as otherwise provided in this Section.

23 (1) **Basic Floor Area Ratio.** The basic floor area ratio limit shall be 7.0 to 1 in
24 the 130-foot height district and at the hospital site within the Van Ness Medical Use
25 Subdistrict, and 4.8:1 in the 80-foot height district. These limits shall apply to dwellings
notwithstanding Section 124(b) of this Code, including floor space used for nonaccessory off-

1 street parking, driveways, and maneuvering areas. The floor area ratio may be increased to
2 up to 7.5:1 for a medical office building if located within the Van Ness Medical Use Subdistrict.
3 For definitions of ~~f~~Floor ~~a~~Area ~~r~~Ratio and ~~g~~Gross ~~f~~Floor ~~a~~Area, see Sections ~~102.11 and 102.9,~~
4 ~~respectively~~. The provisions allowing a floor area premium set forth in Section 125(a) shall not
5 apply in the Van Ness Special Use District.

6 (2) **Housing Density.** The restrictions on density set forth in *the Zoning Control*
7 *Tables Sections 207, 207.1, 208, 209.1 and 209.2 of this Code* shall not apply.

8 (3) **Height and Bulk Restrictions.** See Height and Bulk Map No. HT02. See
9 Section 270 of this Code for bulk limits. However, medical centers within the Van Ness
10 Medical Use Subdistrict subject to otherwise applicable standards for bulk limits per Section
11 270 and 271(c)(2) shall be permitted to exceed such standards to allow for unique massing
12 and volume required for medical facilities, if authorized as a Conditional Use pursuant to
13 Section 303 of this Code, in lieu of findings otherwise required under Section 271 of this
14 Code.

15 (4) **Awnings, Canopies, and Marquees.** Medical centers within the Van Ness
16 Medical Use Subdistrict subject to otherwise applicable standards for awnings per Section
17 136.1 of this Code shall be permitted to exceed such standards to allow for coverage of
18 patient drop-off and entry areas.

19 (5) Medical Centers within the Van Ness Medical Use Subdistrict subject to
20 otherwise applicable standards for obstructions over streets or alleys per ~~s~~Section 136(c)(1)(B)
21 of this Code shall be permitted to exceed such standards for vertical dimensions and
22 horizontal projections for architectural features to provide visual interest, achieve appropriate
23 articulation of building fa~~e~~çades, and reduce pedestrian level wind currents.

24 (6) **Rear Yards.** The requirements of this Code applicable to rear yards may be
25 modified or waived by the Zoning Administrator pursuant to Section 307(g) if all of the
following conditions are met:

1 (A) The interior block open space formed by the rear yards of abutting
2 properties will not be adversely affected; and

3 (B) A comparable amount of usable open space is provided elsewhere
4 on the lot or within the development where it is more accessible to residents; and

5 (C) The access of light and air to abutting properties will not be
6 significantly impeded.

7 This provision shall be administered pursuant to the procedures that ~~which~~ are
8 applicable to variances, as set forth in Sections 306.1 through 306.5 and 308.2 of this Code.

9 (7) **Required Setbacks.** Setbacks for buildings exceeding a height of 50 feet
10 shall be regulated as provided in Section 253.2 of this Code.

11 (8) **Limitation of Nonresidential Uses.**

12 (A) **Residential Uses; Ratio Established.** In newly constructed
13 structures, nonresidential uses shall only be permitted if the ratio between the amount of net
14 additional occupied floor area for residential uses, as defined in this paragraph below, to the
15 amount of occupied floor area for nonresidential uses in excess of the occupied floor area of
16 structures existing on the site at the time the project is approved is 3 to 1 or greater. In
17 additions to existing structures that ~~which~~ exceed 20 percent of the gross floor area of the
18 existing structure, nonresidential uses shall be permitted in the addition in excess of 20
19 percent only if the ratio between the amount of occupied floor area for residential use, as
20 defined in this paragraph below, to the area of occupied floor area for nonresidential use is 3
21 to 1 or greater. This residential use ratio shall not apply to development sites in the Van Ness
22 Special Use District that ~~which~~ have less than 60 feet of street frontage on Van Ness Avenue
23 and have no street frontage other than the Van Ness Avenue frontage. For purposes of this
24 Section, "nonresidential uses" shall mean any use not defined as a Residential Use in Section 102
25 and principally or conditionally permitted in the Van Ness Special Use District. ~~except Dwelling Uses~~
~~or Group Housing).~~

1 (B) **Reduction of Ratio of Residential Uses for Affordable Housing.**

2 The Planning Commission may modify the Van Ness Special Use District residential to
3 nonresidential use ratio between Golden Gate Avenue and California Street as a conditional
4 use in one of the following ways:

5 (i) **In-Lieu Fee.** By conditional use, the developer may elect to
6 fulfill the obligation to build housing by paying an in-lieu fee to the Affordable Housing Fund as
7 provided in Section 413 of this Code. No more than a 50 percent reduction of the required
8 housing for a specific project can be fulfilled by paying an in-lieu fee. Use of these funds shall
9 provide affordable housing within 2,000 feet of the Van Ness Special Use District. The in-lieu
10 fee shall be determined by the following formula:

19 (ii) **Providing Affordable Housing.** By conditional use, the
20 developer may reduce up to 50 percent of the required amount of on-site housing by
21 maintaining a portion of that housing as permanently affordable for the life of the project.
22 Affordable units shall be managed by a nonprofit housing agency through a duly executed
23 agreement between the project sponsor, the nonprofit agency, and the Planning Department.
24 The mix of affordable units retained in the project shall conform to the overall dwelling unit
25 size mix of the project. The portion of retained residential ~~that which~~ shall be affordable will be
determined by calculating the number of market rate units ~~that which~~ could be subsidized by

1 the amount of "in-lieu fee" calculated in Paragraph (i) above. The number of square feet of
2 affordable housing shall be calculated in the following manner:

3 (1) In-Lieu Fee Square Feet of
4 Affordable Housing
5 \$30/square foot = Retained in the
6 subsidy Project

7
8 (iii) **Annual Reporting, Evaluation, and Adjustments to**
9 **Affordability and Fee Calculations.** The Department shall report annually to the Planning
10 Commission on the activity and utilization of Section 243(~~4C~~)(8)(B). Based on an evaluation of
11 this report, the Planning Commission may initiate a modification or deletion of Section
12 243(~~4C~~)(8)(B). The dollar amounts used in the calculation for Paragraphs (i) and (ii) of this
13 Subsection shall be subject to annual adjustments in accord with Section 413.6(1) of this
14 Code. Affordability shall be defined by rents or sale prices affordable by households with no
15 more than 80 percent of median income standards developed by HUD.

16 (iv) If the *Planning* Commission finds that taking into consideration
17 projects constructed since the effective date of the Van Ness Special Use District and the
18 housing development potential remaining in the District the overall objective of adding a
19 substantial increment of new housing on Van Ness Avenue will not be significantly
20 compromised, the Commission may by conditional use modify the 3:1 housing ratio or may
21 modify the rules regarding the timing and location of linked projects if in addition to Section
22 303(c) standards of this Code it finds that:

23 (1) The project is to provide space for expansion of an
24 established business from an adjacent site (for this purpose two sites separated by an alley
25 shall be deemed to be adjacent); or,

1 (2) The project is to provide space for an institutional, hotel,
2 medical, cultural, or social service use meeting an important public need which cannot
3 reasonably be met elsewhere in the area; and

4 (3) Housing cannot reasonably be included in the project
5 referred to in (1) and (2) above.

6 The Commission shall consider the feasibility of requiring the project to be constructed
7 in such a manner that it can support the addition of housing at some later time.

8 (C) **Off-Site Provision of Required Residential Space.** For the
9 purpose of calculating the 3 to 1 ratio between residential and nonresidential use, two or more
10 projects for new construction within the Van Ness Special Use District may be considered and
11 approved together as linked projects. The requirements of Paragraph (A) above may be
12 satisfied if the aggregate amount of occupied floor area for residential use in two or more
13 linked projects is at least three times greater than the aggregate amount of occupied floor
14 area for nonresidential use.

15 (i) Those building permit applicants who wish to link two or more
16 projects for the purpose of meeting the 3 to 1 residential to nonresidential ratio shall file with
17 the Planning Department a statement of intent identifying the applications covering the
18 projects that are to be considered and approved together;

19 (ii) When the Planning Department approves an application for a
20 project containing only nonresidential use and the project is linked to one or more other
21 projects pursuant to the statement of intent filed with the Department, it shall include as a
22 condition of approval a requirement prohibiting the project sponsor from commencing any
23 work on the site until the Zoning Administrator issues a written determination that such work
24 may proceed. The Zoning Administrator shall not issue such a determination until those
25 permits authorizing the projects containing residential use have been issued and foundations
have been completed at each such site;

1 (iii) If a permit for a project containing nonresidential use expires
2 because of delays in the completion of foundations for linked projects containing residential
3 uses, new permits may be approved for the nonresidential project within three years of such
4 expiration without regard to the 3 to 1 residential ratio requirement if a Temporary Certificate
5 of Occupancy or a Permit of Occupancy has been issued for each project containing
6 residential use;

7 (iv) No building or portion of a building approved as a linked
8 project that contains residential use required to meet the 3 to 1 residential to nonresidential
9 ratio requirement shall be used for any nonresidential purposes; provided, however, that this
10 restriction shall no longer apply if 50 percent or more of the non-residential occupied floor
11 area in the linked projects has been converted to residential use, or has been demolished, or
12 has been destroyed by fire or other act of God;

13 (v) The Zoning Administrator shall impose as a condition of
14 approval of a permit authorizing the residential uses of linked projects the requirement that the
15 owner record in the land records of the property a notice of restrictions, approved as to form
16 by the Zoning Administrator, placed on the use of the property by this Section.

17 (D) **Nonconforming Uses.** A use which existed lawfully at the effective
18 date of this Section and which fails to conform to the use limitation of Section 243(~~4c~~)(8)(A)
19 above, shall be considered a nonconforming use and subject to the provisions of Sections 180
20 through 188 of this Code, including the provisions of Section 182 regarding change of use,
21 except as follows:

22 (i) In calculating the cost of structural alterations pursuant to
23 Section 181(b)(4), the cost of reinforcing the building to meet the standards for seismic loads
24 and forces of the 1975 Building Code shall not be included; and
25

1 (ii) Notwithstanding the provisions of Section 181(b), the structure
2 occupied by the nonconforming use may be enlarged by an amount equal to 20 percent of the
3 gross floor area of the existing structure.

4 (E) **Demolitions.** All demolitions of buildings containing residential use
5 and all conversions from residential uses to nonresidential uses above the ground floor shall
6 be permitted only if authorized as a conditional use under Section 303 of this Code, unless the
7 Director of the Department of Building Inspection or the Chief of the Bureau of Fire Prevention
8 and Public Safety determines that the building is unsafe or dangerous and that demolition is
9 the only feasible means to secure the public safety. When considering whether to grant a
10 conditional use permit for the demolition or conversion, in lieu of the criteria set forth in
11 ~~Planning Code~~ Section 303 of this Code, consideration shall be given to the adverse impact on
12 the public health, safety and general welfare of the loss of housing stock in the ~~D~~District and to
13 any unreasonable hardship to the applicant if the permit is denied. The definition of residential
14 use shall be as set forth in Section 243(~~4c~~)(8)(A), but shall not include any guest room in a
15 building classified as a residential hotel subject to the Residential Hotel Unit Conversion and
16 Demolition Ordinance.

17 A ~~e~~Conditional ~~u~~Use ~~permit~~ authorization shall not be required if the demolition permit is
18 sought in order to comply with a court order directing or permitting the owner to demolish a
19 building because it is unsafe. No person shall be permitted to construct anything on the site of
20 a demolished building subject to such an order for a period of two years unless (a) the
21 proposal is for at least the same number and size of dwelling units and guest rooms and the
22 same amount of nonresidential floor area as that which was demolished or (b) the applicant
23 requests and is granted an exemption from this requirement on the ground that the applicant
24 has demonstrated that (1) the need for demolition did not arise because of the deliberate or
25 unreasonable neglect of the maintenance of the building, or that (2) the restrictions would

1 cause undue hardship to the property owner or that (3) the restrictions would leave the
2 property without any substantial remaining market value or reasonable use.

3 (9) **Residential Parking.** Projects with parking which exceeds the
4 amount permitted in Section [151.1](#) for an RC District shall be permitted if:

- 5 (A) the project was approved prior to the effective date of this Ordinance No. [232-14](#);
- 6 (B) the project builds no more parking than the amount approved; and
- 7 (C) the project proceeds to construction within three years of the effective date of this
8 Ordinance No. [232-14](#).

9 (10) **Medical Center Parking.** Notwithstanding any contrary provision of
10 this Code, the maximum parking provisions for the Van Ness Medical Use Subdistrict shall not
11 exceed the lesser of 990 spaces or 125% percent of the minimum number of spaces required
12 by Code in the aggregate for the Cathedral Hill Campus which, for purposes of this
13 ~~subsection~~, shall be the Van Ness Medical Use District and Assessor's Block 0690, Lot 016,
14 located at 1375 Sutter Street. Any parking sought up to this maximum but that exceeds the
15 parking provisions outlined elsewhere in this Code may only be granted by the Planning
16 Commission as a Conditional Use Aauthorization.

17 (11) **Medical Center Loading.** Loading standards for medical centers
18 within the Van Ness Medical Use Subdistrict applicable under Section 154(b) of this Code may
19 be reduced from the required minimum dimensions through a Conditional Use Aauthorization,
20 provided that the dimensions provided will be sufficient to meet the reasonably foreseeable
21 loading demands associated with the proposed facility

22 (12) **Adult Entertainment Businesses ~~Enterprises.~~** Adult Businesses per
23 Section 102 of this Code ~~The uses described in Section 221(k) of this Code~~ are not permitted.

24 (13) **Entertainment Uses.** Nighttime Entertainment and Arts Activities, as
25 defined in Section 102 ~~Other Entertainment Uses as defined in Section 790.38~~ of this Code shall
require notification as set forth in Section 312 of this Code.

1 (14) **Medical Center Street Frontages.** If authorized as a Conditional
2 Use under Section 303 of this Code, a medical center within the Van Ness Medical Use
3 Subdistrict may deviate from the street frontage requirements of Section 145.1 of this Code,
4 so long as the Planning Commission finds that the proposed street frontages otherwise
5 achieve the intended purposes of Section 145.1 to "preserve, enhance and promote
6 attractive, clearly defined street frontages that are pedestrian-oriented, fine-grained, and
7 which are appropriate and compatible with the buildings and uses" in the surrounding areas.

8 (15) **Reduction of Ground Level Wind Currents.**

9 (A) New buildings and additions to existing buildings shall be shaped, or
10 other wind baffling measures shall be adopted, so that the development will not cause year-
11 round ground level wind currents to exceed, more than 10 percent of the time, between 7:00
12 a.m. and 6:00 p.m., the comfort level of 11 m.p.h. equivalent wind speed in areas of
13 pedestrian use and seven m.p.h. equivalent wind speed in public seating areas. When pre-
14 existing ambient wind speeds exceed the comfort levels specified above, the building shall be
15 designed to reduce the ambient wind speeds in efforts to meet the goals of this requirement.

16 (B) An exception to this requirement may be permitted but only if and to
17 the extent that the project sponsor demonstrates that the building or addition cannot be
18 shaped or wind baffling measures cannot be adopted without unduly restricting the
19 development potential of the building site in question.

20 (i) The exception may permit the building or addition to increase
21 the time that the comfort level is exceeded, but only to the extent necessary to avoid undue
22 restriction of the development potential of the site.

23 (ii) Notwithstanding the above, no exception shall be allowed and
24 no building or addition shall be permitted that causes equivalent wind speeds to reach or
25 exceed the hazard level of 26 m.p.h. for a single hour of the year.

1 (C) For the purposes of this Section, the term "equivalent wind speed"
2 shall mean an hourly wind speed adjusted to incorporate the effects of gustiness or turbulence
3 on pedestrians.

4 (d) **Van Ness Medical Use Subdistrict – Conditional Use for Medical Center.**

5 Within the Van Ness Medical Use Subdistrict, the boundaries of which are shown on
6 Sectional Map No. SU02 of the Zoning Map, medical facilities affiliated with the same
7 institution, separated only by a street or alley, shall be considered a single medical center for
8 purposes of this section.

9 (~~H~~) The "Van Ness Medical Use Subdistrict" shall be defined as the area shown on
10 Sectional Map No. SU02, to provide medical services by a licensed medical provider. The
11 purpose of the Subdistrict is to allow for the development of a seismically compliant medical
12 facility with unique design requirements not otherwise permitted within the Van Ness Special
13 Use District. To the extent provided in Section 243, deviations from the controls of Section
14 243 shall be permitted in the Subdistrict relating to bulk, FAR, parking, loading, projections
15 and obstructions over streets and alleys, and street frontage due to the unique requirements
16 of new medical centers.

17 **SEC. 247. DOWNTOWN SUPPORT SPECIAL USE DISTRICT.**

18 (a) **Purpose.** In order to provide that a certain area within the C-3-S District be able to
19 be developed for ~~H~~H Hotel use with an increased basic floor area ratio of 7.5 to 1, there shall be
20 a "Downtown Support Special Use District" (also referred to as the "C-3-S (SU) District") as
21 designated on ~~Zoning~~ Sectional Map SU01 of the Zoning Map. Development at densities above
22 the basic floor area ratio of 7.5:1 in this special use district will not be permitted.

23 (b) **Requirements.** The basic and maximum floor area ratio of the C-3-S (SU) District,
24 after purchase of all market-rate, available TDR within the C-3-S District, shall be 7.5:1.
25 Where there are fewer square feet of TDR within the C-3-S District available than the
Planning Commission determines is required for a project, the Planning Commission may, as

1 part of a Section 309 review, authorize a project sponsor to make a monetary contribution
2 towards the preservation of a Landmark building within the C-3 area in an amount to be
3 determined by the Commission. For purposes of this Section 247, the C-3 area shall include
4 any C-3 District and any P District adjacent thereto. All other provisions of this Code
5 applicable to the C-3-S District shall apply in the C-3-S (SU) District.

6 **SEC. 248. TRANSIT CENTER C-3-O(SD) COMMERCIAL SPECIAL USE DISTRICT.**

7 A Special Use District entitled the "Transit Center C-3-O(SD) Commercial Special Use
8 District" is hereby established for a portion of the C-3-O(SD) district in the downtown area
9 around the Transbay Transit Center within the City and County of San Francisco, the
10 boundaries of which are designated on Sectional Map No. ~~1~~ SU01 of the Zoning Maps of the
11 City and County of San Francisco. The following provisions shall apply within the Special Use
12 District:

13 * * * *

14 (b) ~~Definitions of~~ **"Commercial Use."**

15 (~~H~~) "Commercial Use" shall mean any use other than a Residential Use, as defined
16 in Section 102 of this Code, ~~than dwellings and other housing uses~~ permitted in the underlying
17 zoning district, ~~and shall include any permitted or conditional use described in Sections 217 through~~
18 ~~226 and shall also include hotel uses permitted as conditional uses per Sections 216(b) and 303(g).~~

19 (c) **Controls.**

20 (~~H~~) All new development on lots larger than 15,000 square feet in the Special
21 Use District shall include not less than 2 gross square feet of principally or conditionally
22 permitted commercial uses for every 1 gross square foot of dwellings or other housing uses.

23 (d) **Exceptions.** Exceptions to the controls in ~~s~~Subsection (c) may be granted by the
24 Planning Commission according to the procedures in Section 309 only if the Commission
25 makes one of the following affirmative findings:

1 (1) That the development consists of multiple buildings on a single lot or
2 adjacent lots that are entitled as a single development project pursuant to Section 309, and
3 that commercial uses account for greater than 50% percent of the project's aggregate total
4 gross floor area for all buildings and where the project sponsor demonstrates that it is
5 infeasible or impractical to construct commercial uses on the footprint of the portion of the site
6 dedicated to dwellings and/or other housing uses due to the size and configuration of that
7 portion of the lot; or

8 (2) That the footprint of the portion of the site dedicated to dwellings and/or
9 other housing uses is less than 15,000 square feet and the lot contains existing buildings
10 which are to be retained.

11 **SEC. 249.1. FOLSOM AND MAIN RESIDENTIAL/COMMERCIAL SPECIAL USE**
12 **DISTRICT.**

13 (a) **Purpose.** In order to convert an under-utilized and outmoded industrial area to a
14 unique residential neighborhood close to downtown which will contribute significantly to the
15 City's housing supply, create tapered residential buildings, provide an appropriate mixture of
16 retail sales and personal services to support new residential development, provide a buffer of
17 office and parking use between the bridge and freeway ramps and the housing sites, and
18 allow the existing industrial, service and office uses to remain, there shall be the Folsom and
19 Main Residential/Commercial Special Use District as designated on Sectional Map No. 4SU01
20 of the Zoning Map of the City and County of San Francisco.

21 (b) **Controls.** The following zoning controls are applicable in the
22 Residential/Commercial Special Use District.

23 (1) **Reduction of Ground-Level Wind Currents.**

24 (A) **Requirement.** New buildings and additions to existing buildings shall
25 be shaped, or other wind-baffling measures shall be adopted, so that the developments will
not cause ground-level wind currents to exceed, more than 10 percent of the time year-round,

1 between 7:00 a.m. and 6:00 p.m., the comfort level of 11 m.p.h. equivalent wind speed in
2 areas of substantial pedestrian use and seven m.p.h. equivalent wind speed in public seating
3 areas. The term "equivalent wind speed" shall mean an hourly mean wind speed adjusted to
4 incorporate the effects of gustiness or turbulence on pedestrians.

5 When preexisting ambient wind speeds exceed the comfort level, or when a proposed
6 building or addition may cause ambient wind speeds to exceed the comfort level, the building
7 shall be designed to reduce the ambient wind speeds to meet the requirements. The
8 provisions of this Section 249.1(b)(3) shall not apply to any buildings or additions to existing
9 buildings for which a draft EIR has been published prior to January 1, 1985.

10 (B) **Exception.** The Zoning Administrator may allow the building or
11 addition to add to the amount of time the comfort level is exceeded by the least practical
12 amount if (1) it can be shown that a building or addition cannot be shaped and other wind-
13 baffling measures cannot be adopted to meet the foregoing requirements without creating an
14 unattractive and ungainly building form and without unduly restricting the development
15 potential of the building site in question, and (2) it is concluded that, because of the limited
16 amount by which the comfort level is exceeded, the limited location in which the comfort level
17 is exceeded, or the limited time during which the comfort level is exceeded, the addition is
18 insubstantial.

19 The Zoning Administrator shall not grant an exception and no building or addition shall
20 be permitted that causes equivalent wind speeds to reach or exceed the hazard level of 26
21 miles per hour for a single hour of the year.

22 (C) **Procedures.** Procedures and methodologies for implementing this
23 Section shall be specified by the Office of Environmental Review of the Planning Department.

24 (2) **Uses.**

25 (A) Permitted uses are ~~(i) those listed in Sections 209.1 and 209.2 of this Code and~~ (ii) those permitted in an RC-4 District, plus the uses listed in ~~§~~ subsection (e)(1)(B)

1 below; provided that, for newly constructed buildings or additions of 20 ~~twenty~~ percent (20%) or
2 more of an existing building's gross floor area, at least six net square feet of residential use is
3 provided for each one net square foot of non-residential use on any lot. Additions of less than
4 20 ~~twenty~~ percent (20%) of a building's gross floor area are exempt from the six to one
5 residential requirements. Once granted, this exemption from the residential development
6 requirement for building additions may not be repeated for any single property. Any addition of
7 more than 20 ~~twenty~~ percent (20%) of gross square feet of building area shall be required to
8 provide the housing on a ~~6-to-1~~ six-to-one basis for all of the additional building area. All areas
9 used for parking for either residential or non-residential uses shall be excluded in the
10 calculation of the residential/non-residential ratio. For the purposes of application of this 6 to 1
11 ratio, ~~Hotels, inns or hostels~~ as defined under Section 102 ~~209.2(d) and (e)~~ shall be considered
12 a non-residential rather than a residential use.

13 (B) The use provisions applicable to an RC-4 District shall be applicable
14 to the "Residential/Commercial" Subdistrict with the following modifications or additions:

15 (i) all uses defined as Institutional uses listed under Section 102 ~~209.3~~
16 ("Institutions") shall be permitted as of right as principal uses;

17 ~~(ii) all uses listed under Section 209.4 ("Community Facilities") shall be~~
18 ~~permitted as of right as principal uses;~~

19 (ii) ~~(iii)~~ Utility Installation uses, utility uses listed defined in Section
20 102 ~~209.6~~, shall be permitted as conditional uses, with such utility uses to include
21 telecommunications and internet communication co-location, web-hosting and other similar
22 facilities, provided such uses are primarily conducted within enclosed buildings;

23 ~~(iii) (iv)~~ Automotive uses, as defined in Section 102 in lieu of Section
24 ~~209.7, automotive uses shall be those permitted in Section 223(a), Section 223(m) (except that such use~~
25 shall be permitted as a principal use for only five (5) years after the construction of the
building, after which a eConditional ~~#U~~ use authorization shall be required, and Private Auto

1 Parking Lots, as defined in Section 102 of this Code ~~Section 223(p) (except that such parking lot shall~~
2 be a conditional use limited to two years per each conditional use authorization);

3 ~~(iv) (v) Section 209.8 shall not be applicable;~~ Planned Unit
4 Developments, Arts Activities, and Mortuaries, as defined in Code Section 102, are not permitted.

5 ~~(v) (vi)~~ all Retail Sales and Service uses listed in Section 218, as defined
6 in Section 102 of this Code, shall be permitted as of right as principal uses;

7 ~~(vi) (vii)~~ Office Uses ~~all uses listed in Section 219(c)~~ shall be permitted
8 as of right above the ground floor or below the ground floor, and ~~all office uses listed in Section~~
9 ~~219(c) shall require conditional use authorization be permitted~~ on the ground floor ~~as conditional~~
10 ~~uses;~~

11 ~~(vii) (viii)~~ Trade Shops and Catering uses ~~all uses listed in Section 222~~
12 shall be permitted as of right above or below the ground floor level, and shall require be
13 eConditional ~~Uses~~ authorization at the ground floor;

14 ~~(viii) (ix)~~ Movie Theaters, Nighttime Entertainment and General
15 Entertainment ~~all uses listed in Section 221(a)-(f)~~ shall be permitted as of right as principal uses;

16 ~~(ix) (x)~~ Animal Hospital ~~all uses listed in Section 224(a)~~ shall be
17 permitted as conditional uses;

18 ~~(x) (xi)~~ Wholesale Establishment ~~all uses listed in Section 225(b)~~ shall
19 be permitted as of right as principal uses;

20 ~~(xi) (xii)~~ Light Manufacturing ~~all uses listed in Section 226(a)~~ shall be
21 permitted as of right as principal uses;

22 ~~(xii) (xiii)~~ commercial w Wireless f Facilities ~~as per Section 227(h) or (i)~~
23 shall be permitted as conditional uses;

24 ~~(xiii) (xiv)~~ Internet Service Exchanges ~~all uses listed in Section 227(r)~~
25 shall be permitted as of right as principal uses.

1 (C) A nonconforming use may be changed to any equally or more
2 conforming use without providing the 6 to 1 ratio of required residential space.

3 (D) No use, even though listed as a permitted use or otherwise allowed,
4 shall be permitted in the Residential/Commercial Subdistrict which, by reason of its nature or
5 manner of operation, creates conditions that are hazardous, noxious, or offensive through the
6 emission of odor, fumes, smoke, cinders, dust, gas, vibration, glare, refuse, water-carried
7 waste, or excessive noise.

8 (3) **Density.**

9 (A) **Residential Density.** There shall be no density limit for residential
10 uses in the Residential/Commercial Subdistrict. The provisions of Sections 207.1 and 208
11 related to residential density shall not apply.

12 (B) **Non-residential Density.** There shall be a density limit for non-
13 residential uses, which shall be measured as a Floor Area Ratio (FAR), as defined by Section
14 ~~102.9, 102.10, 102.11 and 124~~ 102 of this Code. The maximum nonresidential FAR for newly
15 constructed buildings or additions of 20 ~~twenty~~ percent (~~20%~~) or more of an existing building
16 shall be 0.75. Otherwise the FAR for the Residential/Commercial Subdistrict shall be five-to-
17 one ~~5-to-1~~. The provisions of Section 123, 124, 125 and 127 relating to Floor Area Ratio shall
18 apply.

19 (C) Area used for parking for ~~e~~Commercial ~~uses~~ or ~~r~~Residential uses
20 including parking permitted as of right or by conditional use shall not be considered as
21 commercial FAR.

22 (4) **Open Space.**

23 (A) Open space shall be provided at the ratio of thirty-six net square feet
24 of open space for each ~~d~~Dwelling ~~u~~Unit if all private, with a ratio of 1.33 of common usable
25 open space that may be substituted for private; open space shall be provided at the ratio of
one square foot of open space per 50 square feet of gross floor area for all other uses.

1 (B) The open space requirement for ~~residential~~ residential use may be met by
2 providing one or more of the following types of open space: private usable open space as set
3 forth below; common open space, including an unenclosed park or plaza at grade or above, or
4 an enclosed or partly enclosed pool or a health club, accessible to residents and guests of
5 residents and not to the general public, and "publicly accessible open space" as set forth in
6 C)(i) below. Where any publicly accessible open space is used to satisfy the open space
7 requirements for both ~~residential~~ residential and non-residential use, the open space area must be of
8 an area at least equal to the sum of the separate open space requirements to be satisfied by
9 that open space. Up to ~~forty~~ 40 percent (~~40%~~) of the open space requirement for residential
10 uses may be met by providing private open spaces, provided that any such private open
11 space counted toward a portion of the open space requirement has a minimum area of 36
12 square feet, with a minimum dimension of four feet in any direction.

13 (C) The open space requirement for non-residential uses shall be met by
14 providing "publicly accessible open space," which is defined as open space situated in such
15 locations and which provides such ingress and egress as will make the area accessible to the
16 general public and which is open to the public daily for at least twelve daylight hours.

17 (i) Publicly accessible open space. One or more of the following
18 types of open space shall satisfy the definition of publicly accessible open space:

19 (AA) An unenclosed park or garden at grade or above;

20 (BB) An unenclosed plaza with seating areas and
21 landscaping and no more than 10 ~~ten~~ percent (~~10%~~) of the floor area devoted to food or
22 beverage service;

23 (CC) An enclosed pedestrian pathway, which extends
24 through the building, which is accessed from a public street at grade, which is landscaped and
25 has access to natural light and ventilation, and in which retail space may face the pedestrian

1 path inside the building provided that no more than 20 ~~twenty~~ percent (~~20%~~) of the floor area
2 of the required open space may be devoted to seating areas within the pedestrian path;

3 (DD) A sun terrace or solarium with landscaping;

4 (EE) Sidewalk widening following a regular pattern of
5 setbacks;

6 (FF) A recreation facility on the roof of a parking garage;

7 (GG) An unenclosed pedestrian street that traverses a
8 large block in an east-west direction;

9 (HH) A publicly-accessible area with a scenic overlook;

10 (II) A publicly-accessible area within 900 feet of the site;

11 (JJ) Streetscapes on surrounding streets, as approved by
12 the Planning Department; or

13 (KK) Other similar open space features as more particularly
14 defined in the Recreation and Open Space Section of the Rincon Hill Plan, a part of the
15 General Plan. If a sidewalk widening is used to meet the open space requirement, the
16 Planning Commission shall require approval of the open space proposal by the Department of
17 Public Works prior to Planning Commission approval of the project.

18 (ii) The required publicly accessible open space shall, as
19 determined by the Zoning Administrator:

20 (AA) Be in such locations and provide such ingress and
21 egress as will make the area convenient, safe, secure and easily accessible to the general
22 public;

23 (BB) Be appropriately landscaped;

24 (CC) Be accessible to public water and toilet facilities;

25 (DD) Be protected from uncomfortable winds;

1 (EE) Incorporate ample seating and, if appropriate,
2 access to limited amounts of food and beverage service, which will enhance public use of the
3 area;

4 (FF) Be well signed and accessible to the public during
5 daylight hours;

6 (GG) Have adequate access to sunlight if sunlight access
7 is appropriate to the type of area;

8 (HH) Be well lighted if the area is of the type requiring
9 artificial illumination;

10 (II) Be designed to enhance user safety and security;

11 (JJ) Be of sufficient size to be attractive and practical for
12 its intended use; and

13 (KK) The owner of the property on which the open space is
14 located shall maintain it by keeping the area clean and free of litter and keeping in a healthy
15 state any plant material that is provided. The Zoning Administrator shall have authority to
16 require a property owner to hold harmless the City and County of San Francisco, its officers,
17 agents and employees, from any damage or injury caused by the design, construction or
18 maintenance of open space, and to require the owner or owners or subsequent owner or
19 owners of the property to be solely liable for any damage or loss occasioned by an act or
20 neglect in respect to the design, construction or maintenance of the open space.

21 (D) The provisions of Section 135 concerning usable open space shall
22 not apply.

23 (5) **Parking Requirements.** Parking requirements in the Special Use District
24 shall be those of a Downtown Residential (DTR) District, as defined in Section 151.1 of this
25 eCode.

(6) **Street-Facing Use Requirements.**

1 (A) Ground floor retail space (including personal service and
2 restaurants) and space devoted to building and pedestrian circulation is required along the
3 street frontage for a minimum of ~~50~~ ~~ifty~~ percent (~~50%~~) of the street frontage; exceptions to this
4 standard may be granted administratively by the Zoning Administrator if (s)he deems the
5 exception to provide a more attractive, usable and visually interesting pedestrian streetscape.

6 (B) Uses along a street frontage at grade level shall be visually
7 interesting and attractive to pedestrians. Curb cuts shall be minimized. No parking ingress or
8 egress shall be permitted that would disrupt or delay transit service.

9 (7) **Site Coverage.** There shall be no limit on site coverage. One hundred
10 percent (~~100%~~) site coverage shall be permitted.

11 (8) **Dwelling Unit Exposure.** In light of the high-density nature of the
12 Residential/Commercial Subdistrict, the dwelling unit exposure requirements of Section 140
13 shall not apply.

14 (9) **Height and Tower Separation Standards.**

15 (A) There shall be an 85-foot maximum height for the podium/base of a
16 building.

17 (B) There shall be an overall height limit of 400 feet in the
18 Residential/Commercial Subdistrict.

19 (C) There shall be a 50 foot minimum tower height differential between
20 towers on the same development site.

21 (D) In the Residential/Commercial Subdistrict, there shall be a minimum
22 82 1/2 foot separation between towers.

23 (E) All space above the 200-foot height level shall be devoted to
24 residential use.

25 (10) **Bulk Standards.** The Residential/Commercial Subdistrict shall be subject
to "W" Bulk District controls, as follows:

1 (A) Base (0 - 85 feet): Unlimited. The site coverage limitations of Section
2 249.1(b)(1) shall not apply.

3 (B) (i) Buildings over 85 in height, but less than 300 feet in height,
4 shall be limited to a maximum plan length of 100 feet and a maximum diagonal length of 125
5 feet.

6 (ii) Buildings over 300 feet in height shall not exceed a maximum
7 plan length of 115 feet and a maximum diagonal length of 145 feet.

8 (iii) Minor increases in Plan length for the purposes of improved
9 design may be approved pursuant to Section 271.

10 (C) A 10% percent volume reduction is required for the upper tower of any
11 building that is 300 feet in height or taller. The upper tower is defined as the top one-third
12 portion of a free standing tower; for a tower that sits atop a podium or base, the upper tower is
13 defined as the top one-third of the height of the tower as measured from the top of the podium
14 or base.

15 (D) **Folsom Street Setback:** Above the 85 foot base, at least 50%
16 percent of the entire Folsom Street frontage shall be set back a minimum of 12½ feet. No
17 setback will be required for any portion of the frontage occupied by a tower with a height in
18 excess of 85 feet, unless that tower or towers occupies more than 50% percent of the total
19 Folsom Street frontage.

20 (E) The floor plates on either tower shall not exceed an average of
21 11,000 gross square feet over the entire tower.

22 **SEC. 249.5. NORTH OF MARKET RESIDENTIAL SPECIAL USE DISTRICT.**

23 (a) **General.** A special use district entitled the "North of Market Residential Special
24 Use District," which includes RC-4 and P Use Districts, the boundaries of which are shown on
25 Sectional Map No. ~~ISUB~~ SU01 of the Zoning Map of the City and County of San Francisco, is
hereby established for the purposes set forth below.

2 (c) **Controls.** The following zoning controls are applicable in the North of Market
3 Residential Special Use District. Certain controls are set forth in other Sections of this Code
4 and are referenced herein.

5 (1) **Conditional Use Criteria.** In making determinations on applications for
6 ~~e~~Conditional ~~#~~Use authorizations required for uses located within the North of Market
7 Residential Special Use District, the Planning Commission shall consider the purposes as set
8 forth in Subsection (b) above, in addition to the criteria of Section 303(c) of this Code.

9 (2) Notwithstanding *the Zoning Control Table for RC Districts found in Section 209.3*
10 ~~provisions of Section 209.8~~ of this Code, commercial establishments shall be limited to the
11 ground floor and the first basement floor, except that such establishments may be permitted
12 on the second story as a conditional use if authorized pursuant to Section 303 and Section
13 249.5(c)(1) of this Code.

14 (3) The following uses are not permitted:

15 (A) A ~~H~~Hotel, ~~inn, hostel~~ or ~~M~~Motel; and

17 Residential Care Facilities, Health Services, and Social Service or Philanthropic Facility uses ~~the~~

20 is used primarily for instruction and training in body building, exercising, reducing, sports,

25 Subarea No. 2, as shown on Section Map ~~ISUB~~ No. SU01 of the Zoning Map, the density ratio
shall be one dwelling unit for each 200 feet of lot area. The double density provisions for

1 Senior Housing, as defined in Section 102, of Section 209.1(m) shall not result in greater density
2 than that permitted in an RC-4 District.

3 ~~(5) There are no minimum parking requirements in this Special Use District, as~~
4 ~~provided in Section 161(h) of this Code.~~

5 ~~(6)~~ A bulk district "T" shall apply pursuant to the provisions of Section 270,
6 Table 270 of this Code.

7 ~~(6) (7)~~ Special exceptions to the 80-foot base height limit in height and bulk
8 districts 80-120-T and 80-130-T may be granted pursuant to the provisions of Section 263.7 of
9 this Code.

10 ~~(7) (8)~~ Building setbacks are required in this district pursuant to Section 132.2;
11 provisions for exceptions are also set forth in Section 132.2 of this Code.

12 ~~(8) (9)~~ Exceptions to the rear yard requirements for an RC-4 District may be
13 granted pursuant to Section 134(g) of this Code.

14 ~~(10) Awnings, Canopies and Marquees, as defined in Sections 102 790.20, 790.26~~
15 ~~and 790.58 of this Code, and further regulated by the Building Code and Sections 249.5(e)(12), 136.2~~
16 ~~and 607.4 of this Code are permitted.~~

17 ~~(11) Signs located in the RC-4 portion of this district shall be regulated as provided in~~
18 ~~Section 607.4 of this Code.~~

19 ~~(9) (12)~~ All provisions of the ~~City~~ Planning Code applicable in an RC-4 Use
20 District shall apply within that portion of the district zoned RC-4, except as specifically
21 provided above. All provisions of the ~~City~~ Planning Code applicable in a P Use District shall
22 apply within that portion of the district zoned P, except as specifically provided above.

23 ~~(10) (13)~~ All demolitions of buildings containing residential units shall be
24 permitted only if authorized as a conditional use under Section 303 of this Code, unless the
25 Director of the Department of Building Inspection or the Chief of the Bureau of Fire Prevention
and Public Safety determines that the building is unsafe or dangerous and that demolition is

1 the only feasible means to secure the public safety. When considering whether to grant a
2 conditional use permit for the demolition, in lieu of the criteria set forth in ~~City~~ Planning Code
3 Section 303(c), consideration shall be given to the purposes of the North of Market
4 Residential Special Use District set forth in Section 249.5(b), above, to the adverse impact on

13 (2) An Off-Sale Liquor Establishment lawfully existing in the North of Market
14 Residential Special Use District and selling alcoholic beverages as licensed by the State of
15 California prior to the effective date of this legislation may continue operation only under the
16 following conditions, as provided by California Business and Professions Code Section 23790:

17 (A) The premises shall retain the same type of retail liquor license within
18 a license classification; and

19 (B) The licensed premises shall be operated continuously without
20 substantial change in mode or character of operation.

21 (3) The prohibition on Off-Sale Liquor Establishments shall not be interpreted
22 to prohibit the following, provided that the type of California liquor license does not change,
23 the location of the establishment does not change, and the square footage used for the
24 display and sale of alcoholic beverages does not increase:

25 (A) A change in ownership of an Off-Sale Liquor Establishment or an
owner-to-owner transfer of a California liquor license; or

1 (B) Re-establishment, restoration or repair of an existing Off-Sale Liquor
2 Establishment on the same lot after total or partial destruction or damage due to fire, riot,
3 insurrection, toxic accident or act of God; or

4 (C) Temporary closure of an existing Off-Sale Liquor Establishment for
5 not more than ninety (90) days for repair, renovation or remodeling.

6 (4) The prohibition on Off-Sale Liquor Establishments shall not be interpreted
7 to prohibit the following:

8 (A) Temporary uses, as described in Planning Code Section 205.1; or

9 (B) Establishment of an Off-Sale Liquor Establishment if application for
10 such Off-Sale Liquor Establishment is on file with the California Department of Alcoholic
11 Beverage Control prior to the effective date of this legislation; or

12 (C) Re-location of an existing Off-Sale Liquor Establishment in the North
13 of Market Residential Special Use District to another location within the North of Market
14 Residential Special Use District with conditional use authorization from the ~~City~~ Planning
15 Commission, provided that (i) the type of California liquor license does not, change, (ii) the
16 square footage used for the display and sale of alcoholic beverages does not increase, and
17 (iii) the original premises shall not be occupied by an Off-Sale Liquor Establishment unless by
18 another Off-Sale Liquor Establishment that is also relocating from within the North of Market
19 Residential Special Use District. Any such conditional use authorization shall include a
20 requirement that the establishment comes with the "Good Neighbor Policies" set forth in
21 Subsection (d)(6) below; or

22 (D) A change in liquor license from a Type 21 (Off-Sale General) to a
23 Type 20 (Off-Sale Beer and Wine), provided that the square footage used for the display and
24 sale of alcoholic beverages does not increase.

25 (5) The prohibition on Off-Sale Liquor Establishments shall be interpreted to
prohibit the transfer of any California Alcoholic Beverage Control Board off-sale liquor license

1 from a location outside of the North of Market Residential Special Use District to a location
2 within the North of Market Residential Special Use District or the issuance of any original
3 California Alcoholic Beverage Control Board off-sale liquor license for a location within the
4 North of Market Residential Special Use District.

5 (6) The following "Good Neighbor Policies" shall apply to all Liquor
6 Establishments in the North of Market Residential Special Use District in order to maintain the
7 safety and cleanliness of the premises and vicinity:

8 (A) Employees of the establishment shall walk a 100-foot radius from
9 the premises some time between 30 minutes after closing time and 8:00 a.m. the following
10 morning, and shall pick up and dispose of any discarded beverage containers and other trash
11 left by patrons;

12 (B) The establishment shall provide outside lighting in a manner
13 sufficient to illuminate street and sidewalk areas and adjacent parking, as appropriate to
14 maintain security, without disturbing area residences;

15 (C) No alcoholic beverages shall be consumed on any outdoor property
16 adjacent to the establishment and which is under the control of the establishment, excepting
17 those areas of the property that are enclosed and not visible from the sidewalk. are intended
18 for patron services, are supervised by the establishment, and are not located adjacent to any
19 sidewalk areas;

20 (D) No more than 33 percent of the square footage of the windows and
21 clear doors of the establishment shall bear advertising or signage of any sort, and all
22 advertising and signage shall be placed and maintained in a manner that ensures that law
23 enforcement personnel have a clear and unobstructed view of the interior of the premises,
24 including the area in which the cash registers are maintained, from the exterior public
25 sidewalk or entrance to the premises. This requirement shall not apply to premises where

1 there are no windows, or where existing windows are located at a height that precludes a view
2 of the interior of the premises to a person standing outside the premises;

3 (E) No person under the age of 21 shall sell or package alcoholic
4 beverages;

5 (F) Employees of the establishment shall regularly police the area under
6 the control of the establishment in an effort to prevent the loitering of persons about the
7 premises; and

8 (G) The establishment shall promptly remove any graffiti from the
9 exterior of the premises.

10 (7) For purposes of this Section, the following definitions shall apply:

11 (A) "Liquor Establishment" shall mean any enterprise selling alcoholic
12 beverages pursuant to a California Alcoholic Beverage Control Board license.

13 (B) "Off-Sale Liquor Establishment" shall mean *a Liquor Store, as defined*
14 *in Section 102 any establishment that is defined in Section 790.55* of this Code.

15 (C) "Alcoholic Beverages" shall mean "alcoholic beverages," as defined
16 by California Business and Professions Code Sections 23004 and 23025;

17 (D) "Sell" or "Sale" shall mean and include any retail transaction
18 whereby, for any consideration, an alcoholic beverage is transferred from one person to
19 another.

20 * * * *

21 **SEC. 249.13. GEARY BOULEVARD/DIVISADERO STREET SPECIAL USE DISTRICT.**

22 (a) **General.** A Special Use District entitled the Divisadero Street/Geary Boulevard
23 Special Use District, consisting of Lots 5, 5A, 6, 7, 8, 9, 9A, 10, 11 and 12 of Assessor's Block
24 1079 is hereby established for the purposes set forth below.

25 (b) **Purposes.** The following controls, imposed in the Geary Boulevard/Divisadero
Street Special Use District, will advance the policies of the Commerce and Industry Element

1 of the City's General Master Plan in that they will encourage the expansion of needed health
2 services, yet manage such expansion ensuring the preservation and integrity of residential
3 neighborhoods in the City, and will promote the provision of adequate health services to all
4 geographical districts and cultural groups within the City.

5 (c) **Controls.** The specific controls set forth herein shall apply only to the development
6 of out-patient facilities affiliated with and operated by a health maintenance organization solely
7 for the benefit of its members. Any development which does not meet the purposes set forth
8 herein shall be governed by the underlying zoning controls.

9 (1) **Design Review By Planning Commission.** An applicant submitting an
10 application for a proposed development and use pursuant to this Section shall be required to
11 submit an application for design review by the Planning Commission. The design review
12 application may be submitted concurrently with or before a building permit application.

13 (2) **Fees.** In addition to the building permit review fee set forth in Section 352,
14 the project sponsor shall pay a fee of fifteen thousand dollars (\$15,000.00) per application to
15 compensate the ~~Department of City~~ Planning Department for compliance with this Section.

16 (3) **Principal Permitted Uses.** Ground floor uses shall be limited to those set
17 forth for NC-3 Districts. Upper floor uses shall be limited to out-patient facilities, including
18 physicians' offices needed to providing preventive health-care, and accessory administrative
19 uses affiliated with and operated by a health maintenance organization, provided however that
20 the accessory administrative use shall not occupy more than 15% percent of the floor area
21 subject to the floor area ratio. For the purposes of interpreting "out-patient facilities" under this
22 section, such facilities shall not be deemed an office use subject to the provisions of Sections
23 309 through 325 et seq.

24 (4) **Basic Floor Area Ratio.** The basic floor area ratio shall be six (6) to one
25 (1). The ~~definitions for provisions of Sections 102.9 and 102.10 defining g~~Gross f~~l~~Floor A~~e~~area and
Occupied Floor Area in Section 102 of this Code shall be used for calculating the floor area ratio.

1 In addition to the floor area excluded from the floor area ratio calculation set forth *in the*
2 *definitions for Gross Floor Area (Subsections Sections 102.9 (b)(1) through 102.9(14) inclusive),*
3 and *Occupied Floor Area Section 102.10*, dwelling units and other residential uses as defined in
4 this *Section 249.13 ordinance* shall be exempted from the floor area calculation.

5 (5) **Dwelling Unit Density and Residential Use.** The dwelling unit density shall
6 be governed by the underlying zoning classification as set forth in *the Zoning Control Table for*
7 *the district in which the lot is located Sections 207, 207.1, 209.1 and 209.2 of this Code.* For the
8 purposes of this section, residential use shall include rooms or beds used by out-patients
9 receiving medical treatment at the health maintenance organization, including but not limited
10 to patients receiving treatment at the AIDS infusion center, or receiving chemo-therapy
11 treatment, regardless of the length of stay of such out-patients.

12 (6) **Height And Bulk Restrictions.** The applicable Height and Bulk for this
13 Special Use District shall be 105-X.

14 (7) **Rear Yards.** The requirements of this Code applicable to rear yards and
15 applicable to dwelling units or other residential use may be modified by the Planning
16 Commission as part of the design review, if all of the following conditions are met:

17 (A) The interior block open space formed by the rear yards of the
18 abutting properties will not be adversely affected;

19 (B) A comparable amount of usable open space is provided elsewhere
20 on the lot or within the development where it is more accessible to the residents; and

21 (C) The access to light and air for abutting properties will not be
22 significantly impeded.

23 (8) **Required Setbacks.** The Planning Commission may impose a side setback
24 of up to 15 feet above the building height of 65 feet if it determines that this requirement is
25 necessary to achieve a superior architectural design.

1 (9) **Demolitions.** Demolition of any building containing residential uses and
2 any conversion from residential to non-residential uses above the ground floor shall be
3 permitted provided that the notice and relocation assistance provisions of Chapter 37 of the
4 San Francisco Administrative Code (The San Francisco Residential Rent Arbitration and
5 Stabilization Ordinance) are met.

6 If the Commission determines, during its design review, that the public benefits to be
7 gained do not outweigh the adverse impacts from the demolition of the residential units, the
8 Commission may impose conditions to reduce such adverse impact. The conditions may
9 require that the applicant pay to the City Controller the sum of one hundred thousand dollars
10 (\$100,000.00) to mitigate the loss of housing units. Said amount paid to the City shall
11 thereafter be used exclusively for the development of housing affordable to individuals or
12 households with income not to exceed 80% percent of the median income of the San
13 Francisco Standard Metropolitan Areas as defined by HUD.

14 (10) **Parking.** One (1) off-street parking space for every 500 square feet of
15 occupied floor area of out-patient facility space and accessory use space shall be provided.
16 The provisions of Section 151 of this Code shall govern off-street parking requirements for all
17 other allowable uses in this Special Use District. The Planning Commission may reduce the
18 off-street parking requirement if it finds that all or part of the off-street parking requirement is
19 provided by existing off-street parking serving the health maintenance organization, and that
20 such off-street parking is located within one block of the Special Use District.

21 (11) **Appeal.** The decision of the Planning Commission may be appealed to the
22 Board of *Permit* Appeals within fifteen (15) days after action by the Planning Commission on
23 the design review application. The procedure for appeal shall be as described in Section
24 308.2. The decision of the Planning Commission, or that of the Board of *Permit* Appeals on
25 appeal shall constitute a final determination on all land use and Planning Code issues, except
for review by a court of competent jurisdiction. Review by the Board of *Permit* Appeals on the

1 issuance of a building or site permit for a proposed structure for this Special Use District shall
2 be limited to issues arising out of the San Francisco Building Code, Health Code and Fire
3 Code.

4 **SEC. 249.14. THIRD STREET SPECIAL USE DISTRICT.**

5 (a) **Purpose.** There shall be a special use district known as the Third Street Special
6 Use District, as designated on Sectional Map No. ~~10~~SU10 of the Zoning Map of the City and
7 County of San Francisco, encompassing the commercially and industrially zoned property
8 fronting Third Street from Cesar Chavez ~~Army~~ Street to Meade Avenue. The purpose of this
9 special use district is to enhance the social and economic vitality of Third Street as the
10 primary neighborhood commercial district for the Bayview Hunters Points area and encourage
11 a healthier mix of essential neighborhood-serving retail uses and by allowing for drive-up
12 facilities as a conditional use.

13 (b) **Controls.**

14 (1) A Restaurant or a Limited Restaurant, as defined in Section 102 of this Code, ~~large~~
15 ~~fast food restaurant or a small self-service restaurant~~ may have a drive-up facility only with
16 conditional use authorization by the ~~City~~ Planning Commission. In addition to the conditional
17 use criteria set forth in Section 303, the Commission shall find that:

18 (A) The restaurant does not form a part of any continuous retail frontage
19 (defined for purposes of this ~~s~~Subsection as two or more buildings which contain commercial
20 uses and which have a continuous ~~façade~~ facade line at street level unbroken by any driveway, alley
21 or walkway having a width greater than five feet;

22 (B) The restaurant is located on a lot that:

- 23 (i) Adjoins three city streets,
24 (ii) Is not within 500 foot walking distance of an elementary or
25 secondary school; and

1 (C) The restaurant has sufficient off-street queuing space for at least
2 eight cars and has off-street parking as required in Article 1.5 of this Code; and

3 (D) The proposed building massing and site planning is designed to
4 complement the urban character of the street and respect pedestrian access along Third
5 Street; and

6 (E) To the extent feasible, the project provides for additional residential
7 development and/or other land use activities on the site.

8 **SEC. 249.18. NORTHEAST CHINA BASIN SPECIAL USE DISTRICT.**

9 A Special Use District entitled the "Northeast China Basin Special Use District," the
10 boundaries of which are shown on the Zoning Map, is hereby established for the purposes set
11 forth below. The following provisions shall apply within the Northeast China Basin Special Use
12 District:

15 (1) **General.** The provisions of the M-2 use district established by Section 201
16 of this Code shall prevail except as provided in paragraphs (2) through (4) below.

20 related to ballpark and assembly and entertainment uses, including sports clubs, restaurants,
21 and retail shops, shall all be permitted as conditional uses.

22 (3) **Parking.** In recognition of the public transit anticipated to be available to
23 serve a ballpark in the proposed location, in recognition of the large supply of parking in the
24 vicinity, much of which can be made available for ballpark use in the evening and on
25 weekends, and in recognition of the availability of approximately 5,000 off-site parking spaces
near the ballpark during the first five years of the ballpark's operation, there shall be no

1 minimum requirement for off-street parking spaces for the uses permitted in the Northeast
2 China Basin Special Use District. This provision supersedes the parking requirements set
3 forth in Section 151 of this Code applicable to the permitted uses set forth herein.

4 (4) **Architectural Design.** In recognition of the prominence of the location and
5 vital importance of the uses described in ~~s~~subsection (b)(2) above, such uses shall be subject
6 to conditional use review and approval by the ~~City~~ Planning Commission. A conditional use

9 location and civic purpose. This criterion shall be in lieu of the criteria set forth in Section
10 303(c)(1) through (4) of this Code.

12 ~~In order to provide for housing for seniors, there shall be a Scott Street Senior Housing Special~~

14 ~~designated on Sectional Map 2SU of the Zoning Map. The following provisions shall apply within such~~
15 ~~special use district:~~

16 ~~(a) Any developer of housing who (i) agrees to construct at least 50 percent of the total~~

14 Center Special Use District" (also referred to as the "California-Presidio Special Use District")
15 the boundaries of which are shown on Sectional Map No. 3SU03 of the Zoning Map of the City
16 and County of San Francisco, is hereby established for the purposes set forth below.

17 (a) **Purposes.** ~~The purpose of this Special Use District is To~~ provide for the development
18 of a Community Facility, Child Care Facility, School, Post-Secondary Educational Institution,
19 Religious Institution, Social Service or Philanthropic Facility or a Residential Care Facility ~~or Other~~
20 ~~Institution, Large~~, on a site that is currently split-zoned, which will serve both the immediate
21 neighborhood and the larger San Francisco community, with related educational, cultural,
22 social and recreational uses, including, but not limited to, retail sales, eating and drinking
23 facilities and parking.

24 (b) **Controls.** All provisions of the Planning Code currently applicable to the RM-1
25 District and Sacramento Street Neighborhood Commercial District ("Sacramento NCD")

1 portions of the California-Presidio Special Use District shall continue to apply to those portions
2 of the site, except as otherwise provided in this Section 249.21.

3 (1) **Permitted Uses.** The following uses (including, without limitation, all uses
4 which are principal permitted uses in RM-1 and Sacramento NCD Districts) shall be permitted
5 as principal uses in this Special Use District:

6 Community Facility, Child Care Facility, School, Post-Secondary Educational Institution,
7 Religious Institution, Social Service or Philanthropic Facility or a Residential Care Facility ~~or Other~~

18 uses shall not be limited by story and may serve both the immediate neighborhood and the
19 larger San Francisco community. The permitted hours of operation of commercial
20 establishments shall be from 5 a.m. to 12 a.m.; any extended hours will require conditional
21 use authorization pursuant to ~~s~~Subsection (b)(2) hereunder.

22 (2) **Conditional Uses.** The Planning Commission may authorize the following
23 uses within the California-Presidio Special Use District as a conditional use in accordance
24 with the requirements of Section 303 of this Code:

25 (A) ~~(i)~~ Any principally permitted use under Subsection (b)(1) above where
the total floor area exceeds 130,000 gross square feet of floor area, excluding all parking and

1 loading areas, including driveways and maneuvering areas incidental thereto, located entirely
2 below curb level at the center line of the building along its California Street frontage.

3 (B) ~~(ii)~~ Any use not authorized as a principal permitted use in Subsection
4 (b)(1) which is allowed as a conditional use in either the RM-1 or Sacramento NCD Districts.

5 **(3) Conditional Use and Architectural Design Review by Planning**
6 **Commission.** Any application for any new structure, or significant enlargement of any existing
7 structure to house a use permitted within the California-Presidio Special Use District shall be
8 subject to conditional use review and approval by the Planning Commission in accordance
9 with the requirements in this ~~s~~ subsection (b)(3). The Planning Commission shall approve such
10 application if it finds that the proposed project:

11 (A) ~~(i)~~ Meets the height, bulk, floor area limitation, parking standards and
12 other standards or requirements of the California-Presidio Special Use District set forth below,

13 (B) ~~(ii)~~ Is consistent with the Priority Policies set forth in Planning Code
14 Section 101.1, and

15 (C) ~~(iii)~~ With respect to the architectural design that:

16 (i) ~~(a)~~ The mass and ~~faeçade~~ façade of the proposed structure are
17 compatible with the existing scale of the underlying RM-1 and Sacramento NCD Districts,

18 (ii) ~~(b)~~ The ~~faeade~~ façade of the proposed structure is compatible
19 with design features of other non-residential ~~faeçades~~ façades and contributes to the positive visual
20 quality of the underlying RM-1 and Sacramento NCD Districts,

21 (iii) ~~(c)~~ The treatment of screening, service areas, lighting and
22 general signage program is compatible with non-residential buildings in the area or with the
23 design and purposes of the proposed project, and

24 (iv) ~~(d)~~ The building is designed in discrete elements which
25 respect the scale of development in the neighborhood.

1 The criteria in this Subsection (b)(3) shall be in lieu of the criteria set forth in Sections
2 303(c), Section 121.1 (Development of Large Lots, Neighborhood Commercial Districts) and
3 Section 121.2 (Use Size Limits (Non-Residential), Neighborhood Commercial Districts) and
4 Section 253 (Review of Proposed Buildings and Structures Exceeding a Height of 40 Feet in
5 R Districts) of this Code. In making determinations on applications for conditional use
6 authorization within the California-Presidio Special Use District, the Planning Commission
7 shall consider the purposes set forth in Subsection (a) above, in addition to any other criteria
8 to be applied hereunder.

9 (4) **Floor Area Ratio.** The floor area ratio limit shall be 2.5 to 1, provided,
10 however, that the limit shall not apply to floor area used for off-street parking and loading and
11 for driveways and maneuvering areas incidental thereto, where such parking and loading is
12 located entirely below curb level as measured from the property line at the center point of the
13 building along its California Street frontage.

14 (5) **Height and Bulk Restrictions.** The applicable Height and Bulk for this

18 (7) **Parking.** The off-street parking requirement may be modified by the

21 parking requirements the Planning Commission shall consider the criteria set forth below in
22 lieu of the criteria set forth in Section 303, or elsewhere in the Code, and shall grant the

25 reasonable anticipated auto usage by visitors of the project, including, without limitation,
taking into consideration appropriate link factors due to multiple uses of programs and

1 facilities, the normal hours of operation of such uses, programs and facilities and other factors
2 applicable to the proposed uses; or

3 (B) ~~(ii)~~ Modification of the parking requirement will not be detrimental to
4 the health, safety, convenience or general welfare of persons residing or working in the
5 vicinity of the project. In making such finding, the Planning Commission may, among other
6 things, take into consideration ~~(A)~~ (i) the proposed project's net effect on parking demand as
7 compared to the parking demand that is not currently being met because of the absence of
8 off-street parking associated with existing uses, and ~~(B)~~ (ii) whether the parking proposed for
9 the project will decrease the deficiency that currently exists with respect to the parking that
10 would normally be required under the Planning Code for the existing structures and uses.

11 Notwithstanding any other provisions of the Planning Code, parking may be made
12 available to nearby residents, businesses and the general public for use as short-term or
13 evening parking when not utilized by the uses authorized hereunder to which such parking is
14 otherwise accessory.

15 (8) **Demolitions.** The demolition of all buildings in this California-Presidio
16 Special Use District containing residential uses shall be authorized pursuant to the procedures
17 for granting authorization set forth in Section 303 of this Code, provided that the notice and
18 relocation assistance provisions of Chapter 37 of the San Francisco Administrative Code (the
19 San Francisco Residential Rent Stabilization and Arbitration Ordinance) are met. In
20 considering whether to grant a conditional use permit for demolition, in lieu of the criteria set
21 forth in Section 303, consideration shall be given to:

14 which fronts and opens on the street is permitted, provided that for a business or authorized
15 use located at the street intersection that fronts on two streets two wall signs shall be
16 permitted. The area of a wall sign shall not exceed 50 square feet and the height of the wall
17 sign shall not exceed 20 feet. The wall sign may be non-illuminated, indirectly illuminated or
18 directly illuminated.

19 (iii) ~~C.~~ **Projecting Signs.** One projecting sign per business or
20 authorized use that fronts and opens on the street is permitted, provided that for a business or
21 use located at the street intersection that fronts on two streets two signs shall be permitted. In
22 no case shall more than five such projecting signs be permitted within this California-Presidio
23 Special Use District. The area of the projecting signs shall not exceed 32 square feet and the
24 height shall not exceed 30 feet. Projecting signs may be non-illuminated, indirectly illuminated,
25 or directly illuminated.

1 (iv) ~~D.~~ **Signs on Awnings.** One awning or marquee per business
2 or authorized use which fronts and opens on the street shall be permitted, provided that for a
3 business or use located at a street intersection which fronts on two streets two awnings or
4 marquees may be permitted. The area of the sign copy on such marquee shall not exceed 40
5 square feet and may be non-illuminated or indirectly illuminated.

6 Only one wall sign, awning sign, or projecting sign as described in this Subsection is

8 business or use at the intersection fronting on two streets, any two of such signs is permitted.

9 (B) ~~(ii)~~ **Projecting Signs (Banner Type).** Up to four banner-type
10 projecting signs adjacent to the main entrance are permitted. The area of these projecting
11 signs shall not exceed 32 square feet and the height shall not exceed 50 feet. Such signs
12 shall be non-illuminated or indirectly illuminated non-fluttering fixed banner types (principally
13 used to celebrate holidays or announce events).

14 (C) ~~(iii)~~ **Identifying Sign.** One project name identifying sign above the
15 main entrance to the building shall be permitted and the area of the identifying sign shall not
16 exceed 200 square feet and 40 feet in height. The identifying sign may be non-illuminated or
17 indirectly illuminated.

18 (D) ~~(iv)~~ **Directly Illuminated Wall Sign.** A directly illuminated digitally
19 programmable sign or signs attached to the building facade at or around the corner of the
20 building at California Street and Presidio Avenue to display announcements about community
21 center events, programs and related matters consistent with the purposes and uses of the
22 project is permitted.

23 **SEC. 249.25. JACKSON SQUARE SPECIAL USE DISTRICT.**

24 In order to provide for the protection and enhancement of specialty retail and antique store
25 uses in the Jackson Square area, there shall be established the Jackson Square Special Use
District as designated on Sectional Map No. SU01 of the Zoning Map. The boundaries of this

5 (a) **Purposes.** These controls are intended to protect and enhance the unique retail

7 Department for the establishment of ground floor use shall be guided by the following factors:

8 (1) Continuation and enhancement of existing ground floor retail uses are of
9 critical importance to the character of the District and displacement of such uses should be

11 (2) Attraction and retention of similar new retail establishments that conform
12 with the character of this District should be encouraged; and

13 (3) Uses that greatly intensify the density of employment have a negative
14 impact on the provision of neighborhood services, traffic circulation, and limited on- and off-
15 street parking.

17 (1) **General.** The provisions of the C-2 use district as established in Section
18 210.2 and applicable provisions of the Washington-Broadway Special Use District (Section

11 Section 102 of this Code, ~~221(k)~~ are prohibited.

12 **SEC. 249.31. JAPANTOWN SPECIAL USE DISTRICT.**

13 A Special Use District entitled "Japantown Special Use District," the boundaries of
14 which are shown on Sectional Map No. 2SU02 of the Zoning Map of the City and County of
15 San Francisco is hereby established for the purposes set forth below.

6 (A) (i) The use is not incompatible with the cultural and historic integrity,
7 neighborhood character, development pattern, and design aesthetic of the Special Use
8 District; and

9 (B) (ii) The use supports one or more of the purposes for establishing

15 designates. Said locations shall be easily visible to members of the public and shall be
16 posted, at a minimum, on Geary Boulevard, Post Street, and Webster Street, Fillmore Street,
17 or Laguna Street.

18 **SEC. 249.32. LAGUNA, HAIGHT, BUCHANAN AND HERMANN STREETS SPECIAL USE**
19 **DISTRICT.**

20 (a) **Purpose.** In order to facilitate the development of a mixed-use project including
21 affordable and market-rate rental and ownership dwelling units, affordable senior dwelling
22 units welcoming to the lesbian, gay, bisexual and transgender (LGBT) senior community,
23 community facilities, open space and retail services generally consistent with the policies of
24 the Market and Octavia Area Plan, approved by the Board of Supervisors on October 24,
25 2007 (the "Area Plan"), there shall be the Laguna, Haight, Buchanan and. Hermann Streets
Special Use District, applicable to the two RM-3 and NC-3 zoned blocks bounded by Laguna,

1 Haight, Buchanan and Hermann Streets, consisting of Assessor's Blocks 857 and portions of
2 Assessor's Block 870. The following provisions shall apply within the Special Use District:

3 (b) **Applicability.** The provisions of this Special Use District shall only apply to
4 projects which require conditional use authorization under Section 303 of this Code. In
5 considering the appropriateness of conditional use authorization within the Special Use
6 District, the Commission shall, in addition to the factors required by Section 303, consider the
7 following factors:

8 (1) **Parking.** Consistent with the Area Plan, there shall be no minimum number
9 of off-street parking spaces required for any use within the Special Use District. There shall be
10 no more than 0.75 off-street parking space per unit, including dwelling units, senior dwelling
11 units, which parking spaces may be located anywhere in the Special Use District. In addition,
12 up to 51 replacement parking spaces may be provided in the Special Use District for the
13 existing dental clinic located on Assessor's Block 870, Lot 3, provided that 15 of such spaces
14 should be subject to a parking rate structure to encourage short-term use, and that the Project
15 Sponsor AF Evans, or its successor, should use good faith efforts to agree with the owner of
16 the dental clinic that any after tax revenue from such parking spaces should be used to
17 support the indoor community facility; and provided that the owner of the dental clinic, within
18 five years from the effective date of this ordinance, submits a plan consistent with *Planning*
19 ~~Code~~ Section 304.5 *of this Code*, for reuse of the dental clinic. The minimum number of parking
20 spaces required for any commercial or community facility use set forth in Section 151 of this
21 Code shall instead be the maximum number of spaces that can be provided for such
22 commercial and community facility uses.

23 (2) **Off-Street Parking Standards.** The off-street parking standards for both
24 residential and non-residential parking spaces set forth in the Area Plan shall be generally
25 applied, including that: ~~(i) (A) that~~ no more than 20 feet per block frontage of any building may
be devoted to off-street parking ingress and egress, and such ingress and egress is not

1 located on a Transit Preferential Street, Citywide Pedestrian Network or designated
2 Neighborhood Commercial Street where an alternative frontage exists; ~~(B) (ii) that~~ off-street
3 parking at or above the ground floor be set back at least 25 feet from any street exceeding a
4 width of 30 feet and that active uses be provided along such street frontages within the
5 required setback; ~~(C) (iii) that~~ vehicle movement on or around the project does not unduly
6 impact pedestrian spaces or movement, transit service, bicycle movement, or the overall
7 traffic movement in the district; ~~(D) (iv) that~~ accommodating off-street parking does not
8 degrade the overall urban design quality of the project; ~~(E) (v) that~~ parking does not diminish
9 the quality and viability of existing or planned streetscape enhancements; ~~(F) (vi) that~~ for
10 residential projects of 50 units or more, all residential accessory parking in excess of 0.5
11 spaces per unit is stored and accessed by mechanical stackers or lifts, valet, or other space-
12 efficient means that reduces space used for parking and maneuvering, maximizes other uses,
13 and discourages the use of vehicles for commuting for daily errands; ~~(G) (vii) that~~ projects that
14 provide 10 or more spaces for non-residential uses dedicate 5% percent of those spaces,
15 rounded down, to short-term, transient use by vehicles from certified car sharing organizations
16 per Section 166, vanpool, rideshare, taxis, or other co-operative auto programs; ~~(H) (viii) that~~
17 retail uses larger than 20,000 square feet which sell merchandise that is bulky or difficult to
18 carry by hand or by public transit offer door-to-door delivery services and/or shuttle service; ~~(I)~~
19 ~~(ix) that~~ car-share parking spaces be offered in at least the minimum amounts set forth in
20 Planning Code 166; ~~(J) (x) that~~ accessory non-residential parking spaces be available to the
21 general public from the hours of 7:00 p.m. to 7:00 a.m. Monday through Friday, and at all
22 times on Saturday and Sunday; and ~~(K) (xi) that~~ parking spaces be leased or sold separately
23 from the rental or purchase price of units.

24 (3) **Loading.** The minimum number of loading spaces required for any use as
25 set forth in Section 152 of this Code shall instead be the maximum number of spaces that can
be provided.

1 (4) **Residential Density.** The base residential density limits of the underlying
2 zoning as set forth in the Zoning Control Table for the district in which the lot is located Sections 209
3 and 712 shall apply. For a project that exceeds those base density limits through a Section 304
4 planned unit development authorization, the policy of the Area Plan that 40% percent of on-site
5 family units be two or more bedroom units shall apply.

6 (5) **Impact Fees or In-Kind Provision of Community Infrastructure.** The
7 Planning Commission shall consider imposition of a community infrastructure impact fees or
8 accept in lieu the in kind provision of community infrastructure improvements generally
9 consistent with the priorities set forth in the Area Plan, including publicly accessible open
10 space in excess of the residential open space requirements of this Code and an indoor
11 community facility, of a value comparable to the Area Plan policies. In the event the Planning
12 Commission does not accept in lieu the in kind provision of publicly accessible open space in
13 excess of the residential open space requirements of this Code or an indoor community
14 facility, such in kind open space and community facilities shall not otherwise be required to be
15 provided by a project in the Special Use District. Should impact fees, rather than in kind
16 provision of infrastructure improvements, be provided in whole or part, such fees shall be
17 deposited in the Market & Octavia Community Improvements Fund as proposed to be
18 established by the Area Plan. Fees deposited in the Market & Octavia Community
19 Improvements Fund, as proposed to be established by the Area Plan, may be used to support
20 the indoor community facility.

21 (c) **Affordable Housing.** Should the percentage of family and senior dwelling units in
22 a project in the Special Use District proposed to be affordable to households of low- or
23 moderate-income meet or exceed 35 thirty-five percent ~~(35%)~~ of the total number of ~~d~~Udwelling
24 ~~#~~Units in the project, the proposed amendments to Section 315.4(a)(1)(A), which can be
25 found in Board of Supervisors File Nos. 071156 and 080255, imposing an additional
affordable housing fee in the Market and Octavia Plan Area, shall not apply.

1 (d) **Waller Street.** The project sponsor shall gain approval for the use of Waller Street
2 from the Board of Supervisors prior to issuance of a building or site permit.

3 (e) **Expiration.** If a site or building permit has not been issued and construction
4 commenced on the mixed-use project described above, the provisions of this Special Use
5 District shall expire five years from the effective date of this legislation.

6 **SEC. 249.33. VAN NESS & MARKET DOWNTOWN RESIDENTIAL SPECIAL USE**
7 **DISTRICT.**

8 (a) **Purpose.** There shall be a Van Ness & Market Downtown Residential Special Use
9 District, which is comprised of the parcels zoned C-3-G in the Market Octavia Better
10 Neighborhoods Plan area, and whose boundaries are designated on Sectional Map No. 2SU02
11 and 7SU07 of the Zoning Map of the City and County of San Francisco. This dDistrict is
12 generally comprised of parcels focused at the intersections of Van Ness Avenue at Market
13 Street and South Van Ness Avenue at Mission Street, along with parcels on both sides of
14 Market and Mission Streets between 10th and 12th Streets. This dDistrict is intended to be a
15 transit-oriented, high-density, mixed-use neighborhood with a significant residential presence.
16 This area is encouraged to transition from largely a back-office and warehouse support
17 function to downtown into a more cohesive downtown residential district, and serves as a
18 transition zone to the lower scale residential and neighborhood commercial areas to the west
19 of the C-3. A notable amount of large citywide commercial and office activity will remain in the
20 area, including government offices supporting the Civic Center and City Hall. This area was
21 initially identified in the Downtown Plan of the General Plan as an area to encourage housing
22 adjacent to the downtown. As part of the city's Better Neighborhoods Program, this concept
23 was fully articulated in the Market and Octavia Area Plan, and is described therein.

24 (b) **Use Controls.**

25 (1) **Non-residential Uses.** For newly-constructed buildings or additions which
exceed 20 percent or more of an existing structure's gross floor area, non-residential uses are

1 not permitted above the ~~4th~~ fourth story, and at least two occupied square feet of residential
2 use shall be provided for each occupied square foot of non-residential use. In order to
3 accommodate local government office uses near City Hall, publicly-owned or leased buildings
4 or lots are exempted from the requirements of this ~~s~~ubsubsection.

5 (2) **Residential Density.** There shall be no density limit for residential uses by
6 lot area, but by the applicable requirements and limitations elsewhere in this Code, including
7 but not limited to height, bulk, setbacks, open space, and exposure, as well as by the Market
8 & Octavia Area Plan Fundamental Principals for Design, other applicable design guidelines,
9 applicable elements and area plans of the General Plan, and design review by the Planning
10 Department. The limitations set forth in the Zoning Control Table for the district in which the lot is
11 located ~~of Section 215~~ shall not apply.

12 (3) **Residential Affordable Housing Program.** All projects in this ~~d~~District
13 shall be subject to all the terms of Section 415 and following of the Inclusionary Affordable
14 Housing Program. Notwithstanding the foregoing, projects within the Van Ness and Market
15 Downtown Residential Special Use District shall at a minimum fulfill the requirements to the
16 levels specified in this section. Should Section 415 require greater contributions to the
17 affordable housing program, those requirements shall supercede this section. Proposed
18 exceptions to these requirements due to hardships associated with construction type,
19 specifically heights above 120 feet, are not applicable in this Special Use District because
20 parcels are receiving an up zoning through increased density and benefits through the general
21 transformation of the district to a transit oriented neighborhood with a mixed use character.
22 Requirements and administration of this program shall follow the conditions outlined in
23 Section 415 of ~~the Planning~~ this Code unless otherwise specified in this ~~s~~ubsubsection.

24 (A) **Payment of Affordable Housing Fee.** Except as provided in
25 Section 415.5(g) of this Code, all development projects subject to Section 415 et seq. in the

1 Van Ness Market Special Use District shall be required to pay an Affordable Housing Fee
2 under Section 415.5 equivalent to 20 percent of the number of units in the principal project.

3 (B) **Alternatives to Payment of Affordable Housing Fee.** If a project
4 sponsor both qualifies for and chooses to meet the requirements through an Alternative to the
5 Program, the project sponsor may choose one of the Alternatives in Section 415.5(g).

6 (i) **On Site Housing Requirements and Benefits.** For projects
7 that qualify for and choose to fulfill the requirements of Section 415 through the provision of
8 onsite housing, the Planning Department shall require that 12% percent of all units constructed
9 on the project site shall be affordable to qualifying households so that a project applicant must
10 construct .12 times the total number of units produced in the principal project. If the total
11 number of units is not a whole number, the project applicant shall round up to the nearest
12 whole number for any portion of .5 or above.

13 (ii) **Compliance Through Off-Site Housing Development.** For
14 projects that qualify for and choose to fulfill the requirements of Section 415 through the
15 provision of off-site housing, the Planning Department shall require that 20% percent of all
16 units constructed on the project site shall be affordable to qualifying households so that a
17 project applicant must construct .20 times the total number of units produced in the principal
18 project. If the total number of units is not a whole number, the project applicant shall round up
19 to the nearest whole number for any portion of .5 or above.

20 (4) **Open Space Provider.** The off-site open space permitted by this Section
21 may be provided individually by the project sponsor or jointly by the project sponsor and other
22 project sponsors, provided that each square foot of jointly developed open space may count
23 toward only one sponsor's requirement. With the approval of the Planning Commission, a
24 public or private agency may develop and maintain the open space, provided that (A) (i) the
25 project sponsor or sponsors pay for the cost of development of the number of square feet the
project sponsor is required to provide, (B) (ii) provision satisfactory to the Commission is

1 made for the continued maintenance of the open space for the actual lifetime of the building
2 giving rise to the open space requirement, and (C) ~~(iii)~~ the Commission finds that there is
3 reasonable assurance that the open space to be developed by such agency will be developed
4 and open for use by the time the building, the open space requirement of which is being met
5 by the payment, is ready for occupancy.

6 (A) **Off-Site Provision of Required Open Space.** Up to 40 percent of
7 usable open space required by Sections 135 and 138 may be provided off-site if it is within the
8 SUD or within 900 feet of the project site and meets the standards described below for
9 publicly accessible open space described below.

10 (B) **Publicly-Accessible Open Space Standards.**

11 (C) Open space must be of one or more of the following types:

12 (i) An unenclosed park or garden at street grade or following the
13 natural topography, including improvements to hillsides or other unimproved public areas
14 according to the Market & Octavia Area Plan;

15 (ii) An unenclosed plaza at street grade, with seating areas and
16 landscaping and no more than 10 percent of the floor area devoted to food or beverage
17 service;

18 (iii) An unenclosed pedestrian pathway that meets the minimum
19 standards described in Section 827(g)(3)(A) - (E) *of this Code*;

20 (iv) A terrace or roof garden with landscaping;

21 (v) Streetscape improvements with landscaping and pedestrian
22 amenities that result in additional space beyond the pre-existing sidewalk width and conform
23 to the Market & Octavia Area Plan, such as sidewalk widening or building setbacks; and

24 (vi) Streetscape improvements with landscaping and pedestrian
25 amenities on alleyways from building face to building face, beyond basic street tree planting or

1 street lighting as otherwise required by this Code, in accordance with the Market & Octavia
2 Area Plan.

3 (D) Open space must meet the following standards:

4 (i) Be in such locations and provide such ingress and egress as
5 will make the area convenient, safe, secure and easily accessible to the general public;

6 (ii) Be appropriately landscaped;

7 (iii) Be protected from uncomfortable winds;

8 (iv) Incorporate ample seating and, if appropriate, access to
9 limited amounts of food and beverage service, which will enhance public use of the area;

10 (v) Be well signed and accessible to the public during daylight
11 hours;

12 (vi) Be well lighted if the area is of the type requiring artificial
13 illumination;

14 (vii) Be designed to enhance user safety and security;

15 (viii) Be of sufficient size to be attractive and practical for its
16 intended use; and

17 (ix) Have access to drinking water and toilets if feasible.

18 (E) **Maintenance.** Open spaces shall be maintained at no public
19 expense, except as might be provided for by any community facilities district that may be
20 formed. The owner of the property on which the open space is located shall maintain it by
21 keeping the area clean and free of litter and keeping in a healthy state any plant material that
22 is provided. Conditions intended to assure continued maintenance of the open space for the
23 actual lifetime of the building giving rise to the open space requirement may be imposed in
24 accordance with the provisions of Section 309.1 *of this Code*.

25 (F) **Informational Plaque.** Prior to issuance of a permit of occupancy, a
plaque of no less than 24 inches by 36 inches in size shall be placed in a publicly conspicuous

1 location outside the building at street level, or at the site of any publicly-accessible open
2 space, identifying said open space feature and its location, stating the right of the public to
3 use the space and the hours of use, describing its principal required features (e.g., number of
4 seats, availability of food service) and stating the name and address of the owner or owner's
5 agent responsible for maintenance.

6 (G) The Zoning Administrator shall have authority to require a property
7 owner to hold harmless the City and County of San Francisco, its officers, agents and
8 employees, from any damage or injury caused by the design, construction or maintenance of
9 open space, and to require the owner or owners or subsequent owner or owners of the
10 property to be solely liable for any damage or loss occasioned by any act or neglect in respect
11 to the design, construction or maintenance of the open space.

12 (5) **Lot Coverage.** The rear yard requirements of Section 134 *of this Code* shall
13 not apply. Lot coverage is limited to 80 percent at all residential levels except on levels in
14 which all residential units face onto a public right-of-way. The unbuilt portion of the lot shall be
15 open to the sky except for those obstructions permitted in yards per Section 136(c) *of this*
16 *Code*. Exceptions to the 20 percent open area may be granted pursuant to the procedures of
17 Section 309 for conversions of existing non-residential structures where it is determined that
18 provision of 20 percent open area would require partial demolition of the existing non-
19 residential structure.

20 (6) **Floor Area Ratio.**

21 (A) The maximum FAR allowed, except as allowed in this Section, shall

1 (B) **Floor Area Bonus Permitted for Public Improvements or In-lieu**
2 **Contributions to the Van Ness and Market Neighborhood Infrastructure Fund and In**
3 **lieu Contributions to the Citywide Affordable Housing Fund.**

4 (i) The gross floor area of a structure or structures on a lot may
5 exceed the maximum ratio described in Section 123(c) *of this Code* through participation in the

3 (c) The terms of this Special Use District shall apply only to the existing building on
4 the subject lot and all successor lots or units that may be created through a subdivision. Any
5 demolition, new construction, or building additions within this Special Use District shall be
6 subject to all applicable terms of the Planning Code in effect at the time of the demolition, new
7 construction, or building addition.

8 **SEC. 249.42. INDIA BASIN INDUSTRIAL PARK SPECIAL USE DISTRICT.**

9 In order to provide continued enhancement and protection of certain retail, office, and
10 social service uses in the India Basin Industrial Park area, and to generally retain setback
11 requirements previously required under the India Basin Industrial Park Redevelopment Plan,
12 there shall be an India Basin Industrial Park Special Use District, the boundaries of which are
13 shown on Sectional Map *Nos. 8SU08 and 10SU10* of the Zoning Map *of the City and County of*
14 *San Francisco*. The following provisions shall apply within this Special Use District:

15 (a) **Parcels in close proximity to Third Street.** Parcels numbers 5203/035,
16 5203/043, 5203/083, 5203/084, 5211/028-054, 5235/012, 5235/015, 5242/001, 5242/002,
17 5242/007 and 5242/031, are subject to the provisions of the PDR-2 District except as provided
18 below:

4 square feet shall require Conditional Use authorization pursuant to Section 303 and must
5 comply with the criteria of Sections 121.2(a)(1) through (3) of this Code.

6 (3) ~~3.~~ **Institutional uses.** Social ~~s~~ervice and Philanthropic fFacilities as defined
7 in within the meaning of Section 102 217(d) shall not be subject to the use-size limit for the PDR-
8 2 District set forth in the PDR Zoning Control Table Section 217(d). Child-~~e~~Care facilities as defined
9 in Section 102 within the meaning of Section 217(e) shall be principally permitted. Health Service
10 uses, as defined in Section 102 of this Code. ~~C~~linics primarily providing outpatient care in medical,
11 psychiatric or other healing arts shall be principally permitted if the gross floor area of such
12 facility is less than 7,000 square feet. Such clinics may be affiliated with a medical institution,
13 which institution has met the applicable provisions of Section 304.5 of this Code concerning
14 institutional master plans. Health Service uses ~~C~~linics primarily providing outpatient care in
15 medical, psychiatric or other healing art with a gross floor area equal to or greater than 7,000
16 square feet, whether or not affiliated with a Hospital ~~medical institution~~, which institution has
17 met the applicable provisions of Section 304.5 of this Code concerning institutional master
18 plans, shall require ~~e~~Conditional ~~u~~se authorization pursuant to Section 303.

19 (4) ~~4.~~ **Off-Street Parking.** The minimum off-street parking requirements set
20 forth in Section 151 of this Code shall not apply. However, for the purpose of determining the
21 maximum amount of parking allowed as an accessory use under Section 204.5, the amount of
22 parking required ~~by this Code~~ shall be the amount set forth in Section 151.

23 (b) **Front setbacks.** All parcels within this Special Use District shall provide landscaped
24 front setbacks at depths and along frontages identified in this Subsection. The intent is to
25 maintain and reinforce existing landscaped front setbacks, including the landscaped berms,
India Basin Industrial Park signs, and tree hedges. Such setbacks shall be completely and

1 appropriately landscaped and shall remain unpaved and devoted to plant material, excepting
2 reasonable space necessary for ingress and egress to properties. Except as set forth in this

19 In order to facilitate the development of the Veterans Commons Project for homeless
20 veterans, that shall be a ~~special use district known as the~~ Veterans Commons Special Use
21 District, consisting of Assessor's Block No. 3513, Lot No. 07, at the street location address
22 150 Otis Street, and as designated on ~~Sheet~~ Sectional Map No. SU07 of the Zoning Map of the
23 City and County of San Francisco. The following provisions shall apply within the Veterans
24 Common Special Use District:

- 25 (a) **Construction of Affordable Housing Project.** The property in the Veterans
Commons Special Use District may be converted from public institutional special to a

1 residential housing project with attendant meeting rooms, community kitchens and ancillary
2 services, and property management offices.

3 (b) **Controls.** Notwithstanding any other provisions of this Code, the following
4 controls shall govern uses in this Special Use District:

5 (1) This Special Use District shall permit uses consistent with the RTO
6 (Residential Transit Oriented) subject to the exceptions listed below:

7 (A) **Rear Yard.** The rear yard requirements under Section 134 shall not
8 apply.

9 (B) **Usable Open Space.** The usable open space requirements under
10 Section 135(d) shall not apply.

11 (C) **Sunlight and Dwelling Unit Exposure.** The sunlight and dwelling
12 unit exposure requirements of Section 140 shall not apply to any west facing units.

13 (D) **Section 155.2 Bicycle Parking.** Bicycle parking requirements under
14 Section 155.2 shall not apply.

15 (E) **Section 207.6 Dwelling Unit Mix.** The two-bedroom unit
16 requirements under Section 207.6 shall not apply.

17 (2) **Density.** Notwithstanding the density requirements *in the Zoning Control Table*
18 *for the district in which the lot is located* ~~of Section 209~~, the Special Use District shall allow up to
19 76 dwelling units (or a ratio of no less than 89.41 sq. ft./dwelling) in a single building.

20 (3) **On-site Social Services.** The area dedicated to on-site social
21 services/special service provision shall be no greater than 6,300 sq. ft. and shall be located in
22 or below the ground story.

23 **SEC. 249.54. EXECUTIVE PARK SPECIAL USE DISTRICT.**

24 (a) **General.** A Special Use District entitled the Executive Park Special Use District is
25 hereby established for Assessor's Block 4991, Lots 024, 061, 065, 074, 075, 078, 085 and
086 and Assessor's Block 5076, Lots 012 and 013, generally bounded by Harney Way on the

1 south, Highway 101 on the west, Executive Park Boulevard North on the north and Executive
2 Park Boulevard East on the east, and is set forth in Sectional Map No. SU10 of the Zoning
3 Map of the City and County of San Francisco.

4 (b) **Purpose.** The purpose of the Executive Park Special Use District (SUD) is to
5 accommodate and encourage medium to high density, mixed-use, predominately residential
6 development at the location of an existing office park. The new mixed-use development is
7 envisioned to tie together the new development with existing and approved residential
8 development north and east of the SUD, along with long-established neighborhoods to the
9 west. The SUD provides controls tailored to Executive Park's unique circumstances: the
10 existing area does not feature a fine-grained street and block pattern typical of San Francisco
11 residential development adequate to serve the access, circulation and open space needs of
12 the envisioned urban residential and mixed use neighborhood. Also, some portions of the
13 area may become part of dedicated public right-of-way as a result of the anticipated future
14 widening of Harney Way and redesign of on-ramps and off-ramps to Highway 101 at Alana
15 Way and Harney Way. The SUD anticipates a new mixed-use, predominately residential
16 neighborhood, with a fine-grained block and street pattern and new open space, and provides
17 for the transfer of buildable density from portions of the area that may become part of
18 dedicated public right-of-way to other parts of the area, among other provisions.

19 (c) **Controls.** The Planning Code provisions for the underlying use district shall
20 control except as provided below.

21 (1) **Executive Park Design Guidelines.** In addition to the Planning Code
22 provisions, developments in the SUD shall comply with the Executive Park Subarea Plan of
23 the Bayview Hunters Point Area Plan of the General Plan, approved by the Board of
24 Supervisors by Ordinance No. 143-11, on file with the Clerk of the Board of Supervisors in File
25 No. 110624 and the Executive Park Design Guidelines as established by Planning
Commission Resolution 18352, on file with the Clerk of the Board of Supervisors in File No.

1 110626 and incorporated into this Section by this reference. The Executive Park Design
2 Guidelines also are on file with the Planning Department in File No. 2006.0422EMUTZ.

3 (2) **Uses.**

4 (A) Retail Sales and Service Uses as defined in ~~under~~ Planning Code
5 Section 102-218 are principally permitted at street level throughout the SUD when individual
6 establishments are less than 10,000 square feet of gross floor area. Retail establishments
7 equal to or greater than 10,000 square feet of gross floor area require Permit Design Review
8 under ~~Planning Code~~ Section 309.2 of this Code. Tenant spaces that are expanded to be
9 10,000 square feet or greater after initial approval will require addition review under ~~Planning~~
10 ~~Code~~ Section 309.2.

11 (B) Ground floor retail is required at the two southern corners of the
12 intersection of Executive Park Boulevard North and Thomas Mellon Circle. (Portions of Block
13 4991, Lots 085 and 086). For each corner, retail frontage is required for a minimum of 100
14 feet along Executive Park Boulevard North and 50 feet along Thomas Mellon Circle.

15 (C) Child-]eCare facilities as defined in Section 102 of this Code ~~under~~
16 ~~Section 209.3(f)~~ are principally permitted.

17 (D) Community fFacilities and Private Community Facilities as defined in
18 Section 102 of this Code ~~under Section 209.4(a) and (b)~~ are principally permitted.

19 (E) Non-accessory parking is not permitted.

20 (3) **Required Residential to Non-Residential Use Ratio.** Non-residential
21 uses are limited to one occupiable square foot for every six occupiable square feet of
22 residential use.

23 (4) **Density Transfer.**

24 (A) In accordance with the provisions of this sSubsection, (i) the
25 density allowed on Block 4991, Lots 024, 061, 065 and 078, and Block 5076, Lots 012 and
013, may be transferred to any other lot within the SUD north of Alana Way or north of the

1 proposed Harney Way setback line and (ii) if the portion of Assessor's Block 4991, Lot 085
2 south of the Harney setback line becomes its own lot through a subdivision action, the new lot
3 south of the setback line may transfer its density to any other lot north of Alana Way or north
4 of the Harney setback line pursuant to the procedures described in this §Subsection. The
5 Blocks and Lots in the SUD and the location of the proposed Harney Way setback line are
6 shown on the map in Figure 249.54(A). In addition, a detailed description of the Harney Way
7 setback line is on file with the Clerk of the Board of Supervisors in File No. 110625 and
8 incorporated into this Section by this reference.

9 [Figure 249.54(A) is not shown but is not to be deleted.]

10 (B) To transfer density, a Notice of Special Restriction ("NSR") must be
11 recorded against lots that both provide and receive the density transfer. Prior to recording a
12 NSR for a density transfer, the Planning Department must have verified that the density
13 transfer proposed is authorized by this §Subsection. The NSR shall explicitly state the square
14 footage of the providing lot, and the maximum number of residential units and the maximum
15 gross square footage of non-residential uses that are being forgone on the providing lot and
16 transferred to the receiving lot or lots. If density is being distributed between more than one
17 lot, the NSR shall explicitly state how much density each lot is receiving. The NSR must also
18 explicitly state that by transferring density, the providing lot is foregoing all rights to develop on
19 the providing lot the number of units and amount of non-residential square footage
20 transferred. In all cases, lots receiving density transfers will continue to be subject to all
21 relevant controls and guidelines notwithstanding new maximum allowed density. The NSR
22 memorializing the transfer must be approved as to form by the City Attorney.

23 (5) **Family Size Units.** Section 207.6 applies to lots within the SUD.

24 (6) **Harney Way Setback.** No building shall be built on the southern side of
25 the Harney setback line as shown on Figure 249.54(A) and described in the detailed
description of the Harney Way setback line on file with the Clerk of the Board of Supervisors

1 in File No. 110625. Residential and non-residential densities that would have otherwise been
2 allowed south of the setback line may be applied to other portions of the lot or transferred to
3 other lots within the SUD pursuant to Section 249.54(c)(4).

4 (7) **Site Coverage.** Rear yard provisions of Planning Code Section 134 do not
5 apply. The maximum site coverage of any building is 75 percent of the site area as measured
6 at the grade level of the building's main pedestrian entry and at each succeeding level or story
7 of the building. The site area used to create new publicly accessible streets, will be credited
8 toward the area required to be unbuilt when calculating the site coverage. The location of
9 proposed new publicly accessible streets and resulting new formulated blocks are shown in
10 Figure 249.54(B).

11 [Figure 249.54(B) is not shown but is not to be deleted.]

12 (8) **Open Space.** For all residential uses, 75 square feet of open space is
13 required per dwelling unit. All residential open space must meet the provisions described in
14 Section 135, except where modified through Design Review under Section 309.2. Open space
15 requirements may be met with the following types of open space: "private usable open
16 space" as defined in Section 135(a) of this Code, "common usable open space" as defined in
17 Section 135(a) of this Code, and "publicly accessible open space" as defined in Section
18 135(h) and (i) of this Code, except that in the case of new publicly accessible streets, "publicly
19 accessible open space" does not include the curb-to-curb area that is open to vehicles and
20 includes only the sidewalk area. At least 36 square feet of open space per dwelling unit must
21 be provided on-site. Exceptions to this requirement may be sought through the Section 309.2
22 approval process. For purposes of this Section "on-site" means the area within the new
23 formulated blocks shown in Figure 249.54(B). On-site includes setback area, but not areas
24 used to create new publicly accessible streets.

25 (9) **Obstructions.** Provisions in the Executive Park Design Guidelines shall
be used in-lieu of Planning Code Section 136 in determining allowable obstructions.

1 (10) **Off-Street Parking.** The minimum off-street parking requirements set
2 forth in Section 151 shall not apply. However, for the purpose of determining the maximum
3 amount of parking allowed as an accessory use under Section 204.5, the amount of parking
4 required by this Code shall be the amount specified in Section 151 for the use or activity.

5 (11) **Parking Location in Building.** Parking shall be located below the grade
6 of the floor of the main pedestrian entrance to the building, with exceptions for (A) parking
7 ingress and egress, and (B) parking spaces dedicated to car sharing, vanpools, and handicap
8 accessible parking spaces. Notwithstanding the above, for sloping lots, building floor
9 dedicated to parking may be partially above grade, if fully wrapped with active uses as defined
10 by Planning Code Section 145.1.

11 (12) **Off-street Loading.** Off-street loading pursuant to Section 152 through
12 152.2 is not required. There is no limit to the number of allowed loading spaces as long as
13 loading facilities meet the Executive Park Design Guidelines.

14 (13) **Car Sharing.** The car sharing provisions of Planning Code Section 166
15 shall apply to lots within the SUD.

16 (14) **Signs.** Sign controls for NC-2 Districts shall apply to the SUD in-lieu of
17 sign controls for the underlying use district.

18 (15) **Streetscape and Other Infrastructure Improvements.**

19 (A) **General Requirements For New Publicly Accessible Streets
20 and Improvements to Existing Streets.** For each building or phase of development, all
21 bordering streets, including proposed new publicly accessible streets as shown on Figure
22 249.54(B), shall be fully improved for the entire width of the right-of-way consistent with the
23 Executive Park Subarea Plan and the Executive Park Design Guidelines. If a proposed
24 building or phase does not directly connect with Thomas Mellon Drive, Executive Park
25 Boulevard West, Executive Park Boulevard North or Executive Park Boulevard East,
construction of the building or phase must also include right-of-way improvements leading to

1 at least one of these streets. Said improvements must be completed and operational prior to
2 the issuance of the first certificate of occupancy, whether temporary or final ("the time of
3 occupancy"), as required by the conditions of approval for each building or phase of
4 development.

5 (B) **General Requirements for New Publicly Accessible Open**
6 **Space.** To provide adequate public open space, the Executive Park Subarea Plan and
7 Executive Park Design Guidelines identify three new public open space areas in the SUD as
8 shown in Figure 249.54(B). For any building or phase of development that is immediately
9 adjacent to any of the three identified open spaces in the SUD as shown in Figure 249.54(B),
10 the construction of the open space shall be completed to the satisfaction of the City prior to
11 the issuance of any temporary or final certificate of occupancy. This requirement applies to
12 the first such building or phase of development adjacent to the open space.

13 (C) Planning Commission approval of a building or phase under
14 Section 309.2 shall incorporate conditions for each building or phase that clearly identifies
15 which portions of the publicly accessible streets and open space in Figure 249.54(B) will be
16 constructed pursuant to Subsections (A) and (B) above.

17 The Planning Commission may make exceptions to these General Requirements
18 in formulating the related conditions of approval in extraordinary circumstances, such as but
19 not limited to: (1) a subject right-of-way or open space is wholly or partially on a property
20 under different ownership; or (2) strict adherence to the delivery schedule pursuant to the
21 General Requirements would require a portion of a newly constructed right-of-way or open
22 space to be demolished and reconstructed within two years given construction phasing.

23 In making such exceptions, the Planning Commission shall include conditions
24 that will assure either of the following: (1) that the delivery of open space or right-of-way
25 improvements otherwise generally required at the time of occupancy be delivered no more
than two years after said occupancy as guaranteed by a letter of credit acceptable to the City

1 Attorney's Office or other instrument providing a similar level of guarantee acceptable to the
2 City Attorney's Office; or (2) delivery of other public improvements as described in the
3 Executive Park Subarea Plan of equal or greater value at the time of occupancy of the related
4 build or phase of development.

5 (D) Street improvements must comply with any applicable provisions of
6 the San Francisco Charter or Municipal Code and adopted implementing regulations,
7 including, without limitation, those contained in the City's Subdivision Code and Public Works
8 Code regarding street lighting, sidewalk paving, storm-water management, landscaping and
9 design of public structures.

10 (E) Conditions of approval of a building or phase within the SUD shall
11 require the abutting property owner or owners to hold harmless the City and County of San
12 Francisco, its officers, agents, and employees, from any damage or injury caused by reason
13 of the design, construction or maintenance of the improvements, and shall require the
14 owner(s) and their successors and assigns of the respective property to be solely liable for
15 any damage or loss occasioned by any act.

16 (F) Project Sponsors shall apply for all required permits for changes to
17 the legislated sidewalk widths and street improvements and pay all required fees.

18 **SEC. 249.61. 17TH AND RHODE ISLAND STREET GROCERY STORE SPECIAL USE**
19 **SUBDISTRICT.**

20 In order to facilitate the development of a neighborhood grocery store at 17th and
21 Rhode Island Street in the Potrero Hill neighborhood, in an area that does not have a
22 proliferation of off-sale Type 20 or Type 21 liquor establishments and previously was zoned
23 M-1 (which permitted liquor stores as a principal permitted use), there shall be a 17th and
24 Rhode Island Street Grocery Store Special Use Subdistrict, applicable to the NC-3 zoned
25 block bounded by 17th Street, Rhode Island Street, Mariposa Street and Kansas Street

1 (Assessor's Block 3978, Lot 1). The following provisions shall apply within the Special Use
2 Subdistrict:

3 (a) One off-sale Type 20 and Type 21 liquor store, as defined by Section 102-790.55
4 of this Code, is permitted as a conditional use on the first or second story, provided that it is
5 operated as an integral element of a grocery store of not less than 30,000 gross square feet.

6 (b) Nighttime Entertainment, as defined by Section 102.17 of this Code, shall not be
7 permitted.

8 **SEC. 249.65. BAYSHORE BOULEVARD HOME IMPROVEMENT SPECIAL USE**
9 **DISTRICT.**

10 (a) **General.** A Special Use District entitled the Bayshore Boulevard Home
11 Improvement Special Use District, the boundaries of which are designated on Sectional Maps
12 SU08 and SU10 of the Zoning Map of the City and County of San Francisco, is hereby
13 established for the purposes set forth below. The Bayshore Boulevard Home Improvement
14 Special Use District consists of properties on lots fronting Bayshore Boulevard from Jerrold
15 Avenue south to the 1-280 Freeway, the west side of Loomis Street from Jerrold Avenue
16 south to the 1-280 Freeway, Oakdale Avenue from Loomis Street to Bayshore Boulevard,
17 Marengo Street from Bayshore Boulevard to Waterloo Street and the west side of Boutwell
18 Street from Industrial Street south to the 1-280 Freeway, and also include some lots on
19 Cortland Avenue; the blocks and lots included in the Bayshore Boulevard Home Improvement
20 Special Use District are designated in amendments to Sectional Maps SU08 and SU010 of
21 the Zoning Map of the City and County of San Francisco.

22 * * * *

23
24 (c) **Controls.** The following controls shall apply in the Bayshore Boulevard Home
25 Improvement Special Use District:

1 (1) A ~~R~~etail ~~S~~ales and ~~P~~ersona ~~S~~ervice use as defined in Section ~~102 218~~
2 of this Code shall be permitted regardless of the use size limitations in the *PDR Zoning Control*
3 *Table Sections 218*, however the use size controls set forth in Section 121.6 and 121.8 shall
4 continue to apply.

5 (2) Establishment of any of the following uses shall require Conditional Use
6 Authorization under Section 303 of this Code:

7 (A) a ~~f~~Formula ~~R~~etail use as defined in Section ~~102 703.3(b)~~ of this
8 Code that is 10,000 square feet or larger;

9 (B) a ~~L~~iquor ~~S~~Store as defined in Section ~~102 790.55~~ of this Code;

10 (C) a ~~d~~rive ~~U~~pp ~~f~~Facility as defined in Section ~~102 790.30~~ of this Code;

11 (D) an ~~a~~Adult Business ~~entertainment~~ establishment as defined in
12 Section ~~102 221(k)~~ of this Code;

13 (E) an ~~a~~Automotive use as defined in Section ~~102 223~~ of this Code; and

14 (F) a ~~f~~Fringe ~~f~~inancial ~~S~~ervice as defined in Section ~~102 249.35~~ of this
15 Code.

16 (3) No off-street parking spaces shall be required. The maximum permitted
17 number of accessory off-street parking spaces shall be that which would apply to accessory
18 off-street parking for a PDR-2 District absent this Special Use District.

19 (4) The following projects shall be consistent with the policies and guidelines
20 of the "Bayshore Boulevard Home Improvement District Design Guidelines" as adopted by the
21 Planning Commission and amended from time to time:

22 (A) New construction; or

23 (B) An increase in gross floor area of more than 25 percent.

24 (5) The provisions set forth in Section 230 of this Code, which relate to
25 demolition of industrial buildings in PDR districts, shall not apply.

1 (6) The requirements for street trees set forth in Section 428 of this Code shall
2 apply.

3 (7) Formula retail uses as defined in Section 703.3(b) of this Code that are
4 10,000 square feet or larger shall be subject to the Redevelopment Agency's Bayview
5 Hunters Point "Employment and Contracting Policy."

6 * * * *

7 **SEC. 249.67. ART & DESIGN EDUCATIONAL SPECIAL USE DISTRICT.**

8 (a) **Purpose.** The Art & Design Educational Special Use District is intended to
9 facilitate the continued operation of the California College of the Arts campus at 1111 Eighth
10 Street, which is characterized by instruction in industrial arts and/or fine arts, while providing
11 an appropriate regulatory scheme for a potential phased expansion of the campus in the
12 future.

13 (b) **Geography.** The boundaries of the Art & Design Educational Special Use District
14 are shown on Sectional Map No. SU08 of the Zoning Map. The area includes Parcel numbers
15 3808/004, 3820/002, 3913/002, and 3913/003.

16 (c) **Controls.** All provisions of the Planning Code currently applicable shall continue
17 to apply, including but not limited to the provisions of the PDR-1-D zoning district, except as
18 otherwise provided in this Section.

19 (1) **Postsecondary Educational Institutional Uses.** Postsecondary
20 educational institutional uses are exempted from use size limitations and shall be permitted as
21 of right. Postsecondary educational institutional uses for the purposes of academic,
22 professional, business or fine-arts education shall have an institutional master plan
23 considered by the Planning Commission pursuant to Section 304.5 of this Code.

24 (2) **Student Housing.** Student ~~h~~Housing, as defined by Section 102.36 of this
25 Code, is permitted subject to the following requirements:

1 (A) ~~(i)~~ For any housing project within this Special Use District, the
2 standards for development project review, entitlement process, and impact fees of the UMU
3 District shall apply.

4 (B) ~~(ii)~~ The total number of beds on all parcels within the Special Use
5 District shall not exceed 750. The number of beds per parcel is not limited, but will be
6 determined by the regulations on the built envelope of buildings, including height, bulk,
7 setbacks, and lot coverage.

8 (3) **Temporary Structures.** The Zoning Administrator may authorize a
9 temporary structure without a public hearing provided that the structure is occupied by a use
10 that is permitted by right or is a use authorized by this Section 249.67.

11 **SEC. 253. REVIEW OF PROPOSED BUILDINGS AND STRUCTURES EXCEEDING A**
12 **HEIGHT OF 40 FEET IN RH DISTRICTS, OR MORE THAN 50 FEET IN RM AND RC**
13 **DISTRICTS.**

14 (a) Notwithstanding any other provision of this Code to the contrary, in any RH, RM,
15 or RC District, established by the use district provisions of Article 2 of this Code, wherever a
16 height limit of more than 40 feet in a RH District, or more than 50 feet in a RM or RC District,
17 is prescribed by the height and bulk district in which the property is located, any building or
18 structure exceeding 40 feet in height in a RH District, or 50 feet in height in a RM or RC
19 District, shall be permitted only upon approval by the Planning Commission according to the
20 procedures for conditional use approval in Section 303 of this Code; provided, however, that a
21 building over 40 feet in height in a RM or RC District with more than 50 feet of street frontage
22 on the front ~~façade~~ façade is subject to the conditional use requirement.

23 (b) **Commission review of proposals.**

24 (1) In reviewing any such proposal for a building or structure exceeding 40 feet
25 in height in a RH District, 50 feet in height in a RM or RC District, or 40 feet in a RM or RC
District where the street frontage of the building is more than 50 feet the Planning

1 Commission shall consider the expressed purposes of this Code, of the RH, RM, or RC
2 Districts, and of the height and bulk districts, set forth in Sections 101, ~~206 through 206.3~~ 209.1,
3 209.2 ~~209.3~~, and 251 hereof, as well as the criteria stated in Section 303(c) of this Code and
4 the objectives, policies and principles of the ~~Master~~ General Plan, and may permit a height of
5 such building or structure up to but not exceeding the height limit prescribed by the height and
6 bulk district in which the property is located.

7 ~~(2) (1) On narrow streets and alleys.~~ In reviewing a proposal for a building
8 exceeding 50 feet in RM and RC districts, the Planning Commission may require that the
9 permitted bulk and required setbacks of a building be arranged to maintain appropriate scale
10 on and maximize sunlight to narrow streets (rights-of-way 40 feet in width or narrower) and
11 alleys.

12 **SEC. 260. HEIGHT LIMITS: MEASUREMENT.**

13 (a) **Method of Measurement.** The limits upon the height of buildings and structures
14 shall be as specified on the Zoning Map. In the measurement of height for purposes of such
15 limits, the following rules shall be applicable:

16 (1) The point above which such measurements shall be taken shall be as
17 specified ~~in the definition of "height" in this Code as follows.~~

18 (A) In the case of either (B) or (C) below, such point shall be taken at the
19 centerline of the building or, where the building steps laterally in relation to a street that is the basis
20 for height measurement, separate points shall be taken at the centerline of each building step.

21 (B) Where the lot is level with or slopes downward from a street at the
22 centerline of the building or building step, such point shall be taken at curb level on such a street. This
23 point shall be used for height measurement only for a lot depth not extending beyond a line 100 feet
24 from and parallel to such street, or beyond a line equidistant between such street and the street on the
25 opposite side of the block, whichever depth is greater. Measurement of height for any portion of the lot
extending beyond such line shall be considered in relation to the opposite (lower) end of the lot, and

1 that portion shall be considered an upward sloping lot in accordance with Subsection (C) below,
2 whether or not the lot also has frontage on a lower street.

3 (C) Where the lot slopes upward from a street at the centerline of the building
4 or building step, such point shall be taken at curb level for purposes of measuring the height of the
5 closest part of the building within 10 feet of the property line of such street; at every other cross-section
6 of the building, at right angles to the centerline of the building or building step, such point shall be
7 taken as the average of the ground elevations at either side of the building or building step at that
8 cross-section. The ground elevations used shall be either existing elevations or the elevations resulting
9 from new grading operations encompassing an entire block. Elevations beneath the building shall be
10 taken by projecting a straight line between ground elevations at the exterior walls at either side of the
11 entire building in the same plane.

12 (D) Where the lot has frontage on two or more streets, the owner may choose
13 the street or streets from which the measurement of height is to be taken, within the scope of the rules
14 stated above.

15 Where the height limits for buildings and structures are established by this Code, the upper
16 points to be taken for measurement of height shall be as prescribed in the provisions relating to such
17 height limits.

18 (2) The upper point to which such measurement shall be taken shall be the
19 highest point on the finished roof in the case of a flat roof, and the average height of the rise in
20 the case of a pitched or stepped roof, or similarly sculptured roof form, or any higher point of a
21 feature not exempted under Subsection (b) below. For any building taller than 550 feet in
22 height in the S-2 Bulk District, the height of the building shall be measured at the upper point
23 of all features of the building and exempted features in such cases shall be limited to only
24 those permitted in ~~s~~Subsection (b)(1)(M) and which are permitted by the Planning Commission
25 according to the procedures of Section 309.

(3) In cases where the height limit is 65 feet or less and a street from which height measurements are made slopes laterally along the lot, or the ground slopes laterally on a lot that also slopes upward from the street, there shall be a maximum width for the portion of the building or structure that may be measured from a single point at curb or ground level, according to the definition of "height," as specified in the following table. These requirements shall not apply to any property to which the bulk limitations in Section 270 of this Code are applicable.

(b) **Exemptions.** In addition to other height exceptions permitted by this Code, the features listed in this Subsection shall be exempt from the height limits established by this Code, in an amount up to but not exceeding that which is specified.

* * * *

1 (2) The following features shall be exempt, without regard to their horizontal
2 area, provided the limitations indicated for each are observed:

3 (A) Railings, parapets and catwalks, with a maximum height of four feet.

4 (B) Open railings, catwalks and fire escapes required by law, wherever
5 situated.

6 (C) Unroofed recreation facilities with open fencing, including tennis and
7 basketball courts at roof level, swimming pools with a maximum height of four feet and play
8 equipment with a maximum height of 10 feet.

9 (D) Unenclosed seating areas limited to tables, chairs and benches, and
10 related windscreens, lattices and sunshades with a maximum height of 10 feet.

11 (E) Landscaping, with a maximum height of four feet for all features
12 other than plant materials.

13 (F) Short-term parking of passenger automobiles, without additional
14 structures or equipment other than trellises or similar overhead screening for such
15 automobiles with a maximum height of eight feet.

16 (G) Amusement parks, carnivals and circuses, where otherwise
17 permitted as temporary uses.

18 (H) Flagpoles and flags, clothes poles and clotheslines, and
19 weathervanes.

20 (I) Radio and television antennae where permitted as accessory uses
21 and towers and antennae for transmission, reception, or relay of radio, television or other
22 electronic signals, where permitted as principal or conditional uses, subject to the limitations in
23 the definition for Wireless Facilities in Section 102 of this Code and the Zoning Control Table for the
24 district in which the Lot is located ~~of Subsections 227(h) and (i) of this Code~~ and limitations imposed
25 by the ~~City~~ Planning Commission.

1 (J) Warning and navigation signals and beacons, light standards and similar
2 devices, not including any sign regulated by this Code.

3 (K) Public monuments owned by government agencies.

4 (L) Cranes, scaffolding and batch plants erected temporarily at active
5 construction sites.

6 (M) Structures and equipment necessary for the operation of industrial plants,
7 transportation facilities, public utilities and government installations, where otherwise
8 permitted by this Code and where such structures and equipment do not contain separate
9 floors, not including towers and antennae for transmission, reception, or relay of radio,
10 television, or other electronic signals where permitted as principal or conditional uses by this
11 Code.

12 (N) Buildings, structures and equipment of the San Francisco Port
13 Commission, where not subject to this Code due to provisions of the San Francisco Charter or
14 State law.

15 (O) Additional building height, up to a height of five feet above the otherwise
16 applicable height limit, where the uppermost floor of the building is to be occupied solely by
17 live/work units located within a South of Market District.

18 (P) Enclosed recreational facilities up to a height of 10 feet above the otherwise
19 applicable height limit when located within a 65-U Height and Bulk District and either an MUO
20 or SSO District, and only then when authorized by the Planning Commission as a conditional
21 use pursuant to Sections 303 and 316 of this Code, provided that the project is designed in
22 such a way as to reduce the apparent mass of the structure above a base 50 foot building
23 height.

24 (Q) Historic signs within an historic sign district permitted pursuant to Sections
25 302, 303 and 608.14 of this Code.

1 (R) In the Eastern Neighborhoods Mixed Use Districts, enclosed utility sheds of
2 not more than 100 square feet, exclusively for the storage of landscaping and gardening
3 equipment for adjacent rooftop landscaping, with a maximum height of 8 feet above the
4 otherwise applicable height limit.

5 **SEC. 263.28. SPECIAL EXCEPTIONS: SALI DISTRICTS IN THE 40-55-X HEIGHT AND**
6 **BULK DISTRICT.**

7 (a) **Purpose.** Arts activities are encouraged in the Western SoMa Planning Area
8 Special Use District, and especially in the SALI District. Therefore, additional development
9 potential is provided in the SALI District when additional space is provided for the exclusive
10 use of arts activities.

11 (b) **Applicability.** This Section shall apply to all properties zoned SALI and a Height
12 and Bulk district of 40-55-X.

13 (c) **Controls.**

14 (1) **Additional Height Permitted.** In SALI Districts in the 40-55-X Height and
15 Bulk District, buildings are limited to a maximum height of 40 feet unless all of the following
16 criteria are met, in which case they may extend to a maximum height of 55 feet:

17 (A) At least one ~~s~~Story of the ~~b~~Building, as defined in Section 102.23,
18 located on the ~~First ground s~~Story or above, as defined in Section 102.24 *under the definition for*
19 *Story*, is designated for the exclusive use of Arts Activities, as defined in Section 102.2. If the
20 ~~First Story ground floor~~ is designed for the use of Arts Activities, it shall also be permitted to
21 contain lobbies, egress, building services, and other features necessary for the operation of
22 the building and permitted uses elsewhere in the building.

23 (B) Any such story dedicated to arts activities pursuant to ~~s~~Subsections
24 (2) and (3) below, regardless of its location within the building, shall have a minimum floor-to-
25 floor height of 15 feet.

1 (2) **Timing of Designation.** In the case of the new construction of a building
2 that extends beyond 40 feet in height, exclusive of permitted obstructions under Section
3 260(b), any designated arts activity story shall be established prior to the issuance of a first
4 building permit or along with any associated Planning Commission action, whichever occurs
5 first. In the case of buildings that were constructed prior to the effective date of this Section
6 that would be expanded such that they would extend beyond 40 feet in height, exclusive of
7 permitted obstructions under Section 260(b), any such story shall be designated prior to the
8 issuance of any building permit or along with any associated Planning Commission action,

19 possible revocation of a conditional use or the possible modification of or placement of
20 additional conditions on a conditional use when the Planning Commission determines, based
21 upon substantial evidence, that the applicant for the conditional use had submitted false or
22 misleading information in the application process that could have reasonably had a substantial
23 effect upon the decision of the Commission or the conditional use is not in compliance with a
24 condition of approval, is in violation of law if the violation is within the subject matter
25 jurisdiction of the Planning Commission, or operates in such a manner as to create
hazardous, noxious or offensive conditions enumerated in Section 202(c) if the violation is

6 above, the Commission shall make the following findings:

7 (A) The concentration of such establishments in the particular zoning
8 district for which they are proposed does not appear to contribute directly to peace, health,
9 safety, and general welfare problems, including drug use, drug sales, drug trafficking, other
10 crimes associated with drug use, loitering, and littering, as well as traffic circulation, parking,
11 and noise problems on the district's public streets and lots;

23 (1) **Criteria.** In acting on any application for Conditional Use authorization for a Power
24 Plant, the Commission shall consider the conditional use authorization requirements set forth in
25 Subsection (c) above and, in addition, shall only approve an application for a Conditional Use
authorization if facts are presented to establish that, on the basis of the record before the Commission:

1 (A) The benefits to the City's energy system resulting from the energy generated
2 by the proposed power plant cannot be obtained in a reasonable time from a technically and
3 economically feasible power plant and/or energy conservation project that would have materially fewer
4 potential environmental impacts considering, but not limited to, the following: (i) Emissions of criteria
5 air pollutants and greenhouse gas emissions; (ii) Storm-water and wastewater discharges; and (iii)
6 noise and vibration impacts.

7 (B) A newly proposed Power Plant use would not directly and adversely impact
8 existing or reasonably foreseeable adjoining land uses, or, as applied to a prior nonconforming use,
9 the extension of the power plant use or the increase in intensity of the use would not result in increased
10 direct and adverse impacts on existing or reasonably foreseeable adjoining land uses; and

11 (C) Granting Conditional Use authorization would not reasonably be expected
12 to leave known contamination in place in such a way that would prolong or increase public health risks

14 the proposed power plant use; and

15 (D) Granting Conditional Use authorization would not reasonably be expected
16 to preclude future redevelopment and reuse of the property for non-power plant uses.

17 (2) **Written Findings.** The Planning Commission shall make detailed written findings
18 explaining the basis for its decision under this Section.

19 (3) **Severability.** In the event that a court or agency of competent jurisdiction holds that
20 Federal or State law, rule, or regulation invalidates any clause, sentence, paragraph of this Section or
21 the application thereof to any person or circumstances, it is intended that the court or agency sever
22 such clause, sentence, paragraph or section so that the remainder of this Section shall remain in effect.

23 **SEC. 304.5. INSTITUTIONAL MASTER PLANS.**

24 * * * *

25 (b) **When Required.** Each Hospital ~~medical institution~~ and each pPost-sASecondary
eEducational iInstitution in the City and County of San Francisco (for the purposes of this Section

1 *collectively referred to as "institution(s)"*, including *G*roup *H*ousing affiliated with and
2 operated by any such institution, ~~as described in Sections 209.2(c), 209.3(a) and (i), 216(a), and~~
3 ~~217(a) and (h) of this Code~~, shall have on file with the Planning Department a current
4 institutional master plan describing the existing and anticipated future development of that
5 institution as provided in Subsection (c) below. Medical and educational institutions of less
6 than 50,000 square feet or medical and educational institutions of less than 100,000 square
7 feet in the C-3 district may submit an Abbreviated Institutional Master Plan as described in
8 Subsection (d) below.

9 Thereafter, at intervals of two years, each such institution shall file an Update with the
10 Planning Department describing the current status of its institutional master plan. The
11 requirements for an update are provided in Subsection (f) below.

12 The Zoning Administrator shall be notified whenever the following occur to determine
13 whether a new Institutional Master Plan or an Update shall be required: there are significant
14 revisions to the information contained in the Institutional Master Plan; or 10 years have
15 passed since the last Institutional Master Plan was submitted and heard by the Planning
16 Commission (as described by Subsection (e) below). Significant revisions may include plans
17 to construct new facilities that were not previously discussed in the Institutional Master Plan,
18 plans to demolish existing facilities that were not discussed in the Institutional Master Plan,
19 closure of an existing unit, opening of a new unit, change in use of an existing unit or inpatient
20 facility, an increase in the institutions size by 10,000 square feet or 25% of total square
21 footage (whichever is less), or significant changes in use of existing facilities that were not
22 discussed in the Institutional Master Plan.

23 **SEC. 307. OTHER POWERS AND DUTIES OF THE ZONING ADMINISTRATOR.**

24 In addition to those specified in Sections 302 through 306, and Sections 316 through
25 316.6 of this Code, the Zoning Administrator shall have the following powers and duties in
administration and enforcement of this Code. The duties described in this Section shall be

1 performed under the general supervision of the Director of Planning, who shall be kept
2 informed of the actions of the Zoning Administrator.

4 (j) **Conversion from Student Housing to Non-Student Residential Use.** If a
5 residential project no longer qualifies as Student Housing as defined in Planning Code Section

8 determination that the converted Student Housing has complied with any applicable
9 Inclusionary Affordable Housing Requirements as outlined in Planning Code Section
10 415.3(c)(5)(C)(iii), and that all other Planning Code requirements applicable to that residential
11 use have been met or modified through appropriate procedures.

12 **SEC. 309.2. PERMIT REVIEW IN THE EXECUTIVE PARK SPECIAL USE DISTRICT.**

13 The provisions and procedures set forth in Section 309.1, applicable in Downtown
14 Residential Districts, shall also apply in the Executive Park Special Use District (SUD) to
15 achieve the objectives and policies of the General Plan and the purposes of this Code,
16 including but not limited to Section 249.54 and Section 263.27, except that Section 309.2(a)
17 and (b) shall apply instead of the provisions in Section 309.1(a) and (b), the provisions of
18 Section 309.1(c) are modified as provided in Section 309.2(c) and Section 309.1(e) is
19 inapplicable in the SUD.

20 (a) **Design Review.**

21 (1) In addition to the standard permit review process, the design of projects
22 for all new construction shall be subject to design review and approval by Department staff. A
23 detailed design review will be initiated by Department staff working with the project sponsor, at
24 the time an application for Section 309.2 review or building permit is filed, and may take place
25 in advance of filing a building permit application. This comprehensive review shall resolve
issues related to the project's design, including the following:

- 1 (A) Overall building massing and scale;
- 2 (B) Architectural treatments, faeçade design and building materials;
- 3 (C) The design of lower floors, including building setback areas,
- 4 townhouse-style units and entries, and parking and loading access;
- 5 (D) The provision of required open space, both on- and off-site;
- 6 (E) Streetscape and other public improvements, including tree planting,
- 7 street furniture, and lighting and adherence to all relevant regulations, plans and guidelines;
- 8 (F) Circulation, including streets, alleys and mid-block pedestrian
- 9 pathways.

10 (2) For review of projects that include ~~retail~~-space for Retail Sales and Service
11 uses as defined specified in ~~Planning~~ Code Section 102-218 of 10,000 gross square feet or more,
12 the Planning Commission shall consider the criteria in Section 121.2(a)(1)-(3).

13 (3) Other changes necessary to bring a project into conformance with the
14 Executive Park Subarea Plan of the Bayview Hunters Point Area Plan, approved by the Board
15 of Supervisors on July 12, 2011, the Executive Park Design Guidelines, approved by the
16 Planning Commission by Resolution No. 18352 and incorporated by this reference into this
17 Section, and other elements and area plans of the General Plan. If the project sponsor
18 opposes project modifications and conditions recommended by the Director of Planning
19 pursuant to the design review, the Director shall prepare a report of recommended
20 modifications which shall be presented to the Planning Commission for a hearing pursuant to
21 Subsection (c) and which shall be available to the public upon mail notification of said hearing.

23 **SEC. 317. LOSS OF DWELLING UNITS THROUGH MERGER, CONVERSION, AND**
24 **DEMOLITION.**

25 (a) **Findings.** San Francisco faces a continuing shortage of affordable housing.
There is a high ratio of rental to ownership tenure among the City's residents. The General

1 Plan recognizes that existing housing is the greatest stock of rental and financially accessible
2 residential units, and is a resource in need of protection. Therefore, a public hearing will be
3 held prior to approval of any permit that would remove existing housing, with certain
4 exceptions, as described below. The Planning Commission shall develop a Code
5 Implementation Document setting forth procedures and regulations for the implementation of
6 this Section 317 as provided further below. The Zoning Administrator shall modify economic
7 criteria related to property values and construction costs in the Implementation Document as
8 warranted by changing economic conditions to meet the intent of this Section.

9 (b) **Definitions.** For the purposes of this Section 317, the terms below shall be defined
10 as follows:

11 (1) "Residential Conversion" shall mean the removal of cooking facilities in a
12 Residential Unit or the change of occupancy (as defined and regulated by the Building Code),
13 or the change of use (as defined and regulated by the Planning Code), of any Residential Use
14 or Live-Work Unit to a non-residential use. The change of occupancy from a ~~d~~Dwelling ~~u~~Unit,
15 ~~g~~Group ~~h~~Housing, or SRO to Student Housing is also considered a conversion of a
16 Residential Unit. Notwithstanding the foregoing, the change of use or occupancy of a
17 ~~d~~Dwelling ~~u~~Unit, ~~g~~Group ~~h~~Housing, or SRO to Student Housing is not considered a conversion
18 of a Residential Unit if the ~~d~~Dwelling ~~u~~Unit, ~~g~~Group ~~h~~Housing or SRO will be Student Housing
19 owned, operated or otherwise controlled by a not for profit ~~p~~Post-~~s~~Secondary Educational
20 Institution and

- 21 (A) it was built by the post-secondary Educational Institution;
- 22 (B) it is in a convent, monastery, or similar religious order facility;
- 23 (C) it is on an adjoining lot (i.e., sharing the same lot line) to the ~~p~~Post-
24 ~~s~~Secondary Educational Institution, so long as the lot has been owned by the ~~p~~Post-
25 ~~s~~Secondary Educational Institution for at least ten years as of the effective date of Ordinance
188-12; or

1 (D) as of August 10, 2010, it was owned, operated or otherwise
2 controlled by a ~~p~~Post-~~s~~Secondary Educational Institution that had an Institutional Master Plan
3 on file with the Planning Commission, and where the occupancy by those other than students
4 at that date was less than 20% of the total occupants. For purposes of determining
5 occupancy, the ~~p~~Post-~~s~~Secondary Educational Institution shall present to the Planning
6 Department verified information regarding its rental or lease of units as of that date.

7 (2) "Residential Demolition" shall mean any of the following:

8 (A) Any work on a Residential Building for which the Department of
9 Building Inspection determines that an application for a demolition permit is required, or

10 (B) A major alteration of a Residential Building that proposes the
11 Removal of more than 50% of the sum of the Front Facade and Rear Facade and also
12 proposes the Removal of more than 65% of the sum of all exterior walls, measured in lineal
13 feet at the foundation level, or

14 (C) A major alteration of a Residential Building that proposes the
15 Removal of more than 50% of the Vertical Envelope Elements and more than 50% of the
16 Horizontal Elements of the existing building, as measured in square feet of actual surface
17 area.

18 (D) The Planning Commission may reduce the above numerical
19 elements of the criteria in Subsections (b)(2)(B) and (b)(2)(C), by up to 20% of their values
20 should it deem that adjustment is necessary to implement the intent of this Section 317, to
21 conserve existing sound housing and preserve affordable housing.

22 (3) "Facade" ~~Facade is defined in Section 102 of this Code shall mean an entire~~

11 or the enlargement of one or more existing units while substantially reducing the size of others
12 by more than 25% of their original floor area, even if the number of units is not reduced. The
13 Planning Commission may reduce the numerical element of this criterion by up to 20% of its
14 value should it deem that adjustment is necessary to implement the intent of this Section 317,
15 to conserve existing housing and preserve affordable housing.

16 (8) "Rear Facade ~~Facade~~" is defined in Section 102 of this Code shall mean that
17 ~~portion of the Facade facing the part of a lot that most closely complies with the applicable Planning~~
18 ~~Code rear yard requirements.~~

19 (9) "Removal" shall mean, with reference to a wall, roof or floor structure, its
20 dismantling, its relocation or its alteration of the exterior function by construction of a new
21 building element exterior to it. Where a portion of an exterior wall is removed, any remaining
22 wall with a height less than the Building Code requirement for legal head room shall be
23 considered demolished. Where exterior elements of a building are removed and replaced for
24 repair or maintenance, in like materials, with no increase in the extent of the element or
25 volume of the building, such replacement shall not be considered Removal for the purposes of

1 this Section. The foregoing does not supersede any requirements for or restrictions on

8 subject to the TIDF, the project shall be considered in its entirety. A sponsor shall not seek
9 multiple applications for building permits to evade paying the TIDF for a single development

11 (1) The TIDF shall not be payable on new development, or any portion thereof,
12 for which a TIDF has been paid, in full or in part, under the prior TIDF Ordinance (former
13 Chapter 38 of the Administrative Code as amended through June 30, 2010), except where

15 (B) the TIDF rate for the new development is in an economic activity
16 category with a higher fee rate than the current rate for the economic activity category under
17 which the TIDF was originally paid, as set forth in Section 411.3(e).

18 (2) No TIDF shall be payable on the following types of new development.

19 * * * *

20 (F) The following types of new developments, except to the extent that
21 any such new development is also captured under a more specific use under this Code that is
22 not otherwise exempt:

23 (i) Public Facility, facilities/utilities-Internet Service Exchange and
24 Utility Installation uses, as defined in Section 102 209.6 of this Code, except that this exclusion
25 shall not apply to new development on property owned by a private person or entity and
leased to the City;

9 that are in a new development, where the project sponsor has met the deadline established in

19 (3) The exclusions from TIDF set forth in Section 411.3(a)(2)(F)(iv) and (v)
20 (automotive services and ~~Wholesale s~~Storage ~~of materials and equipment~~) shall only apply
21 where a project sponsor for a new development has filed an application for environmental
22 evaluation, a categorical exemption or a preliminary project assessment for the project on or
23 before the effective date of Ordinance No. 18-14, or, for new development subject to a
24 redevelopment plan, development agreement, interagency cooperation agreement, or other
25 agreement entered into by the City, the project sponsor submits proof that the sponsor has
submitted to the successor agency to the former Redevelopment Agency of the City and

1 County of San Francisco documentation comparable to that required for an application for
2 environmental evaluation, a categorical exemption or a preliminary project assessment for the
3 project, on or before the effective date of Ordinance No. 18-14.

4 (b) **Timing of Payment.** ~~Except for those Integrated PDR projects subject to Section 328~~
5 ~~of this Code, the~~ The TIDF shall be paid prior to issuance of the first construction document,
6 with an option for the project sponsor to defer payment until prior to issuance of the first
7 certificate of occupancy upon agreeing to pay a deferral surcharge in accordance with Section
8 107A.13 of the San Francisco Building Code. Under no circumstances may any City official or
9 agency, including the Port of San Francisco, issue a certificate of final completion and
10 occupancy for any new development subject to the TIDF until the TIDF has been paid.

12 (d) **Credits.** When determining the number of gross square feet of use to which the
13 TIDF applies, the Department shall provide the following credits:

14 (1) **Prior Use Credits.** There shall be a credit for prior uses eliminated on the
15 site. The credit shall be calculated according to the following formula:

16 (A) There shall be a credit for the number of gross square feet of use
17 being eliminated by the new development, multiplied by an adjustment factor to reflect the
18 difference in the fee rate of the use being added and the use being eliminated. The
19 adjustment factor shall be determined by the Department as follows:

20 (i) The adjustment factor shall be a fraction, the numerator of
21 which shall be the fee rate which the Department shall determine, in consultation with the
22 MTA, if necessary, applies to the economic activity category in the most recent calculation of
23 the TIDF Schedule approved by the Board or Supervisors for the prior use being eliminated by
24 the project.

1 (ii) The denominator of the fraction shall be the fee rate for the
2 use being added, as set forth in the most recent calculation of the TIDF Schedule approved by
3 the Board of Supervisors.

4 (B) A credit for a prior use may be given only if the prior use was active
5 on the site within five years before the date of the application for a building or site permit for
6 the proposed use.

7 (C) As of September 4, 2004, no sponsor shall be entitled to a refund
8 of the TIDF on a building for which the fee was paid under the former Chapter 38 of the San
9 Francisco Administrative Code.

10 (D) Notwithstanding the foregoing, the adjustment factor shall not
11 exceed one.

12 (2) **Policy Credits.** Development projects that meet the criteria outlined in
13 Subsection 411.3(d)(2)(B) may receive Policy Credits, subject to the following limitations:

14 (A) **Limit on Available Policy Credits.** When making a determination
15 under this Article for the amount of TIDF owed, the Department shall allocate available Policy
16 Credits, described in Section 411.3(d)(2)(B), as follows:

17 (i) No development project shall receive a Policy Credit under
18 Section 411.3(d)(2)(B) if the total amount of credits received by development projects under
19 that section would exceed 3% of the total anticipated TIDF revenue for the current Fiscal
20 Year. To the extent Policy Credits allowed in any Fiscal Year are not allocated, the
21 unallocated amount shall be carried over to the next Fiscal Year. The amount to be carried
22 over to the next Fiscal Year shall be calculated based upon 3% of the sum of the actual TIDF
23 revenues collected during the current Fiscal Year and the total amount of policy credits
24 granted during the current Fiscal Year.

25 (ii) In no event shall the Policy Credits for a single development
exceed 100% of the total TIDF that would otherwise be due.

1 (B) The Planning Department shall maintain and shall make available
2 on the Planning Department's website, a list showing:

3 (i) All development projects receiving Policy Credits under
4 Section 411.3(d)(2)(C) of this Article, and, if applicable, the date(s) of approval and the
5 issuance of any building or site permit;

6 (ii) The total amount of Policy Credits received with respect to
7 each listed development project;

8 (iii) Any Policy Credits allocated to a development project the
9 site permit for which is modified, cancelled, revoked, or has expired;

10 (iv) Such other information as the Department may determine is
11 appropriate.

12 (C) **Available Policy Credits.** The following development projects may
13 receive Policy Credits, subject to the limitations set forth in Section 411.3(d)(2)(A):

14 (i) **Small Businesses.** Businesses that either occupy or expand
15 any preexisting non-residential space, provided that: (a) the gross square footage of such
16 non-residential space is not greater than 5,000 square feet, and (b) the business is not
17 formula retail, as defined in this Code. Only the gross square footage dedicated to such
18 business shall be eligible for the Policy Credit.

19 (ii) **Reduced Parking Developments.** In zoning districts that set
20 a parking maximum, development projects that provide a lower number, or ratio, of off-street
21 parking than permitted on an as-of-right basis without conditional use authorization in Table
22 151.1 of this Code. The credit shall be determined by the Department as follows:

(D) **Process for Allocation of Policy Credits.** The Policy Credits described in this Section shall be allocated to qualifying development projects by the Zoning Administrator at the moment their first entitlement is approved by the Planning Commission or the Planning Department. In addition, the following considerations shall apply:

(i) If a development project is modified for any reason after it is first approved, and such modification would result in a potential increase in the amount of Policy Credits allocated to it, the development project shall maintain the credits allocated on the list described in Section 411.3(d)(2)(~~B~~)(~~A~~)(~~+~~). Any additional credit may only be allocated at the time such modification is approved, subject to the limits of Section 411.3(d)(2)(A)(i).

(ii) If a development project is modified for any reason after it is first approved, and such modification would result in a potential decrease in the amount of Policy Credits allocated to it, the remainder Policy Credits shall become available for other qualifying development projects during the approval period on account of such a modification.

(iii) The maximum amount of Policy Credits available for the approval period shall be increased by the amount of Policy Credits allocated to a development project for which an issued site or building permit has been finally cancelled or revoked, or has expired, with the irrevocable effect of preventing construction of the development.

(3) **Limitation.** In no event shall the combined Policy Credits and Prior Use Credits for a single development exceed 100% of the total TIDF that would otherwise be due.

SEC. 415.3. APPLICATION.

(a) Notwithstanding any other provision to the contrary in this Code, Section 415.1 *et seq.* shall apply to any housing project that consists of ten or more units where an individual project or a phased project is to be undertaken and where the total undertaking comprises a project with ten or more units, even if the development is on separate but adjacent lots; and

1 (1) Does not require Commission approval as a Conditional Use
2 ~~A~~authorization or Planned Unit Development;

3 (2) Requires Commission approval as a Conditional Use Authorization or
4 Planned Unit Development;

5 (3) Consists of ~~L~~ive/~~W~~ork ~~U~~nits as defined by Section 102.~~13~~ of this Code;
6 or

7 (4) Requires Commission approval of replacement housing destroyed by
8 earthquake, fire or natural disaster only where the destroyed housing included units restricted
9 under the Inclusionary Affordable Housing Program or the City's predecessor inclusionary
10 housing policy, condominium conversion requirements, or other affordable housing program.

11 * * * *

12 (c) Section 415.1 et seq., the Inclusionary Housing Program, shall not apply to:

13 (1) That portion of a housing project located on property owned by the United
14 States or any of its agencies or leased by the United States or any of its agencies for a period
15 in excess of 50 years, with the exception of such property not used exclusively for a
16 governmental purpose;

17 (2) That portion of a housing project located on property owned by the State
18 of California or any of its agencies, with the exception of such property not used exclusively
19 for a governmental or educational purpose; or

20 (3) That portion of a housing project located on property under the jurisdiction
21 of the San Francisco Redevelopment Agency or the Port of San Francisco where the
22 application of Section 415.1 et seq. is prohibited by California or local law.

23 (4) A 100% percent affordable housing project in which rents are controlled or
24 regulated by any government unit, agency or authority, excepting those unsubsidized and/or
25 unassisted units which are insured by the United States Department of Housing and Urban

1 Development. The Mayor's Office of Housing must represent to the Planning Commission or
2 Planning Department that the project meets this requirement.

3 (A) **Restrictions.** If a project sponsor takes advantage of this
4 ~~s~~Subsection, all of the rules and regulations of the programs or recorded documents
5 guaranteeing the affordability of the units shall govern the units and the requirements of this
6 Program shall not apply.

7 (B) **Conditions.** In order to qualify for this provision, the project
8 sponsor must record an NSR against the property that provides that, in the event of
9 foreclosure or for any other reason, the project no longer qualifies as a project meeting the
10 requirements of ~~s~~Subsection (4) the project will either:

11 (i) pay the Affordable Housing Fee plus interest from the date
12 the project received its first construction document for the project if no affordable units were
13 ever provided or, if affordable units were provided and occupied, then the Affordable Housing
14 Fee with no interest is due on the date the units were no longer occupied by qualifying
15 households; or

16 (ii) provide the required number of on-site affordable units
17 required at time of original project approval and that those units shall be subject to all of the
18 requirements of this Program.

19 (C) In the event that there is a foreclosure or other event triggering the
20 requirements of ~~s~~Subsection (B) above, the project sponsor shall record a new NSR specifying
21 the manner ~~it~~in which it complies with this Program, including but not limited to any specific
22 units restricted as affordable under (B)(ii). The new NSR shall provide that the units must
23 comply with all of the requirements of this Program.

24 (5) A Student Housing project that meets all of the following criteria:

25 (A) The building or space conversion does not result in loss or
conversion of existing housing, including but not limited to rental housing and dwelling units;

1 (B) An institutional master plan (IMP) pursuant to Section 304.5 is on
2 file with the Planning Department prior to the issuance of any building permit or alteration
3 permit in connection with the creation of the Student Housing project, and, in addition to the
4 requirements of Section 304.5, such IMP shall describe:

- 5 (i) to the extent such information is available, the type and
6 location of housing used by its students;
- 7 (ii) any plans for the provision of Student Housing; and
- 8 (iii) the Educational Institution's need for student housing to
9 support its program; and (iv) the percentage of its students, on an average annual basis, that
10 receive some form of need-based assistance as described in (113B).

11 (C) The Mayor's Office of Housing (MOH) is authorized to monitor this
12 program. MOH shall develop a monitoring form and annual monitoring fee to be paid by the
13 owner of the real property or the ~~p~~Post-~~s~~Secondary Educational Institution or *Religious*
14 Institutions, as defined in Section ~~102 209.3(j)~~ of this Code. The owner of the real property and
15 each ~~p~~Post-~~s~~Secondary Educational Institution or Institutions shall agree to submit annual
16 documentation to the Mayor's Office of Housing (MOH) and the Planning Department, on or
17 before December 31 of each year, that addresses the following:

- 18 (i) Evidence that the ~~p~~Post-~~s~~Secondary Educational Institution
19 continues to own or otherwise control the Student Housing project under a master lease or
20 other contractual agreement with at least a 5 year term, including a certificate from the owner
21 of the real property and the ~~p~~Post-~~s~~Secondary Educational Institution attaching a true and
22 complete copy of the master lease or other contractual agreement (financial information may
23 be redacted) and certifying that the lease or contract has not otherwise been amended or
24 terminated; and
- 25 (ii) Evidence, on an average annualized basis, of the percentage
of students in good standing enrolled at least half time or more in the post-secondary

1 Educational Institution or Institutions who are occupying the beds or accessory living space in
2 the Student Housing project; and

3 (iii) The owner of the real property records a Notice of Special
4 Restrictions (NSR) against fee title to the real property on which the Student Housing is
5 located that states the following:

6 - The ~~p~~Post-~~s~~Secondary Educational Institution, or the owner of the real property
7 on its behalf, must file a statement with the Department if it intends to terminate the Student
8 Housing project at least 60 days before it terminates such use ("statement of termination");

9 - The Student Housing project becomes subject to the Inclusionary Housing
10 Ordinance requirements applicable to Housing Projects other than Qualified Housing Projects
11 if (1) a post-secondary Educational Institution files a statement of termination with the
12 Department and another ~~p~~Post-~~s~~Secondary Educational Institution or Institutions have not
13 been substituted or obligated to meet the requirements of this section; or (2) the owner of the
14 real property or the post-secondary Educational Institution fails to file a statement of
15 termination and fails to meet the requirements for a Student Housing project, then within not
16 more than one year of a Notice Of Violation issued by the Planning Department;

17 - If units in a Student Housing project become subject to the Inclusionary
18 Housing Ordinance then the owner of those units shall (1) pay the Affordable Housing Fee
19 plus interest from the date the project received its first construction document for the project if
20 there is no evidence the Project ever qualified as Student Housing or, if Student Housing was
21 provided and occupied, then the Affordable Housing Fee with no interest is due on the date
22 the units were no longer occupied by qualifying households and interest would accrue from
23 that date if the fee is not paid; or (2) provide the required number of on-site affordable units
24 required at time of original project approval and that those units shall be subject to all of the
25 requirements of this Program. In this event, the owner of the real property shall record a new

1 NSR providing that the designated units must comply with all of the requirements of this
2 Program.

3 - The ~~P~~Post-~~S~~Secondary Educational Institution is required to report annually
4 as required in ~~s~~Subsection (C) above;

5 - The City may commence legal action against the owner and/or ~~P~~Post-
6 ~~S~~Secondary Educational Institution to enforce the NSR and the terms of Article IV of the
7 Planning Code and Planning Code Section 415 *et seq.* if it determines that the project no
8 longer meets the requirements for a Student Housing project; and

9 - The Student Housing project may be inspected by any City employee to
10 determine its status as a Student Housing project and its compliance with this Section at any
11 time upon at least 24 hours' prior notice to the owner of the real property or to the master
12 lessee.

13 (d) For projects that have received a first site or building permit prior to the effective
14 date of Section 415.1 *et seq.*, the requirements in effect prior to the effective date of Section
15 415.1 *et seq.* shall apply.

16 (e) In November, 2012 the voters amended the Charter by adopting Proposition C
17 "The Affordable Housing Trust Fund and Housing Production Incentives" which is, in part,
18 codified as Charter Section 16.110 ("Proposition C"). To the extent that there is any
19 inconsistency between the provisions of Proposition C and Sections 415 *et seq.* or any other

1 Section 6. Article 6 of the Planning Code is hereby amended by amending Sections

4 Signs in Residential and Residential Enclave Districts, other than those signs exempted by
5 Section 603 of this Code, shall conform to the following provisions:

6 (a) **General Provisions for All Signs.**

7 (1) No sign shall project beyond a street property line or legislated setback line,
8 or into a required front setback area.

9 (2) No sign shall have or consist of any moving, rotating or otherwise animated
10 part, or (if permitted to be illuminated) any flashing, blinking, fluctuating or otherwise animated
11 light.

12 (3) No roof sign, wind sign, or general advertising sign shall be permitted.

13 (4) No sign shall extend above the roofline of a building to which it is attached,
14 or above a height of 12 feet.

15 (b) **Signs for Uses Permitted in Residential and Residential Enclave Districts.** The
16 following types of signs, subject to the limitations prescribed for them, shall be the only signs
17 permitted for uses authorized as principal or conditional uses in R and RED Districts, except
18 that signs for any commercial establishments ~~so authorized in RC Districts~~ shall be subject to
19 the limitations of Paragraph (c)~~(3)~~ below.

20 (1) One nonilluminated or indirectly illuminated nameplate for each street
21 frontage of the lot, not exceeding a height of 12 feet, and having an area not exceeding one
22 square foot in RH Districts or two square feet in RM or RED Districts.

23 (2) One identifying sign for each street frontage of the lot, not exceeding a
24 height of 12 feet, and meeting the following additional requirements:

25 (A) In RH Districts: nonilluminated or indirectly illuminated only;
maximum area 12 square feet;

1 (B) In RM, RTO or RED Districts: maximum area eight square feet if
2 directly illuminated, and 20 square feet if nonilluminated or indirectly illuminated.

3 ~~(C) In RTO Districts: nonilluminated or indirectly illuminated only; maximum~~
4 ~~area 12 square feet; signage related to commercial uses permitted under Sections 209.8(e) and 230 is~~
5 ~~regulated according to the provisions described in Section 230.~~

6 (3) Sale or Lease Signs. One temporary nonilluminated or indirectly illuminated
7 sale or lease sign for each street frontage of the total parcel involved, not exceeding a height
8 of 24 feet if freestanding and not above the roofline if attached to a building, and having an
9 area not exceeding six square feet for each lot or for each 3,000 square feet in such total
10 parcel, whichever ratio permits the larger area, provided that no such sign shall exceed 50
11 square feet in area and any such sign exceeding 18 square feet in area shall be set back at
12 least 25 feet from all street property lines. Any sale or lease sign shall be removed within
13 seven days following removal of the property from the market.

14 (4) Construction Signs. Temporary nonilluminated signs of persons and firms
15 connected with work on buildings under actual construction or alteration, giving their names
16 and information pertinent to the project, not exceeding a height of 12 feet, with the combined
17 area of all such signs not to exceed 10 square feet for each street frontage of the project.

18 (c) Business Signs for Limited Commercial Uses. For Limited Commercial Uses, as
19 described in Section 186 of this Code, and for Limited Corner Commercial Uses, as permitted by
20 Section 231, the following controls shall apply:

21 (1) Wall Signs. One wall sign is permitted for each street frontage occupied by the use,
22 placed flat against the wall that faces such street and not located above the ground floor. Such sign
23 shall not exceed an area of one square foot for each linear foot of street frontage occupied by the
24 building or part thereof that is devoted to the commercial use or 50 square feet per street frontage,
25 whichever is less. Any such sign may be nonilluminated or indirectly illuminated.

1 (2) **Window Signs.** Window signs, limited to signs painted or similarly applied directly
2 on the surface of the window glass, are permitted. The total area of all window signs, as defined in
3 Section 602.1(b), shall not exceed one-quarter the area of the window on which the signs are located.
4 Such signs may be nonilluminated or indirectly illuminated.

5 (3) **Projecting Signs.** The number of projecting signs shall not exceed one per business.
6 The area of such sign, as defined in Section 602.1(a), shall not exceed six square feet. The height of
7 such sign shall not exceed 14 feet, or the height of the lowest residential windowsill above the
8 commercial use, whichever is lower. No part of the sign shall project more than 75 percent of the
9 horizontal distance from the street property line to the curblin, or four feet, whichever is less. Any
10 such sign may be nonilluminated or indirectly illuminated.

11 (4) **Signs on Awnings.** Sign copy may be located on permitted awnings in lieu of wall
12 signs and projecting signs. The area of such sign copy as defined in Section 602.1(c) shall not exceed
13 20 square feet per business. Such sign copy may be nonilluminated or indirectly illuminated.

14 (5) **Illumination.** Any illumination permitted for signs covered by this Subsection (c)
15 shall be extinguished at all times when the commercial use is not open for business.

16 (d) **Signs for Other Nonconforming Uses.** Signs for any use in an R District which is
17 nonconforming under the provisions of Sections 180 through 187 of this Code, or which is given
18 conditional use status under said sections, shall be subject to the provisions of this Subsection (e),
19 except that any such use that would first be permitted as either a principal or a conditional use in some
20 other R District under Article 2 of this Code, other than an RC District, shall be subject to the
21 provisions of Subsection 606(b) above. Any illumination permitted for signs covered by this
22 Subsection (e)(d) shall be extinguished at all times when the nonconforming use is not open
23 for business.

24 **(1) Automobile Service Stations.** The following business signs are permitted
25 for an automobile service station. Any such signs may be nonilluminated or indirectly or
directly illuminated. Directly illuminated signs may be illuminated only during open business hours.

1 (A) A maximum of two oil company signs, which shall not extend ~~more~~
2 ~~than 10 feet~~ above the roofline if attached to a building, or exceed a height of 24 feet if
3 freestanding. The area of any such sign shall not exceed 180 square feet, and along each
4 street frontage all parts of such a sign or signs that are within 10 feet of the street property line
5 shall not exceed 80 square feet in area. The areas of other permanent and temporary signs
6 as covered in Subparagraph 606~~(e)~~(d)(1)(B) below shall not be included in the calculation of
7 the areas specified in this Subparagraph.

8 (B) **Other Permanent and Temporary Signs Customarily Incidental to**
9 **the Service Station Business.** No such sign shall extend above the roofline if attached to a
10 building, or exceed a height of 12 feet if freestanding. The area of such signs shall not exceed
11 20 square feet for each such sign or a total of 80 square feet for all such signs on the
12 premises.

10 Districts as characterized by building height, bulk, and appearance, and the width of streets

13 (b) **Signs or Sign Features Not Permitted in NC and RC Districts.** Roof signs as
14 defined in Section 602.16 of this Code, wind signs as defined in Section 602.22 of this Code,
15 and signs on canopies, as defined in Section 136.1(b) of this Code, are not permitted in NC
16 and RC Districts. No sign shall have or consist of any moving, rotating, or otherwise physically

6 *(1) In November 1962, the electorate of San Francisco voted approval of an investment*
