9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Dawn Ruggeroli v. City and County of
12 San Francisco, San Francisco Superior Court, Case No. CGC-24-612680 by the payment of
13 \$275,000. The lawsuit involves an employment dispute.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 February 26, 2024, and the following parties were named in the lawsuit: plaintiff Dawn
16 Ruggeroli and defendant City and County of San Francisco.
