9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. The San Francisco Administrative Code is hereby amended by amending
11 Section 2A.250, to read as follows:


12 **SEC. 2A.250. OFFICE DEPARTMENT OF THE CHIEF MEDICAL EXAMINER.**

13 (a) The Office of the Chief Department of the Medical Examiner. There shall be an a
14 Office Department of the Chief Medical Examiner. The City Administrator with the concurrence
15 of the Mayor, shall appoint and may remove a Chief Medical Examiner who shall meet the
16 qualifications for Chief Medical Examiner as provided by state law. The Chief Medical
17 Examiner shall serve as a department head and appointing officer for the Office Department,
18 and shall succeed to all of the duties of the Coroner. The Office department shall include such
19 officers and employees as are authorized pursuant to the budgetary and fiscal provisions of
20 the Charter.

21 (b) **Duties and Functions.** The Department Office of the Chief Medical Examiner shall be
22 responsible for the duties of the Medical Examiner as provided by state law, and such other
23 duties and functions as assigned pursuant to the Charter or by ordinance.


