17 with an interest and knowledge in the elections process, and show a commitment to fair and
18 impartial elections (must also be nominated by a citizens group interested in civic participation
19 and/or fair elections), for a new four-year term (ending date to be determined via drawing);

20 Vito Corcia, new position, seat 3, must be a registered San Francisco voter with an
21 interest and knowledge in the elections process, and show a commitment to fair and impartial
22 elections, for a new four-year term (ending date to be determined via drawing);

23 Melissa Dodd, new position, seat 4, must be a registered San Francisco voter with an
24 interest and knowledge in the elections process, and show a commitment to fair and impartial
25 elections, for a new four-year term (ending date to be determined via drawing).
