5	RESOLVED, That, in accordance with the provisions of the California Vehicle
6	Code and the San Francisco Traffic Code, the following regulations governing the
7	parking of vehicles are hereby enacted or rescinded as designated below:
8	RESIDENTIAL PERMIT PARKING AREA "Z" (2-HOUR TIME LIMIT, 8 AM - 6 PM,
9	MONDAY THROUGH FRIDAY) - ESTABLISH
10	Sanchez Street, both sides, between 27th and Duncan Streets (1400 block).
11	RESIDENTIAL PERMIT PARKING AREA "W" (2-HOUR TIME LIMIT, 8 AM - 6 PM
12	MONDAY THROUGH FRIDAY) - ESTABLISH
13	York Street, west side, between 19th and 20th Streets (700 block, even addresses only); and
14 15	25 <sup>th</sup> Street, both sides, between Kansas and Rhode Island Streets (2300 block).
16	UNMETERED MOTORCYCLE PARKING - ESTABLISH
17	Dolores Street, east side, between the driveways of 401 and 405 Dolores Street (a 10-foot zone, accommodating two motorcycle parking spaces);
18	Francisco Street, south side, between the driveways of 1567-1569 ar 1573-1575 Francisco Street (8-foot zone, accommodating 2 motorcyc parking spaces); and,

21	15 <sup>th</sup> Street, north side, from Harrison Street to 7 feet easterly (2 spaces).
22	UNMETERED MOTORCYCLE PARKING – RESCIND
23	18th Street, north side, from the west property line of #3922 - 18th Street to 7 feet easterly (7-foot zone accommodating 2 motorcycle parking spaces)

1	PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH
2	Anza Street, south side, from Masonic Avenue to 500 feet westerly.
3	NO PARKING ANYTIME - ESTABLISH
4 5	Anza Street south side, at Collins Street, along the sidewalk extension.
6	TOW-AWAY, NO STOPPING - ESTABLISH
7	Evans Avenue, west side, from Napoleon Street to 100 feet northerly; and
8	Evans Avenue, east side, from Napoleon Street to 120 feet northerly.
9	TWO-HOUR PARKING TIME LIMIT, APRIL THROUGH OCTOBER, 7 AM TO 10 PM,
10	MONDAY THROUGH FRIDAY, 9 AM TO 6 PM, SATURDAY AND SUNDAY AND TWO-HOUR PARKING TIME LIMIT, NOVEMBER THROUGH MARCH, 7 AM TO 6
11	PM, MONDAY THROUGH SATURDAY - RESCIND
12	Townsend Street, south side, from 2nd Street to 27 feet westerly (rescinds the
13	ballpark hours for motorcycle parking).
14	TOW-AWAY, NO PARKING ANYTIME - ESTABLISH
15	15 <sup>th</sup> Street, south side, between Harrison Street and Treat Avenue.
16	10-MINUTE PARKING TIME LIMIT, 9 AM TO 6 PM, EVERYDAY - RESCIND
17	15 <sup>th</sup> Street, north side, from Harrison Street to 8 feet easterly.
18	20-MINUTE TIME LIMIT, 9 AM TO 6 PM, EVERYDAY – ESTABLISH
19	15 <sup>th</sup> Street, north side, from Alabama Street to 50 feet easterly.
20	13 Street, north side, north Alabama Street to 30 feet easterly.
21	Categorically exempt from Environmental Review Class 1(c)(9) changes in the traffic and
22	parking regulations where such changes do not establish a higher speed limit or result in more
23	than a negligible increase in the use of the street.
