3 **Ordinance amending the Public Works Code to enhance and modify the sidewalk**
 4 **flower stand permit program by, among other things, 1) updating and clarifying the**
 5 **applicable fees, 2) authorizing Public Works to consult with the Office of Small**
 6 **Business to identify and evaluate eligible permit applicants, 3) updating permit**
 7 **application requirements, 4) supplementing permit conditions and restrictions, 5)**
 8 **establishing minimum operating hours of 35 hours per week, 6) requiring permittees to**
 9 **be present at sidewalk flower stands for at least 50% of the applicable hours of**
 10 **operation and to dedicate a minimum of 75% of the sidewalk flower stand for the sale**
 11 **or storage of certain eligible flowers and plants, 7) prohibiting the leasing or sub-**
 12 **leasing of sidewalk flower stands, and 8) prohibiting the sale, assignment, inheritance,**
 13 **or transfer of flower stand permits; amending the Police Code to authorize Public**
 14 **Works to impose, assess, and collect administrative penalties; and affirming the**
 15 **Planning Department's determination under the California Environmental Quality Act.**

21 Be it ordained by the People of the City and County of San Francisco:

22

23 Section 1. Environmental Findings.

24 The Planning Department has determined that the actions contemplated in this
 25 ordinance comply with the California Environmental Quality Act (California Public Resources

1 Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of
2 Supervisors in File No. 260133 and is incorporated herein by reference. The Board affirms
3 this determination.

4
5 Section 2. General Background and Findings.

6 (a) Once home to dozens of sidewalk flower stands, San Francisco now has four
7 active sidewalk flower stands while twelve sidewalk flower stand locations within the nine
8 “Street Flower Market” areas identified in Article 5 of the Public Works Code remain inactive
9 and available for operation.

10 (b) Sidewalk flower stands provide unique retail opportunities for small businesses to
11 bring commercial vibrancy and seasonal cheer to key downtown locations for the enjoyment
12 of workers, residents, and visitors alike. In addition, active and operational sidewalk flower
13 stands will help revitalize downtown.

14 (c) This ordinance makes amendments to the sidewalk flower stand permit program
15 that will help activate sidewalk flower stand locations that currently sit empty and appear to be
16 abandoned. This ordinance amends the Public Works Code to streamline, simplify, and
17 strengthen the process of activating sidewalk flower stands, and authorizes the Department of
18 Public Works to issue sidewalk flower stand permits and to collaborate with the Office of Small
19 Business to identify and evaluate qualified and eligible sidewalk flower stand permittees to
20 operate flower stands. In addition, the amendments clarify and expand the categories and
21 types of flowers, plants, and accessories that may be sold at a sidewalk flower stand.

22
23 Section 3. The Public Works Code is hereby amended by revising Article 2.1, Section
24 2.1.1 and Article 5, Sections 155, 156, 157, 159, 161, 162, and 163, and deleting Section 160,
25 to read as follows:

1 **SEC. 2.1.1. FEES.**

2 Notwithstanding the permit fee provisions listed elsewhere in this Code, the permit fee
3 and assessment schedule for the permit categories and uses specifically listed below shall be:

4 (a) ~~Sidewalk Street~~ Flower ~~Stand~~ Market Permit pursuant to Article 5 (Sections 155 et
5 seq.): \$1,299 permit application fee plus an annual public right-of-way occupancy assessment fee per
6 square foot of occupied space (initial fees); \$1,299 permit renewal fee plus an annual public right-of-
7 way occupancy assessment fee per square foot of occupied space (annual renewal fees) ~~\$103.36~~
8 administrative fee and inspection fee of \$6.75 per square foot of occupancy;

9 * * * *

10
11 **SEC. 155. DESIGNATION OF LOCATIONS—~~PROVISO.~~** Sidewalk flower ~~vending~~
12 stands shall be located within the following designated street flower market areas upon the
13 sidewalks of the City and County of San Francisco ~~at the curb or building line.~~

14 * * * *

15 **The Market Street and 5th ~~Emporium~~ Street Flower Market**

16 On the south sidewalk of Market Street facing the location of 835 Market Street.

17 * * * *

18
19 **SEC. 156. AUTHORITY TO ISSUE PERMITS.**

20 The Director of Public Works is hereby authorized and empowered to issue permits for
21 the maintenance of sidewalk flower ~~vending~~ stands at the locations specified in Section
22 155 of this Article ~~5, subject to the proviso contained in said Section 155.~~ In considering the
23 issuance of sidewalk flower ~~vending~~ stand permits and in prescribing the location of such
24 stands within the areas set forth in Section 155 ~~of this Article,~~ the Director of Public Works
25 shall give due regard to the conveniences and necessities of the owners, occupants, or

1 tenants of offices, stores, or shops in the vicinity and nearby residents. In consultation with the
2 Office of Small Business, the Department of Public Works (the “Department”) shall also consider the
3 unique needs and qualifications of small businesses in San Francisco.

4 **SEC. 157. APPLICATION FOR PERMIT.**

5 Each application for a sidewalk flower ~~vending~~ stand permit shall include all information
6 that the Department requires including but not limited to the applicant’s ~~state~~ the name, phone number,
7 email address, mailing address, physical address, and Proof of Identity, as defined in Administrative
8 Code Section 95.2, as may be amended from time to time of the applicant therefor as well as the names
9 of the individuals to be employed by or engaged with the applicant in displaying or selling flowers at
10 said flower vending stand.

11 **SEC. 159. PERMIT—PERMIT FEE.**

12 No person or business, firm or corporation shall operate, maintain, or conduct business in any
13 sidewalk flower ~~vending~~ stand in the City and County of San Francisco without first obtaining a
14 permit to so do, along with any other required permits and paying the fees for said permit in
15 accordance with the provisions of this Article. The fee for any such permit shall be \$100 per quarter
16 year, commencing on the first day of July, 1981, and in addition to said quarterly fee herein provided
17 for, each permittee shall pay a quarterly fee of \$30 for each employee employed in and about said
18 sidewalk flower vending stands. When any application for a permit for a sidewalk flower stand-
19 vending permit shall be granted by the Director of Public Works, the same permit shall be
20 issued delivered to the permittee only upon the payment of the initial fees set forth in Section 2.1.1 of
21 this Code. first quarter’s permit fee due thereon, and the payment of the same shall be endorsed on
22 said permit, and said P permittee shall thereafter pay annually quarterly, in advance, the renewal
23 permit fees set forth in Section 2.1.1 herein provided for, and on the failure to so do, said permit
24 may be revoked by the Director of Public Works.

1 **SEC. 160. [RESERVED] NO OTHER FEE OR PEDDLER'S LICENSE.**

2 *The permit fees provided for in Section 159 of this Article shall be the only fees charged for the*
3 *privilege of maintaining said sidewalk flower vending stands or for displaying or selling flowers*
4 *thereat. No peddler's license shall be required for such permittees or for any other person employed in*
5 *and about the conduct of said sidewalk flower vending stands.*

6 **SEC. 161. PERMIT CONDITIONS AND RESTRICTIONS.**

7 The issuance of permits and licenses and the maintenance of sidewalk flower ~~vending~~
8 stands by the persons granted permits hereunder shall be subject to and comply with all of the
9 following conditions and restrictions:

10 (a) No permanent stands of any kind shall be erected on the sidewalks of said
11 locations; the permittee of each sidewalk flower stand shall be solely responsible for the costs of
12 installing, repairing, modifying, and removing the permittee's sidewalk flower stand. The permittee
13 shall be billed and shall pay for any costs incurred by the City to remove the permittee's sidewalk
14 flower stand.

15 (b) The design and construction of all sidewalk flower ~~vending~~ stands placed at the
16 locations designated in Section 155 of this Article 5 and the maintenance of said stands shall
17 be subject to the approval of the Director of Public Works; provided, that no such flower-
18 ~~vending~~ stand shall exceed the following dimensions, ~~to-wit:~~ 10 feet in length and three feet in
19 width, and any person, ~~firm~~ or business corporation having a permit to maintain and operate a
20 sidewalk flower ~~vending~~ stand as provided in Sections 155 to 162 of this Article may maintain
21 and operate a stand ~~not~~ exceeding 10 feet in length and three feet in width, and provided that no
22 part of the permittee's flower vender's display or activities may take place in ~~outside of~~ an area
23 that exceeds five feet in width and 20 feet in length.

24 (c) No more than one sidewalk flower ~~vending~~ stand shall be granted a permit to
25 operate at any one of the locations designated in Section 155.

1 (d) No more than two persons shall at any given time be engaged or employed in
2 displaying or selling flowers at any stand. The permittee shall be present at the sidewalk flower
3 stand for at least 50%; provided, that for a substantial portion of time during the sidewalk flower
4 stand's hours of operation of any stand, one of said persons engaged in displaying or selling flowers
5 thereat shall be the person to whom the permit to operate said stand is issued; provided, however, that
6 if the permit is issued to a firm or corporation, one of said persons engaged in displaying or selling
7 flowers for a substantial portion of the time said stand is operated shall be an officer or partner of said
8 firm or corporation.;

9 (e) Measured by the percentage of the footprint of the sidewalk flower stand that is occupied by
10 the specified merchandise or the vessels containing such merchandise, a minimum of 75% of the square
11 footage of the footprint of each sidewalk flower stand shall be dedicated to the storage or sale of ~~Only~~
12 cut flowers, floral arrangements, evergreens, potted flowers or plants, shrubs, and wearable flowers
13 (together "Eligible Flowers and Plants"), and a maximum of 25% of the square footage of the footprint
14 of each sidewalk flower stand shall be dedicated to the storage or sale of accessories related to Eligible
15 Flowers and Plants. corsages ~~Only Eligible Flowers and Plants and related accessories~~ shall be
16 displayed or sold at any stand, and no display, sale, or orders for the sale ~~and/or~~ delivery of
17 Eligible Flowers and Plants floral arrangements, potted plants, or shrubs shall be made, taken,
18 received or solicited, at any stand, or by the permittees, owners, or operators thereof.;

19 (f) No rubbish, ~~or~~ cuttings, or debris resulting from the operation of the sidewalk flower stand
20 shall be deposited in any public waste container.;

21 (g) Each sidewalk flower stand shall operate for a minimum of 35 hours per week. No
22 sidewalk flower stand shall be operated between the hours of 9:00 p.m. and 7:00 a.m., and the
23 sidewalk and street surrounding each stand shall be kept free of rubbish, cuttings, or debris
24 resulting from the operation of the stand.;

1 (h) ~~No permit shall be issued to any person unless he or she has been a resident of the City and~~
2 ~~County of San Francisco for a period of one year prior to his or her application for a permit~~
3 ~~hereunder;~~

4 ~~(i) No owner, landlord, lessee, or occupant of any premises in the block occupied by a~~
5 ~~sidewalk flower-vending stand as provided for herein, and no permittee, shall receive rent or any~~
6 ~~remuneration directly or indirectly for the space occupied by such sidewalk flower-vending~~
7 ~~stand or its operation;~~

8 ~~(i) No individual shall be issued a permit for more than one sidewalk flower stand. Each~~
9 ~~permittee shall be prohibited from leasing or sub-leasing any sidewalk flower stand;~~

10 (j) Each person operating a sidewalk flower-vending stand under a permit as herein
11 provided for, shall at all times carry and maintain at the permittee's own cost and expense a
12 policy of liability insurance ~~that is satisfactory to the City's Risk Manager in the minimum amount of~~
13 ~~\$500,000 single limit applying to bodily injuries, personal injuries and property damage.~~ Said policy
14 shall directly protect the City and County of San Francisco, including by designating its officers,
15 ~~and~~ employees, and agents as named insureds, and shall provide that the insurance will
16 operate as primary insurance and no other insurance effected by the City will be called on to
17 contribute to a loss covered by said policy. ~~Permittee~~Said policy shall provide 30 days' notice
18 of cancellation or material change to the Director of Public Works ~~of the City and County of San~~
19 ~~Francisco.~~ Said policy shall be approved in writing by the Director of Public Works ~~and the City~~
20 ~~Attorney of the City and County of San Francisco.~~ A copy of the policy and the certificate shall be
21 filed with the Director of Public Works;

22 ~~(k) Within 48 hours of the removal of a sidewalk flower stand, the permittee shall restore the~~
23 ~~sidewalk to a condition acceptable to the Director of Public Works. The permittee shall be billed and~~
24 ~~shall pay for any costs incurred by the City to remove the permittee's sidewalk flower stand.~~

1 ~~(l)~~ In addition, ~~T~~he permittee shall agree to hold harmless, defend, and indemnify the
2 City and County of San Francisco, including, without limitation, each of its commissions,
3 departments, its officers, agents, and employees from and against all losses, liabilities, expenses,
4 actions, claims, demands, injuries, any damages, fines, penalties, suits, costs, and/or judgments,
5 including, without limitation, attorneys' fees and costs (collectively, "Claims") ~~or injury~~ caused by
6 reason of the placement, ~~or~~ maintenance, repair, operation, and/or removal of the sidewalk
7 ~~flower-vending stand on the sidewalk,~~ and the permittee shall be solely liable for any
8 Claims ~~damage or loss, claims, injury and liability of every kind, nature and description directly or~~
9 ~~indirectly arising from said activity~~ caused by reason of the installation, maintenance, repair,
10 operation, and/or removal of the sidewalk flower stand and the permittee shall be solely liable for any
11 Claims occasioned by any act or neglect in respect to the installation, maintenance, repair, operation,
12 and/or removal of the sidewalk flower stand. Approval of insurance shall in no way relieve the
13 permittee ~~operator~~ from liability under this hold harmless ~~hold harmless~~ clause.

14 ~~(m)~~ There shall be no liability on the City or upon any of its officers, agents, or
15 employees for any damage sustained by the permittee, employee, owner, or operator of any
16 sidewalk ~~flower-vending~~ stand from any cause whatsoever, no matter whether said damage be
17 caused by an officer, agent, or employee of the City or by any other person;

18 ~~(n)~~ No flower stand permit shall be sold, assigned, inherited, or otherwise transferred. An
19 assignment or sale of a flower stand permit, without the approval of the Board of Supervisors, is
20 prohibited; provided, however, that in the event of the death of a permittee, his or her permit shall be
21 considered to be assigned to a living member of the deceased permittee's immediate family. In the
22 event that a sidewalk flower stand location ceases to have a permittee, Public Works may elect to issue
23 a permit to an eligible applicant in consultation with the Office of Small Business. Provided further,
24 however, that such living member of a deceased permittee's immediate family must thereafter
25 personally operate the flower-vending stand within six months from the date of the distribution of the

1 ~~proceeds of the deceased permittee's estate or, with the approval of the Board of Supervisors, sell the~~
2 ~~permit within said six-month period.~~

3 ~~For the purposes of this Subparagraph (l), the term "immediate family" shall be limited to the~~
4 ~~children, grandchildren, spouse, co-habitant, parent, brother, sister, or child of a deceased brother or~~
5 ~~sister of a deceased permittee.~~

6 ~~An individual shall be considered a "co-habitant" if he or she resided with the permittee, shared~~
7 ~~the common necessities of life with the permittee, was not married to or related by marriage to the~~
8 ~~permittee, was the permittee's sole co-habitant, and is over 18 years of age.~~

9 ~~An individual claiming a right to a permit as co-habitant under this Subparagraph (l) shall have~~
10 ~~resided with the permittee, and been a resident of the City and County of San Francisco, for a period of~~
11 ~~one year prior to the assignment or sale of said permit.~~

12 **SEC. 162. SUSPENSION, MODIFICATION, OR REVOCATION OF PERMIT; APPEAL**
13 **OF PERMITTING DECISIONS.**

14 ~~(a) The permitteeoperator of any sidewalk flower-~~vending~~ stand, licensed hereunder, who~~
15 ~~shall violate any of the restrictions and conditions set forth in Section 161 of this Article 5, or~~
16 ~~any rule or regulation of the Director of ~~the Department of~~ Public Works adopted pursuant to~~
17 ~~pursuance of the provisions of Section 158 of this Article, shall be subject to the suspension or~~
18 ~~revocation of ~~the~~this permit by said Director.~~

19 ~~(b) The Director is authorized to initiate proceedings to suspend or revoke the permit for any~~
20 ~~reason including but not limited to the permittee's failure to comply with any of the permit's conditions~~
21 ~~of approval; the sidewalk flower stand poses a threat to public safety, health, or welfare; or all or a~~
22 ~~portion of the public right-of-way on which the sidewalk flower stand is located, or a portion of public~~
23 ~~right-of-way near a sidewalk flower stand, is required for a different public purpose.~~

24 ~~(c) To initiate revocation proceedings, or to suspend or modify a permit, the Director shall~~
25 ~~provide the permittee with written notification, to the permittee's address on file with the Department,~~

1 of the time and date of a public hearing to consider the grounds stated in the written notification for
2 revoking, suspending, or modifying the permit. Following the public hearing, the Director may issue
3 an order revoking, suspending, or modifying the permit. If the failure to comply with the conditions of
4 approval poses an imminent threat to public safety, health, or welfare, the Director shall immediately
5 suspend the permit pending a final decision to revoke, suspend, or modify the sidewalk flower stand
6 permit. The Director's modification, revocation, or suspension of a permit may be appealed under
7 subsection (c). Following the final decision of the Director or the Board of Supervisors, if applicable,
8 to revoke the permit, the former permittee shall remove the sidewalk flower stand and restore the public
9 right-of-way to a condition satisfactory to the Director. Any restoration shall be performed at the sole
10 and absolute expense of the former permittee.

11 (d) Within 15 days following the Director's approval, denial, or revocation of a permit, any
12 person may file a notice of appeal with the Clerk of the Board of Supervisors. Pending a decision by
13 the Board of Supervisors, the Director's decision to approve, deny, modify, or revoke a permit shall be
14 suspended. The Board of Supervisors may affirm, reverse, or modify any permit decision made by the
15 Director under the provisions of this Article 5. The decision by the Board of Supervisors is final.

16
17 **SEC. 163. VIOLATIONS ~~A MISDEMEANOR.~~**

18 Any ~~person, firm or corporation~~ violation ~~g~~ any of the provisions of this Article 5 or any
19 ~~lawful~~ rule or regulation adopted pursuant thereto shall be deemed a public nuisance subject to
20 enforcement actions pursuant to Administrative Code Chapter 100, which is hereby incorporated in its
21 entirety, Administrative Code Chapter 80, and Police Code Section 39-1 ~~guilty of a misdemeanor.~~

22
23 Section 4. The Police Code is hereby amended by revising Article 1, Section 39-1 to
24 read as follows:
25

1 **SEC. 39-1. PROCEDURE FOR ASSESSMENT AND COLLECTION OF**
2 **ADMINISTRATIVE PENALTIES FOR SPECIFIED LITTERING AND NUISANCE**
3 **VIOLATIONS.**

4 (a) This Section 39-1 shall govern the imposition, assessment, and collection of
5 administrative penalties imposed pursuant to Sections 37, 38, and 63 of the Police Code;
6 Sections 41.13, 283.1, 287, 288.1 and 600 of the Health Code; Sections 163, 170, 173, 174,
7 174.2, 723, 723.5, 724.5, 794, and 1606 of the Public Works Code; and Section 22G.4 of the
8 Administrative Code.

9
10 Section 5. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors
11 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,
12 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal
13 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment
14 additions, and Board amendment deletions in accordance with the “Note” that appears under
15 the official title of the ordinance.

16
17 Section 6. Effective Date. This ordinance shall become effective at 12:00 a.m. on the
18 31st day after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor
19 returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it,
20 or the Board of Supervisors overrides the Mayor’s veto of the ordinance.

LEGISLATIVE DIGEST

[Public Works, Police Codes - Sidewalk Flower Stand Permits]

Ordinance amending the Public Works Code to enhance and modify the sidewalk flower stand permit program by, among other things, 1) updating and clarifying the applicable fees, 2) authorizing Public Works to consult with the Office of Small Business to identify and evaluate eligible permit applicants, 3) updating permit application requirements, 4) supplementing permit conditions and restrictions, 5) establishing minimum operating hours of 35 hours per week, 6) requiring permittees to be present at sidewalk flower stands for at least 50% of the applicable hours of operation and to dedicate a minimum of 75% of the sidewalk flower stand for the sale or storage of certain eligible flowers and plants, 7) prohibiting the leasing or sub-leasing of sidewalk flower stands, and 8) prohibiting the sale, assignment, inheritance, or transfer of flower stand permits; amending the Police Code to authorize Public Works to impose, assess, and collect administrative penalties; and affirming the Planning Department’s determination under the California Environmental Quality Act.

Existing Law

Currently, the Department of Public Works regulates Street Flower Market permits under Article 5 of the Public Works Code. Article 5 identifies nine “Street Flower Market” areas where a total of 16 sidewalk flower-vending stands have been installed on City sidewalks and are eligible to be operated by one permittee per stand.

Amendments to Current Law

This ordinance would amend the Public Works Code to enhance and modify the sidewalk flower stand permit program by implementing the changes described below. The ordinance would:

- Clarify and update the applicable fees, which would consist of an initial permit application fee of \$1,299 and, thereafter, an annual permit renewal fee of \$1,299; these fees cover the administrative costs of the program. In addition, permittees would pay an annual right-of-way occupancy fee for the use of the sidewalk.
- Authorize Public Works to consult with the Office of Small Business, which will assist with the identification and evaluation of eligible permit applicants.
- Update permit application requirements.

- Supplement and update permit conditions and restrictions, including requiring permittees to be solely responsible for the costs of installing, repairing, modifying, and removing the permittee's sidewalk flower stand.
- Require a permittee to restore the sidewalk to a condition acceptable to the Director of Public Works, if a permittee were to remove a sidewalk flower stand.
- Establish minimum operating hours of 35 hours per week.
- Require permittees to be present at sidewalk flower stands for at least 50% of the applicable hours of operation and to dedicate a minimum of 75% of the sidewalk flower stand for the sale or storage of certain eligible flowers and plants.
- Prohibit the leasing or sub-leasing of sidewalk flower stands.
- Prohibit the sale, assignment, inheritance, or transfer of flower stand permits.
- Authorize the Department of Public Works to impose, assess, and collect administrative penalties for permit violations.
- Remove the designation of permit violations as misdemeanors.

This ordinance would amend the sidewalk flower stand permit program to better equip the Department of Public Works and the Office of Small Business to activate sidewalk flower stand locations that are currently underutilized.

On February 23, 2026, the Small Business Commission (the Commission) heard BOS File 260133 - Sidewalk Flower Stand Permits. The legislation establishes an updated permit process for existing flower stands in the downtown area. The updated process will allow new operators to use the flower stands with low-cost permit fees.

The Commission noted that flower stands have added to the vibrancy of downtown streets, but in recent years the stands have gone vacant. Commissioners agreed that a simplified permit process with a low barrier to entry would support greater foot traffic. The Commission voted to support this legislation with four aye votes and three absences. Please feel free to contact me should you have any questions.



If this legislation passes, the Sidewalk Flower Stand Permit fee would increase from an administrative fee of \$103.36 and inspection fee of \$6.75 per square foot of occupancy to a \$1,299 permit application fee plus an annual public right-of-way occupancy assessment fee per square foot of occupied space as an initial fee; with annual renewal fees of \$1,299 permit plus an annual public right-of-way occupancy assessment fee per square foot of occupied space.

On behalf of the Alliance for a Better District 6, we write in strong support of **Board of Supervisors File 260133**, the ordinance to modernize the sidewalk flower stand permit program in downtown San Francisco.

As an organization dedicated to improving the quality of urban life in District 6—San Francisco's vibrant downtown core—we have long advocated for policies that empower small businesses, activate underused public spaces, and enhance the pedestrian experience in our neighborhood. The historic sidewalk flower stands, once iconic features along streets like Market, Powell, and near Union Square, have unfortunately sat vacant in recent years, contributing to a diminished sense of vitality and reduced foot traffic in an area that thrives on small-scale commerce and visual appeal.

We strongly endorse the proposed updates to the Public Works Code, including clarifying and lowering permit fees to create a truly low barrier to entry, simplifying the application process, expanding eligibility to allow new operators (beyond family inheritance), and establishing clear operating requirements to ensure active use for selling flowers and plants. By authorizing the Office of Small Business to assist in identifying and evaluating eligible applicants, while prohibiting the leasing or transfer of permits to prevent speculation, this legislation provides a balanced, practical pathway for more small business owners to enter the market and revive these locations.

The Small Business Commission has already voted to support this measure (four aye votes), affirming that a streamlined, accessible permit process will encourage greater

activation of the stands, support entrepreneurial opportunities, and bring renewed color, fragrance, and energy to our streets. In District 6, where small businesses are essential to economic recovery and community character, this low-cost initiative represents an important step toward fostering more diverse small business ownership and helping downtown reclaim its lively, welcoming atmosphere.

We urge the Board to pass File 260133 without delay. Revitalizing these flower stands will deliver tangible benefits for residents, visitors, and aspiring entrepreneurs alike, aligning directly with our mission to build a stronger, more dynamic District 6.

Ordinance amending the Public Works Code to enhance and modify the sidewalk flower stand permit program by, among other things, 1) updating and clarifying the applicable fees, 2) authorizing Public Works to consult with the Office of Small Business to identify and evaluate eligible permit applicants, 3) updating permit application requirements, 4) supplementing permit conditions and restrictions, 5) establishing minimum operating hours of 35 hours per week, 6) requiring permittees to be present at sidewalk flower stands for at least 50% of the applicable hours of operation and to dedicate a minimum of 75% of the sidewalk flower stand for the sale or storage of certain eligible flowers and plants, 7) prohibiting the leasing or sub-leasing of sidewalk flower stands, and 8) prohibiting the sale, assignment, inheritance, or transfer of flower stand permits; amending the Police Code to authorize Public Works to impose, assess, and collect administrative penalties; and affirming the Planning Department's determination under the California Environmental Quality Act.
