[Encroachment Permit - Hidden Garden Tiled Steps Project - 16th Avenue between Kirkham and Lawton Streets1

Resolution granting revocable permission to The Hidden Garden Steps Organizing Committee to occupy a portion of the public right-of-way to install and maintain a mosaic tiled mural on the risers, and non-slip paving tiles on the treads of the existing City concrete stairway, and a garden habitat adjacent to the existing concrete City stairway, along 16th Avenue between Kirkham and Lawton Streets; accepting as a gift to the City said tiled steps, garden habitat, and a \$20,000 maintenance fund for the tiled steps; and making findings of consistency with the General Plan, and the eight priority policies of Planning Code, Section 101.1.

WHEREAS, Pursuant to Public Works Code Section 786, permission was requested by The Hidden Garden Steps Organizing Committee to occupy a portion of the public right-ofway to install a mosaic tiled mural on the risers and non-slip paving tiles on the treads of the existing City concrete stairway, a garden habitat adjacent to the existing concrete City stairway along 16th Avenue between Kirkham and Lawton Streets, as shown on the permit plans. The Hidden Garden Steps Organizing Committee has also offered as a gift to the City and County of San Francisco, the tiled steps project, the associated landscaping and a \$20,000 maintenance fund for the tiled steps. Copies of the permit plans and The Hidden Garden Steps Organizing Committee's gift offer are on file in the office of the Clerk of the Board of Supervisors in File No. 130979 and are incorporated herein by reference; and

WHEREAS, The Transportation Advisory Staff Committee (TASC) at its meeting of January 10, 2013, recommended approval of the proposed tiled steps and landscaping improvements; and

WHEREAS, The Planning Department, by letter dated February 8, 2013, determined that the proposed improvements are in conformity with the General Plan and with the eight priority policies of Planning Code, Section 101.1. A copy of said letter is on file with the Clerk of the Board of Supervisors in File No. 130979 and is incorporated herein by reference; and

WHEREAS, The San Francisco Arts Commission by Resolution No. 0206-12-026 approved the design of the Hidden Garden Steps project, and a tile mural by Aileen Barr and Colette Crutcher at 16th Avenue at Kirkham Street. A copy of said Resolution is on file with the Clerk of the Board of Supervisors in File No. 130979 and is incorporated herein by reference; and

WHEREAS, After a duly noticed public hearing on April 17, 2013, the Department of Public Works by Order No. 181272, approved May 9, 2013, recommended approval of the proposed encroachments. A copy of said Order is on file with the Clerk of the Board of Supervisors in File No. 130979 and is incorporated herein by reference; and

WHEREAS, The permit and associated encroachment agreement (the "Encroachment Agreement") shall not become effective until:

- (a) The Permittee executes and acknowledges the permit and delivers said permit to the City's Controller;
- (b) Permittee delivers to the City Controller a policy of insurance provided for in said agreement and the Controller shall have had approved the same as complying with the requirement of said agreement. The Controller may, in his discretion, accept, in lieu of said insurance policy, the certificate of an insurance company certifying to the existence of such a policy; and
- (c) The City Controller records the permit and associated agreement in the office of the County Recorder; and

WHEREAS, The Encroachment Agreement is attached to the permit as Exhibit A. Copies of said Permit and the Agreement are on file with the Clerk of the Board of Supervisors in File No. 130979 and are incorporated herein by reference; and

WHEREAS, The Permittee, at the Permittee's sole expense and as is necessary as a result of this permit, shall make the following arrangements:

- (a) To provide for the support and protection of facilities belonging to the Department of Public Works, San Francisco Public Utilities Commission, the San Francisco Fire Department and other City Departments, and public utility companies; and
- (b) To remove or relocate such facilities and provide access to such facilities for the purpose of constructing, reconstructing, maintaining, operating, or repairing such facilities; and

WHEREAS, The Permittee shall procure the necessary permits from the Central Permit Bureau, Department of Building Inspection, Department of Public Works Bureau of Street-Use and Mapping, or both, and pay the necessary permit fees and inspection fees before starting work; and

WHEREAS, No structure shall be erected or constructed within the subject street rightof-way except as specifically permitted herein; and

WHEREAS, The Department of Public Works recommends that the Board accept the tiled steps and garden habitat, along with a \$20,000 maintenance fund as a gift to the Department of Public Works on behalf of the City and County of San Francisco upon completion of the permit work. The Department further recommends that upon completion, inspection, and approval of the permit work, the maintenance requirements set forth herein shall become the responsibility of the Department of Public Works, and the Permittee shall be released from any duty or obligation whatsoever under the Encroachment Agreement,

including without limitation, any and all indemnification, liability, and insurance obligations provided for therein (the "Encroachment Agreement Release"); and,

WHEREAS, Notwithstanding the Encroachment Agreement Release, after Department of Public Works final inspection and approval of the permit work, the Permittee, as part of the gift offer to the City, agrees to establish a \$20,000 fund for the purpose of maintaining the tiled steps project until such funds have been fully depleted; now, therefore be it;

RESOLVED, That pursuant to Public Works Code Section 786, the Board of Supervisors hereby approves permission, revocable at the will of the Director of the Department of Public Works, to The Hidden Garden Steps Organizing Committee to occupy a portion of the public right-of-way to install a mosaic tiled mural on the risers and non-slip paving tiles on the treads of the existing City concrete stairway and a garden habitat adjacent to the existing concrete City stairway along 16th Avenue between Kirkham and Lawton Streets; and, be it

FURTHER RESOLVED, The Board of Supervisors hereby accepts as a gift to the City and County of San Francisco the offer from The Hidden Garden Steps Organizing Committee for said tiled steps project and garden habitat along with a \$20,000 maintenance fund as set forth in the conditions that the Department of Public Works recommended; and, be it

FURTHER RESOLVED, That this Board finds the permit to be consistent with the General Plan and priority policies of Planning Code Section 101.1 for the reasons set forth in the City Planning Department letter.
