9 Be it ordained by the People of the City and County of San Francisco:


10 Section 1. Pursuant to Charter section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Sean Alexander Hold v. City and  
12 County of San Francisco, et al., United States District Court for the Northern District of  
13 California, Case No. C14-5814 CW, by the payment of \$210,000.

14 Section 2. The above-named action was filed in the United States District Court for the


