

1 [Sewer Emergency]

2 APPROVING THE EXPENDITURE OF FUNDS FOR THE EMERGENCY WORK TO REPLACE  
3 THE STRUCTURALLY INADEQUATE SEWER IN SPRUCE STREET FROM SACRAMENTO  
4 STREET TO CALIFORNIA STREET.

5 WHEREAS, On March 10, 1998, Sewer Operations of the Public Utilities Commission identified  
6 an emergency condition on Spruce Street from Sacramento Street to California Street; and,

7 WHEREAS, The existing sewer had failed, and immediate replacement was required in order to  
8 protect the health, welfare, and property of the Citizens of San Francisco; and,

9 WHEREAS, DPW's Bureau of Engineering prepared the Plans and Specifications for Contract  
10 No. CW-172, "Spruce Street Emergency Sewer Replacement" to replace the existing 12-inch diameter  
11 sewer in Spruce Street from Sacramento Street to California Street; and,

12 WHEREAS, The Contractor, Harty Pipelines, Inc. began the emergency work on March 19, 1998  
13 and completed it on April 9, 1998; and,

14 WHEREAS, The cost of the work is estimated to be \$78,151.74, of which \$55,501.74 is for the  
15 Construction Contract. Funds are available from the R&R Fund (Fund 5C/CPF/R&R, FAMIS Project  
16 No. CENRNR961, Job Order No. 1595N); and,

17 WHEREAS, Because this was an emergency contract, HRC subcontracting goals were not  
18 established by the HRC Contract Compliance Officer assigned to monitor the sewer Repair and  
19 Replacement Program; and,

20 WHEREAS, The Public Utilities Commission, in accordance with the provisions of Section 6.30  
21 of the Administrative Code of the City and County of San Francisco, declared the existence of an  
22 emergency; now, therefore, be it

23 RESOLVED, That this Board of Supervisors hereby approves the expenditure of funds for the  
24 emergency work to replace the structurally inadequate sewer in Spruce Street from Sacramento Street to  
25 California Street.
