8 WHEREAS, The recruitment and retention of qualified public school teachers is a
9 benefit to the children of San Francisco; and,

10 WHEREAS, Government agency surveys indicate that 40% to 90% of Bay Area
11 teacher attrition is attributable to high housing costs; and,

12 WHEREAS, The San Francisco Unified School District and the United Educators of
13 San Francisco agree that the development of an SFUSD Educator Affordable Housing
14 Plan would be beneficial to the SFUSD staff; and,

15 WHEREAS, The San Francisco Unified School District and the United Educators of
16 San Francisco do not have expertise in the development of housing policies; and,

17 WHEREAS, The San Francisco Unified School District and the United Educators of
18 San Francisco need the assistance of City staff experienced in the policy development of
19 Affordable Housing programs; now, therefore, be it

20 RESOLVED, That the Board of Supervisors urges the Mayor to direct the Mayor's
21 Office of Housing to assign an appropriate staff member to provide guidance, counseling and
22 assistance to the Advisory Committee on Educator Housing being formed by the San
23 Francisco Unified School District and the United Educators of San Francisco.


