Conditions: (1) Sales and service of alcoholic beverages shall be permitted only between the hours of 10:00 a.m. and 9:00 p.m. each day of the week; (2) No wine shall

be sold with an alcoholic content greater than 15% by volume except for "Dinner Wines" which have been aged two years or more and maintained in corked bottles; (3) Beer, malt beverages, and wine coolers in containers of 12 oz. or less cannot be sold by single containers, but must be sold in manufactured pre-packaged multi-unit quantities; and (4) The petitioner shall be responsible for maintaining free of litter the area in front of and adjacent to the premises over which they have control.
