3 **Resolution authorizing the Airport Commission to retroactively accept and expend**
4 **funding in a total amount of \$350,500 from the Transportation Security Administration**
5 **("TSA") for the Airport K-9 Explosives Detection Team Program.**

7 WHEREAS, The Airport utilizes canine (K-9) teams to detect explosives at the Airport;
8 and,

10 WHEREAS, The Airport K-9 Explosives Detection Team Program incurs expenses for
11 handler salaries, handler overtime, handler uniforms (laundry), K-9 food, K-9 veterinary care
12 (medications), K-9 kenneling, vehicles, vehicle care and maintenance, handler training/travel,
13 explosives training/travel, and in costs associated with the deployment of Airport K-9 team(s)
14 in support of the Secure Automated Inspection Lane (SAIL II) Project; and

16 WHEREAS, The Airport will be reimbursed by the TSA \$350,500 for the Airport K-9
17 Explosives Detection Team Program expenses incurred at AIRPORT; and

19 WHEREAS, The grant does not require ASO amendment, and grant terms prohibit
20 including indirect costs in the grant budget; and

22 WHEREAS, The Airport Commission approved the acceptance and expenditures of the
23 TSA K-9 Explosives Detection Team Program grant pursuant to Resolution No. 08-0050,
24 dated March 4, 2008, now, therefore, be it


26 **RESOLVED**, That this Board of Supervisors hereby authorizes the Airport to accept


