16 ending March 1, 2007.

17 Sharon Brunn, succeeding herself, term expired, seat 3, must be a consumer at-large  
18 over the age of 55, for the unexpired portion of a three-year term ending March 1, 2008.

19 Kelly Dearman, succeeding June Keller, term expired, seat 6, must be a member of the  
20 Human Services Commission, recommended to the Board by the Commission, for the  
21 unexpired portion of a three-year term ending March 1, 2006.

22 Rosie Byers, new appointment, seat 12, must be a member representing the  
23 bargaining unit of the union that represents IHSS independent providers, for the unexpired  
24 portion of a three-year term to be determined.
