10 WHEREAS, The Community United Against Violence has established and will
11 maintain networks of persons to safeguard neighborhoods, conduct workshops on personal
12 safety, self-defense and property protection, and, under the direction of the Victim Witness
13 Assistance Program, helps victims and witnesses to cooperate with the criminal justice
14 system in prosecution of the guilty and alleviation of their own injuries; and

16 WHEREAS, The electorate of the City and County of San Francisco passed
17 Proposition J in November 1976 adding Section 8.300-1 to the Charter allowing City
18 Departments to contract with private companies for specific services which can be
19 practically performed for a lower cost than similar work by City and County employees;

22 WHEREAS, The Office of the District Attorney has sought and received estimates
23 from private contractors and wishes to contract for these services, and the Controller has
24 certified on November 30, 1999, that said services can be performed at a lower cost in the
25 City and County by a private contractor than by employees of the City and County; now,


