8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. The City Attorney is hereby authorized to settle the action entitled
10 "Kouremetis v. City and County of San Francisco, et al.", United States District Court for the
11 Northern District of California, Case No. C02-02980 MEJ, by payment of \$95,000. The sum
12 shall be allocated as follows: a) \$31, 439.70 for back wages; and b) \$63,560.30 for general
13 damages for personal injury, attorney's fees and costs.

14 Section 2. The above-named action was filed in San Francisco Superior Court on May
15 13, 2002, and removed to United States District Court for the Northern District of California,
16 Case No. C02-02980 MEJ. The following parties were named in the lawsuit: Poppie
17 Kouremetis, plaintiff; City and County of San Francisco, defendant.


