APPROVING THE EXPENDITURE OF FUNDS FOR THE EMERGENCY WORK TO REPLACE THE STRUCTURALLY INADEQUATE SEWERS ON BUCHANAN STREET FROM JACKSON STREET TO WASHINGTON STREET, ON WASHINGTON STREET FROM WEBSTER STREET TO LAGUNA STREET.

WHEREAS, On March 20, 1998, PUC Sewer Operations identified an emergency condition on Buchanan Street from Jackson Street to Washington Street and on Washington Street from Webster Street to Laguna Street; and

WHEREAS, The existing sewer had collapsed, and immediate replacement was required in order to protect the health, welfare, and property of the Citizens of San Francisco; and

WHEREAS, DPW's Bureau of Engineering prepared the Plans and Specifications for Contract No. CW-180E, "Washington/Buchanan Streets Emergency Sewer Replacement" to replace approximately 812 feet of 12-inch and 316 feet of 15-inch VCP sewer, 155 feet of 10-inch culvert, and slipline 28 feet of 16-inch Polyethylene Pipe; and

WHEREAS, The Contractor, A. Ruiz Construction, began the emergency work on April 20, 1998 and completed it on July 17, 1998; and

WHEREAS, Because this was an emergency contract, HRC subcontracting goals were not established by the HRC Contract Compliance Officer assigned to monitor the Clean Water Repair and Replacement Program; and

WHEREAS, The cost of the project is estimated to be \$305,277.00, of which \$261,627.00 is for the construction contract. Funds are available from the Repair and Replacement Fund (Fund 5C/CPF/R&R, FAMIS Project No. CENRNRR967, Job Order No. 1597N); and

WHEREAS, The Public Utilities Commission, in accordance with the provisions of Section 6.30 of the Administrative Code of the City and County of San Francisco, declared the existence of an emergency; now, therefore, be it

RESOLVED, That this Board of Supervisors hereby approves the expenditure of funds for the emergency work to repair the structurally inadequate sewer on Buchanan Street from Jackson Street to Washington Street and on Washington Street from Webster Street to Laguna Street.
