1 [Accept and Expend Grant - Sheriff's Department program providing life skills for prisoners in  
2 county jail.]

3 **Resolution authorizing the Sheriff's Department to accept and expend a grant in the**  
4 **amount of \$ 1,259,470 from the U.S. Department of Education for providing a life skills**  
5 **program for prisoners in the county jail.**

7 WHEREAS, The U.S. Department of Education has made available funding through  
8 the life skills for state and local prisoner programs; and,

9 WHEREAS, Due to the need for education, counseling and life skills training among  
10 incarcerated people, the Sheriff's Department will offer a program to address the life skill  
11 needs of offenders while in custody and upon release; and,

12 WHEREAS, The grant budget includes provision for indirect costs of \$ 70,842; and,

13 WHEREAS, The grant identifies matching non-federal funds of \$1,022,868; now,  
14 therefore, be it

15 RESOLVED, That a grant award notification has been received from the U.S.  
16 Department of Education; and, be it

17 FURTHER RESOLVED, That the grant provides for the creation of two positions as  
18 follows: Class 8420 – Rehabilitation Services Coordinator at a salary of \$ 1,990 to \$ 2,448  
19 BW plus benefits; and, be it


20 FURTHER RESOLVED, That the City & County of San Francisco will adhere to the  
21 requirements of the U.S. Department of Education and all conditions specified in the grant  
22 contract.

23 FURTHER RESOLVED, That the Board of Supervisors does hereby urge  
24 the Controller to designate the Life Skills Program Coordinator and  
25 the Senior Case Manager created under the grant as "G" or "Grant-  
funded" positions, which would terminate if the grant is not renewed.




