WHEREAS, By Resolution 362-99, The Board of Supervisors created a Potrero Power Plant Citizen Advisory Task Force consisting of eight (8) neighborhood residents and five (5) City officials for the purpose of providing input to the City & County of San Francisco regarding the sale, operation and maintenance of the Potrero Power Plant; and

WHEREAS, By Resolution 139-01 The Board of Supervisors added one (1) additional City official representing Supervisorial District 10; and,

WHEREAS, The Task Force was formed in response to the concerns of San Francisco residents that the closure of the Bayview Power Plant and sale of the Potrero Power Plant may result in the Potrero Power Plant operating at a higher capacity, and thereby emitting higher levels of pollution and noise than earlier suspected; and,

WHEREAS, The advisory purpose of the Task Force would be better served by removing from its membership the City officials appointed under Resolutions 362-99 and 139-01, so that any actions taken by the Task Force will reflect the wishes of the citizen representatives of the Potrero and Hunters Point neighborhoods; and

WHEREAS, The Task Force's advisory purpose would be facilitated by having those City officials, appointed under Resolutions 362-99 and 139-01, to serve as non-voting, advisory members of the Task Force who shall not be counted in determining the quorum for the Task Force; therefore, be it
