

1 [Accept and Expend Grant - Keys to Freedom Program - \$599,894]

3 **Resolution authorizing the Sheriff's Department to retroactively accept and expend**  
4 **\$599,894 in funds from the U.S. Department of Justice, Office of Justice Programs,**  
5 **through the Second Chance Act Reentry Program for adult offenders with co-occurring**  
6 **substance abuse and mental health disorders, for The Keys to Freedom Program to**  
7 **increase public safety, and reduce recidivism among incarcerated and recently**  
8 **released women and transgendered adults in the City and County of San Francisco;**  
9 **and waiving any indirect costs for the period of October 1, 2012, through September**  
10 **30, 2014.**

12 WHEREAS, The U.S. Department of Justice, Office of Justice Programs, Second  
13 Chance Act Reentry Program for Adult Offenders with Co-Occurring Substance Abuse and  
14 Mental Health Disorders seeks applicants and encourages partnerships between criminal  
15 justice and mental health providers to respond to the increasing number of people who are in  
16 need of these services and related resources to achieve a successful return to their  
17 communities; and

18 WHEREAS, The Sheriff's Department proposes to maximize use of available grant  
19 funds on program expenditures by not including indirect costs; and

20 WHEREAS, The San Francisco Sheriff's Department has established in-jail and  
21 community-based program to support incarcerated and recently released adults; and

22 WHEREAS, That the funds received will target women and transgendered adults  
23 involved with the criminal justice system who are in need of mental health services and who  
24 are returning to the City and County of San Francisco; and

1           WHEREAS, That services addressing Post-Traumatic Stress Disorder (PTSD) and  
2 related services totaling \$464,452 will be provided through a collaboration with  
3 healthRIGHT360, and other community based agencies which includes the hiring of a Case  
4 Managers and support staff; and

5           WHEREAS, That these services are designed to increase public safety and reduce  
6 recidivism; and

7           WHEREAS, That the City and County of San Francisco will participate in data  
8 collection on key variables related to client-level performance and outcome data as required;  
9 now, therefore, be it

10          RESOLVED, That the Sheriff's Department is hereby authorized to maximize use of  
11 available grant funds on program expenditures by not including indirect costs; and, be it

12          FURTHER RESOLVED, That the Sheriff's Department is hereby authorized to  
13 retroactively accept and expend \$599,894 in funds from the U.S. Department of Justice; and,  
14 be it

15          FURTHER RESOLVED, That the Sheriff's Department is authorized to furnish  
16 whatever additional information or assurances the funding agency may request in connection  
17 with this grant, and execute any and all agreements necessary to complete the transfer of  
18 funds. The grant period is from October 01, 2012 to September 30, 2014; and, be it

19          FURTHER RESOLVED, That the City and County of San Francisco assures that it will  
20 abide by the statues governing the Office of Justice Programs as well as the terms and  
21 conditions of the Grant Agreement as set forth by the U.S. Department of Justice, Office of  
22 Justice Programs.






