3 **Resolution urging the Department of Public Works (DPW) and the City Architect, in**
4 **consultation with the San Francisco Unified School District (SFUSD), to suggest**
5 **possible options for DPW assistance in providing expertise and services to the School**
6 **District regarding facility repairs and managing construction projects pursuant to the**
7 **SFUSD Facilities Master Plan.**

9 WHEREAS, The City, through the Department of Public Works, and the San Francisco
10 Unified School District have entered into a Memorandum of Understanding whereby DPW has
11 agreed to provide professional services and project management for SFUSD projects; and

12 WHEREAS, Pursuant to this Memorandum of Understanding, the Department of Public
13 Works has agreed to provide architectural, engineering, and other professional services for
14 projects at School District facilities as requested by SFUSD; and

15 WHEREAS, The Memorandum of Understanding is on file with the Clerk of the Board
16 of Supervisors in File No. ⁰³⁰⁴⁹⁰, which is hereby declared to be a part of this resolution as if set
17 forth fully herein; and

18 WHEREAS, The School District is developing a Facilities Master Plan which will in
19 future phases provide an assessment of existing facilities, identify those facilities requiring
20 repair, and provide a cost estimate for repairs; and

21 WHEREAS, The Department of Public Works and the City Architect can provide
22 expertise to the School District in developing the Facilities Master Plan with respect to
23 assessing existing facilities, identifying facilities requiring repairs, and providing cost estimates
24 for repairs; and

1 WHEREAS, The Department of Public Works has developed an indirect costs program
2 that allows for the recovery of administrative costs from multiple funding sources which could
3 serve as a guide to the possible development of such a program within SFUSD; and

4 WHEREAS, The Department of Public Works and the City Architect can provide this
5 assistance, expertise, and services to the School District in an effort to reduce the cost impact
6 of facility reconstruction to the School District; now, therefore, be it

7 RESOLVED, That the Board of Supervisors urges the Department of Public Works and
8 the City Architect, in consultation with the San Francisco Unified School District, to suggest
9 possible options for DPW assistance in providing expertise and services to the School District
10 regarding facility repairs and managing construction projects, including but not limited to DPW
11 project management or joint SFUSD/DPW project management, pursuant to the existing
12 Memorandum of Understanding or a new Memorandum of Understanding; and, be it

13 FURTHER RESOLVED, That the Board of Supervisors urges the Department of Public
14 Works to work with the SFUSD to develop an indirect costs program for the School District to
15 recover administrative costs from multiple funding sources; and, be it

16 FURTHER RESOLVED, That the Board of Supervisors urges the Department of Public
17 Works and the City Architect to provide such assistance, expertise, and services to the School
18 District in an effort to reduce the cost impact of facility reconstruction to the School District and
19 enhance project delivery.
