4 **City and County of San Francisco for \$200,000; the lawsuit was filed on November 25,**
5 **2024, in San Francisco Superior Court, Case No. CGC-24-620091; entitled James**
6 **Williamson v. City and County of San Francisco; the lawsuit involves alleged personal**
7 **injury on a City street.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled James Williamson v. City and County
12 of San Francisco, San Francisco Superior Court, Case No. CGC-24-620091 by the payment
13 of \$200,000. The lawsuit involves alleged personal injury on a City street.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 November 25, 2024, and the following parties were named in the lawsuit: Plaintiff: James
16 Williamson; Defendant: City and County of San Francisco.
