APPROVING LEASE MODIFICATION NUMBER THREE FOR LEASE NO. 73-0066  
BETWEEN UNITED AIRLINES, INC. AND THE CITY AND COUNTY OF  
SAN FRANCISCO, ACTING BY AND THROUGH ITS AIRPORT COMMISSION.

WHEREAS, Pursuant to that certain Lease No. 73-0066 dated June 18, 1973 as amended  
by Airport Commission Resolutions No. 80-0066 and No. 94-0139 ("the Lease"), United  
occupies approximately 129.75 acres of land on Parcels 1 and 2 for a Maintenance Operations  
Center (MOC) and employee parking; and

WHEREAS, United has agreed to relinquish a portion of Parcel 2 as a common access  
driveway to allow the Airport to expand Lot DD surface parking, subject to United receiving, as  
a modification of the Premises under the Lease, additional parking following completion of the  
Airport's Multi-Modal Center and AirTrain extension projects; and

WHEREAS, On December 5, 2000, by Resolution No. 00-0440, the Airport Commission  
approved Lease Modification Number Three between United Airlines and City and County of  
San Francisco accomplishing said Premises modification in a two-step process; now, therefore,  
be it

, retroactively,  
RESOLVED, That this Board of Supervisors hereby approves Lease Modification  
Number three of Lease No. 73-0066 between United Airlines, and the City and County of San  
Francisco, acting by and through its Airport Commission a copy of which is on file with the  
Clerk of the Board of Supervisors in File No. 010039.


