

1 [Expand supportive housing services to the homeless in San Francisco.]

3 **Resolution authorizing the San Francisco Department of Public Health, Housing and**  
4 **Urban Health (SFDPH) to accept retroactively and expend a grant in the amount of**  
5 **\$745,125 from the Substance Abuse and Mental Health Services Administration**  
6 **(SAMHSA) to expand supportive housing services to the homeless in San Francisco**  
7 **and to enter into an agreement for the use of these funds; for the period of September**  
8 **30, 2003 to September 29, 2004.**

10 WHEREAS, SFDPH has applied for and been awarded a grant from SAMHSA in the  
11 amount of \$745,125 to expand supportive housing services to the homeless in San Francisco;  
12 and,

13 WHEREAS, As a condition of receiving the grant funds, SAMHSA requires the City to  
14 enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the  
15 Board of Supervisors in File No. 031947, which is hereby declared to be a part of  
16 this resolution as if set forth fully herein; and,

17 WHEREAS, The grant budget includes provision for indirect costs of \$67,061; and,

18 WHEREAS, This Resolution requires expedited review by the Board of Supervisors  
19 because we did not receive the grant award notice until October 7, 2003; and,

20 WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds  
21 may be placed automatically on the consent agendas in committee, as they are usually  
22 considered to be routine items, and this resolution authorizes the acceptance and expenditure  
23 of grant funding; now, therefore, be it


24 RESOLVED, That SFDPH is hereby authorized to accept retroactively and expend a  
25 grant in the amount of \$745,125 from SAMHSA; and, be it

1 FURTHER RESOLVED, That SFDPH is hereby authorized to accept and expend the  
2 grant funds in accordance with the requirements set forth in the Agreement pursuant to San  
3 Francisco Administrative Code section 10-170-1; and, be it


4 FURTHER RESOLVED, That the Director of Health is authorized to enter into the

6 FURTHER RESOLVED, That the Controller is directed to designate the positions  
7 funded under this agreement as "G" or grant-funded positions which would terminate when


