12 County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-21-591939 by
13 the payment of \$125,000. The lawsuit involves alleged personal injury and wrongful death
14 from medical negligence.

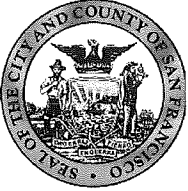
