

1 [Parking Regulations.]

3 **Resolution enacting and rescinding parking regulations at various locations.**

5 RESOLVED, that, in accordance with the provisions of the California Vehicle Code and the
6 San Francisco Traffic Code, the following regulations governing the parking of vehicles are
7 hereby enacted or rescinded as designated below:

8 **TOW-AWAY, NO PARKING ANYTIME, 8 PM - 8 AM, EVERYDAY - ESTABLISH**

9 Mendell Street, west side, from 93 feet to 137 feet south of Oakdale Avenue (44-foot
10 zone); and

11 Mendell Street, east side, from 3rd Street to 112 feet northerly (112-foot zone).

12 **ONE-HOUR PARKING TIME LIMIT, APRIL THROUGH OCTOBER, 7 AM TO 10 PM,**
13 **MONDAY THROUGH FRIDAY; 9 AM TO 6 PM, SATURDAY AND SUNDAY - RESCIND**
14 **ONE-HOUR PARKING TIME LIMIT, NOVEMBER THROUGH MARCH, 7 AM TO 6 PM,**
15 **MONDAY THROUGH SATURDAY - RESCIND**
16 **PARKING METERS (EXTEND PARKING METER AREA 3) - ESTABLISH**

17 3rd Street, both sides, between King and Townsend Streets.

18 **PARKING METERS (EXTEND PARKING METER AREA 3) - ESTABLISH**

19 King Street, north side, from 135 feet to 212 feet and 278 feet to 346 feet west of
20 2nd Street (77-foot and 68-foot zones, respectively).

21 **RESIDENTIAL PERMIT PARKING AREA "Z" (TWO-HOUR TIME LIMIT, 8 AM - 6 PM,**
22 **MONDAY THROUGH FRIDAY) - ESTABLISH**

23 27th Street, both sides, between Noe and Sanchez Streets (400 block).

24 **UNMETERED MOTORCYCLE PARKING - RESCIND**
25 **UNMETERED MOTORCYCLE PARKING, 7 PM to 7 AM, DAILY - ESTABLISH**

6th Street, east side, from nine feet to 30 feet south of Harrison Street, accommodating
six motorcycle stalls.

4 HOUR PARKING TIME LIMIT, 8 AM TO 6 PM, MONDAY THROUGH SATURDAY -
ESTABLISH

Van Ness Avenue, center parking area, from North Point Street to 300 feet northerly.

1 **PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH**

2 18th Street, north side, from 52 feet east of Rhode Island Street to Carolina Street.

3 **TOW-AWAY NO STOPPING ANYTIME - ESTABLISH**

4 Folsom Street, north side, from 3rd Street to 140 feet easterly; and

5 Folsom Street, north side, from 2nd Street to 140 feet easterly.

6 **NO PARKING ANYTIME - RESCIND**
7 **TOW AWAY NO PARKING ANYTIME - ESTABLISH**

8 Burgoyne Street, both sides, south of Pacific Avenue.

9 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

10 133 Palm Avenue, west side, from 263.5 feet to 270.5 feet south of Euclid Avenue
11 (seven-foot zone in front of 133 Palm ~~Street~~ Avenue, accommodating two
motorcycle stalls).

12 **TOW AWAY NO STOPPING ANYTIME - ESTABLISH**

13 Broderick Street, east side, from Sutter Street to 15 feet northerly; and

14 Sutter Street, north side, from Broderick Street to 14 feet easterly.

15 **NO PARKING ANYTIME - ESTABLISH**

16 Sears Street, along the south terminus, south of Sickles Avenue.

17 **NO PARKING ANYTIME - ESTABLISH**

18 Lyon Street, east side, from Green Street to 150 feet southerly to the terminus and
19 from the terminus to 36 feet westerly.

20 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

21 1366 Hayes Street, between the driveways of 1366 and 1370 Hayes Street
(12-foot zone, accommodating two motorcycle stalls).

22 **RESIDENTIAL PERMIT PARKING AREA "S" (TWO-HOUR TIME LIMIT, 8 AM - 9 PM,
23 MONDAY THROUGH FRIDAY) - ESTABLISH**

24 ~~Hill Street, both sides, between Church and Sanchez Streets (300 block); and~~

25 Sanchez Street, both sides, between Hill and Liberty Streets (portions of the 700 and
800 blocks).

1 **RESIDENTIAL PERMIT PARKING AREA "S" (FOUR-HOUR TIME LIMIT, 8 AM - 6 PM,**
2 **MONDAY THROUGH FRIDAY) - ESTABLISH**

3 Hill Street, both sides, between Church and Sanchez Streets (300 block).

4 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

5 1570 -1574 Waller Street, north side, from 100 feet to 109.5 feet west of Belvedere
6 Street (9.5 foot zone in front of 1570-1574 Waller Street, accommodating one
7 motorcycle only).
