

1 [Parking Regulations.]

2 **Resolution enacting and rescinding parking regulations at various locations.**

3 RESOLVED, That, in accordance with the provisions of the California Vehicle  
4 Code and the San Francisco Traffic Code, the following regulations governing the  
5 parking of vehicles are hereby enacted or rescinded as designated below:  
6

7 **UNMETERED MOTORCYCLE PARKING ESTABLISH**

8 ~~Frederick Street, north side, from Delmar Street to 9 feet westerly.~~

9 **PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH**

10 Rhode Island Street, west side, between 15<sup>th</sup> and Alameda Streets (100 block),  
11 legalizing existing conditions; and

12 Cunningham Place, south side (60-foot zone), legalizing existing conditions.

13 **NO PARKING ANYTIME - ESTABLISH**

14 Cunningham Place, at the terminus between the north and south curbs (40-foot  
15 zone).

16 **TOW-AWAY, NO STOPPING ANYTIME - RESCIND**  
17 **TOW-AWAY, NO PARKING ANYTIME - ESTABLISH**

18 3<sup>rd</sup> Street, east side, from Kirkwood Avenue to 70 feet southerly.

19 **TOW-AWAY, NO STOPPING, MONDAY THOROUGH FRIDAY, 4 PM TO 6 PM -**  
20 **RESCIND**

21 Howard Street, north side, from 100 feet east of 3<sup>rd</sup> Street to Fremont Street.

22 **TOW-AWAY LANE MUST TURN RIGHT - RESCIND**

23 Howard Street, at 5<sup>th</sup> Street.

24 **RESIDENTIAL PERMIT PARKING AREA "A" (2-HOUR TIME LIMIT, 8 AM - 9 PM,**  
25 **MONDAY THROUGH SATURDAY) - RESCIND**  
**TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

Taylor Street, both sides, from Francisco Street to 124 feet northerly.

1 **TOW-AWAY, NO PARKING 9 AM TO 9 PM, EVERYDAY - ESTABLISH**

2 Masonic Avenue, west side, from 120 feet to 380 feet north of Geary Boulevard  
3 (frontage of Trader Joe's).

4 **NO PARKING ANYTIME - ESTABLISH**

5 Sears Street, west of Sickles Avenue, from north curb to south curb along the  
6 terminus of the street.

7 **TOW-AWAY, NO STOPPING, 7 AM TO 7 PM - RESCIND**

8 Folsom Street, south side, from 90 feet to 105 feet west of 4<sup>th</sup> Street.

9 **RESIDENTIAL PERMIT PARKING AREA "D" (4-HOUR TIME LIMIT, 9 AM - 5 PM,  
10 MONDAY THROUGH FRIDAY) - ESTABLISH**

11 Roanoke Street, both sides, between Arlington Street and southern terminus.

12 **PARKING METER AREA NO. 3 (2-HOUR PARKING TIME LIMIT, 9 AM - 6 PM,  
13 MONDAY THROUGH SATURDAY) - EXTEND**

14 Harrison Street, north side, between 11<sup>th</sup> Street and Norfolk Street.

16 Categorically exempt from Environmental Review  
17 Class 1(c)(9) changes in the traffic and parking  
18 regulations where such changes do not establish a  
19 higher speed limit or result in more than a  
negligible increase in the use of the street.
