3 **Resolution authorizing the Department of the Environment to accept and expend a**
4 **grant in the amount of \$25,000 from the Richard and Rhoda Goldman Fund to support**
5 **the development of a hydrogen fueling infrastructure in the City and County of San**
6 **Francisco.**

8 WHEREAS, the Richard and Rhoda Goldman Fund has awarded funds to the
9 Department of the Environment to support the development of a hydrogen fueling
10 infrastructure for a hydrogen fuel cell vehicle pilot project; and,

11 WHEREAS, as part of their ongoing effort to combat global warming and other
12 environmental problems, the City's Commission on the Environment and its Board of
13 Supervisors have passed resolutions declaring San Francisco a "Hydrogen City"; and,

14 WHEREAS, the resolutions call for the City and County of San Francisco to seek pilot
15 projects using hydrogen as a clean alternative fuel; and,

16 WHEREAS, to meet the requirements of these resolutions and to explore the
17 opportunities presented by this zero-emission vehicle technology, the San Francisco
18 Department of the Environment (SF Environment) has been seeking ways to partner on such
19 pilot demonstration projects with several automakers; and,

20 WHEREAS, SF Environment and the City and County of San Francisco have been
21 selected by Honda Motor Co. to participate in a fuel cell vehicle pilot project that will include
22 the leasing of two Honda FCX fuel cell vehicles and temporary hydrogen refueling
23 infrastructure; and,

24 WHEREAS, this grant will go towards the leasing of the vehicles and fueling
25 infrastructure; and,


WHEREAS, the grant budget includes provision for indirect costs of \$2,273; now, therefore, be it


