2 AUTHORIZING THE DISTRICT ATTORNEY OF THE CITY AND COUNTY OF SAN  
3 FRANCISCO TO RETROACTIVELY ACCEPT AND EXPEND FUNDS MADE AVAILABLE  
4 THROUGH THE OFFICE OF CRIMINAL JUSTICE PLANNING FOR A PROJECT  
5 ENTITLED "SPECIAL EMPHASIS VICTIM ASSISTANCE PROGRAM - ELDER ABUSE",  
6 AND WAIVING INDIRECT COSTS DUE TO FUNDING CONSTRAINTS.

7 WHEREAS, The City and County of San Francisco desires to  
8 continue a certain project designated the Special Emphasis Victim  
9 Assistance Program - Elder Abuse to be funded in part from funds made  
10 available through the Victims of Crime Act (VOCA), Public Law 98-473,  
11 as amended, administered by the California Office of Criminal Justice  
12 Planning ("OCJP"); and,

13 WHEREAS, this project provides assistance to all victims of  
14 elder abuse committed in the City and County of San Francisco; now,  
15 therefore, be it

16 RESOLVED, That the District Attorney of the City and County of  
17 San Francisco is authorized, retroactively, on behalf of the City and  
18 County of San Francisco to accept and expend continued funding for  
19 this project from OCJP, and waiving indirect costs due to funding  
20 constraints, and be it

21 FURTHER RESOLVED, That the District Attorney is authorized to  
22 execute on behalf of the City and County of San Francisco the  
23 necessary Grant Award Agreements for this project including any  
24 extensions, funding augmentations from OCJP, or amendments thereof;

9 OCJP disclaim responsibility for any such liability; and be it


10 FURTHER RESOLVED, That grant funds received hereunder shall not




