

1 **[Acquisition – Noise Easements]**

2 **AUTHORIZING THE ACQUISITION OF 1,764 NOISE EASEMENTS LOCATED IN THE**  
3 **CITIES OF DALY CITY (1,260) AND SAN BRUNO (490) AND IN UNINCORPORATED**  
4 **SAN MATEO COUNTY (14) WITH FUNDING PROVIDED BY THE AIRPORT’S**  
5 **COMMERCIAL PAPER PROGRAM UP TO A TOTAL OF \$34.2 MILLION DOLLARS.**

7 WHEREAS, The Airport Commission has approved supplemental funding agreements with  
8 the City of Daly City, the City of San Bruno, and the County of San Mateo in order to complete noise  
9 insulation work, with such supplemental funding in addition to the \$120 million Memorandum of  
10 Understanding Noise Insulation Program; and,

11 WHEREAS, The addresses for said dwellings have been included in previous Airport  
12 Commission Resolutions approved on an annual basis by the Board of Supervisors; and,

13 WHEREAS, In accordance with Airport Commission Resolution Nos. 00-0059A, 00-0059B,  
14 00-0059C, a copy of which is on file with the Clerk of the Board of Supervisors in file no.  
15 000606, the Director of Property is hereby authorized to purchase and to accept on behalf of  
16 the City 1,764 noise easement deeds consisting of 1,260 deeds for Daly City, 490 deeds for San  
17 Bruno, and 14 deeds for San Mateo County; now, therefore, be it

18  
19 RESOLVED, That the total cost to acquire said easements shall not exceed \$34.2 million  
20 dollars, with each easement to expire twenty (20) years from the date of recordation; and, be it


21 FURTHER RESOLVED, Said noise insulation program is in conformity with the Airport  
22 Commission’s master plan program.




