12 own and incorporates by reference herein as though fully set forth the findings made by  
13 the City Planning Commission, by its letter dated April 21, 2000, that the project  
14 intended by the map is consistent with the Master Plan and the Priority Policies of City  
15 Planning Code Section 101.1 and the provisions of Case No. 98.187E, the Final  
16 Negative Declaration, adopted and issued on November 23, 1998.

17 FURTHER MOVED, That approval of this map is also contingent upon  
18 compliance by the subdivider with all applicable provisions of the San Francisco  
19 Subdivision Code and amendments thereto.


