2017 APPLICATION FOR YOUTH SEATS 2 AND 7 ON THE CHILDREN, YOUTH, AND FAMILIES OVERSIGHT AND ADVISORY COMMITTEE (OAC)

What is the OAC?

The Children Youth and Families Oversight and Advisory Committee (OAC) is an 11 member council created following the passage of Proposition C in November 2014. Proposition C approved the extension of the city's Children's Fund (now Children and Youth Fund) and Public Education Enrichment Fund (PEEF) for 25 years.

The Children's Fund was established in 1991 and sets aside a portion of the city's property tax to provide services for young people in San Francisco, mostly through the Department of Children, Youth and Their Families (DCYF). DCYF's main priority areas are in early care & education; out of school time; youth leadership, empowerment & development; family support; and violence prevention and intervention.

The Oversight and Advisory Committee includes three seats for youth members: Two members age 19 or under, and one seat for a transitional age youth age 18-24.

Members of the OAC are responsible for:

- Reviewing the budget, governance, and policies of DCYF
- Monitoring and participating in the administration of the Children and Youth Fund
- Taking steps to ensure that the Children and Youth Fund is administered in a manner accountable to the community

In short, members of the OAC make sure that the Children and Youth fund is put to the purpose that voters intended—providing the children and youth of San Francisco with high quality services and programs; and that the community has a say in decision-making about how the fund will be used.

“What is the time commitment? Is the position paid?”

The role will require a regular commitment of 5 hours a month, with extra time needed during some months. This includes:

- OAC meetings take place at least 6 times a year, but usually monthly, in the evening
- You will receive support and training from Youth Commission staff via monthly check-ins to prepare for upcoming meetings and OAC business
- Two daytime weekend retreats with youth commissioners to connect and build skills with other youth leaders in city government. Orientation retreat will be held Saturday and Sunday September 2nd-3rd 2017.

- There will be an opportunity to participate in the DCYF Youth Advisory Board (YAB) meetings, with other young people who help advise DCYF. There would be a \$500 stipend for your participation in the Youth Advisory Board.
- The term for the seat is three years. If you are interested but have questions or concerns about the length of the term, please ask!

Who is eligible to join the OAC?

1. Must live in the City and County of San Francisco
2. Seat 2 must be a youth 19 years old or younger at the time of appointment.

Seat 7 must be a transitional age youth 18 through 24 years of age who is familiar with challenges faced by disconnected transitional-age youth, including those who are: homeless; have dropped out of high school; disabled; familiar with substance abuse issues; low-income parents; undocumented; new immigrant and/or English Learners; LGBTQQ; transitioning from foster care; or involved in the juvenile justice, criminal justice, or special education systems.

3. Must possess a social security number

A strong candidate will possess:

- Knowledge of and direct experience with after-school, summer, and youth-focused programs in San Francisco
- Interest in making systems and organizations work well and a desire to see that youth are being served well by the Children's Fund
- A passion for youth-inclusion in decision making
- Awareness of, and connection to, the diverse experiences of youth in San Francisco

Please submit a complete application to the Youth Commission (by fax, email, regular mail or in person). Applications will be accepted until the seat is filled, but the first review of applications to date will take place on July 12, 2017.

A complete application will contain:

- Short Essay Question Responses (*to questions below*)
- Letter of Recommendation:** Please provide a recommendation—a few paragraphs are sufficient—from a mentor who can speak to your involvement in youth programs and your ability to advocate for the community. They can include the information here, or submit a letter separately. Your recommender can be another youth leader or an adult.
- Resume (*optional*)
- If applying for Seat 7 (TAY seat): **The Application for Boards, Commissions, Committees & Task Forces** (*attached here for those applying to Seat 7 only*).

The Youth Commission will make recommendations to the Mayor about who to appoint for seat 2. The Youth Commission will also advise the Board of Supervisors of qualified candidates for seat 7. **The Board of Supervisors and the Mayor will ultimately decide who to appoint to the OAC.**

You will also be asked to attend a Board of Supervisors Rules Committee meeting when they review your application. Youth Commission staff will be available to help you prepare.

The past experiences that I have in youth-focused activities consist of my involvement in Black Student Union; my participation in various groups offered through Enterprise for Youth; and my participation in Young Community Developers summer program.

BSU has given me the opportunity educate my peers about black culture and issues facing the black community, throughout history and currently. Through Enterprise I had the opportunity to join two groups centered around professional development and leadership development. As apart of Enterprise I was able to get two different internships, including the current internship I have with Fort Mason Center for Arts & Culture. My participation in YCD's 2015 summer youth program, allowed me to explore career and college opportunities that are available to me. To whom it may concern,

This letter is being written in recognition of the outstanding contributions of Jada Curry as a community leader throughout San Francisco. After having known and worked closely with her for two-years, Jada has proven herself to be a resilient young lady, upholding all of the values one would expect from an aspiring leader, advisor. From her involvement in George Washington's High School AVID program (Advancing via Individual Determination) and her steadfast dedication our schools Black Student Union, I have seen her grow into an exceptional example of adolescent leadership ability and potential.

While I'm not a betting man, probability dictates that this young woman stood a better chance of becoming another victim of our nation's socio-political shortcomings, as opposed to the inspiring personality she's developed into in recent years. At the end of the day, this young woman isn't just motivated; she's driven to make something of herself and the community she hails from. This drive however, and in my opinion, is a result of her life experiences and circumstances.

Raised in a "tough" area of San Francisco, Jada is a half Black, half Puerto Rican daughter of a loving mother, whose biological father has been non-existent because of his imprisonment nearly a year after her birth. With that in mind, she's learned to survive in one of our nation's most expensive cities, that at times, feels as if it's purposely enabling the decay of its black community. Jada is a youthful adult who considers knowledge to be a figurative vehicle for social mobility and personal advocacy, as opposed to another example of institutionalized education falling short. In one of many cases, Jada's way of spreading knowledge and positivity to her fellow classmates at Washington was carried out by her active involvement in Black Student Union. Consistently, her leadership enabled the students of this student organization to complete goals in a timely fashion, inform and develop a school climate of positivity, and most importantly, it allowed Jada to hone her leaderships skills in such way that she identified the effectiveness of positive role modeling and personal communication as opposed to forceful diplomacy and pressure.

Furthermore, over the span of her Junior and Senior year, Jada evolved into not only an academically notable student but also, that of a driven individual seeking change in the communities she identifies with. Through her involvement in multiple clubs, multiple advanced placement classes, getting involved in extracurricular volunteering opportunities, tutoring lower classmen, and then study during lunch and/or after school on any given day, she has helped to establish and foster an academic culture of rigor and support in our schools AVID program and our school's campus. After exiting high school in May, Jada left as young woman that was a far cry from the young girl that showed up to school nearly 4-years prior. Now, she's a steely eyed, binder carrying, debate destroying, socially uplifting, private university attending, woman of color with a GPA of 3.5. This upcoming fall, Jada Curry will be attending the University of San Francisco, and there's no doubt that her experience and contributions there will be no less than the reputation that precedes her at George Washington High School. I have no doubt that she would make great contributions to the Oversight and Advisory Committee she's applying for. Behind her undisputedly awesome hair and big smile, is a girl that's driven not just to succeed, but also to compete – always ready to ask the question – what's next?

NOTICE IS HEREBY GIVEN of the following vacancies and term expirations (**in bold**), appointed by the Board of Supervisors:

Vacant Seat 7, succeeding Mia "Tu Mutch" Satya, resigned, shall be a person who is a disconnected transitional-aged youth, as that term is used in Charter, Section 16.108, 18 through 24 years of age at the time of appointment, and who is familiar with the issues and challenges faced by disconnected transitional-aged youth and with services, programs, and systems for them, for the unexpired portion of a two-year term ending July 1, 2018.

Seat 8, Winnie Chen, term expiring July 1, 2019, shall be a person who is a parent or guardian of a child, which child is enrolled in kindergarten through 8th grade at the time of the member's appointment for the term. This member shall be from a low-income community or have expertise or substantial experience working to promote the interests of communities of color and shall have demonstrated a commitment to improving access and quality of services for children, youth and families, for a two-year term.

Seat 9, Sarah Thompson-Peer, term expiring July 1, 2018, shall be a person who is a parent or guardian of a child, which child, at the time of the member's appointment for the term, is under the age of 5 years and enrolled in a publicly-subsidized or City-funded program. This member shall have demonstrated a commitment to improving access and quality of services for children, youth and families, for a two-year term.

Seat 10, Eddy Xiao Fei Zheng, term expiring July 1, 2019, shall be a person with expertise or substantial experience working in the field of children and youth services in communities that are low-income or underserved, for a two-year term.

Seat 11, Rob Gitin, term expiring July 1, 2018, shall be a person who has demonstrated commitment to improving access to and quality of services for children, youth and families, for a two-year term.

Exclusions: Current City employees who are at the department head or deputy department head level of authority, San Francisco Unified School District (SFUSD) employees who are at the Director or Assistant Superintendent level of authority or higher, and current employees or members of the board of directors for organizations where the Department of Children, Youth and Their Families (DCYF) is the decision-maker for funding may not serve as members of the Oversight and Advisory Committee. A part-time intern with a DCYF-funded organization who is 24 years old or younger shall not be considered an employee of that organization.

Board Qualifications:

The Children, Youth and Their Families Oversight and Advisory Committee (Oversight and Advisory Committee) was established pursuant to Charter, Section 16.108-1 (adopted by the voters as part of Proposition C at the November 2014 election), to review the governance and policies of the Department of Children, Youth and Their Families (DCYF), to monitor and participate in the administration of the Children and Youth Fund, and to take steps to ensure the Fund is administered in a manner accountable to the community.

The Oversight and Advisory Committee shall consist of eleven (11) members, as follows:

Appointed by the Mayor (effective 30 days after transmittal of the "Notice of Appointment" to the Board of Supervisors, who may hold a public hearing but cannot reject the appointment)

> Seat 1: A youth 19 years old or younger at the time of appointment for the term, recommended to the Mayor by the Youth Commission (this member is not subject to the elector requirement since they may be younger than 18 years old).

> Seat 2: A youth 19 years old or younger at the time of appointment for the term, recommended to the Mayor by the Youth Commission (this member is not subject to the elector requirement since they may be younger than 18 years old).

> Seat 3: A parent or guardian of a youth, which youth, at the time of the member's appointment for the term, is under the age of 18 years and enrolled in the San Francisco Unified

School District. This member shall have demonstrated commitment to improving access to the quality of services for children, youth and families.

- > Seat 4: A person with expertise or substantial experience working in services and programs for children ages 5 and younger.
- > Seat 5: A person with expertise or substantial experience working in the field of children and youth services in communities that are low-income or underserved.
- > Seat 6: A person who has demonstrated commitment to improving access and quality of services for children, youth and families in communities that are low-income or underserved.

Appointed by the Board of Supervisors

- > Seat 7: A person who is a disconnected transitional-aged youth, as that term is used in Charter, Section 16.108, 18 through 24 years of age at the time of appointment, and who is familiar with the issues and challenges faced by disconnected transitional-aged youth and with services, programs, and systems for them.
- > Seat 8: A parent or guardian of a child, which child is enrolled in kindergarten through 8th grade at the time of the member's appointment for the term. This member shall be from a low-income community or have expertise or substantial experience working to promote the interests of communities of color and shall have demonstrated a commitment to improving access and quality of services for children, youth and families.
- > Seat 9: A parent or guardian of a child, which child, at the time of the member's appointment for the term, is under the age of 5 years and enrolled in a publicly-subsidized or City-funded program. This member shall have demonstrated a commitment to improving access and quality of services for children, youth and families.
- > Seat 10: A person with expertise or substantial experience working in the field of children and youth services in communities that are low-income or underserved.
- > Seat 11: A person who has demonstrated commitment to improving access to and quality of services for children, youth and families.

Exclusions: Current City employees who are at the department head or deputy department head level of authority, San Francisco Unified School District (SFUSD) employees who are at the Director or Assistant Superintendent level of authority or higher, and current employees or members of the board of directors for organizations where DCYF is the decision-maker for funding may not serve as members of the Oversight and Advisory Committee. A part-time intern with a DCYF-funded organization who is 24 years old or younger shall not be considered an employee of that organization.

The Mayor and Board of Supervisors shall appoint the initial members by July 1, 2015. The terms of the initial appointees shall commence on the first date of the meeting and no later than July 1, 2015. Members may not serve more than two consecutive two-year terms, except that the members initially appointed to seats 1, 3, 5, 7, 9, and 11 shall serve for a first term of three

years. Serving more than half of a term shall count as serving a full term.

The Department of Children, Youth and Their Families shall provide staffing for the Oversight and Advisory Committee and the Youth Commission shall provide support to the members in seats 1, 2 and 7.
