8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. The San Francisco Park Code is hereby amended by amending Section
10 4.10, to read as follows:

11 **Sec. 4.10 ALCOHOLIC BEVERAGES.**

12 (a) Except as provided in Subsection 4.10(b), No person shall consume alcoholic beverages of
13 any kind in any building, children's playground, swimming pool, restroom, park that contains a
14 children's playground or play structure, or any of the following parks or portions of parks: as
15 follows, except with the permission of the Recreation and Park Department.

4 where such activity is prohibited by Subsection (a), above, if the General Manager or the
5 Commission determines that the consumption of alcohol will not interfere with the public's use
6 and enjoyment of the park.
