3 Ordinance waiving the permit fee in Public Works Code Section 724.1(b) for temporary  
4 street space occupancy on certain blocks of 22<sup>nd</sup> Street on Saturday, June 19, 2010, as  
5 part of a fundraiser to launch the Mission Community Market.

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. (a) Notwithstanding the permit fee for temporary street space occupancy  
11 set forth in Public Works Code Section 724.1(b), the Board hereby finds that it is in the public  
12 interest to waive said fee in order to allow for the maximization of fund raising and promotion  
13 related to the launch of the Mission Community Market on Saturday, June 19, 2010, between  
14 11 am and 3 pm. On the abovementioned date, the fee waiver shall be applicable to the  
15 following geographic areas of the City:

16 22nd Street between Bartlett Street and Mission Street.

17 (b) All other provisions of Public Works Code Sections 724 et seq. shall remain in full  
18 effect.
