3 **Resolution approving the modification of the contract between the City and County of**
4 **San Francisco and Addus Healthcare for the provision of In-Home Supportive Services**
5 **for the period from July 1, ¹⁹⁹⁹~~2000~~ to June 30, 2001, in the increased amount of ~~\$2,308,327~~**
6 **for a total contract amount of \$17,197,171.**

8 WHEREAS, The City and County of San Francisco approved the contract with the
9 Addus Healthcare, on file with the Clerk of the Board of Supervisors in File No. 98-0934,
10 which is hereby declared to be a part of this resolution as if set forth fully herein; and,

11 WHEREAS, In October 1999, in anticipation of passage of a minimum compensation
12 ordinance, the Board of Supervisors approved an increase in provider wages for employees of
13 Addus Healthcare in the amount of \$1,929,567, in the DHS 1999-2000 budget; and because
14 of a procedural misunderstanding DHS did not obtain separate and additional Board approval
15 for the actual contract modification; and

16 WHEREAS, The City and County of San Francisco Board of Supervisors passed the
17 Minimum Compensation Ordinance; and,

18 WHEREAS, The Department of Human Services has allocated additional funds in their
19 budget to increase the average wage of the IHSS contract workers to \$9.70 per hour; and

20 WHEREAS, The City and County of San Francisco Board of Supervisors approved the
21 Department of Human Services budget which includes the additional funds; and

22 WHEREAS, The Human Services Commission has recommended approval of this
23 contract modification with the Addus Healthcare at its meeting of July 27, 2000; now,
24 therefore, be it


