9 WHEREAS, the Portola community is a lesser-known neighborhood in the
10 southeastern quadrant of San Francisco and is primarily made up of single-family homes with
11 a neighborhood balance of city and suburban feel; and

12 WHEREAS, there is a major shopping area on San Bruno Avenue between Silver and
13 Mansell Avenues and in the last few years, the area undergone a fairly large changeover, with
14 many new residents renovating homes, planting trees, and becoming active in local politics;
15 and,

16 WHEREAS, this area has become accustomed to rapid change from a primarily Italian
17 and Maltese area in the fifties and sixties, to an ethnically diverse area in the seventies and
18 eighties and nineties; and,

19 WHEREAS, the St. Elizabeth Chapter of the San Francisco Organizing Project created
20 an economic revitalization plan for the Portola community in which included among other
21 efforts the creation of a community festival; and,

22 WHEREAS, Family Connections in conjunction with San Bruno Merchants Association
23 are spearheading efforts to create the first San Bruno Ave Community Festival on Sunday,
24 September 29, 2002; now, therefore, be it




