2 **Resolution approving the settlement of the unlitigated claims filed by Pearl Howell**
3 **("Howell") against the City and County of San Francisco ("City") for \$80,000.00. The**
4 **claims were filed on September 15th and 16th, 2010.**

5 WHEREAS, Howell filed unlitigated claims with the Equal Employment Opportunity
6 Commission (EEOC Charge Nos. 550-2010-01808/37AB008477) on September 15, 2010 and
7 with the Department of Fair Employment and Housing on September 16, 2010 (DFEH No.
8 Charge E201011M0352-00-pev) against the City and County of San Francisco for
9 discrimination based on disability; failure to engage in the interactive process; and retaliation;

11 WHEREAS, the Human Services Agency of the City and County of San Francisco has
12 recommended settlement of said charges by payment of \$80,000.00 and that Howell shall
13 release all claims relating to her employment with the City; and


14 RESOLVED, that pursuant to Section 10.22 of the San Francisco Administrative Code,
15 settlement and compromise of said charges by payment of \$80,000.00 is hereby approved.
