uses and retail facilities. The integrated mix of uses has attracted national attention. Although typical urban centers are designed with densities similar to a downtown area, this design emphasizes open space, landscaped medians, waterways and other amenities to create an aesthetic atmosphere unique to most central business districts. The original master plan was redesigned to achieve higher densities, a better integrated mix of uses and a higher degree of urbanity that are the signatures of successful downtowns. Integrated transportation concepts were studied to ensure that the densified urban center will remain highly accessible.

 The Valley Ranch, located near the Dallas-Fort Worth International Airport, is a
 2,400-acre mixed-use community with low and medium density housing, office and
 retail. The Master Plan contains a series of strategies that emphasize the distinctive
 landforms of the site; a range of low, mesquite covered hills to the west and a levee
 along the Elm Fork of the Trinity River to the east. A gently curving parkway defines
 the natural, valley-like central portion of Valley Ranch. A network of roads,
 landscaped waterways and canals subdivides the site so that all development parcels
 have access to a community-wide open space system. Higher density housing and
 neighborhood facilities are located at the intersections of roads and waterways to
 increase accessibility. Pedestrian walkway system and park spaces were created at
 the canal edges to maximize green and open space. The plan set a new standard for
 site sensitive planning and neighborhood design for suburban development in the
 Dallas MetroPlex. The landscape, pedestrian way and streetscape design was
 designed by JJR Ann Arbor.

- Villages of Bear Creek Master Plan, Euless, TX The Villages of Bear Creek is a 700-acre site located in a rapidly developing area within the city of Euless, Texas. The Villages of Bear Creek is situated on land that is rich in natural features. The topography is that of rolling hills, with numerous creeks, extensive meadows, wide flood plains, and dense oak and mesquite forests. The primary design concept for the Villages of Bear Creek introduces a north-south road that ties together the many housing and commercial environments into a single and uniquely identifiable residential community. With the underlying idea of creating a memorable parkway this road is curvilinear and narrow, and has been designed to preserve the feeling of existing topography, trees and water features of the site. Along its entire length, the parkway landscape and lighting treatment are designed to be informal and park-like. Bordering the parkway are jogging trails and walkways that lead to larger open spaces and recreation facilities located in the flood plain of the two creeks that pass through the site and connect the Villages to the larger community. The landscape implementation plan and streetscape design was designed by JJR Ann Arbor.


