- That the \$23,283,979 of salary and fringe funding currently on Controller's Reserve is released;
- That the \$8,158,920 of salary and fringe funding currently on Budget and Finance Committee Reserve is released;
- That there are no significant increase in service deployment, which are directly related to increases in serious criminal activity, natural disasters or elevated homeland security threat levels; and
- That any legislative mandates related to re-deployment of Police Department resources include the appropriation of additional funds to address these mandates.

From Office of the Sheriff, confirming that the funding provided in the budget for FY2010-2011 as adopted by the Board of Supervisors is adequate for their department to meet service levels as proposed to the Board with four exceptions: (68)
