9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Craig Smith v. City and County of San  
12 Francisco, et al., San Francisco Superior Court, Case No. CGC-25-622137 by the payment of  
13 \$75,000. The lawsuit involves alleged personal injury on a City sidewalk.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 February 5, 2025, and the following parties were named in the lawsuit: Plaintiff Craig Smith;  
16 Defendant City and County of San Francisco.
