18 WHEREAS, Ms. Villafuerte was awarded an "Excellence in Education" Award by
19 Exceptional Parent magazine in December 2000; and

21 WHEREAS, Twelve years ago, West Portal Elementary School began a successful
22 affiliation with Early Childhood Resources of Marin and shared some of its best practices
23 in the ECR's 2001 fall publication of "Teach Out Children Well: Essential




