WHEREAS, The contract budget includes provision for indirect costs of \$16,364; now, therefore, be it

RESOLVED, That the SFDPH is hereby authorized to enter retroactively into the contract agreement with the SDHS; and, be it

FURTHER RESOLVED, That the Director of Health is authorized to enter into the Agreement on behalf of the City.
