3 **Resolution urging nationwide mobilization of renewable energy resources, beyond the**  
4 **requirements of the Kyoto Protocol, to stabilize atmospheric conditions and to mitigate**

8 WHEREAS, Global climate change is destroying ecosystems all over the world and  
9 poses a grave threat to human life; and

10 WHEREAS, Carbon dioxide, one of the most prevalent of these greenhouse gases,  
11 stays in the atmosphere for more than a century and greatly contributes to global warming;  
12 and

13 WHEREAS, Requirements set forth in the Kyoto Protocol, which call for industrial  
14 countries to reduce their greenhouse gas emissions by 5% below the 1990 levels in the  
15 commitment period 2008 to 2012, are woefully inadequate to slow the accelerating pace of  
16 carbon dioxide emissions; and

17 RESOLVED, that the San Francisco Board of Supervisors urges a nationwide  
18 mobilization of renewable energy resources, beyond requirements of the Kyoto Protocol, to  
19 mitigate the ecological and economic damage and injury to human life caused by global  
20 warming; and be it

21 FURTHER RESOLVED, That the Board of Supervisors promote the goals established  
22 in the President Bill Clinton's 1996 "Car Talk" commission, namely an increase over a 10-year  
23 period in CAFE standards from the present 27.5 miles per gallon to 45 mpg for cars and from  
24 the present 20.7 to 34 mpg for light trucks; and, be it




