

1 [Approval of the sale of street flower market permit on Grant Avenue near Post Street and  
2 deletion of site location.]

3 **Ordinance approving the sale of a street flower market permit pursuant to San**  
4 **Francisco Public Works Code Article 5, Section 161, and amending Public Works Code**  
5 **Article 5, Section 155 to delete the flower market location on the east sidewalk of Grant**  
6 **Avenue within 100 feet south of the southerly line of Post Street.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Findings.

12 (a) Pursuant to a letter dated August 25, 1927, the Mayor’s Office and Chief of the  
13 Police Department issued revocable permission to Henry Camozzi, to occupy and maintain  
14 the street flower market location on the east sidewalk of Grant Avenue within 100 feet south of  
15 the southerly line of Post Street to replace the original permit dated February 11, 1922 that  
16 had been lost. Copies of said documents are in Clerk of the Board of Supervisors File No.  
17 \_\_\_\_\_ and are incorporated herein by reference.

18 (b) As set forth in DPW Order No. \_\_\_\_\_ referencing an agreement between  
19 Ron Camozzi and 185 Post Street, L.P., a copy of which is on file with the Clerk of the Board  
20 of Supervisors in File No. \_\_\_\_\_, Mr. Camozzi has agreed to convey the subject  
21 flower market permit to the fronting property owner, 185 Post Street, L.P., and requests  
22 permission from this Board to do so in accordance with Public Works Code Section 161(l). A  
23 copy of said request is on file with the Clerk of the Board of Supervisors in File No.  
24 \_\_\_\_\_ and is incorporated herein by reference.

1 (c) If this Board approves the sale of the permit to 185 Post Street, L.P., said company  
2 has requested that this Board delete this street flower market location from the list of market  
3 locations authorized under Public Works Code Article 5, Section 155. A copy of said request  
4 is on file with the Clerk of the Board of Supervisors in File No. \_\_\_\_\_ and is  
5 incorporated herein by reference.

6 (d) The Department of Public Works, as stated in DPW Order No. \_\_\_\_\_ makes  
7 no recommendation on the sale of the street flower market permit and the subsequent  
8 deletion of this site from the list of stand locations because it believes that this is a policy  
9 matter for this Board to consider. A copy of said Order is on file with the Clerk of the Board of  
10 Supervisors in File No. \_\_\_\_\_ and is incorporated herein by reference.

11 (e) Based on the information presented and in accordance with Public Works Code  
12 Article 5, this Board determines that the actions requested are appropriate and in the public  
13 interest.

14 Section 2. Pursuant to Public Works Code Section 161(l), this Board hereby authorizes  
15 the sale of the street flower market permit for the site located on the east sidewalk of Grant  
16 Avenue within 100 feet south of the southerly line of Post Street to 185 Post Street, L.P. This  
17 Board urges the parties to complete the sale of the subject permit within ninety (90) days of  
18 the effective date of this legislation.

19 Section 3. The San Francisco Public Works Code is hereby amended by amending  
20 Article 5, Section 155, to read as follows:

21 SEC. 155. DESIGNATION OF LOCATIONS - PROVISIO.

22 Sidewalk flower-vending stands shall be located within the following designated  
23 street flower market areas upon the sidewalks of the City and County of San Francisco at the  
24 curb or building line.

25 The Grant Avenue Street Flower Market

1                    On the west sidewalk of Grant Avenue within 100 feet south of the southerly line  
2 of Geary Street.

3                    ~~On the east sidewalk of Grant Avenue within 100 feet south of the southerly line of Post~~  
4 ~~Street.~~

5                    The Stockton Street Flower Market

6                    On the west sidewalk of Stockton Street within 100 feet south of the southerly  
7 line of Geary Street.

8                    On the east sidewalk of Stockton Street within 100 feet south of the southerly  
9 line of Geary Street.

10                   On the west sidewalk of Stockton Street within 100 feet north of the northerly  
11 line of Ellis Street.

12                   On the east sidewalk of Stockton Street within 100 feet north of the northerly line  
13 of O'Farrell Street.

14                   On the north sidewalk of Post Street within 50 feet west of 250 Post Street.

15                   The Powell Street Flower Market

16                   On the east sidewalk of Powell Street between 25 feet and 100 feet south of the  
17 southerly line of Geary Street.

18                   On the west sidewalk of Powell Street within 100 feet north of the northerly line  
19 of Eddy Street.

20                   The Emporium Street Flower Market

21                   On the south sidewalk of Market Street facing the location of 835 Market Street.

22                   The Post Street Flower Market

23                   On the north side of Post Street, east of Powell Street within 200 feet east of the  
24 easterly property line of Powell Street.

25                   The Upper Market Street Flower Market

1                    On the north sidewalk of Sixteenth Street within 100 feet south of the southerly  
2 line of Market Street.

3                    The Market Street Flower Market

4                    On the south sidewalk of Market Street facing the location of 101 Market Street.

5                    On the south sidewalk of Market Street facing the location of 215 Market Street.

6                    On the east sidewalk of Montgomery Street, at Market Street, within 50 feet  
7 south of the north property line of Post Street.

8                    The Columbus Avenue and Powell Street Flower Market

9                    On the northwestern end of Marini Park on Columbus Avenue and Powell  
10 Street.

11                   The Harvey Milk Plaza Flower Market

12                   On the west sidewalk of Castro Street north of the main entrance to the Harvey  
13 Milk Plaza Muni Metro Station.

14                   Section 4. The Board authorizes the Director of the Department of Public Works to  
15 take any and all actions necessary to ensure that the permit is sold within the time specified in  
16 this Ordinance and that 185 Post Street, L.P. removes the street flower market located on the  
17 east sidewalk of Grant Avenue within 100 feet south of the southerly line of Post Street in a  
18 diligent and safe manner and restores the subject right-of-way.
