2018, under the California Emergency Solutions and Housing (CESH) Program; and

FURTHER RESOLVED, That the Applicant is hereby authorized and directed to receive a CESH grant, in an amount not to exceed \$4,000,000 in accordance with all applicable rules and laws; and, be it

FURTHER RESOLVED, That the Applicant hereby agrees to use the CESH funds for eligible activities as approved by the Department and in accordance with all Program requirements, and other rules and laws, as well as in a manner consistent and in compliance with the Standard Agreement and other contracts between the Applicant and the Department; and, be it
