

1 [Landmark Designation Nomination for Trees Located at 1141-1145 Filbert Street.]

3 **Resolution of intent initiating the nomination of the Monterey Cypress tree located at**
4 **1141-1145 Filbert Street for landmark tree status pursuant to Public Works Code**
5 **Section 810(b), acknowledging the temporary designation of such tree pursuant to**
6 **Public Works Code Section 810(d), and authorizing other official acts in furtherance of**
7 **this Resolution.**

9 WHEREAS, The Board of Supervisors adopted Ordinance No. 17-06, which amended
10 the Urban Forestry Ordinance, Public Works Code Sections 801 et seq. concerning landmark
11 and significant trees. A copy of said Ordinance is on file with the Clerk of the Board of
12 Supervisors in File No. 060912 and is incorporated herein by reference; and,

13 WHEREAS, As part of the implementation of Ordinance No. 17-06, the Urban Forestry
14 Council, after duly noticed public hearings, developed criteria and procedures for the
15 designation and removal of landmark trees and recommended that this Board of Supervisors
16 adopt such criteria and procedures. Copies of said documents are on file with the Clerk of the
17 Board of Supervisors in File No. 060912 and are incorporated herein by reference;
18 and,

19 WHEREAS, Trees provide numerous environmental, social, and economic benefits
20 such as reducing storm water runoff, reducing energy use, improving air quality, increasing
21 property values, and promoting wildlife habitat; and,

22 WHEREAS, The purpose of this resolution shall be to initiate landmarking proceedings
23 for six trees of varying species, located on Assessor's Block 97, Lot 35 and listed individually
24 below with corresponding photographs on File with the Clerk and referenced herein; and,

1 WHEREAS, The trees that are the subject of this resolution satisfy many of the
2 designation criteria in Public Works Code Section 810(f)(4)(A)-(E), including having prominent
3 and beautiful visual impacts, as well as historic, cultural, and economic significance to their
4 surrounding community; now, therefore, be it,

5 RESOLVED, This Board, pursuant to the Public Works Code Section 810(b), hereby
6 adopts this Resolution of intent to initiate a landmark tree nomination for the Monterey
7 Cypress tree located at 1141-1145 Filbert Street, Assessor's Block 97, Lot 35, identified as
8 tree #1 in attachment A to this Resolution; and, be it

9 FURTHER RESOLVED, This Board, pursuant to the Public Works Code Section
10 810(b), hereby adopts this Resolution of intent to initiate a landmark tree nomination for the
11 Monterey Cypress tree located at 1141-1145 Filbert Street, Assessor's Block 97, Lot 35,
12 identified as tree #2 in attachment B to this Resolution; and, be it

13 FURTHER RESOLVED, This Board, pursuant to the Public Works Code Section
14 810(b), hereby adopts this Resolution of intent to initiate a landmark tree nomination for the
15 Monterey Cypress tree located at 1141-1145 Filbert Street, Assessor's Block 97, Lot 35,
16 identified as tree #3 in attachment B to this Resolution; and, be it

17 FURTHER RESOLVED, This Board, pursuant to the Public Works Code Section
18 810(b), hereby adopts this Resolution of intent to initiate a landmark tree nomination for the
19 Black Acacia tree located at 1141-1145 Filbert Street, Assessor's Block 97, Lot 35, identified
20 as tree #4 in attachment C to this Resolution; and, be it

21 FURTHER RESOLVED, This Board, pursuant to the Public Works Code Section
22 810(b), hereby adopts this Resolution of intent to initiate a landmark tree nomination for the
23 Black Acacia tree located at 1141-1145 Filbert Street, Assessor's Block 97, Lot 35, identified
24 as tree #5 in attachment C to this Resolution; and, be it

1 FURTHER RESOLVED, This Board, pursuant to the Public Works Code Section
2 810(b), hereby adopts this Resolution of intent to initiate a landmark tree nomination for the
3 Black Acacia tree located at 1141-1145 Filbert Street, Assessor's Block 97, Lot 35, identified
4 as tree #6 in attachment C to this Resolution; and, be it

5 FURTHER RESOLVED, This Board acknowledges the temporary designation of such
6 tree for landmark tree status pursuant to Public Works Code Section 810(d); and, be it

7 FURTHER RESOLVED, The Board directs the Clerk to forward this Resolution and
8 accompanying documents contained in the file to the Urban Forestry Council, and due to the
9 urgent nature of the situation, to urge the Urban Forestry Council to expeditiously complete
10 the landmark tree designation review for the subject tree; and, be it,

11 FURTHER RESOLVED, The Board urges the Director of Public Works to immediately
12 notify the affected property owner of the pending nomination and inform said owner of the
13 special permit and approval requirements for removal of landmark trees under Public Works
14 Code Section 810(f) if such notification has not yet occurred.
