WHEREAS, In January 1995, the San Francisco Board of Supervisors, to honor Mr. Cesar Chavez, changed the name of Army Street to Cesar Chavez Street by Resolution 32-95; and,

WHEREAS, The California Department of Transportation (Caltrans) is responsible for signing on State highways; and

WHEREAS, The corresponding street name changes have not occurred to date on the U.S.-101 and I-280 freeways; and

WHEREAS, The 3M Company has offered to donate 23 Cesar Chavez Street signs (equivalent value of \$55,000) which meet the newly adopted Caltrans specifications, to honor Mr. Cesar Chavez and his legacy; and

WHEREAS, Caltrans has agreed to install the new signs donated to the City through a maintenance contract provided that the City pay for the amount Caltrans has determined to the City's responsibility; and

3	WHEREAS, The City's share for the replacement project is \$31,500				
4	which is the labor cost for replacing five existing signs that are				
5	still in relatively good condition; and				
6	WHEREAS, The Cesar E. Chavez Foundation has agreed to donate				
. 7	\$31,500 through private fundraising; and				
8	WHEREAS, Section 10.116 of the San Francisco Municipal Code				
9	specifies that gifts valued at more than \$5,000 are subject to				
10	approval by the Board of Supervisors; now, therefore, be it				
11	RESOLVED, That the Board of Supervisors authorizes the				
12	acceptance of the 23 signs from the 3M Company and \$31,500 from the				
13	Cesar E. Chavez Foundation, which will be transferred to Caltrans fo

16	of Parking and Traffic is authorized to execute all documents
