2 Department of Boating and Waterways in the amount of \$35,000 for the development of a  
3 Boat Pumpout/Dump Station Facility at the San Francisco Marina Small Craft Harbor]

4 **Resolution authorizing the San Francisco Recreation and Park Department to accept**  
5 **and expend a Clean Vessel Act Grant administered by the California Department of**  
6 **Boating and Waterways in the amount of \$35,000 for the installation of a boat pumpout**  
7 **and dump station combination in the San Francisco Small Craft Harbor**

9 WHEREAS, The City and County of San Francisco is desirous of improving a boat  
10 pumpout / dump station facility at the San Francisco Marina Small Craft Harbor to meet the  
11 needs of the boaters and to provide public access to these facilities; and

12 WHEREAS, Equipment now in use is antiquated and requires regular and increased  
13 maintenance; and,

14 WHEREAS, By replacing with new equipment provided by this grant there should be a  
15 net decrease in annual maintenance cost; and,

16 WHEREAS, The Department of Boating and Waterways is authorized to provide grants  
17 to cities, counties, districts, and other public agencies for the construction and development of  
18 boat pump out / dump station facilities; and,

19 WHEREAS, The City and County of San Francisco is willing to enter into an agreement  
20 to provide for the operation and maintenance of the proposed facilities at no cost to the State;  
21 and,

22 WHEREAS, The grant terms prohibit including indirect costs in the grant budget; and,  
23 now, therefore, be it

24 **RESOLVED**, That the Board of Supervisors of the City and County of San Francisco by  
25 adoption of this resolution hereby requests that the Department of Boating and Waterways



13 execute and submit all documents including, but not limited to applications, agreements,  
14 payment requests and so on, which may be necessary for the completion of the  
15 aforementioned project.
