3 **Resolution authorizing the Sheriff's Department to accept and expend a grant in the**  
4 **amount of \$ 32,900 from the Zellerbach Family Fund for providing a family literacy**  
5 **program for women prisoners in the county jail.**

7 WHEREAS, The Zellerbach Family Fund has made available funding for family  
8 literacy programs for prisoners in the county jail; and,

9 WHEREAS, Due to the need for education and support in family reunification among  
10 incarcerated women, the Sheriff's Department will offer a program to encourage family  
11 literacy, improve skills and use learning as a means of family reunification for incarcerated  
12 women and their children while in custody; and,

13 WHEREAS, The grant does not require matching funds; and,

14 WHEREAS, the Sheriff's Department proposes to maximize use of available grant  
15 funds on program expenditures by not including indirect costs in the grant budget; now,  
16 therefore, be it


17 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in  
18 the grant budget; and, be it

19 FURTHER RESOLVED, That a grant award notification has been received from the  
20 Zellerbach Family Fund; and, be it

21 FURTHER RESOLVED, That the City & County of San Francisco will adhere to the  
22 requirements of the Zellerbach Family Fund and all conditions specified in the grant  
23 agreement.




