8 WHEREAS, The City and County of San Francisco has always supported the rights of
9 workers to join and support unions of their own choosing; and,
10

11 WHEREAS, Unions have always played a vital role in raising the living and working
12 standards of all Americans; and,
13

14 WHEREAS, Blue Diamond Growers headquartered in Sacramento, California is the
15 largest almond processing facility in the world and the Blue Diamond brand is a well known
16 retail product that is a major sponsor of professional sporting events including the San
17 Francisco 49ers; and,

19 WHEREAS, Blue Diamond Growers exports 70% of its almonds to world markets and
20 relies heavily on its positive brand name identification; and,

22 WHEREAS, Blue Diamond has chosen to respond to the efforts of its employees to join
23 the International Longshore and Warehouse Union (ILWU) with an "aggressive union
24 avoidance campaign" and the National Labor Relations Board has issued 28 separate
25 complaints against Blue Diamond for violations of federal labor laws; and,

27 WHEREAS, the ILWU is one of California and San Francisco's most respected unions
28 with traditions of rank and file democracy that are unparalleled; now, therefore, be it

8 make a decision about unionization through a card check procedure.
