7 Section 1. The San Francisco Traffic Code is hereby amended by repealing Section  
8 176.32 thereof, which reads as follows:

9 ((**SEC. 176.32.** A prima facie speed limit of 35 miles per hour is hereby established on  
10 Marina Boulevard between Buchanan and Lyon Streets.))

11 Section 2. The San Francisco Traffic Code is hereby amended by adding Section  
12 174.10 thereto, to read as follows:

13 **SEC. 174.10.** A prima facie speed limit of 25 miles per hour is hereby established on  
14 Marina Boulevard between Buchanan and Lyon Streets.


